

21 New Airports Approved

New Delhi(KCN): Government of India has accorded 'In-Principle' approval for setting up of 21 new Greenfield Airports namely- Mopa in Goa, Navi Mumbai, Shirdi and Sindhudurg in Maharashtra, Kalaburagi, Vijayapura, Hassan and Shivamogga in Karnataka, Dabba (Gwalior) in Madhya Pradesh, Kushinagar and Noida (Jewar) in Uttar Pradesh, Dholera and Hirasar in Gujarat, Karaikal in Puducherry, Daga d a r t h i, Bhogapuram and Orvakal (Kurnool) in Andhra Pradesh, Durgapur in West Bengal, Pakyong in Sikkim, Kannur in Kerala and Hollongi (Itanagar) in Arunachal Pradesh across the



country. Out of these, 11 Greenfield airports viz. Durgapur, Shirdi, Kannur, Pakyong, Kalaburagi, Orvakal (Kurnool), Sindhudurg, Kushinagar, Itanagar, Mopa and Shivamogga have been operationalised. State Government of Tamil Nadu has submitted an application to Ministry of Civil Aviation (MoCA) for

grant of first stage clearance i.e. 'Site-Clearance' for development of a Greenfield airport at Parandur, Kancheepuram District, Tamil Nadu. As per GFA Policy, the proposal has been sent to Airports Authority of India (AAI), Directorate General of Civil Aviation (DGCA) and Ministry of Defence (MoD) for their comments. After completion of this consultation with stakeholders, the proposal is required to be placed before the Steering Committee on Greenfield Airports for their recommendation, with respect to award of Site Clearance. As per the GFA Policy, 2008, the responsibility of implementation of

airport projects including funding of the project, land acquisition, R&R etc rests with the concerned airport developer including the respective State Government (in case the State Government is the project proponent). The timeline for construction of airports depends upon various factors such as land acquisition, mandatory clearances, removal of obstacles, financial closure etc. by the respective airport developers. This information was given by the Minister of State in the Ministry of Civil Aviation Gen. (Dr) V. K. Singh (Retd) in a written reply to a question in Rajya Sabha today.

Low Pressure-Induced Very Heavy Rainfall To Lash Odisha Districts During Next 2 Days



Bhubaneswar(KCN): Due to the prevalent monsoon trough, heavy rainfall is very likely to occur at one or two places over the districts of Odisha during next 48 hours. India Meteorological Department (IMD) regional centre today issued Orange Warning in some districts of the State for next two days. In its evening bulletin, the IMD regional centre mentioned, "The

cyclonic circulation over Westcentral and adjoining Northwest Bay of Bengal now lies over Westcentral and adjoining Northwest Bay of Bengal off North Andhra Pradesh-south Odisha coasts." Light to moderate rain or thundershower is very likely to occur at most places over the districts of South Interior Odisha and at many places over the rest districts of Odisha. It is said that the team will apprise the software and internet companies about the investment opportunities in Odisha as there are plans to have a dedicated fiber net grid and its laying.

Vedanta engaged in illegal coal mining at Sundargarh's Jamkani, alleges Congress

Bhubaneswar(KCN): Vedanta company is engaged in illegal coal mining at Jamkani in Sundargarh district, alleged Odisha Congress citing that illegal mining activities are rampant near the human settlement which has sparked resentment.

Congress campaign committee chairperson, Bijay Patnaik targeted the Odisha government by levelling such allegations. Patnaik also alleged that Vedanta doesn't have environmental clearance for the same. According to Patnaik, new process should have been followed if there is no physical possession within 5 years of getting permission as per the 2013 rules. The senior Congress leader further alleged that people are now living under haphazard conditions. There has been no gram sabha and no action has been taken towards rehabilitation, Patnaik said.

"As per norms, if there is no environmental clearance, Vedanta needs to take it. If it already has, the Company should fulfil the conditions," said Patnaik. Similarly, if the land acquisition has not taken place and people are staying there, land acquisition should be carried out as per the new Act, said Patnaik adding that all these amount to violation of law. OSSC question paper leak: BJP seeks SIT probe, Congress wonders where is 5T



Bhubaneswar, (KCN): The state units of the Bharatiya Janata Party (BJP) and the Congress party on Monday launched a fierce attack on the ruling Biju Janata Dal (BJD) over the leak of the question paper of the recently-conducted Main Written Examination for JE (Civil).

Alleging rampant corruption in the government recruitment process, the saffron party wished to know how question papers reached the arrested persons of

Bihar and Andhra Pradesh.

"How did the question

papers reach the middlemen of Bihar and Andhra Pradesh who had been active here?" asked state BJP spokesperson Anil Biswal.

"The present chairman of the Odisha Staff Selection Commission is a former police DG. Doesn't he know the modus operandi to be followed when a complaint is received? Is the racket being run by middlemen only? Is none of the OSSC involved in

it?" he asked.

"I want to say what role the Odisha government is playing in such scams. All these things are coming under the GA department. Its investigation should be conducted by the SIT. And the officers of the OSSC involved in the scam should be brought under the purview of investigation," he demanded.

Demanding action against those responsible, OPCC chief Sarat Pattnayak said there is 5T but no

transparency.

"Someone must be there. If none of the OSSC is involved, how the question papers are leaking? If it has been leaked, why the state government is not punishing the guilty ones? There is 5T here. So why these things are not being settled. There is no transparency anywhere except in words," said Pattnayak.

"The state government

should stop playing with the future of poor students of the state," he added.

Taking the side of his government, BJD spokesperson Lenin Mohanty said, "Odisha unit of the BJP speaking on any issue including job scam is like a devil reciting Veda. In the states where the BJD is ruling, many such scams have been reported and nothing has so far been done. They are now politicising the issue when nine persons have already been arrested on the basis of the enquiry report of the government's agency.



The National Education Policy (NEP): Transforming Higher Education



The National Education Policy (NEP) in India aims to bring about comprehensive reforms in the education sector, particularly in higher education. One of the key recommendations of the NEP is to expand the gross enrolment rate in higher education, with a specific focus on increasing participation in vocational education. Among many issues listed by the NEP (NEP section 9.3), the absence of teacher and institutional autonomy assumes significance in comprehending the rationale behind the higher education reform. The steady growth in privatization did not lead to much of an improvement in the quality because privatization mutated to commercialization, which is inimical to delivering quality education (NEP section 18.2). The NEP observes

fragmentation of the higher education system has restricted the free flow of ideas within the sector, generating confusion and conflicts in regulating the industry resulting in a severe compromise to promote multidisciplinary in teaching and research. Setting up regulatory authority by dismantling the University Grants Commission (UGC) and the All India Council for Technical Education was earlier recommended by the National Knowledge Commission (NKC) in 2007 and the Yash Pal Committee Report in 2009. The NEP argues that fragmentation of the Indian higher education system has created fault lines between general and professional education, public and private, centre and the state and national and foreign institutions, with many being in operation without proper approval. These fragmentations must be clarified for the regulators and the stakeholders, rendering regulatory interventions ineffective and

enforcement difficult. This has made the present system of regulation and funding unsustainable. The NEP has suggested establishing an overarching Higher Education Commission of India (HECI) (NEP section 18.3). This will be supported by four pillars, National Higher Education Regulatory Council (NHERC), National Accreditation Council (NAC), the Higher Education Grants Council (HEGC), and the General Education Council (GEC). The NHERC will focus on "light but tight" regulation, emphasizing transparency in financial probity (NEP section 18.3). Private- and public-funded HEIs will be treated equally. Good governance, transparency in economic affairs and financial integrity through disclosure will be the central focus of the NHERC. However, it may be noted that accounts may show that no profit is being made, whereas accounting manipulations ensure siphoning out of surplus. After all,

subversion of the educational processes is not a big deal in education, and this is a root cause behind the poor quality of higher education. The NEP recognizes the importance of increasing the gross enrolment rate in higher education. It sets an ambitious target of achieving a 50% enrolment rate by 2035, a significant increase from the 26.3% recorded in 2018 (NEP section 10.8). However, the NEP emphasizes a change in the composition of enrolment, with a particular emphasis on vocational education. By 2025, the NEP recommends that at least 50% of learners should be enrolled in vocational education programs (NEP section 16.5). This shift reflects the need to align education with the demands of the job market and equip students with practical skills.

Online Teaching Is a Game Changer:
The higher education sector is undergoing transformative changes with the integration of technology and improved internet

connectivity. While some resistance to online teaching existed, it is no longer significant in the current scenario. Online education eliminates the constraints of time and space associated with traditional classroom teaching. By digitizing and recording lectures, online teaching becomes a digital product that can be accessed by anyone, anywhere in the world, subject to the teacher's or institution's discretion. This shift has significant implications for the market as online teaching gains prominence. However, it is essential to note that offline and online education are not equivalent in their impact on learning outcomes. Classroom interactions and dialogue have a unique value that online teaching cannot fully replicate. Nevertheless, teachers will be better prepared for the classroom as online transactions become more formal and transparent.

While challenges and

differences exist between offline and online teaching, adopting technology offers new opportunities and possibilities for education delivery, market dynamics, and the overall quality of education. According to the NEP, granting autonomy to teachers and institutions will enable them to chart their paths and compete for success. This autonomy will foster a highly competitive market, especially with the potential entry of top-ranking foreign universities in India. While online teaching is generally considered cost-effective, additional expenses may be incurred to provide special assistance to students who require support in coping with the challenges of online learning.

The NEP emphasizes a balanced contribution from the public and private sectors in expanding higher education.

Both sectors are responsible for increasing enrolment rates and ensuring equitable access to quality education. The

involvement of private institutions is expected to stimulate healthy competition and enhance the overall quality of education. The NEP's recommendations for higher education in India outline a comprehensive plan to expand enrolment rates, with a focus on vocational education. The involvement of both the public and private sectors, along with the phasing out of affiliation, will contribute to a more equitable and diverse higher education landscape. The categorization of institutions and the promotion of multidisciplinary education and research universities aim to foster excellence and innovation. Finally, establishing the National Research Foundation will support research and collaboration, strengthening the research ecosystem and enhancing the overall quality of higher education in India.

Nothing is more laughable and contrary to the elementary principles of jurisprudence than the so-called basic structure theory, based on which the Supreme Court has rendered hundreds of judgements and even quashed the NJAC



It is known even to a law student that only a person aggrieved, namely, one whose rights are infringed, alone can go to a Court, and where the fundamental rights are infringed, one could go straight to the Supreme Court under Article 32. Without pleading infringement of a right, no one can go to a court. This is a universal principle. But the celebrated Kesavananda Bharati case laid down that one can go to a court without any of his right, much less fundamental rights, being infringed. Even if Kesavananda Bharati does not say so, it is so understood and done today. In Kesavananda Bharati the full court of the Supreme Court held that the Parliament

has the power to abrogate every article of the constitution, including the fundamental rights, but not the "basic structure". Since then, petitions are filed in the Supreme Court under Article 32, claiming that the "basic structure" is infringed, though no fundamental right is violated. It is not too difficult to understand the folly of the basic structure theory but for which the so-called freedoms and liberties of the citizens, nay, the very concept of democracy would be put to democracy. It requires no great loud thinking to comprehend a situation where the basic structure is abrogated but no fundamental right is violated, what additional right or remedy does Kesavananda confer on him. The answer is absolutely in the negative. To emphasize,

ex facie irrational. Because if the violation of the basic structure does not result in the violation of any legal right, much less fundamental right, why would a citizen be at all concerned and why would he need a right to go to court. On the contrary, rights and fundamental rights in particular, if violated, pre- Kesavananda Bharati, a citizen has a right to approach the Court, which under Article 32 is guaranteed. In other words, if in the pre-Kesavananda era a citizen could approach the court complaining of violation of his right and the Supreme Court under Article 32, directly without approaching any other court where a fundamental right is violated, what additional right or remedy does Kesavananda confer on him. The answer is absolutely in the negative. To emphasize,

sensationalised. I vaguely recollect a judgement by Justice Chettur Shankaran Nair of the Kerala High Court which had dealt with the issue of privacy in just 4 pages quoting Semayne's case, where CJ Coke said that 'to every man his home is his castle', the principle of privacy stated emphatically.

Coming back to the basic structure theory, i beg to submit that the Supreme Court allowed itself to be misled by the South Bombay lobby of lawyers who had been literally holding it for ransom. These "legends" were anti-democratic and because of the overwhelming influence they had over the bar and the bench, create an illusion that the Parliament is anti-democratic and that it's primary job is to enact laws which take away and curtail the rights and

liberties of the citizens and the judiciary is a bulwark against the anti-democratic legislature and executive. The legislature and the executive can be criticised ruthlessly, but the right to criticize the judiciary is the exclusive province of those who can muster the support of half a dozen retired judges, scores of retired bureaucrats and ex servicemen. Let me try to make sense of the basic structure. Whether the basic structure should be altered, for instance, instead of a parliamentary democracy we should adopt the presidential form of government, which will certainly alter the basic structure of the constitution, is for the Parliament to discuss.

The basic structure is not a justiciable issue. It is a political concept. To conclude, whether the basic structure is infringed or not, if fundamental rights are violated, judicial review will lie. On the contrary, if no fundamental right is violated, and assuming for arguments sake that the basic structure is violated, no judicial review will lie. Because why should there be a judicial review when there is no person aggrieved. Kesavananda Bharati has opened the gates for busybodies to institute petitions under Article 32 where they claim no violation of their fundamental or legal right. Through PILs they destroyed the foundations of democracy by making the judiciary a supreme legislature and supreme executive with no accountability to the people. The tragedy of this country is that the

"Here, the majority community has always kept the minority communities like us oppressed. We cannot no longer stay with other community. New Delhi: A leader of Telangana's ruling Bharat Rashtra Samithi (BRS), who briefly trended on social media last year for giving whiskey and chicken to supporters, has surfaced again in a viral video - this time distributing something else.

In October last year, a video of Rajanala Srihari, a leader of Chief Minister K Chandrashekhar Rao's party, had been shared widely on social media after he distributed whiskey and chicken to his supporters in public.

Mr Srihari's kitchen staple philanthropy meets three objectives - birthday wish for KTR, supporters' goodwill, and free vegetable in times of price rise. The government's

Consumers can place their orders from 9.30 am to 3.30 pm daily and the delivery will be made the next day. "There will be doorstep delivery at no extra cost to the consumer," she said.

Cough Syrup Suspected In Gambia Deaths Clean: Health Ministry Sources

New Delhi: Cough syrup from a Haryana-based firm that allegedly caused deaths of children in Gambia, has passed all tests, sources in Union Health Ministry told NDTV today. The investigation was conducted by the government's pharmacology chief. "If any question or communication comes from the Gambia government, we will also reply according to our report," sources said. "We have done a complete investigation from our side regarding Maiden Pharma. The investigation did not find anything that was wrong. Controlled samples kept at the manufacturing unit of Cough Syrup passed the test. All four syrup samples passed," sources said. "The government there may have its own findings, we did not find any problem here," a source added. In October last year, the World Health Organization (WHO) had issued an alert stating that the four cough syrups being supplied to Gambia by the India-based Maiden Pharmaceuticals Ltd were of substandard quality and claimed that they were linked to the death of many children in Gambia. In March, a joint probe by the Centers for Disease Control and Prevention (CDC) of the US and the Gambian health authorities had suggested a strong link between the deaths of many children in Gambia and the consumption of made-in-India cough syrups that were allegedly contaminated.

"No End To Callousness Of State Government": Shashi Tharoor On Manipur



New Delhi: Congress's Shashi Tharoor, at the end of another chaotic day in parliament, sharply criticized the BJP governments at the Centre and in Manipur, and Prime Minister Narendra Modi for not speaking on the issue. In every nation with a parliamentary system, the Prime Minister is accountable to parliament, and he should take the members "into his confidence" if there is any particular reason for not dismissing the elected government of Manipur, he said. There is "no end to ineptitude and callousness of the state government," Mr Tharoor added.

"It has been an irony for some time. The Prime Minister barely speaks in a house where he is a member. He is one of our most eloquent orators... He speaks from every stage and at every available opportunity," Mr Tharoor told NDTV in an exclusive interview.

"This is one of the gravest crisis our country has faced in a long time... There has been a horrendous loss of lives... 140 or more were killed... there were rapes

underscored. The united opposition, he added, is ready for a debate on the issue, but it is essential that the Prime Minister speaks first. Lok Sabha proceedings were adjourned for the day today amid unrelenting protests by opposition members for PM Modi's statement on the Manipur situation. The protests continued even though Union Home Minister Amit Shah assured the House that the government will discuss the issue. Rajya Sabha proceedings too were adjourned for the day following an uproar over the Manipur issue and the suspension of Aam Aadmi Party's Sanjay Singh for the rest of the monsoon session. The BJP has alleged that the opposition is running away from a discussion in Parliament as it does not want certain facts to become public.

Suspension axe on Odisha teacher for beating 70 girl students over poor academic performance

BERHAMPUR: A teacher of RCM Upper Primary school in Ganjam's Soroda NAC was placed under suspension on Saturday on the charge of mercilessly beating around 70 girl students of Class VII who failed in the recent half-yearly examinations. The accused teacher was identified as Palvert Baliarsingh. The missionary school is government aided and has boarding facility.

Sources said on March 6, Baliarsingh huddled the students, most of whom were tribals, in a room of the hostel and thrashed them with a baton. The teacher

was reportedly furious over the dismal performance of the students in the recent examinations. Unable to bear the torture, at least seven girls fell sick. However, instead of taking them to the hospital, the school management allegedly treated them in the hostel. The

school authorities managed to suppress the matter but a video clip of the incident went viral on social media following which action was taken against Baliarsingh. Contacted, in-charge headmaster of the school Pabitra Mohan Mantri admitted that the incident took place in the hostel. The

matter has been apprised to the authorities concerned, he added. Despite repeated attempts, no officer of the district education department was available for comment. Sources said parents of the victim students are yet to lodge a complaint with police in this connection.

Potato bumper harvest turns nightmare for Odisha farmers



BHUBANESWAR: A bumper harvest of potato this year has turned into a nightmare for the farmers who are struggling even to recover the input cost as the farm gate price of the vegetable is depressingly low. With wholesale price of potatoes at Rs 10 per kg in major markets of the state, there are no takers for the local produce at a time when more than 70 per cent of the crop has already been harvested. Traders are offering to buy the vegetable from potato growers at Rs 5 a kg mostly in

neighbouring West Bengal, a major supplier of vegetables to the state. With no institutional mechanism for buyback from the farmers with a remunerative minimum support price, the potato growers are at the mercy of the market dynamics. With no cold storage facilities or organised potato mandi, the farmers are left with little choice but to sell their produce at whatever price is available in local markets, the sources maintained. General secretary of

Aiginia vegetable merchant association, Shakti Shankar Mishra said he is not in position to tell the farm gate price of the potato produced in the state as the vegetable is yet to arrive at the mandi. He said harvesting is still underway and it will take a couple of days for the arrival of locally produced potato.

As per the area expansion programme through cluster approach, the horticulture directorate has increased the tuber cultivation from 27,155 hectare in 2021-22 to 33,000 hectare in 2022-23 with an anticipated production of 7.26 lakh tonne of potato. The government had also provided quality seeds of 50,000 quintal to farmers during this kharif season. Under the area expansion programme, the state government has made a plan to scale up potato production to over 13 lakh tonne by 2025-25.

Orissa High Court case clearance rate over 126 per cent till June this year

CUTTACK: The Orissa High Court recorded a case clearance rate (CCR) of 126.66 per cent (pc) during the first six months of this year. While 49,635 cases were instituted and 62,869 disposed of, the number of pending cases went down from 1,64,771 on January 1 to 1,46,582 by June 30. During this period as many as 1,368 judgments were delivered. Of the 62,869 cases disposed of, 39,620 were civil and 23,249 criminal. Around 29,735 civil and 19,900 criminal

cases were instituted, as per the half-yearly statement released by the high court. While the clearance rate in January was 159.96 pc, it went down to 148.62 pc in February, 131.56 pc in March, 126.72 pc in April and 109.82 pc in May, but again increased in June. In the case of subordinate courts across the state, the CCR was 87.02 pc during the first six months. The CCR was nearly 130 pc in February due to disposal of cases in the Lok Adalat and withdrawal of cases.

BCCI to release India bilaterals tender in next two days

Mumbai: The media rights tender for the bilateral cricket games in India will be released in the coming day or two. The Board of Control for Cricket in India (BCCI) and its consultants, Ernst & Young, have informed the potential parties that the highly anticipated announcement will be made by Tuesday (July 25), if not within the next 24 hours. The target date to complete the media rights sale is set for August 19.

Prospective participants have not been clearly informed whether the

method of sale will be through e-auction or closed bidding as there seems to be still some debate on this. However, considering the BCCI's past experience and blockbuster sale of the Indian Premier League (IPL) media rights last year, it is perceived that the sale will be conducted through online bidding. The media rights will be valid for a period of five years, from 2023 to 2027. The exact number of matches and their breakdown in terms of

Tests, ODIs, and T20Is has not been finalized yet, as the BCCI apparently is yet to lock in a few series. However, it is expected to be around 100 matches, which is similar to the number in the last cycle. For reference, the previous cycle had 103 games. The new cycle is expected to follow the recent trend in world cricket, with fewer ODIs and more Twenty20 Internationals than in the last cycle, while the number of Tests is likely to remain the



same. In the previous deal that ended in March, the BCCI had sold the bilateral rights to Disney Star for INR 6138.10 Crore, approximately INR 61 Crore per international game across formats. The base price this time is expected to be substantially higher than that number. The rights will be sold in different packages, with linear and digital rights separated, and bidders will not have the option to present a consolidated package bid. Other packages, such as the non-India/rest of the world rights, will also be available. However, it is unlikely that the tender will include a special non-exclusive package like the one that contributed significantly to the final value of the IPL tender, which reached INR 48390 Crore (\$6.2 Billion).

The BCCI aims to complete the sale by August 19, allowing the new buyer at least one month to market the first series in the cycle - a three-match ODI series against Australia in September, planned as a preparatory series for the World Cup in October-November.

Ayesha Naseem retires from international cricket for religious reasons

New Delhi: In January 2020, Ayesha Naseem - then 15 years old - was hoping that she could become an inspiration. She was fast-tracked to the national side at the back of her standout power-hitting ability. At that point, when she hadn't even played an international game, she hadn't set sight on becoming the greatest cricketer. All that she hoped for was to become an inspiration for parents who didn't allow their daughters to play in the conservative region of Abbottabad, in Khyber-Pakhtunkhwa. She wanted to get the girls out of their homes to cricket grounds.

Born in the village of Bagan, her family moved to Karachi where she started playing cricket along with her brother. "In my hometown, girls aren't even allowed to step out, let alone play cricket," she had told Cricbuzz then. Ayesha



had a stronger support system; she got access to cricket as well as education. In 2015, when her family returned to Abbottabad and she started playing formal cricket, there were roadblocks. "People frowned upon me for playing cricket. They constantly dissuaded me and suggested that I was a bad influence on their daughters." Eventhough it was becoming difficult to pursue the sport from

her native town and she had the choice of playing from Karachi, she opted not to exercise that option. "What's the point of me returning to Karachi? I had so many friends who were talented but didn't get that opportunity. I had the support of my family, and when others see me excel, I hope they will start sending their daughters to play as well. All that these girls need is the trust and support of their parents."

impact. Ravi Dahiya's Asian Games Dream Comes Crashing As He Shockingly Loses Wrestling Trials

New Delhi: Ravi Kumar Dahiya, silver-medalist of Tokyo Olympics 2020, won't be travelling for the Asian Games 2023 as he was knocked out of the wrestling trials by Maharashtra's Atish Todkar by 20-8 at the Indira Gandhi Arena on Sunday. Olympic and World medalist, Ravi Dahiya crashed out in the first round of wrestling selection trials for the acclaimed tournament. Dahiya started wrestling in his early teens and won the silver medal in the 2015 Junior World Wrestling Championships at Salvador de Bahia in the 55 kg freestyle category.

He picked up an injury in 2017 which kept him out of action for more than a year. In his comeback year, he won the silver medal at the 2018 World U23

Wrestling Championship in Bucharest, India's only medal at the competition, in the 57 kg category. Dahiya remained unbeaten at the 2019 Pro Wrestling League, representing the title-winning team, Haryana Hammers. He was ranked fifth at the 2019 Asian Wrestling Championships in

Xi'an, after losing the bronze medal match. In his World Championships debut in 2019, Dahiya defeated the European champion Arsen Harutyunyan in the round of 16, and the 2017 world champion Yuki Takahashi in the quarterfinal, to earn one of the six available quota places for the 2020 Summer Olympics. He lost to defending champion and eventual gold medalist Zaur Uguev in the semifinal round. He managed to take the bronze after defeating Reza Atri of Iran. On the back of his medal win, Dahiya was included in the Ministry of Youth Affairs and Sports' Target Olympic Podium Scheme (TOPS) in October 2019. He is also a bronze medallist in the 2019 World Wrestling Championships and a three-time Asian champion.

Dahiya won gold at the 2020 Asian Wrestling Championships in New Delhi and the 2021 Asian Wrestling Championships in Almaty. In the 2022 Birmingham Commonwealth Games, he won the gold medal in the men's 57kg freestyle wrestling category in Birmingham, England.

At the 2022 Yasar Dogu Tournament, he won the gold medal after defeating Uzbek Gulomjon Abdullaev 11-10 in the final. At the 2022 World Wrestling Championships, he lost to Uzbekistan's Gulomjon Abdullaev in the pre-quarterfinals.
