Ukraine rejects Russian demand for surrender in Mariupol

LVIV(KCN): Ukrainian officials defiantly rejected a Russian demand that their forces in Mariupol lay down arms and raise white flags Monday in exchange for safe passage out of the besieged strategic port city.

Even as Russia intensified its attempt to bombard Mariupol into surrender, its offensive in other parts of Ukraine has floundered. Western governments and analysts see the broader conflict grinding into a war of attrition, with Russia continuing to barrage cities.

In the capital Kyiv, Russian shelling devastated a shopping centre near the city centre

killing at least eight people.

The encircled southern city of Mariupol on the Sea of Azov has seen some of the worst horrors of the war, under Russian pounding for more than three weeks. Strikes hit an art school sheltering some 400 people only hours before Russia's

offer to open two corridors out of the city in return for the capitulation of its defenders, according to Ukrainian officials.

Ukrainian officials rejected the Russian proposal for safe passage out of Mariupol even before Russia's deadline of 5 a.m. Moscow time (0200GMT) for a response came and went.

"There can be no talk of any surrender, laying down of arms," Ukrainian Deputy Prime Minister Irina Vereshchuk told the news outlet Ukrainian Pravda. "We have already informed the Russian side about this."

Mariupol Mayor Piotr Andryushchenko also dismissed the offer shortly after it was made, saying in a Facebook post he didn't need to wait until the morning deadline to respond and cursing at the Russians, according to the news agency Interfax Ukraine.

Russian Col. Gen. Mikhail Mizintsev had offered two corridors - one heading east toward Russia and the other west to other parts of Ukraine. He did not say what Russia planned if the offer was rejected.



The Russian Ministry of Defense said authorities in Mariupol could face a military tribunal if they sided with what it described as "bandits," the Russian state news agency RIA Novosti reported.

Multiple attempts to evacuate residents from Mariupol and other Ukrainian cities have failed or only partly succeeded, with bombardments continuing as civilians tried to flee. City officials said at least 2,300 people have died in the siege, with some CONTINUED ON: P-7





Necessity of Labour Courts and Labour Tribunals

The Industrial Disputes Act, 1947 did not contain a provision for dealing with the adjudication of the



Industrial Disputes. There was serious criticism that a large number of industrial disputes remained unresolved due to the lack of any appropriate adjudicating institutions under the Industrial Disputes Act, 1947 (hereinafter referred as "Act"). By the Industrial

Disputes (Amendment and Miscellaneous Provisions) Act, 1956, the old Section 7 was substituted with Section 7, 7-A, 7-B and 7-C. The second schedule of the Act was also inserted by the said Amendment Act, 1956. The earlier system of tribunals under the Industrial Disputes (Appellate Tribunal) Act, 1950 a three tier system of original tribunals were substituted and manned by personal of appropriate qualification. Reference to the national tribunals will be made by the Central Government and they will cover disputes which involve the questions of national importance or which are of such a nature that establishment situated in more than one State are likely to be interested in or affected by the dispute. Section 7 : The Labour Courts

- "(1) The appropriate Government may, by notification in the Official Gazette, constitute one or more Labour Courts for the adjudication of industrial disputes relating to any matter specified in the Second Schedule and for performing such other functions as may be assigned to them under this Act.
- (2)A Labour Court shall consist of one person only to be appointed by the appropriate Government.
- (3)A person shall not be qualified for appointment as the presiding officer of a Labour Court, unless
- [(a) he is, or has been, a Judge of a High Court; or he has, for a period of not less than three years, (b) been a District Judge or an Additional District Judge; or
- he has held any judicial office in India for not [(d)] less than seven years; or
- [(e)] he has been the presiding officer of a Labour Court constituted under any Provincial Act or State Act for not less than five years.
- [(f) he is or has been a Deputy Chief Labour Commissioner (Central) or Joint Commissioner of the State Labour Department, having a degree in law and at least seven years' experience in the labour department including three years of experience as Conciliation Officer:

Provided that no such Deputy Chief Labour Commissioner or Joint Labour Commissioner shall be appointed unless he resigns from the service of the Central Government or State Government, as the case may be, before being appointed as the presiding officer; or he is an officer of Indian Legal Service in Grade (g)

Ili with three years' experience in the grade.] Section 7A: Tribunals: (1) The appropriate Government may, by notification in the Official Gazette, constitute one or more Industrial Tribunals for the adjudication of industrial disputes relating to any matter, whether specified in the Second Schedule or the Third Schedule ²[and for performing such other functions as may be assigned to them under this Act].

[(1A) The Industrial Tribunal constituted by the Central Government under sub-section (1) shall also exercise, on and from the commencement of Part XIV of Chapter VI of the Finance Act, 2017, the

Act, 1926; The Payment of Wages Act, 1936; The Factories Act, 1948; The Minimum Wages Act,

1948; The Employees State Insurance Act, 1948; The **Employees Provident Fund and Miscellaneous Provisions** Act, 1952 and the Working Journalist and Other Newspaper Employees (Conditions of Services & Miscellaneous Provisions) Act, 1955; The Motor Transports Workers Act, 1961; The Maternity Benefits Act, 1961; The Payment of Bonus Act, 1965; The Beedi and Cigar Workers (Conditions of Employment) Act, 1966; The Contract Labour (Regulation and Abolition) Act, 1970; The Payment of Gratuity Act, 1972; The Sales Promotion Employees (Conditions of Service) Act, 1976; The Equal Remuneration Act, 1976; The Inter-State Migrant Workman (Regulation of Employment and Conditions of Service) Act, 1979.

7A: Tribunals

The Industrial Tribunals deal with the subjects not only relating to the second schedule but also third schedule. The subjects under second schedule have been mentioned hereinabove but the following subjects under the third schedule to be dealt by the Industrial Tribunals are as under:

- Wages including the period and the mode of (i) payment;
- Compensatory and other allowances; (ii)
- (iii) Hours of work and rest intervals;
- (iv) Leave with wages and holidays; (v)
- Bonus, profit sharing, provident fund and gratuity; Shift working otherwise than in accordance with (vi) the pending orders;
- (vii) Classification by grades;
- Rules of discipline; (viii)
- (ix) Rationalization;
- (x) Retrenchment of workman and closure of establishment; and
- (xi) Any other matter that may be prescribed.

However the Section 7-B of the I.D. Act deals with the function of National Tribunals. The Central Government refers the Industrial Disputes for adjudication where in the opinion of the Central Government involve the question of national importance or are of such a nature that the industrial establishment situated in more than one state are likely to be interested in or effected by such disputes. For referring the disputes there is a provision under Section 10 of the Industrial Disputes Act which deals with the procedure for referring a dispute to boards or tribunals.

- Section 10A deals with the award
- "1[10A. Voluntary reference of disputes to arbitration.— (1) Where any industrial dispute exists or is apprehended and the employer and the workmen agree to refer the dispute to arbitration, they may, at any time before the dispute has been referred under section 10 to a Labour Court or Tribunal or National Tribunal, by a written agreement, refer the dispute to arbitration and the reference shall be to such person or persons (including the presiding officer of a Labour Court or Tribunal or National Tribunal) as an arbitrator or arbitrators as may be specified in the arbitration agreement.
- [(1A) Where an arbitration agreement provides for a reference of the dispute to an even number of arbitrators, the agreement shall provide for the appointment of another person as umpire who shall enter upon the reference, if the arbitrators are equally divided in their opinion, and the award of the umpire shall prevail and shall be deemed to be the arbitration award for the purposes of this Act.]

- (2)The conciliation officer shall, for the purpose of bringing about a settlement of the dispute, without delay, investigate the dispute and all matters affecting the merits and the right settlement thereof and may do all such things as he thinks fit for the purpose of inducing the parties to come to a fair and amicable settlement of the dispute.
- (3) If a settlement of the dispute or of any of the matters in dispute is arrived at in the course of the conciliation proceedings the conciliation officer shall send a report thereof to the appropriate Government ¹[or an officer authorised in this behalf by the appropriate Government] together with a memorandum of the settlement signed by the parties to the dispute.
- (4) If no such settlement is arrived at, the conciliation officer shall, as soon as practicable after the close of the investigation, send to the appropriate Government a full report setting forth the steps taken by him for ascertaining the facts and circumstances relating to the dispute and for bringing about a settlement thereof, together with a full statement of such facts and circumstances, and the reasons on account of which, in his opinion, a settlement could not be arrived at.
- (5) If, on a consideration of the report referred to in (a) sub-section (4), the appropriate Government is (b)satisfied that there is a case for reference to a Board, ²[Labour Court, Tribunal or National Tribunal], it may make such reference. Where the appropriate Government does not make such a reference it shall record and communicate to the parties concerned its reasons therefor. (c)
- A report under this section shall be submitted (6) within fourteen days of the commencement of the conciliation proceedings or within such shorter period as may be fixed by the appropriate Government:

[Provided that, 4[subject to the approval of the conciliation officer,] the time for the submission of the report may be extended by such period as may be agreed upon in writing by all the parties to the dispute.]

Section 15 deals with the duties of the Labour Courts, Tribunals and National Tribunals:

¹[15. Duties of Labour Courts, Tribunals and National Tribunals.—Where an industrial dispute has been referred to a Labour Court, Tribunal or National Tribunal for adjudication, it shall hold its proceedings expeditiously and shall, ²[within the period specified in the order referring such industrial dispute or the further period extended (2)under the second proviso to sub-section (2A) of section 10], submit its award to the appropriate Government.]'

Section 16 deals with the form of report or award. "[16. Form of report or award.—(1) The report of a Board or Court shall be in writing and shall be signed by all the members of the Board or Court, as the case may be: Provided that nothing in this section shall be deemed to prevent any member of the Board or Court from recording any minute of dissent from a report or from any recommendation made therein.

The award of a Labour Court or Tribunal or (2) National Tribunal shall be in writing and shall be [(3)

the employer shall be liable to pay such workman, during the period of pendency of such proceedings in the High Court or the Supreme Court, full wages last drawn by him, inclusive of any maintenance allowance admissible to him under any rule if the workman had not been employed in any establishment during such period and an affidavit by such workman had been filed to that effect in such Court:

Provided that where it is proved to the satisfaction of the High Court or the Supreme Court that such workman had been employed and had been receiving adequate remuneration during any such period or part thereof, the Court shall order that no wages shall be payable under this section for such period or part, as the case may be.]" Section 18 deals with the settlement and awards so far the binding is concerned.

- A settlement arrived at by agreement between the employer and workman otherwise than in the course of conciliation proceeding shall be binding on the parties to the agreement.
- $(2)^{2}$ [Subject to the provisions of sub-section (3), an arbitration award] which has become enforceable shall be binding on the parties to the agreement who referred the dispute to arbitration.]
- [(3)] A settlement arrived at in the course of conciliation proceedings under this Act ⁴[or an arbitration award in a case where a notification has been issued under sub-section (3A) of section 10A1 or 5[an award 6[of a Labour Court, Tribunal or National Tribunal] which has become enforceable] shall be binding on-
- all parties to the industrial dispute;
- all other parties summoned to appear in the proceedings as parties to the dispute, unless the Board, ⁷[arbitrator,] ⁸[Labour Court, Tribunal or National Tribunal], as the case may be, records the opinion that they were so summoned without proper cause;
- where a party referred to in clause (a) or clause (b) is an employer, his heirs, successors or assigns in respect of the establishment to which the dispute relates;
- (d) where a party referred to in clause (a) or clause (b) is composed of workmen, all persons who were employed in the establishment or part of the establishment, as the case may be, to which the dispute relates on the date of the dispute and all persons who subsequently become employed in that establishment or part.'
- Section 19 deals with the period of operation of settlements and awards. "(1)
 - A settlement 1*** shall come into operation on such date as is agreed upon by the parties to the dispute, and if no date is agreed upon, on the date on which the memorandum of the settlement is signed by the parties to the dispute.
 - Such settlement shall be binding for such period agreed upon by the parties, and if no as is such period is agreed upon, for a period of six months ²[from the date on which the memorandum of settlement settlement is signed by the parties to the dispute], and shall continue to be binding on the parties after the expiry of the period aforesaid, until the expiry of two months from the date on which a notice in writing of an intention to terminate the settlement is given by one of the parties to the other party or parties to the settlement.
 - An award shall, subject to the provisions of this

- jurisdiction, powers and authority conferred on the Tribunal referred to in section 7D of the Employees' Provident Funds and Miscellaneous Provisions Act, 1952 (19 of 1952).]
- (3) (2) A Tribunal shall consist of one person only to be appointed by the appropriate Government.
- (3) A person shall not be qualified for appointment as the presiding officer of a Tribunal unless-
- he is, or has been, a Judge of a High Court; or (a) (aa) he has, for a period of not less than three years, been a District Judge or an Additional District Judge; 5***]
- he is or has been a Deputy Chief Labour [(b) Commissioner (Central) or Joint Commissioner of the State Labour Department,, having a degree in law and at least seven years' experience in the labour department including three years of experience as Conciliation Officer:

Provided that no such Deputy Chief Labour Commissioner or Joint Labour Commissioner shall be appointed unless he resigns from the service of the Central Government or State Government, as the case may be, before being appointed as the presiding officer; or

- (c) he is an officer of Indian Legal Service in Grade III with three years' experience in the grade.]
- (4) The appropriate Government may, if it so thinks fit, appoint two persons as assessors to advise the Tribunal in the proceeding before it.
- [7B. National Tribunals.—(1) The Central Government may, by notification in the Official Gazette, constitute one or more National Industrial Tribunals for the adjudication of industrial disputes which, in the opinion of the Central Government, involve questions of national importance or are of such a nature that industrial establishments situated in more than one State are likely to be interested in, or affected by, such disputes.
- (2) A National Tribunal shall consist of one person only to be appointed by the Central Government.
- (3) A person shall not be qualified for appointment as the presiding officer of a National Tribunal ²[unless he is, or has been, a Judge of a High Court].
- (4) The Central Government may, if it so thinks fit, appoint two persons as assessors to advise the National Tribunal in the proceeding before it.]" The Industrial Tribunals are constituted for the adjudication of the Industrial Disputes relating to any matter whether specified in the second schedule or the third schedule. The National Tribunals are constituted for the adjudication of the Industrial Disputes which in the opinion of the Central Government involve questions of national importance or are of such nature that the industrial establishments situated in more than one State are likely to be interested in or effected by such disputes. Under the Second Schedule Part A, the following subjects are to be adjudicated by the labour court under Section 7(1A) and Part B of the Second Schedule the following offences under the Central Acts such as the Trade Union

- (2)An arbitration agreement referred to in subsection (1) shall be in such form and shall be signed by the parties thereto in such manner as may be prescribed.
 - A copy of the arbitration agreement shall be forwarded to the appropriate Government and the conciliation officer and the appropriate Government shall, within ³[one month] from the date of the receipt of such copy, publish the same in the Official Gazette.
- [(3A) Where an industrial dispute has been referred to arbitration and the appropriate Government is satisfied that the persons making the reference represent the majority of each party, the appropriate Government may, within the time referred to in sub-section (3), issue a notification in such manner as may be prescribed; and when any such notification is issued, the employers and workmen who are not parties to the arbitration agreement but are concerned in the dispute, shall be given an opportunity of presenting their case before the arbitrator or arbitrators.]
 - The arbitrator or arbitrators shall investigate the dispute and submit to the appropriate Government the arbitration award signed by the arbitrator or all the arbitrators, as the case may be.

- [(4A) Where an industrial dispute has been referred to arbitration and a notification has been issued under sub-section (3A), the appropriate Government may, by order, prohibit the continuance of any strike or lock-out in connection with such dispute which may be in existence on the date of the reference.]
- (5)Nothing in the Arbitration Act, 1940 (10 of 1940), shall apply to arbitration under this section.]" Section 11 A: Powers of Labour Courts, Tribunals and National Tribunals for giving appropriate relief in case of discharge, dismissal of workman:
- "1[11A. Powers of Labour Courts, Tribunals and National Tribunals to give appropriate relief in in case of discharge or dismissal of workmen.- Where an industrial dispute relating to the discharge or dismissal of a workman has been referred to a Labour Court, Tribunal or National Tribunal for adjudication and, in the course of the adjudication proceedings, the Labour Court, Tribunal or National Tribunal, as the case may be, is satisfied that the order of discharge or dismissal was not justified, it may, by its award, set aside the order of discharge or dismissal and direct reinstatement of the workman on such terms and conditions, if any, as it thinks fit, or give such other relief to the workman including the award of any lesser punishment in lieu of discharge or dismissal as the circumstances of the case may require:

Provided that in any proceeding under this section the Labour Court, Tribunal or National Tribunal, as the case may be, shall rely only on the materials on record and shall not take any fresh evidence in relation to the matter.]

Section 12 deals with the duties of the Conciliation Officer:

"[17A. Commencement of the award.—(1) An award (including an arbitration award) shall become enforceable on the expiry of thirty days from the date of its publication under section 17:

Provided that-(a)

- if the appropriate Government is of opinion, in any case where the award has been given by a Labour Court or Tribunal in relation to an industrial dispute to which it is a party; or
- (b) if the Central Government is of opinion, in any case where the award has been given by a National Tribunal, that it will be inexpedient on public grounds affecting national economy or social justice to give effect to the whole or any part of the award, the appropriate Government, or as the case may be, the Central Government may, by notification in the Official Gazette, declare that the award shall not become enforceable on the expiry of the said period of thirty days.
- (2) Where any declaration has been made in relation to an award under the proviso to sub-section (1), the appropriate Government or the Central Government may, within ninety days from the date of publication of the award under section 17, make an order rejecting or modifying the award, and shall, on the first available opportunity, lay the award together with a copy of the order before the Legislature of the State, if the order has been made by a State Government, or before Parliament, if the order has been made by the Central Government.

- (3) Where any award as rejected or modified by an order made under sub-section (2) is laid before the Legislature of a State or before Parliament, such award shall become enforceable on the expiry of fifteen days from the date on which it is so laid; and where no order under sub-section (2) is made in pursuance of a declaration under the proviso to sub-section (1), the award shall become enforceable on the expiry of the period of ninety days referred to in sub-section (2).

section, remain in operation for a period of one year ⁴[from the date on which the award becomes enforceable under section 17A]:

Provided that the appropriate Government may reduce the said period and fix such period as it thinks fit: Provided further that the appropriate Government may, before the expiry of the said period, extend the period of operation by any period not exceeding one year at a time as it thinks fit so, however, that the total period of operation of any award does not exceed three years from the date on which it came into operation.

- Nothing contained in sub-section (3) shall apply to any award which by its nature, terms or other circumstances does not impose, after it has been given effect to, any continuing obligation on the parties bound by the award.
- Notwithstanding the expiry of the period of operation under sub-section (3), the award shall continue to be binding on the parties until a period of two months has elapsed from the date on which notice is given by any party bound by the award to the other party or parties intimating its intention to terminate the award.
- [(7) No notice given under sub-section (2) or subsection (6) shall have effect, unless it is given by a party representing the majority of persons bound by the settlement or award, as the case may be.]]"

The labour courts or tribunals play a vital role in dispensing with the justice between the employers and the employees / workers. Labour courts have been endowed with the authority to exercise the power of adjudication of the disputes and any order is passed by the labour courts/tribunalsare binding upon the parties to the disputes. The role of the labour courts / tribunals is of public importance and quasi-judicial in nature. The appropriate government may by notification constitute one or more labour courts for the adjudication of the Industrial Disputes relating to any matter specified in the second schedule and for performing such other functions as may be assigned to them under the Industrial Disputes Act, 1947.

from Bhadrak. Pre-municipal poll violence raises ugly head in Bhubaneswar, 11 arrested

violence has raised its ugly head in the Capital ahead of urban elections on March 24. At least 11 persons were arrested on Sunday for their alleged involvement in the violence that took place within Laxmisagar police limits of the city on Friday.

The arrests were made on the basis of FIR lodged by two rival groups, said to be the members of BJD and BJP. Sources said that clash took place following attack on the family of the BJP corporator candidate from Ward No 33 Dharitri Jena, by the rival group.

The husband, brother-in-law, and three other family members of the corporator candidates were allegedly attacked by the rival group near Laxmisagar police station where they had gone to lodge an FIR in connection with the tearing of posters.

The police, however, also received a counter FIR and the arrests were made following investigation. So far six activists of BJP and five of BJD have been arrested, while more are expected to be booked after analysis of the available

BHUBANESWAR: Pre-poll CCTV footage and witnesses present on the spot, police said. A police official also informed that two injured persons of BJP are also undergoing treatment in a private hospital. Moreover, the Laxmisagar incident is the first major political clash prior to the urban elections.



However, officials said at least eight complaints and countercomplaints have been received so far since the commencement of the poll process. Odisha Govt ready to implement PM-ABHIM

BHUBANESWAR: Despite being one of the three states and Union territories that have not



joined the Ayushman Bharat-Pradhan Mantri Jan Arogya Yojana (AB-PMJAY), Odisha government has decided to implement the PM-Ayushman Bharat Health Infrastructure Mission (PM-ABHIM).

The PM-ABHIM is a pan-India health scheme for strengthening health care infrastructure at the grassroots. Launched in October 2021 with an outlay of Rs 64,180 crore, it aims to accomplish the vision of comprehensive health care across the country in the next five years.

The Health and Family Welfare department has designated Odisha State Health and Family Welfare Society as the single nodal agency for implementing the new health infrastructure scheme in the State. As part of the scheme, Ayushman Bharat-Health and Wellness Centres will be set up at 17,788 sub-health centres in the rural areas in seven high focus states, including Odisha and three northeastern states.

As many as 11,044 health and wellness centres along with 3,383 block public health units will be established in urban areas in 11 high focus states/UTs. Integrated district public health laboratories will be set up in all districts apart from critical care hospital blocks in government medical colleges or district headquarters hospitals which cater to a population of more than five lakh.

"The Centrally-sponsored scheme (CSS) will fill the critical gaps in public health infrastructure, especially in critical care facilities and primary care in both the urban and rural areas," said a senior health official.

Despite constant persuasion by the Centre, the Odisha government has refused to implement AB-PMJAY on the pretext that the Union Ministry of Health did not fulfil the State's demands. The State has been demanding the inclusion of 70 lakh families in the scheme and not to make Aadhaar card mandatory for patients seeking treatment at government hospitals.

Instead of AB-PMJAY, the State has implemented its flagship Biju Swasthya Kalyan Yojana (BSKY) health assurance scheme covering 3.5 crore people from 93 lakh families. Men and women have been provided an annual health coverage of Rs 5 lakh and Rs 10 lakh respectively under the State scheme.

Lensman Manas Swain Murder: Former Odisha I&PR Director Arrested

Bhubaneswar: Odisha police arrested former Information & Public Relation (I&PR) Director (Technical) Niranjan Sethi in connection with the sensational murder case of cameraman Manas Swain.

Niranjan Sethi along with his associate identified as Ranjan Nayak has been arrested for their alleged involvement in the murder case. "Niranjan Sethi, who is the retired OIS Officer, is accused of conspiring to murder Manas Swain, physical assault and disposing of the body following murder," informed

India, Australia set to conclude Rs 1,500-crore early harvest trade deal this month

NEW DELHI: India and Australia are on course to ink an early harvest trade deal by end of this month while Australian Prime Minister Scott Morrison is set to unveil a Rs 1,500-crore investment package to boost the bilateral ties at a virtual summit with PM Narendra Modi on Monday. The likely finalisation of the early harvest or 'Phase-one' of the comprehensive economic cooperation agreement was confirmed by Australian High Commissioner to India Barry O'Farrell on Sunday.

"We are hopeful of signing the Phase one (early harvest) trade deal by end of this month," O'Farrell told reporters.

At present, the bilateral trade volume is estimated at around USD 12 billion and it is expected to witness an increase following the signing of the early harvest trade deal on goods and services. Monday's summit follows the historic first virtual summit between Modi and Morrison in June 2020, when the India-Australia relationship was elevated to a 'Comprehensive Strategic Partnership'.

Diplomatic sources said the summit will reflect that Australia and India are "top tier partners" and they are ready for wider ambition and practical progress in a fast-changing world.

They said Morrison will announce a Rs 1,500-crore investment package (Australian dollar 280 million) for expanding cooperation in a range of areas including clean technology and critical minerals and the space sector. At the summit, the two sides are expected to make a specific announcement on cooperation in rare earth minerals.

Australia accounts for 55 per cent of global lithium production and it possesses over 20 per cent of global lithium deposits. Union Mines Minister Prahlad Joshi is likely to travel to Australia soon to explore specific projects relating to rare earth minerals The sources said Rs 152 crore of the total package will be set aside for setting up of new centres to further enhance bilateral ties, a separate amount of Rs 97 crore will be for skill development programmes and Rs 136 crore will be earmarked for boosting space cooperation. The financial package of Rs 1,500 crore will form the largest ever Australian government investment in the India-Australia bilateral relationship, they said.

Ukrainians "have not greeted Russian soldiers with a bunch of flowers," Zelenskyy told CNN, but with "weapons in their hands." U.S. President Joe Biden was expected to talk later Monday with the leaders of France, Germany, Italy and Britain to discuss the war, before heading later in the week to Brussels and then Poland for in-person talks. Zelenskyy has been pleading with the U.S. for more aircraft and advanced air-defence systems, while NATO members on the alliance's eastern flank have also been looking for missile defence systems from the U.S. and Britain. More than three weeks into the invasion, the two sides now seem to be trying to wear down the other, experts say, with bogged-down Russian forces launching long-range missiles at cities and military bases as Ukrainian forces carry out hit-and-run attacks and seek to sever Russian supply lines.

"Prime Minister Morrison will make announcements on a range of creative new initiatives to lift the relationship to even a higher level," a source said The Ministry of External Affairs (MEA) on Thursday said Modi and Morrison are expected to commit to closer bilateral ties in trade, critical minerals, migration and mobility, and education.

"The virtual summit will lay the way forward on new initiatives and enhanced cooperation in a diverse range of sectors between India and Australia," it said. "Prime Minister Modi and I will discuss deepening our trade and investment relationship and harnessing new economic opportunities to support our mutual economic recovery and growth," Morrison said in a statement on Friday.

Ties between India and Australia have been on an upswing in the last few years.

Separately, diplomatic sources said India's position on the Russian invasion appeared to be driven by then Prime Minister Jawaharlal Nehru's policy in 1957 that India was not in the business of condemnation and it focusses on creating a space for resolution of conflicts. The crisis in Ukraine is expected to figure in Modi's virtual summit with Australian Prime Minister Scott Morrison on Monday amid some disquiet in the West over India's position on the conflict. Unlike its Quad partners -- the US, Japan and Australia -- India has not condemned the Russian invasion of Ukraine and has been maintaining that the crisis should be re-

We understand that each country has a bilateral relationship and it is clear from the comments of the MEA (Ministry of External Affairs) and Prime Minister Modi himself that he has used his contacts to call for the end of the conflict and no country will be unhappy with that," Australian High Commis-sioner to India Barry O'Farrell told reporters.

The Australian envoy was asked about increasing disquiet in the West over India's position on the Russian invasion of Ukraine and its purchase of discounted crude oil from Russia. On Friday, Morrison said the situation in Ukraine and its implications for the Indo-Pacific will figure in his virtual summit with Modi. Referring to Japanese PM Fumio Kishida seeking Modi's cooperation in convincing Russian President Vladimir Putin to maintain a free and open international order, the sources said it reflects India's significance and expectations from it.

The situation in Ukraine figured prominently in summit talks between Modi and Kishida on Saturday. After the talks, Kishida said at a media briefing that the Russian invasion of Ukraine has "shaken" the roots of international order and asserted that attempts to alter the status quo by using force in any region should never be tolerated.

There has been increasing uneasiness in the West over India deciding to purchase discounted crude oil from Russia.

White House Press Secretary Jen Psaki said on Tuesday said that India taking the Russian offer of discounted crude oil would not be a violation of the US sanctions on Moscow but underlined that countries should also think about "where you want to stand" on the Russian action.

An India-Japan joint statement, issued after talks between Kishida and Modi on Saturday, said the two leaders expressed serious concern over the conflict and pitched for an immediate end to violence and resolution of the situation through dialogue and diplomacy. After the conflict began, Modi has held three telephonic conversations with Russian President Putin and spoke to Ukrainian President Volodymyr Zelenskyy twice. On March 3, the leaders of the Quad countries held a virtual meeting to discuss the Ukraine crisis. A joint readout released by the White House had said that US President Joe Biden, Modi, Morrison and Kishida discussed the ongoing conflict and humanitarian crisis in Ukraine besides assessing its "broader implications".

"They agreed to stand up a new humanitarian assistance and disaster relief mechanism which will enable the Quad to meet future humanitarian challenges in the Indo-Pacific and provide a channel for communication as they each address and respond to the crisis in Ukraine," it said.

However, no valid bid has been received for operations of UDAN flights from these airports, till completion of the 4.1 round of bidding under the scheme, he informed.

The Ministry of Civil Aviation launched the Regional Connectivity Scheme (RCS) -UDAN (UdeDesh ka Aam Nagrik) on October 21, 2016 to stimulate regional air connectivity and make air travel affordable for the masses.

UDAN is a market driven scheme. Interested airlines based on their assessment of demand on particular routes submit their proposals at the time of bidding under UDAN, added the Union MOS.

The Ukrainian prosecutor general's office says at least 115 children have been killed and 148 injured.

Some Russians also have fled their country amid a widespread crackdown on dissent. Russia has arrested thousands of antiwar protesters, muzzled independent media and cut access to social media sites like Facebook and Twitter.

Flight tracker FlightRadar24 showed no more data for flight MU5735 after 2:22 pm local time, when it had reached Wuzhou. It showed that the plane had sharply dropped from an altitude of 29,100 feet to 3,225 feet in the span of three minutes, before flight information stopped.

China had enjoyed an enviable air safety record in recent years in a country crisscrossed by newly built airports and serviced by new airlines established to match the country's breakneck growth over the last few decades.

A Henan Airlines flight crashed in northeastern Heilongjiang province in 2010, killing at least 42 out of 92 people on board although the final toll was never confirmed.

It was the last Chinese commercial passenger flight crash that caused civilian casualties. The deadliest Chinese commercial flight crash was a China Northwest Airlines crash in 1994 which killed all 160 onboard.

Most of the passengers onboard the Malaysia Airlines Flight MH370, which disappeared in March 2014 en route from Kuala Lumpur to Beijing, were from China.

MADRID: Barcelona's players had just returned to the locker room when Gerard Piqué put out a message on Twitter.

"We are back," it read.

Piqué and his teammates had stayed on the field at the Santiago Bernabéu Stadium celebrating the team's commanding 4-0 victory over Real Madrid in the Spanish league. They jumped and sang along with the few hundred visiting fans still left at the


mostly empty venue. Inside, coach Xavi Hernández waited to embrace each player as they returned. "Vamos, vamos! (Let's go!)," was the common

Barcelona's next league match is at home against Sevilla, which is three points ahead. Barcelona is also in the quarterfinals of the Europa League after failing to get past the group stage of the Champions League for the first time in nearly a decade.

"We have to stay humble. We didn't win a title to-day," Xavi said. "We celebrate now and then we have to start thinking about our next match."
