Ukraine-Russia peace deal soon? Moscow to 'radically' reduce military activity around Kyiv

ISTANBUL(KCN): Russia's military said on ters." Tuesday it would "fundamentally" cut back operations near Ukraine's capital and a northern city, as talks brought a possible deal to end a grinding and brutal war into view.

Deputy Defense Minister Alexander Fomin said the move was meant to increase trust in the talks after several rounds of failed negotiations to halt the conflict that has devolved into a bloody campaign of attrition.

Fomin said Moscow had decided to "fundamentally, cut back military activity in the direction of Kyiv and Chernihiv" to "increase mutual trust and create conditions for further negotiations." That appeared to be a goodwill gesture, but also comes as Russia's troops have become bogged down and struggled to make major advances on the ground recently in the face of stiff Ukrainian resistance, thwarting Russian President Vladimir Putin's aim of a quick military victory. Ukraine's military said it had noted withdrawals around Kyiv and Chernihiv, though the Pentagon said it could not corroborate Russia's claim.

Earlier talks, held in person in Belarus or by video, failed to make progress on ending a more than month-long war that has killed thousands and driven more than 10 million Ukrainians from their homes, including almost 4 million from their country.

But Fomin suggested there had been progress Tuesday, saying "negotiations on preparing an agreement on Ukraine's neutrality and nonnuclear status, as well as on giving Ukraine security guarantees, are turning to practical mat-

Ukraine's team, meanwhile, set out a detailed framework for a future peace deal under which the country would remain neutral but its security would be guaranteed by a group of third countries, including the US, Britain, France, Turkey, China and Poland, in an arrangement

A missile struck the oil depot late Monday, the second attack on oil facilities in a region that has been spared the worst of the fighting.

On Tuesday morning, an explosion blasted a hole in a nine-story administration building in Mykolaiv, a southern port city that Russia has unsuccessfully tried to capture.

Seven people died in the missile attack and 22 were wounded, Zelenskyy said in an address to Danish lawmakers.

"It's terrible. They waited for people to go to work, before striking the building," said regional governor Vitaliy Kim.

"I overslept. I'm lucky.'

In other developments: The head of the United Nations' nuclear watchdog arrived in Ukraine to try to ensure the safety of the country's nuclear facilities.

Russian forces have taken control of the decommissioned Chernobyl plant, site in 1986 of the world's worst nuclear accident, and of the active Zaporizhzhia plant, where a building was damaged in fighting.

Russia has destroyed more than 60 religious buildings across the country in just over a month of war, with most of the damage concentrated near Kyiv and in the east, Ukraine's military said in a post Tuesday.

Bloomberg News said it has suspended its operations in Russia and Belarus.

Welfare schemes and identity: What funders must learn

Haqdarshak works in 26 states across India through its team of haqdarshikas (women field agents) who, via a range of government schemes, help people access



benefits and entitlements that are due to them. These states are often vast and home to a diverse population with many layers of

social and political identities that add peculiar challenges to our work.

For instance, working in Uttar Pradesh is a unique experience as it is the equivalent of three mini states. When one moves from the Jat-dominated and more comcamps, most of the marginalised castes are left out.

If people have their identity documents, it's difficult to exclude them because they can walk into a government office and take assisted help. They no longer have to rely on the largesse of their local elected representative whose allegiances may lie with a particular religious community and/or caste. This is because, since 2018, nearly 90 percent of the schemes in India have been digitised and are run by the central government. So, even though some discretion is left to the state or the district, this centralisation works in favour of the most marginalised



mercial western Uttar Pradesh-Noida, Ghaziabad, and Meerut-towards Lucknow, the Awadh area, and Ayodhya, one finds identities beginning to centre around religion. Finally, when one reaches eastern Uttar Pradesh, a clear dominance of caste identities is seen. This diverse demographic in the state is important to understand because the delivery of government schemes in Uttar Pradesh is geared according to it. Establishing one's identity-and having it validated by government documentation—is one of the biggest demands of the populace in Uttar Pradesh as denominators such as caste, religion, gender, income, and domicile are the basis of eligibility for all government schemes. Exclusion happens because of identity Individuals are excluded from schemes ifthey do not possess or update basic identity documents such as birth and caste certificates, Aadhaar, PAN card, and so on. This is particularly true for areas such as eastern Uttar Pradesh with a large proportion of marginalised and economically weaker castes.

This issue of establishing one's identity must be solved at scale.

For instance, a Dalit person from Balrampur, eastern Uttar Pradesh, with updated and linked identity documents can take the help of a frontline worker— ASHA, anganwadi, nonprofit coordinator, or even their local haqdarshikas—and apply for the schemes directly. There is very little that the MP or MLA can do to stop it. Once the application is accepted, they may be waitlisted, but the system cannot techto this stage at least.

Funders are largely focused on monetary benefits

During the pandemic, funders wanted theirnonprofit partners to help provide immediate support to families in distress by improving their access to government schemes. While their intent was good, their limited understanding of ground realities and how exclusion works has become a barrier in communities benefitting from these programmes.

Funders are focused almost entirely on outputs-how much money reaches the bank accounts of the recipients. They want to fund programmes that will help people get, say, INR 10,000 or INR 20,000 in tangible benefits within a short span of time. But nonprofits that pivoted from their core activities of education, skilling, and livelihoods to provide their communities the support they needed during the pandemic are struggling with this mandate.

A social security ecosystem that believes that delivering welfare benefits to people will directly increase community incomes is simplistic and naive.

It is nearly impossible to ensure that every person receives a certain fixed amount in their bank account, because their eligibility is dependent on the various conditions that dictate their life, including income level, caste, religion, geographic location, family structure, and so on. The nature and value of the entitlements people get will vary based on all these factors. There also aren't enough big-ticket direct benefit transfer (DBT) schemes that meet this monetary threshold set by funders. A social security ecosystem that believes that delivering welfare benefits to people individuals in eastern Uttar Pradesh need, without considering the priorities of the families themselves.

I understand that it is challenging for CSR teams to convince the boards about the value of helping communities with identity documents. Funding access to 7,000 birth certificates might seem irrelevant or insignificant to the boards because it's hard to assign a monetary benefit to a document. It's easier instead to insist that their nonprofit partners show tangible financial improvements. But they must realise that this is almost impossible to do.

Funders should start looking beyond just money in the citizen's bank account; they need to think about outcomes-how many women are getting access to a simple bank account that is usable? How many are using UPI or availing of the Ayushman Bharat health insurance, even though many of them are enrolled in the scheme? How many individuals whose names are listed for pension schemes are contributing INR 12 to be able to sustain that scheme so that they actually get INR 3,000 when they turn 60? In so many of these schemes, you can onboard people but you need to encourage them to keep paying for that social security programme.

With the onset of the pandemic and its devastating impact on livelihoods, a lot of funding in the country has shifted towards the social security sector. Over the last two-three years, funds worth more than INR 100 crore have been raised for social security programming. But almost no one is focusing on the importance of helping communities with identity documents.

We need to give choice back to the people I truly believe that we have to move towards a ground-up choice matrix. We need to give the choice to the citizen as the end user, customer, and recipient of the services, and channel that choice upwards to the grassroots worker, community-based organisation, nonprofit, and then to the funders. Today it's the reverse, where the choice is being made by the funder, which then percolates through the civil society chain to the citizen.

Can we design more programmes and funding and base the entire narrative on the choices made by the citizen? Why should their needs and demands not matter? If we middle- and upper-income citizens need a PAN card to apply for an IPO or open a bank account, the poorer households have just as many use cases for their PAN cards—a construction worker may want a PAN and Aadhaar because it simplifies them getting their UPI in Gurgaon. Getting their Aadhaar verified or PAN card updated is as important as ensuring that they get money in their bank accounts.

We must think of moving the ecosystem to build around citizens' choices versus funder decisions—only then will we see a marked improvement in outcomes.

Nation's Governance Machinery, even when made in opposition to the ruling party, is not acceptable as Indian Railway Engineers are second to none at the Global level and are capable of running Bullet trains even under the sea bed, if the push comes to shove. Obviously, the statement was due to abject ignorance because all types of soil are suitable for an Engineer worth his salt. The second statement of lack of capability again needs to be viewed from the wider perspective that the capabilities of a Nation are not static and are continuously evolving. However, there is definitely a lot of realism in the statement about capabilities as unlike Highways, Railway projects are high precision Linear projects and encounter several external uncertainties and project risks asChanging socio-economic such situation, Weak Law Enforcement, Slack Governance, Litigations etc". Bimal Bisi said that"Going by the case of Talcher -Bimalagarh New Line project where the delay in land acquisition is extra ordinary. Even after depositing more than Rs 422 Cr against Land and acquisition costs with the Odisha government, only 41% of private land and 51% of Government land could be acquired till date. The first parcel of land was acquired in the year 2012. Ten years have passed since then and 60 % land is still to be acquired. In the mean time the share of land cost to overall project cost has increased from 5 % to 30 %. The overall cost overrun is 37% and time overrun is 525%. Even the 41% private land acquisition is not encumbrance free as in several locations , the transfer is only on paper and the original landowners have yet not vacated the land after taking the sanctioned payment of land cost , claiming enhanced costs. Typical cases are that of Keshabpur and Bilinda villages of district Angul. Here the dispute about compensation ended up as stays from Hon'ble High Court Cuttack since 2013. Considering that the applications were also filed for early listing of the cases in the year 2021 Jan/Feb and the wait is still continuing, the whole affair needs to be addressed with a different perspective of capacity enhancement. The concern of the Hon'ble MP about Lack of capability to construct complex high precision Infrastructure in time and in cost needs to be taken in the

Techno-Managerial perspective and requires a serious thinking.

Democracy is precious, it comes at huge price. Road rolling the democratic rights of the public is not acceptable. Circumventing the authority of any of the democratic Institutions viz Executive, Judiciary and Legislature shall result into Infraction, vitiate the fine balance and may lead to emergency as the equilibrium is disturbed".

Bisi said "The solution is therefore to engage domain experts to function as force multipliers on contract basis. Land acquisition for a Linear project such as Railways that pass through various districts and states require domain experts. The Government must accept the realities that the provisions of Land acquisition Act 2013 are very complex and unless a domain expert team is mobilized to assist the Land acquisition authorities in all aspects of Land acquisition, the process will be either very slow or shall end up in a stalemate after some time in form of disputes and litigations. The volume of administrative support work required for Land acquisition for a target project needs to be measured in terms of man-days required to meet the standards desired in the Act. Unless the minimum threshold efforts in form of domain expert man-days are put into the system, the process shall dragon indefinitely. In case of the Talcher Bimalagarh New line project the 19(1) declarations for all except one village have already been done few years back.19(1) declarations display the intent of the state government to acquire the project land. Similarly depositing Rs 422 Cr against the land acquisition cost also displays the intent of the Railways to acquire the land. Any further chasing will simply follow the Law of diminishing returns.

The issue of capability building needs to be approached from Techno-Managerial perspective and not from the conventional perspective.So, in order to complete the acquisition of full 2075 Acreland of various categories in encumbrance free state over a length of 120Kms, the requirement to engage all the stake holders and complete the information collection and associated paperwork may require a Team of some 30 experienced experts and skilled/semiskilled manpower for Six to Nine months. This requires a total administrative workload of 30X30X9=8,100 mandays.Moreover, these man-days are spread over a length of 150 kms passing through three districts, several Tahsils and hundreds of villages. The stakeholders are in thousands. To add to the complexity, the project delivery is feasible only when at least one block section length is available to take up the construction activity. This volume of additional administrative workload is not feasible for any revenue authority without engaging a team of Experts to fill up the vacuum of administrative workload. With Revenue officials already bogged down by daily routine works, reviews and meetings, it is not possible to handle such huge administrative work load. Obviously, the normal human tendency shall be to cut corners during the reviews. As a natural consequence, Review meetings, of whatever level, usually result into another review meeting. What is the solution? The solution is to first recognize that the present system of British colonial administration is not fit to handle the modern-day democratic demands, transparency and civilian rights. The next step is to introduce the Structural and Fundamental change in the way the Project Land Acquisition and project itself is handled.

Structural change refers to dramatic shift in the way a country, industry, or market operates, usually brought on by major economic developments. The key to effect structural change is the dynamism that is inherent in that system. Structural change is often sparked by technological innovation, new economic developments, global shifts in the pools of capital and labor, changes in resource availability, changes in supply and demand of resources, and changes in the political landscape.

The second form of change that is required are Fundamental changes. These are systemic changes thatare required to achieve re-posturing in view of the changed legal-social framework. This means a fundamental, transformative, and cross-cutting form of change that entails major shifts and reorientation in system's goals, incentives, technologies, social practices and norms, as well as in knowledge systems, and governance approaches.

Project workloads are handled by flexible size Project Resource Teams. The volume of resources required for a Project may peak for a few months but once the objective is achieved, the Team needs to be disbanded or engaged in some other project. The new approach being introduced is engaging a Team of professionals and domain experts on contractual basis who will penetrate deep into the layers of bureaucratic complexities and act as force multipliers and strengthen the civil administration in achieving the professionalism in meeting the various legal compliances as well as social acceptability. Not only the financial burden in engaging the Team shall be rigorously analysed but shall also be one time expenditure. Efficient Team imply that efficiency shall replace the otherwise delayed response. Economy shall be achieved by speeding up the removal of external constraints and reducing the duration of Non-Revenue Earning stage of the project. It is learnt that an Expert Team of highly ex-

perienced professionals is being deployed by the Railways for undertaking systematic acBaruan hill Tunnel, Starting of the Brahmani Bridge girders launching work and completion of the formation in decade long stalled location in Biru village can be considered as the direct benefits emerging from the application of modern methods of software based project planning and monitoring.

The third change is that the individual contract packages are also being analysed to sync with the project objectives. The project was infested with contracts that had under gone more than dozen extensions of time. All such extensions were given on some pretext such as non-availability of land or land dispute. In the new monitoring framework, the disputed locations are removed from the contracts so that these locations do not provide a cover to extend the contract duration and cause time overrun. Similarly, introduction of joint agreed programs of work in dispute free locations and breaking down the work into small parts(WBS) has enabled to correctly assess the desired asking rates of progress. Slippages can now be monitored before it is too late to take the mitigatory action.



Key changes in the Project Team are also being affected in order to create a well synchronised highly efficient Team. Those who do not have aptitude in Project handling are being relocated in positions where their aptitudes are fruitfully utilized. The changes have been brought even at the cost of premature transfers. To strengthen the office of the Deputy Chief engineer based at Angul, a support team to handle miscellaneous project works such as short surveys, sampling, testing record keeping is also being introduced from the market source. This will free the Core project Team from avoidable diversions and their energies shall be utilized in superior project planning, monitoring, site layouts, measurements and quality checks.

The project authorities have indicated that there is a fresh cooperation at a very different level from the revenue authorities.Regular reviews by Chief Secretary in PMG meetings, Reviews at the level of RDC and Collectors are bringing sea change in the working environment as the Government's Pro-Infra Posturing is visible. The Project is seeing very positive response from the key administrative functionaries such as ADMS, Spl LAO, Tahsildaars etc who are visiting the dispute sites along with project authorities to remove the obstacles. When the performance is visible the support from the local public automatically evolves. On prodding, the Project authorities indicated that except the Legal Court Stays, all the other issues previously marring the project have been brought into significant control and barring unforeseen issues, the Part Project of Sunakhani-Samal-Parbil shall be completed around August 2022. It is felt that recent efforts in getting early listing of the cases will yield result in a very short time. Similarly, activation of the Railway Estate office will be a major deterrent to those who overstay after taking the compensation money and seek litigations. Considering the Project commissioning uncertainties in the month of October 2021, this statement displays a very positive sentiment.

What would paying for natural gas in rubles mean?

BERLIN: Europe's already high gas prices have gyrated since Russian President Vladimir Putin announced plans to have importers pay for Russian natural gas in rubles instead of dollars and euros.

Europe imports large amounts of Russian natural gas to heat homes, generate electricity and fuel industry, and those imports have continued despite the war in Ukraine.

Around 60 per cent of imports are paid in euros, and the rest in dollars. Putin wants to change that by requiring foreign gas importers to purchase rubles and use them to pay state-owned supplier Gazprom. Putin told the Russian central bank last Wednesday to come up with a workable system.

Importers would have to find a bank that would exchange euros and dollars for rubles. That could be cumbersome because some Russian banks have been either blocked or cut off from the SWIFT messaging system that facilitates international payments. Still, there are some banks that have not been cut off, and for now, sanctions imposed by the US Treasury barring bank transactions con-



tain exceptions for energy payments.

That's a concession to European allies that are much more reliant on Russian oil and gas and fear a total cutoff could throw their economy into recession.

Russia getting paid for gas in their currency would at best help marginally in getting around financial sanctions, propping up the ruble's value or protecting the Russian economy, said Eswar Prasad, professor of trade policy at Cornell University and a former official at the International Monetary Fund. "Either Putin is getting terrible economic advice or he is going further off the rails in his hatred for the West," Prasad said.

"It would be cheaper for foreign importers to pay for Russia's exports in a currency that is collapsing in value, but it is difficult to acquire rubles and make payments in a manner that avoids the sanctions." He warned that the move "could further roil global energy markets by exacerbating current supply disruptions and adding to uncertainty about future supplies, which could all add up to more price spikes." European governments and energy companies have rejected the idea, saying gas import contracts specify the currency and that one side can't change it overnight. They say they intend to keep paying in euros and dollars. More broadly, the Group of Seven major economies including Japan, the US and Canada as well as Germany, France, Italy and Britain have agreed to reject Moscow's demand. The European Union's energy commissioner also agreed, a G-7 statement said. German Vice Chancellor Robert Habeck told reporters on Monday that "all G-7 ministers agreed completely" that such a step would be "a one-sided and clear breach of the existing contracts". In theory, requiring ruble payments could support demand for the currency and its exchange rate, but not by much, Prasad said. As it stands, euros and dollars are already being used to purchase rubles when Gazprom exchanges its foreign earnings.

The Centre for Eastern Studies in Warsaw has suggested that by moving the flow of foreign currency from Gazprom to the largely statecontrolled banking system, the Kremlin will gain added control over foreign currency that has become scarcer since Western countries froze much of Russia's reserves abroad.

Addressing issues of mental well-being apart, there is a lack of up-gradation of skill and training. According to the Status of Policing in India report 2019 by Common Cause and Centre for the Study of Developing Societies (CSDS), only 14.3 per cent SIs/ASIs of the State received inservice training as against the national average of 17 per cent.

Odisha, West Bengal, Bihar, Uttar Pradesh, Uttarakhand, Kerala, Maharashtra and Gujarat are the states that neither has been able to pro-

vide in-service training to a large proportion of personnel nor have they incurred significant expenditure on training. TNIE According to Anuradha Mahapatra, founder of Manam Foundation, a nonprofit facilitating mental wellness, an outbreak of coronavirus pandemic put a severe toll on the well-being of the police personnel across the country. "Police personnel's work has always been very challenging, and the demanding working hours during the pandemic to enforce lockdown/shutdown and assist authorities to manage the containment zones added to their stress. This led to work overload and the police personnel were hardly able to spend time with their families," she said. Government should form batches of police stations in every region and set-up one counselling station for each group. "The counselling stations should be outsourced and not linked with police department. This will ensure police personnel are able to share their problems comfortably and confidentiality is maintained. Besides, senior officers should also organise sessions on mental awareness for their sub-ordinates every three or six months," she added. DGP Sunil Kumar Bansal said Odisha Police has facilities to check and look after the health issues of the cops."We are a large force but incidents like Gangapur IIC can never be ignored. It was a very unfortunate incident, and efforts have always been made to reach out to officers/ personnel who show any sign of depression or anxiety. We are mulling to set up camps to check health parameters (physical and psychological) of the police personnel," he added.

A Bureau of Police Research and Development's (BPR&D) 2019 data on policepopulation ratio says Odisha has 67 cops to man one lakh population. In Andhra Pradesh, it is 85, Gujarat (87), Uttarakhand (95) and West Bengal (97) and they are part of the bottom 10 States.

At the inspector levels, the State suffers from vacancies. Odisha's sanctioned strength for inspectors/reserve inspectors is 1,150 where there are 100 vacancies. As per BPR&D, the sanctioned strength of sub-inspectors/reserve subinspectors is 3,498 and for assistant sub-inspector/reserve ASIs is 4,673 but there are 1,080 and 1,488 vacancies respectively.

The IICs, SIs and ASIs who take up investigation of important cases besides carrying out law and order duties face an increased workload that triggers mental stress among them. A senior officer pointed out that forces like Central Reserve Police Force (CRPF) and Border Security Force (BSF) have come up with organised responses to regularly check their personnel's mental and physical health.

"In Odisha, we have to cover some distance in this regard. We have police hospitals where the doctors attend to the cops and their family members. However, they mostly provide curative treatment. In terms of providing preventive treatment including counselling to the personnel, more needs to be done in the State," he added.

Former DGP GC Nanda agrees. If police's work overload is not managed immediately, their mental and physical well-being will deteriorate further in the coming days, he says."About a Force under stress Odisha Police's current strength is about 70,000

LONDON: World oil prices dived and European equities rallied Tuesday as apparent progress in peace talks between Moscow and Kyiv sparked hope of an end to the Ukraine conflict.Europe's benchmark Brent crude and New York's WTI sank by about 6.5 percent as traders eyed easing Russian oil supply fears amid face-to-face Istanbul talks aimed at resolving the nearly five-

Europe's major stock markets jumped higher, with Frankfurt soaring 3.5 percent, Paris winning 3.1 per-cent and London adding 1.2 percent.

The Russian ruble soared by 10 percent against the dollar and by 1.2 percent versus the euro. Ukraine's top negotiator declared Tuesday that enough

"State economy registered a sharp recovery in 2021-22 as per the advance estimate of Gross State Domestic Product (GSDP). Real GSDP has grown at a rate of 10.1 per cent," it said.

It is one of the fastest growing states in the country and registered a growth rate much higher than India's GDP growth rate of 8.8 per cent as per the first advance estimate.

Like the rest of the world, Odisha also faced the adverse impact of Covif-19 and the State's GSDP contracted by 5.3 per cent in 2020-21 against a contraction of 6.6 per cent in India's GDP.

According to the report, Odisha economy has demonstrated far more resilience vis-à-vis all India. The State economy reverted to the pre-Covid level much faster. While India's real GDP grew by 1.6 per cent between 2019-20 and 2021-22 leaving aside the Covid year of 2020-21, the comparable figure for Odisha is 4.2 per cent. Not only Odisha's recovery process is faster, but it is also more broad-based. Assuming normal monsoon, no furthermore damaging waves of corona virus mutations and induced economic disruption, stable oil prices, and steadily easing of supply chain, GSDP may grow in real terms by 9.0-9.5 per cent in 2022-23, claims the survey. However, the Russia and Ukraine conflict has brought in further uncertainty. It is likely to impact global trade and businesses with its ramifications on domestic price level, exchange rate, commodity supplies and supply chain operations, it pointed out. Industry sector grew at 14.5 per cent followed by service sector with 7.9 per cent growth rate in 2021-22. The agriculture and allied sector registered a contraction of 3.4 per cent in the year 2021-22 due to drought, unseasonal rain, and Cyclone JAWAD. While natural calamities continue to affect agriculture in the State, agriculture and allied activities grew at an average rate of 9.5 per cent between 2018-19 and 2020-21 before the current contraction. The Labour Force Participation Rate (LFPR), worker-population ratio (WPR) and Unemployment rate are three key parameters through which the employment situation is gauged. As per the latest labour force survey (PLFS, 2019-20), the State's performance is better than all India in terms of LFPR and WPR while unemployment rate is a little higher than all India. Nearly 55.3 per cent of the population aged 15+ in Odisha were part of the labour force in 2019-20. This is an increase from 48.3 per cent in 2017-18 and higher than all India LFPR of 53.5 per cent. Unemployment in the state was recorded as 6.2 per cent in 2019-20 in comparison to 4.8 per cent at India level.

While that presents a possible face-saving exit strategy for Putin, it has also raised Ukrainian fears the Kremlin aims to split the country, forcing it to surrender a swath of its territory.

Still, Zelenskyy's comments that he was open to compromise on the region indicated a possible path for negotiations.

US markets headed higher in premarket trading on Tuesday as another round of peace talks between Russia and Ukraine got underway.

On Wall Street, the futures for the S&P 500 and the Dow industrials gained 0.6%, and global shares rose while crude oil prices fell again after sinking 7% on Monday.

Markets remain unsettled as investors try to gauge what's next for inflation and the global economy as the repercussions of Russia's invasion of Ukraine continue to play out.

The first face-to-face talks in two weeks between Russia and Ukraine began Tuesday in Turkey, raising meagre hopes of progress on ending a Bond yields edged higher.

The yield on the 10-year Treasury rose to 2.50% from 2.46% late Monday.

Bond yields have been rising as Wall Street prepares for higher interest rates.

The minister stressed that the Russian military will continue the operation until "the set goals are achieved."

Shoigu also offered an assurance that Russia will not send conscripts recruited in the upcoming April draft to Ukraine.

Earlier this month, the Russian military admitted that a number of conscripts ended up in Ukraine and were even captured there.

Canada advances to FIFA World Cup for first time in 36 years

TORONTO: Cyle Larin, Tajon Buchanan and Junior Hoilett scored and Canada secured its first World Cup berth in 36 years with a 4-0 vic-

tory over Jamaica on Sunday. Canada has been to the World Cup just once before, in 1986. "Speechless. Dream come true," midfielder Jonathan Osorio said. "We all dreamed of this as little kids, and as a Canadian that was impossible. Today the impossible happened. It's an incredible feeling." Canada missed out a chance to secure a spot in Qatar last week with a 1-0 loss to Costa Rica. It was Canada's first loss in three World Cup qualifying rounds and it snapped a six-game winning streak. Boosted by the home crowd at BMO Filed,

Canada rebounded in a big way against the Jamaicans, who were al-ready eliminated from World Cup contention. Following the match, the fans broke into the Canadian national anthem and Osorio led the crowd for a drum chant before the team danced on the field. Buchanan circled the field

waving Canada's flag. Canada coach John Herdman became the first coach ever to lead both a men's and women's team to a World Cup berth. He coached the

Canadian women's team from 2011-18. In a post-game interview, Herdman was doused with champagne by Canadian goalkeeper Milan Borjan. "Canada is a football nation, man. We botjan. Canada is a tootban haton, mail. We better believe it," Herdman said. "And we're going to keep coming. We've only gotten started." Canada sits atop the table in the final qualifying round with 28 points, followed by the United States (25 points), which held the adapt over third place Maxies (25) or seal dif edge over third-place Mexico (25) on goal dif-ference. The United States defeated Panama 5-1 and Mexico downed Honduras 1-0 in the late games Sunday.

Costa Rica won 2-1 at El Salvador to maintain fourth place with 22 points and prevent the U.S. from being able to clinch Sunday night. Anthony Contreras scored on a bicycle kick in the 30th minute, Christian Gil tied the score one minute later and Joel Campbell put the Ticos ahead in the first minute of first-half stoppage time. Costa Rica hosts the U.S. on Wednesday night.

The top three finishers in the North and Central American and Caribbean region book the trip to Qatar. The fourth-place team goes to an in-tercontinental playoff against a team from Oceania.

The Canadians wrap up the qualifying round Wednesday in Panama. Because Canada was ranked 73rd in July 2020
