Petrol crosses Rs 101-mark after 80 paise hike, diesel sees 70 paise increase

NEW DELHI: Petrol and diesel prices were on Wednesday hiked by 80 paise a litre each,

upon the incidence of local taxation.

This is the ninth increase in



taking the total increase in rates in the last nine days to Rs 5.60 per litre. Petrol in Delhi will now cost Rs 101.01 per litre as against Rs 100.21 previously while diesel rates have gone up from Rs 91.47 per litre to Rs 92.27, according to a price notification of state fuel retailers. Rates have been increased across the country and vary from state to state depending prices since the ending of a four-andhalf-month long hiatus in rate revision on March 22. On the first four occasions, prices were in-

creased by 80 paise a litre - the steepest single-day rise since the daily price revision was introduced in June 2017.

On the following days, petrol price went up by 50 paise and 30 paise a litre while diesel rose by 55 paise and 35 paise a litre. Petrol price was on Tuesday hiked by 80 paise a litre and diesel by 70 paise. In all, petrol and diesel rices have gone up by Rs 5.60 per litre each.

Morning Classes from April 2

Bhubaneswar(KCN): With the mercury breached 40 degrees Celsius in many parts of the State, the Government has also decided to start morning classes of school students from April 2.



Speaking to reporters here, School & Mass Education Minister Sameer Ranjan Dash said, "The heat wave condition has forced us to revise the school timings so that the students face minimum heat during school hours."

He said the physical classes for Class I to VIII students will start at 6:20 AM and and at 10 AM while the classes for standard IX and X students will be conducted between 7 AM and 11 AM.

Physical classes for students from Class 8 to 12, along with colleges, universities and other technical institutions had reopened from February 7. However, classes for students from KG to Class 7 were reopened from February 28.

At least eight places in the State recorded a day temperature of 40 degrees Celsius or above on Wednesday.

The mercury soared up to 42.7 degrees Celsius at Titilagarh, making it the hottest place in Odisha for the day.

According to the MET department, Titilagarh recorded the highest temperature followed by Balangir with 42.5 degrees, Sonepur with 41.9 degrees, Jharsuguda (41.2), Bhawanipatna (41) and Boudh (41). The maximum temperature was 40 degrees Celsius at both Sambalpur and Sundergarh towns.

Bahinipati throws headphone towards Speaker's podium BHUBANESWAR(KCN):

Congress MLA T a r a p r a s a d Bahinipati created a ruckus in the Assembly on Tuesday by throwing his headphone toward the Speaker's podium demanding a discussion on the mining scam in the



House. The Congress MLA also stood on a chair in the front of Speaker's table. Describing Bahinipati's behaviour as not appropriate, Speaker Surjya Narayan Patro said that such a senior member should not have acted like this. Bahinipati alleged that 104 mine owners are looting the State and demanded action against them. He raised the issue during the zero hour and also moved an adjournment motion to discuss the issue, which was not accepted by the Speaker. He then walked out of the House. He raised the issue again during the afternoon session. Responding to BJP's allegation about Congress' complicity as a result of which the issue could not be discussed in the House, Bahinipati later told mediapersons that he would quit politics if there is any truth in it. Government chief whip Pramila Mallik, however, said that Congress attempts to disrupt the proceedings when it has no issue to raise in the Assembly.

127 Cr Subsidy for Agri Industries Army's Medium Range Surface-to-Air Missile

Bhubaneswar(KCN): The State Government has released a subsidy of Rs 127 crore to 1085 agri-based enterprises during the year 2016-17 to 2021-22, Agriculture Minister Arun Kumar Sahoo told the As-



sembly on Wednesday.

While giving a written reply to a question asked by MLA Pradeep Panigrahy, the Minister said, during last six years (2016-17 to 2021-22), 1085 Commercial Agri Enterprises have been set up in the State through APICOL and Capital Investment Subsidy amounting to Rs. 127 crore has been released to different entrepreneurs against these projects, Sahoo said.

Through the agri-based industries, employment for 10850 persons has been generated. In the 2016-17, subsidy of Rs 15.10 crore was sanctioned to 144 commercial agri enterprises while Rs 23.33 crore released to 188 agri units in 2017-18.

Similarly, Sahoo said, Rs 24.62 crore has been released to 123 enterprises in the year 2017-18, whereas only 94 industries have received subsidies of Rs 15.99 crore in 2019-20. Subsidy amount of Rs 18.21 crore distributed to 168

agri-based enterprises in 2020-21. Moreover, the highest subsidy amount of Rs 29.72 crore has been released to 368 enterprises in the current year 2021-22, the Minister said.

He further said the State Agriculture Policy was declared during 1996 giving agriculture the status of an Industry. As on date, 92 projects have been included under State Agriculture Policy in various sectors (agriculture, horticulture, fishery, animal husbandry, food processing etc.).

financial assistance in the form of Capital Investment Subsidy (CIS) @ 40% of the fixed capital investment (50% in case of ST/SC/ Women/PWD/ graduates of agriculture and allied discipline) subject to a maximum limit of Rs. 50 lakhs per person, he informed. Apart from that under different schemes of the Directorate of Horticulture, another 51 Agri-based industries have been established. In these Industries there are 350 persons engaged in income generation through employment, he added. Out of the 51 units, 15 are cashew processing units set up in Koraput, Dhenkanal, Nayagarh, Cuttack and Mayurbhanj districts, 34 lemon grass units established in Koraput & Dhenkanal districts, one honey processing unit set up in Mayurbhanj district and another turmeric processing unit established in Gajapati district.

Government spending on innovation has contributed to some of the world's most used applications across a range of fields,



including technology and healthcare. For instance, most of the promising new drugs we see today are a result of research done

by the National Institutes of Health. The internet actually originates from ARPANET, a programme funded by the Defence Advanced Research Projects Agency (DARPA). The current global positioning system (GPS), originally Navstar GPS, began as a 1970s US military project. The iPhone's touchscreen technology was created by a professor and his doctoral candidate at the publicly funded University of Delaware. Even Siri, Apple's digital personal assistant, is a spin-off of DARPA's project PAL (Personalised Assistant that Learns).1 The Satellite Instructional Television Experiment by ISRO and NASA made available 2,400 black-andwhite community TV sets across several villages in six Indian states for the first time in 1975 (when most urban homes didn't have a television).

Since the 1970s, a multitude of factors including the rise of capitalism, targeting of public debt in the wake of the global financial crisis, and calls to spur private investment by cutting down government spending—have increasingly reduced the government's role in facilitating the private sector. In India, the R&D spending

neither give good returns in the short term nor yield the kinds of profits that venture capitalists seek. Therefore, governments need to fundamentally reconsider their role when it comes to public interest innovations and move beyond just facilitating.

table solutions that

The government must step up efforts to reap rewards on taxpayers' money through public investments. In this era powered by technological advancements, it means envisioning tech interventions for the public good and creating markets for their sustainability; it means looking beyond evaluating public spending by mere disbursement, and taking an active role to measure the impact.

Though in its infancy, public interest technology broadly means advancing equitable tech-enabled interventions for the common good. If not done well, these techenabled interventions will fall short of addressing equitability. For instance, VI-SPDAT, a data tool designed to help homeless people find housing facilities, ended up unintentionally improving white

This puts into perspective a key element those developing public interest technology solutions should interact and engage meaningfully with those who are intimately familiar with the situation to produce interventions that address common good. This could be local nonprofits and/ or the people that the tech seeks to benefit. This is not impossible to do, and there are many examples where doing this has had successful results.

Public interest technologies have citizens as participants and co-creators of the intervention.

For instance, Bangalore-based nonprofit Janaagraha created the online networking platform ichangemycity, wherein people stant real-time peer-to-peer and person-tomerchant money transfers were planted way back in 2009 when the RBI formed the National Payment Corporation of India to integrate all the payment mechanisms available in the country-another great example of public investment in technology for good. The UPI pilot was launched only in 2016. This process doesn't suit the aspirations of venture capitalists and entrepreneurs, which is why the government must take a more active role in this area.

How can the government create a market for public interest technology?

Creating a market for public interest technologies requires looking beyond adding tech solutions to tackle government and nonprofit problems. The government needs to establish systems that seamlessly integrate technology-based solutions, design new academia for technologists that enable them to understand the ethical, social, economic, and political ramifications of new technology, create jobs for public interest technologists, train civil servants and nonprofits to become a part of the

movement, and establish networks of various stakeholders.

Understanding the current problems communities are facing, applying appropriate technologies, and iterating

as a percentage of GDP has been decreasing. It is now approximately 0.66 percent of the GDP, almost equal to what it was in the 1990s (it spiked from 0.8 percent in 2004 to its highest-0.86 percent-in 2008, after which there's been a continuous decline).

The trend has more or less been the same in many countries. For instance, budget sequestration in the US (which entails the withdrawal of funding in certain areas) has led to cuts worth USD 95 billion in the federal R&D spending between 2013 and 2021, and the European fiscal compact is squeezing educational and R&D spending.2 These moves are based on the assumption that market forces, when facilitated, regulated, and administered by governments, will themselves efficiently allocate resources. However, as we have seen over the years, market forces are blind to societal and environmental concerns.

Governments need to reconsider their role when it comes to public interest innovations and move beyond just facilitating. Therefore, governments cannot afford to remain facilitators when it comes to addressing challenges such as climate change, hunger, and inequality; they must go beyond fixing market failures, and create markets. Because, these deep-rooted multidimensional issues require long-term risky investments, innovation, and equi-

This happened because many of the questions this application asks the users do not reflect vulnerabilities that people of colour are likely to say they experience. The United States Electronic Immigration System had similar faults. Software designers failed to collaborate with civil servants while developing the programme, and as a result they could not tailor the technology to make it accessible for all.3

Those developing public interest technology solutions should interact and engage meaningfully with those who are intimately familiar with the situation.

Further, Aarogya Setu, the Government of India's digital COVID-19 surveillance application, though well intentioned, doesn't consider constitutional rights to data privacy and usage. The application, which

people's chances of getting housing over from a neighbourhood can discuss and vote on civic issues such as garbage and water supply, and find a resolution through a complaint redressal mechanism. Reap Benefit, another nonprofit in Bangalore, employs gamification tools such as badges while empowering the youth to solve civic problems by developing their skills. The application enables youngsters to identify problems in their communities, and supports them with the skills needed to solve the problem through training.

> These examples of public interest technologies have citizens as participants and co-creators of the intervention. The process is particularly slow, long, and iterative at a larger scale if it aims to promote detailed deliberation, sincere societal engagement, and inclusion. For example, the seeds for the hugely successful unified payments interface (UPI) that powers in-

maximise their returns, we believe that governments have tremendous potential to develop sustainable markets for public interest technologies.

BARIPADA: As summer peaks and mercury soars, Similipal National Park has once been the target of poachers who have begun setting fire to hunt small animals and collect Mahua



flowers.

The blaze has put the flora and fauna at risk as the fire continues to spread toward core area of the tiger habitat. While satellite images show fire continues to rage at several places, Forest department claimed that the incidents were reported from eight peripheral areas of the national park in the last couple of days and most of it is man-made.

Officials of Similipal North division arrested five persons for allegedly starting a fire, attempted poaching, and illicit felling in Nawana Wildlife Range which is part of the core critical area. As many as six axes, two bows, arrows, and matchboxes were seized from their possession while forest personnel intensified patrolling on Tuesday.

The five were identified as Rama Singh, Vima

Singh, Bhada Hembram, Rama Singh, and Tapas Naik. Rama was from of Anlabena under Jamda police station while the rest were from Bangiriposi police limits.

Meanwhile, a patrolling squad of Karanjia division also arrested three persons while they were allegedly setting fire to the forest for poaching in Satkosia and Baliposi in Thakurmunda range. Matchboxes, bows, arrows, nets and axes were seized from their possession.

Regional Chief Conservator of Forests, Baripada Circle M Yogajayanand said the fire was reported at six places in Talbandh under STR North division and two places in Pithabata range under STR South division in the last couple of days. He, however, asserted that the situation is under control.

A fire point in Chahala reportedly identified by the Forest department two days ago was extinguished by fire squads just in time.

The RCCF said, the incidence of fire was mostly reported from peripheries of Similipal. Collection of Mahua flowers and other unlaw-

ful activities were behind the cause of the fire, he said. "There is nothing to worry about as the situation is under control and fire squads are keeping a close watch," he added.

He said as many as 720 fire watchers and 500 fire blower machines are ready to take preventive measures. Presently, 200 fire watchers are engaged in different locations in and peripheries of Similipal.

Taxpayers not linking PAN with Aadhaar by March 31 would be required to pay penalty ranging from Rs. 500 to Rs. 1,000

Kolkata (KCN): The Central Board of Direct Taxes (CBDT) has notified Today Late fees for Delayed/ Non linking of PAN with Aadhaar vide Notification No. 17/2022 Dated 29th March, 2022 which ranges from Rs. 500 to Rs. 1000.

Amended Income Tax Rule 114(5) now provides "Every person who, in accordance with the provisions of section 139AA(2), is required to intimate his Aadhaar number to the prescribed authority in the prescribed form and manner, fails to do so by the date referred to in the said sub-section, shall, at the time of subsequent intimation of his Aadhaar number to the prescribed authority, be liable to pay, by way of fee, an amount equal to Rs.500 in a case where such intimation is made within three months from the last date for linking PAN with Aadhaar under section 139AA(2).

However this fee shall be Rs. 1000, in all other cases in which the Pan is linked with Aadhaar after 3 months of the last date i.e. 31st March, 2022.

Advocate Narayan Jain, Chairman Representation Committee of Direct Taxes Professionals Association informed that if any taxpayer do not link his PAN with Aadhhar, his PAN card will become inoperative or invalid. KK Jain, DTPA President has advised all taxpayers to link their PAN card with Aadhaar card before March 31, 2022.

Using an invalid PAN card may lead to Penalty of upto ?10,000 under sec 272B of Income Tax Act.

The last date for PAN Aadhar linking was extended to 31st March, 2022 by CBDT Notification No. 113 of 2021 dated 17 September, 2021.

A defence official said performance of all weapon system components including missile, radar and command post have been validated during the trials. With the conclusion of flight trials for different ranges and scenarios, the system has

completed its development trials and is ready for induction in the Army, he said.

Secretary Department of Defence (R&D) and Chairman of DRDO Dr G Satheesh Reddy congratulated the teams associated with the successful test firings of the weapon system. Defence Minister Rajnath Singh lauded DRDO, the Indian Army and industry for the successful flight tests. He said the successful launches have once again proved the reliability of the system.

The most advanced next generation missile has been developed by Defence Research and Development Organisation (DRDO) and Israel Aerospace Industries (IAI) in collaboration with public and private sector enterprises. With a strike range of nearly 100 km, the 4.5metre long supersonic quick reaction missile weighs around 2.7 tonnes and can carry a payload of 60 kg. Travelling at a speed of Mach 2, it can achieve high degrees of manoeuvrability at the terminal phase. The weapon system has been developed with

cutting-edge technology to neutralise airborne threats like jets, subsonic and supersonic cruise missiles, anti-tank systems and rockets. One of the variants of the MRSAM system

has already been handed over to the Indian Air Force (IAF). The missile is designed to provide point and area air defence for ground assets against a wide range of threats. On March 27, the missile system was successfully flight tested twice against high-speed aerial targets for different ranges as part of the live firing trials.

It was his hometown pitch where he cemented his sporting legend in 2006 by becoming the first bowler in the world to take 700 test wickets. Warne's death at a Thai resort of a suspected heart attack on March 4 at the age of 52 made headlines around the world. The pain was felt far beyond the cricket world. Tributes came from the fields of music, acting, business, golf, politics, surfing, comedy,

poker and others. Elton John dedicated a rendition of "Don't

Former English cricket team captain Nasser Hussain and former West Indies team captain Brian Lara also spoke at the service.

Warne's love life and off-field indiscretions were often fodder for tabloid journalists. But his determination to be his authentic, flawed and irreverent self endeared him to his friends and fans alike.

A statue of Warne outside the cricket ground became a focus of public grief. Tributes left at the statue included beer bottles and cigarette packets. It was a nod to how Warne once described himself in words repeated at his service by his father, Keith Warne: "I smoked, I drank and I played a little cricket."
