Bhima Bhoi's Mission was "Jagat Uddhara" (liberation of the entire world) and he believed in one God, one society and one religion. And Mr. Sethi is propelling this noble mission in letter and spirit.

Mr. Sethi is now serving as Principal Secretary School & Mass Education, Commerce & Transport, Information & Public Relations as well as Chairman of Odisha Hydro Power Corporation.



The Core Ingredient under the N.D.P.S. Act, 1985

The substantial object of the Narcotic Drugs and Psychotropic Substances Act, 1985 is to control the Narcotic Drugs at National and International Level and to protect it from misuse and abuse of drug traffic. Before the



Act 1985 was introduced there were three Central Acts for controlling and regulating the use of the Narcotic Drugs and Psychotropic Substances such as The Opium Act, 1857;

The Opium Act, 1878 and Dangerous Drugs Act, 1930. The period of imprisonments were not sufficient to control the crime and the drug traffickers were let off by the courts with nominal punishment. Therefore, the Central Government brought the Narcotic Drugs and Psychotropic Substances Act, 1985 by abolishing the above mentioned three Acts and the stringent punishments have been introduced for the infringement of the provisions under the Act 1985. The standard of punishments and the provisions have been evaluated through various international treaties and protocols. The Government of India was party to these treaties and conventions which entail several obligations. To control the illicit traffickers a comprehensive legislation was required on Narcotic Drugs and Psychotropic Substances Act. Hence the bill was introduced and finally the Act was passed in the year 1985 and got the assent of the President on 16th September, 1985.

The Act contains 6 chapters. Chapter 4 of the Act contains 25 sections dealing with the offences and penalties. The definitions under Section 2 also contain the clarifications about the quality and quantity of the Narcotic Drugs and Psychotropic Substances Act. The Clause vii(a) contemplates "commercial quantity" which means in relation to Narcotic Drugs and Psychotropic Substances, any quantity greater than the quantity specified by the Central Government by notification in the official gazette. The clause viii(a) contemplates illicit traffic means in relation to Narcotic Drugs and Psychotropic Substances as under:

[(viiia) "illicit traffic", in relation to narcotic drugs and psychotropic substances, means(i) cultivating any coca plant or gathering

any portion of coca plant;

(c) the Convention

on Psychotropic Substances, 1971 adopted by the United Nations Conference at Vienna in February, 1971; and

in

 (d) any other international convention, or protocol or other instrument amending an international convention, relating to narcotic drugs or psychotropic substances which may be ratified or acceded to by India after the commencement of this Act;

The Section 35 of the Act deals with the presumption of culpable mental state. Presumption of culpable mental state of accused arises only after the evidence proved beyond reasonable doubt. In the case of Bhola Singh Versus State of Punjab (2011) 11 SCC 653, the Hon'ble Supreme Court of India has dealt with the specific provisions under the Act such as Section 35, 25 and 15. Section 15 deals with the punishment for contravention in relation to poppy straw. Section 25 deals with the punishment for premises etc. to be used for commission of an offence. Section 35 categorically deals with presumption of culpable mental state which has been explained in the said section that "culpable mental state" includes intention, motive, knowledge of a fact and belief in or region to believe a fact. In the above mentioned case stated supra Bhola Singh Versus State of Punjab wherein the Hon'ble Supreme Court has held the provision of presumption of culpable mental state would be attracted only when the prosecution has discharged its initial burden. The Hon'ble Supreme Court in the appeal considered the relevant provision at para 8, 10 and 11 and set aside the judgment of the High Court and acquitted the appellant Bhola Singh. The said paragraphs are reproduced as under:

- "8. We have considered the arguments advanced by the learned counsel. We see that Section 25 of the Act would not be applicable in the present case as there is no evidence to indicate that Bhola Singh, the appellant had either knowingly permitted the use of the vehicle for any improper purpose. The sine qua non for the applicability of Section 25 of the Act is thus not made out.

The High Court had drawn the presumption under Section 35 of the Act against him holding that by giving a fake address, his culpability was writ large. In the case of Avtar Singh &Ors. Versus State of Punjab (2002) 7 SCC 419 the Hon'ble Supreme Court while considering the case in favour of the Appellants charged under Section 15 of the Act held that possession was the core ingredient to be established before the accused in the instant case are subjected to the punishment under Section 15. The relevant para 6& 7 of the judgment are reproduced as under:

"6. Possession is the core ingredient to be established before the accused in the instant case are subjected to the punishment under Section 15. If the accused are found to be in possession of poppy straw which is a narcotic drug within the meaning of clause (xiv) of Section 2, it is for them to account for such possession satisfactorily; if not, the presumption under Section 54 comes into play. We need not go into the aspect whether the possession must be conscious possession. Perhaps taking a cue from the decision of this Court in InderSain v. State of Punjab arising under the Opium Act, the learned trial Judge charged the accused of having conscious possession of poppy husk. Assuming that poppy husk comes within the expression poppy straw, the question, however, remains whether the prosecution satisfactorily proved the question, however, remains whether the prosecution satisfactorily proved the fact that the accused were in possession of poppy husk. Accepting the evidence of PW 4, the Head Constable, it is seen that Appellant 3 (Accused 4) was driving the vehicle loaded with bags of poppy husk. Appellants 1 and 2 (Accused 1 and 2) were sitting on the bags placed in the truck. As soon as the vehicle was stopped by ASI (PW2), one person sitting in the cabin by the side of the driver and another person sitting in the back of the truck fled. No investigation has been directed to ascertain the role played by each of the accused and the nexus between the accused and the offending goods. The word "possession" no doubt has different shades of meaning and it is quite elastic in its connotation. Possession and ownership need not always go together but the minimum requisite element which has to be satisfied is custody or control over the goods. Can it be said, on the basis of the evidence available on record, that the three appellants - one of whom was driving the vehicle and the other two sitting on the bags, were having such custody or control? It is difficult to reach such conclusion beyond reasonable doubt. It transpires from the evidence that the appellants were not the only occupants of the vehicle. One of the persons who was sitting in the cabin and another person sitting at the back of the truck made themselves scarce after seeing the police and the prosecution could not establish their identity. It is quite probable that one of them could be the custodian of the goods whether or not he was the proprietor. The persons who were merely sitting on the bags, in the absence of proof of anything more, cannot be presumed to be in possession of the goods. For instance, if they are labourers engaged merely for loading and unloading purposes and there is nothing to show that the goods were at least in their temporary custody, conviction under Section 15 may not be warranted. At best, they may be abettors, but, there is no such charge here. True, their silence and failure to explain the circumstances in which they were travelling in the vehicle at the odd hours, is one strong circumstance that can be put against them. A case of drawing presumption under Section 114 of the Evidence Act could perhaps be made out then to prove the possession of the accused, but the fact remains that in the course of examination under Section 313 CrPC, not even a question was asked that they were the persons in possession of poppy husk placed in the vehicle. The only question put to them was that as per the prosecution evidence, they were sitting on the bags of poppy husk. Strangely enough, even the driver was questioned on the same lines. The object of examination under Section 313, it is well known, is to afford an opportunity to the accused to explain the circumstances appearing in the evidence against him. It is unfortunate that no question was asked about the possession of goods. Having regard to the charge of which the appellants were accused, the failure to elicit their answer on such a crucial aspect as possession, is quite significant. In this state of things, it is not proper to raise a presumption under Section 114 of the Evidence Act nor is it safe to conclude that the prosecution established beyond reasonable doubt that the appellants were in possession of poppy husk which was being carried by the vehicle. The High Court resorted to the presumption under Section 35 which relates to culpable state of mind, without considering the aspect of possession. The trial court invoked the presumption under Section 54 of the Act without addressing itself to the question of possession. The approach of both the courts is erroneous in law. Both the courts rested their conclusion on the fact that the accused failed to give satisfactory explanation for travelling in the vehicle containing poppy husk at an odd hour. But the other relevant aspects pointed out above were neither adverted to nor taken into account by the trial court and the High Court. Non-application of mind to the material factors has thus vitiated the judgment under appeal.

7. Coming to the case of the third appellant who was driving the vehicle, there is one more infirmity in the prosecution case. He would have been charged alternatively for transporting the offensive goods without permit or authorization as required by law; but such a charge was not laid. There was not even a reference to Section 8 of the Act. The result is, he too goes scot-free."

The Hon'ble Supreme Court while deciding the above mentioned case has also referred the case of InderSain Versus State of Punjab (1974) 1 SCR 215 wherein the Hon'ble Supreme Court has held that the plain ordinary grammatical meaning of the words of an enactment affords the best guide. The relevant paragraphs of the said judgment relating to the prosecution to prove the possession of the articles within the exclusive knowledge of the accused are reproduced as under:

"Normally, it is true that the plain ordinary grammatical meaning of the words of an enactment affords the best guide. But in cases of this kind, the question is not what the words mean but whether there are sufficient grounds for inferring that Parliament intended to exclude the general rule that mensrea is an essential element in every offence, And, the authorities show that it is generally necessary to go behind the words of the enactment and take other factors into consideration. So, in the context it is permissible to look into the object of the legislature and find out whether, as a matter of fact, the legislature intended anything to be proved except the possession of the article as constituting the element of the offence....." "In the last analysis, therefore, it is only necessary for the prosecution to establish that the accused has some direct relationship with the article or has otherwise dealt with it. If the prosecution proves detention of the article or physical custody of it, then the burden of proving that the accused was not knowingly in possession of the article is upon him. The practical difficulty of the prosecution to prove something within the exclusive knowledge of the accused must have made the legislature think that if the onus is placed on the prosecution, the object of the Act would be frustrated." The Hon'ble Supreme Court after examining the case pros and cons including the evidence, additionally also referred to the provision under Section 8 of the Act was pleased to set aside the conviction and sentence of the Appellants such as Avtar Singh &Ors. Therefore, while trying a case under the provisions of NDPS Act, 1985 the special court constituted under the Act should examine the ingredients of the charges meticulously before drawing the final conclusion for convicting and sentencing an accused person since the punishment of imprisonment is long and rigorous.

- (1) financing, directly or indirectly, any of the aforementioned activities;
- (2) abetting or conspiring in the furtherance of or in support of doing any of the aforementioned activities; and
- (3) harbouring persons engaged in any of the aforementioned activities;]

Since the illicit traffic is not confined to a particular country and many new drugs of addiction have become to be known as Psychotropic Substances, the Central Government has comprehensively adapted various provisions in the Act through international treaties and protocols. Therefore it is relevant to refer the definition of "international convention" as under Section 2(ix) of the Act:-

(ix) "International Convention" means -

- (a) the Single Convention on Narcotic Drugs, 1961 adopted by the United Nations Conference at New York in March, 1961;
- (b) the protocol, amending the Convention mentioned in sub-clause (a), adopted by the United Nations Conference at

possession in terms of Section 54 of the Act and the presumption raised under Section 35, this Court in Noor Aga v. State of Punjab while upholding the constitutional validity of Section 35 observed that as this section imposed a heavy reverse burden on an accused, the condition for the applicability of this and other related sections would have to be spelt out on facts and it was only after the prosecution had discharged the initial burden to prove the foundational facts that Section 35 would come into play. Applying the facts of the present case to the cited one, it is apparent that the initial burden to prove that the appellant had the knowledge that the vehicle he owned was being used for transporting narcotics still lay on the prosecution, as would be clear from the word "knowingly", and it was only after the evidence proved beyond reasonable doubt that he had the knowledge would the presumption under Section 35 arise. Section 35 also presupposes that the culpable mental state of an accused has to be proved as a fact beyond reasonable doubt and not merely when its existence is established by a preponderance of probabilities. We are of the opinion that in the absence of any evidence with regard to the mental state of the appellant no presumption under Section 35 can be drawn. The only evidence which the prosecution seeks to rely on is the appellant's conduct in giving his residential address in Rajasthan although he was a resident of Fatehabad in Haryana while registering the offending truck cannot by any stretch of imagination fasten him with the knowledge of its misuse by the driver and others."

"It's very good news. The Shivling has been found in the presence of both parties and their lawyers. The finding of Shivling is self-evithe Shivling has been found, is a temple today and was a temple in 1947 also," the VHP leader said.

Extreme temperatures compound poverty in Pakistan's hottest city

JACOBABAD, PAKISTAN: By the time Pakistani schoolboy Saeed Ali arrived at hospital in one of the world's hottest cities, his body was shutting down from heatstroke.

The 12-year-old collapsed after walking home from school under the burning sun, his day spent sweltering in a classroom with no fans.

"A rickshaw driver had to carry my son here. He couldn't even walk," the boy's mother Shaheela Jamali told AFP from his bedside. Jacobabad in Pakistan's arid Sindh province is in the grip of the latest heatwave to hit South Asia -- peaking at 51 degrees Celsius (124 Fahrenheit) at the weekend.

Canals in the city -- a vital source of irrigation

"If our water plants weren't here, there would be major difficulties for the people of Jacobabad," said Zafar Ullah Lashari, who operates an unlicensed, unregulated water supply. 'Nothing we can do'

In a farming village on the outskirts of the city, women wake up at 3am to pump drinking water all day from a well -- but it is never enough. "We prefer our cattle to have clean drinking water first, because our livelihood depends on them," said Abdul Sattar, who raises buffaloes for milk and sale at market.

There is no compromise on this, even when children suffer skin conditions and diarrhoea. "It is a difficult choice but if the cattle die, how



for nearby farms -- have run dry, with a smattering of stagnant water barely visible around strewn rubbish.

Experts say the searing weather is in line with projections for global warming.

The city is on the "front line of climate change," said its deputy commissioner Abdul Hafeez Siyal. "The overall quality of life here is suffering."

Most of the one million people in Jacobabad and surrounding villages live in acute poverty, with water shortages and power cuts compromising their ability to beat the heat.

It leaves residents facing desperate dilemmas. Doctors said Saeed was in a critical condition, but his mother -- driven by a desire to escape poverty -- said he would return to school next week.

"We don't want them to grow up to be labourers," Jamali told AFP, her son listless and tearful at her side.

Heatstroke -- when the body becomes so overheated it can no longer cool itself -- can cause symptoms from lightheadedness and nausea to organ swelling, unconsciousness, and even death. Nurse Bashir Ahmed, who treated Saeed at a new heatstroke clinic run by local NGO Community Development Foundation, said the number of patients arriving in a serious condition was rising. "Previously, the heat would be at its peak in June and July, but now it's arriving in May," Ahmed said. Labourers forced to toil in the sun are among the most vulnerable. Brick kiln workers ply their trade alongside furnaces that can reach up to 1,000 degrees Celsius. "The severe heat makes us feel like throwing up sometimes, but if I can't work, I can't earn, said Rasheed Rind, who started on the site as a child. 'Water mafias'

would the children eat?" he said.

Pakistan is the eighth most vulnerable country to extreme weather caused by climate change, according to the Global Climate Risk Index compiled by environmental NGO Germanwatch.

Floods, droughts and cyclones in recent years have killed and displaced thousands, destroyed livelihoods and damaged infrastructure.

Many people choose to leave Jacobabad in the hottest months, leaving some villages half empty.

Sharaf Khatoon shares a makeshift camp in the city with up to 100 people surviving on a few meagre rupees that male family members earn through menial labour.

They usually relocate the camp in the hottest months, 300 kilometres away to Quetta, where temperatures are up to 20 degrees Celsius cooler. But this year they will leave late, struggling to save the money for the journey.

"We have headaches, unusual heartbeats, skin problems, but there is nothing we can do about it," said Khatoon.

Professor Nausheen H. Anwar, who studies urban planning in hot cities, said authorities need to look beyond emergency responses and think long term. "Taking heatwaves seriously is important, but sustained chronic heat exposure is particularly critical," she said. "It's exacerbated in places like Jacobabad by the degradation of infrastructure and access to water and electricity which compromises people's capacity to cope." 'Battlefield'

Along a dried-up canal filled with rubbish, hundreds of boys and a handful of girls in Jacobabad pour into a school for their end-of-year exams. They gather around a hand pump to gulp down water, exhausted even before the day begins.

"The biggest issue we face is not having basic facilities -- that's why we experience more difficulties," said headteacher Rashid Ahmed Khalhoro.

"We try to keep the children's morale high but the heat impacts their mental and physical health."

With extreme temperatures arriving earlier in the year, he appealed to the government to bring forward summer vacations, which normally begin in June.

A few classrooms have fans, though most do not. When the electricity is cut just an hour into the school day, everyone swelters in semi-darkness.

Some rooms become so unbearable that children are moved into corridors, with youngsters frequently fainting.

"We suffocate in the heat. We sweat profusely and our clothes get drenched," said 15-year-old Ali Raza.

The boys told AFP they suffered from headaches and frequent diarrhoea but refused to skip lessons.

Khalhoro said his students are determined to break out of poverty and find jobs where they can escape the heat.

"They are prepared as though they are on a battlefield, with the motivation that they must achieve something."

AIMIM chief Asaduddin Owaisi on Monday said Muslims are not ready to lose another mosque after the Babri Masjid, on a day it was claimed in a Varanasi court that a Shivling was found in the Gyanvapi complex during a survey.

Reacting to the development, Uttar Pradesh Deputy Chief Minister Keshav Prasad Maurya tweeted, "No matter how much you hide the truth, it will come out one day."

"Satya hi Shiv hai (Truth is Shiva)," he said. The Vishva Hindu Parishad (VHP) claimed that the "finding" has proved that earlier a temple stood on the spot.

Earlier in the day, a Varanasi court directed the district administration to seal a pond in the Gyanvapi Masjid complex after counsels representing the Hindu petitioners said a Shivling was found during a court-mandated videography survey.

Referring to the demolition of the Babri Masjid in Ayodhya three decades ago and a 1949 incident when idols of Hindu deities surfaced there, Owaisi asked Muslims to take a pledge that they won't allow its repeat in Varanasi.

In a video posted on his twitter handle, Owaisi said Muslims are not ready to lose another mosque after the Babri Masjid.

"When I was 19-20 years old, the Babri Masjid was snatched from us, and inshallah, we will not allow this to happen with children of the age group," he said.

He urged community members to take a pledge that they won't allow the loss of another mosque.

Life in Jacobabad is dominated by attempts to cope with the heat.

"It's like fire burning all around. What we need the most is electricity and water," said blacksmith Shafi Mohammad.

Power shortages mean only six hours of electricity a day in rural areas and 12 in the city. Access to drinking water is unreliable and unaffordable due to scarcity across Pakistan and major infrastructure problems.

Khairun Nissa gave birth during the heatwave, her last days of pregnancy spent wilting under a single ceiling fan shared between her family of 13.

Her two-day-old son now occupies her spot under its feeble breeze.

"Of course, I'm worried about him in this heat, but I know God will provide for us," said Nissa. Outside their three-room brick home, where the stench of rotting rubbish and stagnant water hangs in the air, a government-installed water tap runs dry.

But local "water mafias" are filling the supply gap.

They have tapped into government reserves to funnel water to their own distribution points where cans are filled and transported by donkey cart to be sold at 20 rupees (25 cents) per 20 litres.

and the candidates supported by us have won as chairperson and vice-chairperson in most of the blocks," he pointed out.

"From the point of view of our party, this election is very important to us and has to be fought with all seriousness," the CM directed the party leaders.

China also has plans of connecting to Nepal via train under the Sino-Nepal Railway project, connecting Tibet to Nepal. At present there are trains from Lhasa to Shigatse. Extension from Shigatse to Gyirong (540 km) is under construction. The distance between Gyirong to Kathmandu is just 120 km.

"When the two parts are completed and linked, international tourists will be excited about it because they can travel through the magic Himalaya regions between China and Nepal," according to Tibet Tourism.

Meanwhile, PM Modi and Nepal's PM Deuba visited the Mayadevi temple in Lumbini on Monday.

"Happy to be among the wonderful people of Nepal on Buddha Purnima," PM Modi tweeted on reaching Lumbini, where he laid a foundation stone for the construction of the India International Centre for Buddhist Culture and Heritage in Lumbini. Though six MoUs were signed between the two nations, India needs to consider Nepal's requests of improving connectivity by opening more airports that would enable thousands to fly into each other's countries more conveniently. Though both PM Modi and PM Deuba agreed in principle to establish sister city relations between Lumbini and Kushinagar, a further push needs to be given by permitting direct flights linking more airports like Pokhara and Bhairawa in Lumbini with India.

"We know your tactics and we will not allow you to sting again," he said apparently referring to right-wing Hindu outfits.

"The mosque exists and it will exist inshallah till the judgment day. The Gyanvapi mosque existed and till the time Allah keeps the world intact, the mosque will remain," he said. Owaisi said Muslims should make efforts that

mosques keep flourishing.

"Ramzan is over and the walls of mosques are longing for people, who had offered namaz at the home of the God for 30 days.

The mosques in villages and localities should be kept alive as evil forces want to deprive us of our culture.

They should get the message that the Muslims are not ready to lose a mosque in India again," Owaisi said.

In a tweet, the AIMIM chief also said the incident is a textbook repeat of December 1949 in Babri Masjid, apparently referring to the appearance of idols in the mosque then.

The Vishva Hindu Parishad (VHP) expressed happiness over the claimed discovery and said it proved that earlier a temple existed there.

"This Shivling was found in the presence of lawyers from both sides. Therefore, the place where the Shivling has been found is a temple. It has been proved," VHP's working president Alok Kumar said in Prayagraj on Monday. "I hope this evidence will be respected by

people of the whole country," he said, hoping that this matter would reach its logical conclusion.

to CJI to approve AIFF constitution prepared by his panel

NEW DELHI: Former India captain Bhaskar Ganguly, a member of the Supreme Court-appointed Committee of Administrators, has urged the apex court to approve the constitution formulated by the panel and ask the All India Football Federation (AIFF) to conduct elections un-



der its aegis.

In a letter written to Chief Justice of India N V Ramana, Ganguly, a decorated India international, informed that he and co-administrator S Y Quraishi have submitted the draft constitution of the AIFF in January 2020.

In a 2017 order, the SC had appointed a Committee of Administrators comprising former Chief Election Commissioner Quraishi and Ganguly to formulate the constitution of the AIFF in consonance with the National Sports Code.

.the same has been submitted by us in January 2020, but till date there is not much of movement in the case, resulting (to) AIFF unable to take any decision for election and their present president complete his tenure as per the terms,' Ganguly wrote in the letter.

...my prayer to the Hon'ble Court to take priority of this case and approve the new constitution and advise to implement to AIFF immediately and conduct the election as per the 'new constitution' so that development of football in India can continue."

Ganguly said he was unable to hire any advocate as he was "working on this project without any financial support from anywhere (sports ministry/AIFF).'

Meanwhile, the pending case is set to come up before a three-judge bench of the Supreme Court on Wednesday.

The SLP has been listed before a bench comprising Justices D Y Chandrachud, Surya Kant and P S Narasimha.

On Thursday, the SC had agreed to hear a plea of Delhi Football Club alleging the "illegal" continuation of (executive) committee and Praful Patel as president of AIFF for over a decade.

A bench headed by Chief Justice of India N V Ramana was told by lawyer Prashant Bhushan that an illegal committee is continuing to head the AIFF due to the non-hearing of a petition of the football body against the 2017 decision of the Delhi High Court.

The AIFF elections were due in December 2020 but it has not held the polls, citing the pending case in the Supreme Court regarding its constitution.

Patel completed his three terms and 12 years as AIFF president in December 2020, the maximum permitted to a national sports federation chief under the Sports Code.

The AIFF moved an application in the SC only a month before its elections were due, seeking certain clarifications on the status of its constitution, which was under scrutiny in the apex court since 2017.

In an affidavit filed before the Supreme Court last month, the Sports Ministry had said that Patel has no mandate to continue as AIFF president as he has already served three terms and the national body should hold elections without any further delay.
