parting Sanskrit education to students has remained closed for the past few months depriving students of education. A single key, however, keeps hanging at the entrance of the institution. Though the Mass Education Department directed enrolment of 20-30 students at the institute, admissions and readmissions to the institute have been stalled owing to the closure of the school for the past few months.

tury-old institution alive, leaders and workers of BJP on Monday demanded immediate action for its revival. The toll was built by Maharaj Sriramchandra Bhanideo in 1894 for the development of Sanskrit language and offered education to students from class 6 to 10. The Centre has given priority for the development of Sanskrit language so that more teachers and students can be produced but the State Government did not render the support required, said MLABaripada Prakash Soren.

"The State government did not provide any financial assistance for the infrastructure development, as a result there is no protection wall around the school. Thus the land has been illegally encroached upon by vendors," alleged Soren. Anti-socials occupy the place to carry out unlawful activities on the premises, sources said..The MLA however, claimed that the Pradhan Pandit or headmaster of the institute Tarasankar Mohapatra retired from service on February 28 and the District Education Officer Nabakishore Giri gave charge temporarily to Jaysri Nanda. But the toll remains closed.

"We demand imme-

diate posting of adequate manpower, both teaching and non-teaching, opening the institution, allowing admission of students and provision of financial assistance for infrastructure development."The institution is connected to the emotion Mayurbhanj people and a memory of the Maharaj who had contributed immensely to the field of health, education, literature and development of the district," Soren said. He alongwith Kavi Bishnu Satpaand other workers of BJP and local people presented a memorandum in this regard to district Collector

The fact that the Congress leaders from the State including the MLAs had failed in their mission of changing Patnaik from the top post was evident from the meeting they had with former president Rahul Gandhi at New Delhi. Rahul chastised them for the indiscipline and warned of strong action in future.

Patnaik who returned from New Delhi looked confident and said that the programme for Priyanka's visit to the State is being worked out. He said that Congress will perform well in Brajrajnagar bypoll and win it.

The Brajrajnagar bypoll and the organisational elections of the party starting next month have also come as a breather for Patnaik as he will lead the party's campaign in the bypoll. Besides, as the organisational elections of the party will be held next month, there is minimum chance of a change in the OPCC during the period.

The two most challenging issues in the office routine are waking up early and preparing a healthy breakfast. A meal that does not consume much time and is easy to prepare so you can reach the office on time.

To your rescue, celebrated chef Sanjeev Kapoor and dietician Sonia Sinha of Fitfoody.in curated a list of 5 tasty and healthy recipes that can be prepared in the nick of time.

Chef Sanjeev Kapoor, a firm believer of healthy eating, said, "Most of us took a step towards a healthy lifestyle during the pandemic and the travel time that we saved every day, helped. But now offices have opened, this means leaving office in a hurry. But don't break the momentum of eating healthy. Remember that it is important to add lots of vegetables and fruits to your eating habits for a healthy, balanced diet. But don't forget that raw vegetables and fruits may be laden with pesticides and germs as they travel places before reaching you. Hence, it is crucial to thoroughly clean your vegetables with a other non-stick pan.

Broccoli Toast: Heat

done. Trim the edges of the bread slices and halve them. Heat another non-stick pan to place bread halves in it and drizzle a little olive oil to make them golden and crisp. Mash sweet potatoes. Remove pan from heat, add salt, butter, cream, and red chilli powder, and mix well. Remove the toasted bread pieces from the pan and place on a plate. Heat orange juice in the same nonstick pan. Add salt and crushed peppercorns, mix well and let it reduce. Add broccoli, mix well and cook till the broccoli turns a little soft. Transfer into a bowl and let it cool slightly. Spread some mashed sweet potato mixture on each toasted bread half. Place some broccoli over the sweet potato and serve immediately. Oatmeal and MushAdd the garlic and sauté till golden. Add the onion and sauté till translucent. Add the button mushrooms, oyster mushrooms, salt, crushed peppercorns and torn thyme sprigs, mix and cook on high heat

for two to three minutes. Add three cups water, mix and bring to a boil. Add the roasted oats and stir continuously till it is cooked. Add the spinach, mix well and remove from heat. Heat some olive oil in another non-stick pan. Break-in an egg, sprinkle some salt and crushed peppercorns and cook till golden from the underside. Similarly, prepare with remaining eggs. Put some

Dietician Sonia Sinha of Fitfoody.in said, "As most of my clients are working, I share a list of easy to make healthy recipes that are balanced and do not take too much time to prepare, so they don't feel burdened in the morning. I also advise my clients to plan their meals a day before so they have all the ingredients in place. If they have limited time, I suggest they wash the vegetables with a herbal cleaner like Nimwash before chopping and storing them. Remember, only selected vegetables can be chopped and stored a night before, so choose wisely."

Dietician Sonia Sinha shares the following balanced meal recipes to make the morning routine easier.

Palak Mushroom Sandwich: Add 1tbsp of chopped ginger, garlic and green chilly in 1/2 tsp oil. Add onion, mushrooms and boiled spinach and stir fry till the mixture is dry. You can put some herbs or masala of your choice and add a little paneer or lowfat cheese to the mix. Stuff it in toasted bread, and your sandwich is ready.

Palak Paneer Rolled Oats: Add some chopped garlic, ginger, green chillies and onion in 1tsp oil. Put some carrot, beans and 1tbsp peas. Add the rolled oats and stir fry. Put the chopped or steamed spinach (with water) and paneer cubes in the mixture. Add some water if required and stir. Put some salt, pepper or mix herbs as per your taste. If you want to add more protein, break one egg on top and sprinkle salt on the egg. Cover the lid and cook for 2-3 mins. A fit and yummy Oats recipe is ready.

Besan Chilla: A perfectly balanced meal that takes no time to make is Besan chilla stuffed with sauteed veggies. Make a thin batter of besan and curd, add black pepper and salt according to taste and make a thin chilla (like dosa). Now, chop your favourite vegetables like capsicum, bell pepper, carrot, tomatoes, beetroot etc. and saute. Once the besan chilla is crisp, stuff it with the sauteed vegetables and serve with green chutney."

HITK Alumnus Part Of The Team That Made New Biomaterial To Heal Wounds

Kolkata (KCN): The utility of antibiotics to heal bacterial infections suffered a damage

with the advent of multi-drug resistant pathogens, and it was high time for the researchers to develop other ways of curing such bacterial infections. In this context, few scientists had developed a new biomaterial that can be used to heal the wounds and accelerate the process of healing. The same was used in mouse models for a trial run that proved to be successful.

The research findings were published in the journal 'Biomaterials Science'. The research work was done by a group of scientists from Indian Institute of Technology (IIT) Mandi, IIT Delhi and National Institute of Science Education and Research (NISER), Bhubaneswar. 

Climate Change and Food System

Climate change is a growing threat to our food systems, with grim implications for food and nutrition security, livelihoods, and overall well-being, especially for poor and vulnerable



people around the world. The imperative for urgent action on climate change — both to achieve the major emissions reductions needed to limit global warming and to increase adaptive capacity and resilience — is

drawing global attention.

International Food Policy Research Institute (IFPRI) has recently published Global Food Policy Report 2022. The report sets out a broad range of opportunities for accelerated action that should be considered in policy and investment decision-making for climate change adaptation, mitigation, and resilience. The impacts of global warming are becoming increasingly evident. Higher temperatures, changing precipitation patterns, sea level rise, and growing frequency and intensity of extreme weather events such as droughts, floods, extreme heat, and cyclones are already reducing agricultural productivity and disrupting food supply chains. Beyond its direct impacts on production, climate change will create cascading effects on livelihoods, communities, and sustainability through interconnections among economic, environmental, social, and political spheres. At the same time, food systems are estimated to contribute more than a third of global greenhouse gas (GHG) emissions responsible for climate change, placing food production at the center of attention as both a contributor to global warming and a critical sector for mounting an adaptive response to climate change.

Even in the absence of climate change, food systems face enormous challenges and demands. Hunger and malnutrition are rising, and over 3 billion people currently cannot afford a healthy diet. Food systems are the world's largest "employer," but for many, particularly women, youth, and other vulnerable groups, agriculture-based livelihoods are precarious. In addition, food systems are major contributors to environmental degradation beyond GHG emissions, including deterioration of water

resources and loss of habitat and biodiversity, which

compromise the environmental services that

support food production. Yet global aspirations for food systems are extremely high. As was made clear in 2021 at both the UN Food Systems Summit (UNFSS) and UNFCCC COP26, food systems must play a central role in achieving multiple, pressing sustainable development and climate goals, from the local to the global level. These aspirations envision food systems that are far more nature-positive, deliver improved and more resilient livelihoods, empower disadvantaged groups, and produce a healthy mix of foods at affordable prices. Food systems are called on to accomplish all these goals in the context of a rapidly changing climate and while making a substantial contribution to achieving net zero GHG emissions by 2050. Action to address climate change has begun, but it urgently needs to be accelerated by hastening innovation, reforming policies, resetting market incentives, and increasing financing for sustainable food systems transformation, as well as promoting healthy diets and building resilience. The world remains far from achieving the emissions reductions needed to constrain warming to 1.5°C above pre-industrial levels. While this goal remains feasible, the longer we wait, the more difficult achieving it will become. Looking forward, scenarios from IFPRI's IMPACT model indicate that rising temperatures will negatively impact agricultural yields, driving up prices and resulting in increased hunger, especially in Africa. Unless action is taken now, this toll will add to the many people pushed into poverty and hunger by extreme weather events, as well as by local shocks and global crises, such as COVID-19 and the current war in Ukraine, that disrupt food systems and raise food prices. Food production, distribution, and consumption practices must be adapted to climate change to better support rural livelihoods and provide healthy diets for all, even as population and income growth increase the demand for food. At the farm level, adaptation must address changing growing conditions, water scarcity, droughts and floods, increased risks of destructive weather events, and related risks of disease and pests. Along value chains, storage and change, and price volatility will increase, with processors, traders, and

implications for processors, traders, and consumers as well as farmers.

Climate change will put increasing pressure on scarce natural resources, which can increase the risk of conflicts. Such conflicts can affect entire value chains and are a major driver of increases in global food insecurity and hunger. Recent experience with the COVID-19 pandemic has shown us how disruptions in one part of a value chain can have wide-reaching impacts. But it has also shown us how food systems, including public and private sector actors, can respond and adapt quickly to severe shocks. A number of promising innovations show potential to support adaptation and build resilience while also increasing productivity. These climate-smart innovations include new crop varieties that better withstand climate shocks and improve yields, solar energy for product storage, and digital technologies that expand access to knowledge and services for rural producers.

Many climate-smart innovations, such as notill farming, agroforestry, and landscape management, will also support mitigation by sequestering carbon or reducing emissions. However, technical innovations will never reach their full potential without the right enabling environments, including policy incentives and governance approaches that promote climate-positive change and inclusion of all food systems actors. Policies and institutions at the local, national, and international levels need to incentivize the development and adoption of new technologies and practices and ensure adequate finance is available. They must recognize potential trade-offs — in terms of yields and efficiency — between sustainable systems and existing or other modern farming practices and between sectors, such as energy and water. Policies must also facilitate coordinated action across stakeholders and ensure equitable systemic transformation for

Despite international commitments to reduce GHG emissions, total net anthropogenic GHG emissions continue to rise. Stepped-up efforts to reduce GHG emissions are required of developed economies, and progress by developing and emerging economies is also necessary, but it is important to bear in mind that the least developed countries accounted

for only 3.3% of global GHG emissions in 2019. Food systems are estimated to generate as much as 34% of total GHG emissions, which stem from agriculture and land use, storage, transport, packaging, processing, retail, and consumption. Continued progress in energy and transport sector technologies can reduce fossil-fuel use and emissions throughout food systems, including in irrigation, processing, transport, cold storage, and waste recycling. However, two-thirds of food systems GHG emissions — or about 21% of total emissions from all sources — are from agriculture, forestry, and other land use (AFOLU). AFOLU has potential to deliver substantial emissions reductions and carbon sequestration. It is the only economic sector with serious potential to become a net emissions sink — pulling more GHGs out of the atmosphere than it emits — through creation and protection of carbon sinks such as forests. Of AFOLU CO2 emissions, almost half are from land use change and management.

Net agricultural land expansion is now concentrated in the developing world, primarily in Africa and South America, while land use change in some developed countries is offsetting emissions. Some developed countries have scope for creating larger net sinks for emissions, but developing countries should prioritize fostering agricultural practices that both raise productivity and turn the tide on AFOLU emissions. Significant GHG mitigation can also be achieved by reducing nitrous oxide emissions from fertilizers and methane emissions from paddy rice and enteric fermentation (from cattle and other ruminant digestion) as well as decreasing emissions intensity through sustainable production systems and reduced food loss and waste. Shifting food consumption toward healthy diets has also been found to have substantial potential for emissions reduction. Combined, these efforts could move the world toward net zero emissions.

Achieving the ambitious goals set for food systems will require inclusive, holistic approaches that consider all components of our food systems, from local to global and from farmer to consumer. Charting optimal pathways for sustainable food systems transformation will be challenging, but we must step up our efforts now to ensure our global future.

Why are women still opting for unsafe home births in India?

Between 1990 and 2018, India has made notable progress in reducing its maternal mortality rate (MMR). However, this progress has not been uniform throughout the country. Low-performing states (LPS) such as Assam, Bihar, Chhattisgarh, Jharkhand, Madhya Pradesh, Odisha, Rajasthan, Uttar Pradesh, and Uttarakhand still have a relatively higher MMR as compared to the national average (Figure 1). A key component of maternal healthcare is institutional delivery, which reduces the risk of preventable maternal and neonatal mortality arising due to delivery-related complications. To promote and improve the uptake of institutional deliveries in India, the Janani Suraksha Yojana (JSY) was implemented as India's flagship scheme under the National Rural Health Mission in 2015. It has been designed to reduce high out-of-pocket payments and associated catastrophic health expenditure incurred at the point of care. JSY offers centrally sponsored conditional cash transfer incentives—upon delivery and throughout postnatal care—to beneficiaries delivering at public health facilities and authorised private hospitals registered under the scheme. The amount of financial disbursement differs across states, with LPS receiving nearly double the amount (USD 13.6-19) compared to the high-performing states. JSY also provides beneficiaries with free transportation services to healthcare facilities and accredited social health activist or ASHA-led prenatal and postnatal care. Despite these incentives, the coverage of institutional delivery remains extremely low in specific subnational regions and among socio-economically disadvantaged groups. It is especially stark in India's nine LPS, which contribute to 12 percent and 62 percent of all glo-

bal and national preventable maternal deaths respectively.

To further understand the relationship between institutional delivery utilisation and JSY scheme coverage across these nine LPS, we analysed data from the National Family Health Survey-4 (NFHS-4), 2015–16. Our findings indicate that states with the highest institutional delivery coverage had a high JSY scheme coverage and vice versa. In Odisha, for example, both institutional delivery (87 percent) and JSY coverage (73 percent) were found to be high. In contrast, in states such as Bihar where uptake of institutional delivery was lower (66 percent), JSY coverage also remained low at 54 percent (Figure 2).

These findings raise a few other important questions: First, despite comparatively high institutional delivery coverage, why does MMR remain high in states such as Madhya Pradesh and Rajasthan? And, second, why does the uptake of institutional delivery as well as JSY utilisation remain low in states such as Bihar and Jharkhand in spite of monetary incentives? On probing these questions further, we found that a range of socio-demographic factors (beyond financial incentives) determine whether or not a woman will opt for institutional delivery.

Accessibility to health facilities

Even though there has been a committed emergency transport support system under JSY, beneficiaries still face difficulty in accessing them,

delays. We found this to be the case, especially for women residing in the rural areas of Assam, Jharkhand, Madhya Pradesh, and Uttarakhand. Our findings indicate that transport-related challenges, coupled with the overall lack of health facilities, resulted in more women in rural areas opting for unsafe home deliveries as compared to their urban counterparts.

The second important factor that determined the uptake of institutional deliveries was household wealth. In Assam, women from the richest households were 14 times more likely to deliver in a health facility compared to the poorest households. We found a similar pattern in other states such as Jharkhand, Madhya Pradesh, and Uttarakhand. Evidence suggests that even though JSY offers cash incentives, beneficiaries face several obstacles in obtaining them, with untimely cash disbursement being a major issue. Women from poorer households are unable to account for and make some of the necessary payments in advance. For example, in rural districts of Madhya Pradesh, women reported that they did not receive the entire cash reward upon institutional delivery. This is because they had to make forced side payments to the hospital staff, ASHAs, and incur other transport and medicine expenses—all of which were deducted from the cash reward. In addition to this, beneficiaries also face problems while opening local or regional bank accounts and are unsure of when and exactly where their cash rewards will be deposited.

Across the nine LPS, we found that child marriage also deterred institutional deliveries. This may be attributed to the lack of autonomy and

restrictions imposed by family members on child brides. Overall, women who married before the age of 18 were 22 percent less likely to opt for institutional delivery than women who married at 18 years or later.

In our study, education emerged as an important determinant across all the states. Women who had higher educational attainments were almost four times more likely to utilise in-facility birth compared to those who were less educated. The importance of education was majorly observed in the states of Assam and Chhattisgarh where it appeared as the second most important predictor of institutional delivery. Drawing from our research, we can infer that access to education over time could equip women to be more aware of the clinical health benefits of delivering at a health institution.

How can we improve institutional delivery coverage?

Conditional cash transfer incentives under JSY have not proven to be sufficient and satisfactory in escalating the demand for and utilisation of institutional delivery services. However, state-specific solutions can help improve the uptake of safe in-facility deliveries among beneficiaries; this is integral to their sexual and reproductive health rights. Here are a few suggestions:

Spanish government proposes wider abortion rights, menstrual leave

MADRID: The Spanish government approved a draft bill Tuesday that widens abortion rights for teenagers and may make Spain the first country in Europe entitling workers to paid menstrual leave. The measures are part of a package of proposals that will be sent to the Spanish parliament for debate. The package includes an extension of abortion rights, scrapping the requirement for 16- and 17-year-olds to obtain parental consent before terminating a pregnancy.

The Spanish move comes just as the US Supreme Court appears poised to reverse that country's constitutional right to abortion, in place for nearly a half-century.

Spanish government spokeswoman Isabel Rodríguez said the proposals represented "a new step forward for women, a new step forward for democracy.'

The Spanish government also proposes giving workers who are experiencing period pain as much time off as they need, with the state social security system "not employers" paying for sick leave. As with any other temporary medical incapacity, a doctor must sign off on the health problem. The driving force behind the law is the junior member of Spain's left-wing coalition government, the "United We Can" Party. It was not immediately clear whether the Socialist-led coalition has enough support in

parliament to pass the proposed legislation, which could take months.

The government, which came to power almost four years ago, has made women's rights one of its political banners. The Cabinet has 14 women and eight men in ministerial positions. Abortion on demand is permitted in Spain through the 14th week of pregnancy.

ASI's Bhubaneswar Circle Superintending Archaeologist Arun Kumar Mallick, who along with a team of experts, rushed to Puri for inspection of the damaged lion sculpture recovered during exaction of the heritage corridor project on Monday.

The state government was implanting the project which has further intensified into a major controversy after the ASI informed the Orissa High Court that the work carried out near the 12th century shrine in Puri did not have proper permission from the competent authority. The sculpture was found on the premises of the Emar Mutt, about 75 meters Shree Jagannath dating back to the



Temple. A part of the sculpture was damaged during the mindless digging work, locals have alleged.

The ASI team led by Mr.Mallick analyzed the architect, species of the rock and the quality of artifacts from different angles, saying that the lion sculpture could be dating back to the Ganga Dynasty period.

The ASI had already mentioned about recovery of two more such sculptures from the site and submitted pictures of those in its affidavit to the Orissa High Court on 9 May. The ASI, through its affidavit, had earlier informed the high court that no heritage impact assessment studies were conducted before the commencement of the project.

"At several locations stratified deposits of about 15 to 20 ft have taken place, which has caused irreparable damage to the heritage site," the ASI had said.



The Wholesale Price Index (WPI) at 15.08 per cent is the highest in the new series, the data for which is available since 2012-13. The WPI inflation has remained in double digit for the 13th consecutive month since April last year.

"The high rate of inflation in April 2022 was primarily due to rise in prices of mineral oils, basic metals, crude petroleum & natural gas, food articles, non-food aretc. as compared to the corresponding month of the previous year," the commerce and industry ministry said in a statement. Inflation in food ar-

ticles was 8.35 per cent as prices of vegetables, wheat, fruits and potato witnessed a sharp spike over the year-ago period. In the fuel and power basket, inflation was 38.66 per cent, while in manufactured products and oil seeds, it was 10.85 per cent and 16.10 per cent, respectively.

Inflation in crude petroleum and natural gas was 69.07 per cent in April. Data released last week showed that retail inflation rose to a near eight-year high of 7.79 per cent in April, remaining above the Reserve Bank's inflahigh inflation, the RBI earlier this month hiked its key interest rate by 0.40 per cent and cash reserve ratio by 0.50 per cent in a surprise move.

ICRA chief economist Aditi Nayar said with some correction in commodity prices as a result of the bleaker demand outlook in China offsetting the depreciation in rupee, the WPI inflation may recede mildly below 15 per cent in May 2022, while remaining uncomfortably elevated. The heat wave led to a spike in prices of perishables such as fruits, vegetables and milk, which along with a spike in tea prices pushed up the primary food inflation. 

WPI inflation at record high of 15.08 per US hopes India would 'reconsider' cent in April on price rise across all items its decision to restrict wheat export

NEW YORK: The US hopes India will "reconsider" its decision to ban wheat exports, with Washington "encouraging" countries not to restrict exports as that will exacerbate food shortages, amidst Russia's invasion of Ukraine.

India, the world's second-biggest wheat producer, has banned wheat exports in a bid to check high domestic prices amid concerns of wheat output being hit by scorching heat waves.

The decision would help control retail prices of wheat and wheat flour, which have risen

by an average 14-20 per cent in the last one year, besides meeting the foodgrain requirement of neighbouring and vulnerable countries.

US Ambassador to the UN Linda Thomas-Greenfield, during a virtual New York Foreign Press Center briefing on Monday, said: "We have seen

the report of India's decision. We're encouraging countries not to restrict exports because we think any restrictions on exports will exacerbate the food shortages".

"But you've again, India will be one of the countries participating in our meeting at the Security Council, and we hope that they can, as they hear the concerns being raised by other countries, that they would reconsider that position," she said. Thomas-Greenfield was responding to a question on India's decision to restrict wheat exports.

The US envoy said that Ukraine used to be a breadbasket for the developing world, but ever since Russia started blocking crucial ports and destroying civilian infrastructure and grain silos, hunger situations in Africa and the Middle East are getting even more dire. This is a crisis for the whole world, and so it belongs to the UN.

"We have a responsibility to the millions who are worried about where they'll find their next meal or how they'll feed their families. This week is about owning that responsibility and taking action to alleviate food insecurity around the globe," she said.

The US is President of the UN Security Council for the month of May and will host a signature event on food security this week against the backdrop of international conflicts such as the Russia-Ukraine war that have brought food insecurity to the fore.

On May 19, Secretary of State Antony Blinken will preside over an open debate on the 'Maintenance of International Peace and Security: Conflict and Food Security.'

On the eve of the Security Council meeting, Blinken on Wednesday will chair a global food security call to action ministerial meeting which will bring together officials from dozens of countries to review their urgent humanitarian and development needs to address global food security, nutrition and resilience, Thomas-Greenfield said.

"This will include countries with diverse perspectives ranging from major food providers to those facing significant food crises," she said.

Minister of State for External Affairs and Parliamentary Affairs V Muraleedharan, who will be in New York from May 17 to May 20, will participate in the high-level Ministerial Meeting on 'Global Food Security - Call to Action' and deliver a statement at the UNSC open debate.

The Directorate General of Foreign Trade (DGFT) had said in a notification last week that wheat exports will be allowed on the basis of permission granted by the Government of India to other countries to meet their food security needs and based on the request of their governments.

India's wheat exports stood at an all-time high of 7 million tonnes, valuing USD 2.05 billion, in 2021-22 fiscal year on better demand of Indian wheat from overseas. Of the total wheat exports, around 50 per cent of shipments were exported to Bangladesh in the last fiscal.

Thomas-Greenfield had said that the open debate will examine the nexus between conflict and food security and the Council will consider steps needed to ensure increasing



food security does not drive new conflicts, instability, particularly in fragile states. The US on Monday launched several days of action on global food security, an issue Thomas-Greenfield said has been a priority for the Biden administration from day one.

"The hard truth we have to reckon with is that people starve every day all around the world even though we have more than enough food to go around. Worse, many go hungry and don't know where their next meal will come from because warmongers are intentionally using starvation as a weapon of war."

"Ethiopia, South Sudan, Syria, Somalia and Yemen are just a few examples of places where conflict is driving people to desperate hunger. These days of action are about bringing this crisis to the center of the world's attention, and this all takes on heightened significance given Russia's brutal and unprovoked war in Ukraine", Thomas-Greenfield said.

India has noted with concern that the Ukraine conflict is having a destabilising effect with broader regional and global implications.

"Oil prices are skyrocketing and there is shortage of food grains and fertilisers. This has had a disproportionate impact on the Global South and developing countries," India's Permanent Representative to the UN Ambassador T S Tirumurti has said.

Last week, UN Secretary-General Antonio Guterres said in Vienna that he is "deeply concerned" over hunger becoming widespread in different parts of the world because of the "dramatic food security situation we are facing because of the war in Ukraine."

It is my belief that, independently of many other solutions that deal with the need to keep markets open, to avoid export bans, to do everything to interfere in the markets to keep prices as low as possible.

"I do believe that there is no solution to the problem without bringing back to the markets the food production of Ukraine and the food and fertiliser production of the Russian Federation and Belarus," Guterres had said.
