Bhubaneswar(KCN): The State Government has made affixation of High-Security Registration Plates (HSRPs) mandatory for all class of old vehicles which were registered prior to

April 1, 2019. Earlier, the HRPS has already been made mandatory for all new vehicles registered on or after 1 April, 2019.

Transport Commissioner Arun Bothra has issued an order for this purpose in accor-

dance with rule 50 of Central Motor Vehicles

Vehicle owners have been given at least 3 months' time to fix the HSRP on old vehicles before enforcement is undertaken by the transport department and police officials. Accordingly, different deadlines have been set for vehicles as per its registration number.

As per the order, August 31, 2022 is the deadline for the vehicles carrying Odisha registration mark and registration number ending with 1 & 2, while September 31, October 31 and November 30 is the deadline for the Odisha registration vehicles with numbers ending with 3&4, 5&6 and 7&8, respectively.

Similarly, the vehicle owners carrying Odisha registration mark and registration number ending with 9 and 0 will have to affix the HSRP by December 31, 2022.

To avoid last minute rush, Mr.Bothra advised vehicle owners to affix HSRP on their vehicles as soon as possible but not later than the above schedule.

If the vehicle owners fail to replace the existing number plates with HRPS before the above-mentioned deadlines, e-challans will be issued against the offending vehicle and attract fine of Rs. 5000 or Rs. 10,000 under Section 192 of M.V. Act, 1988 as the case may be, warned the commissioner. continued on: P-7

Opportunities for Odisha based Architects

Rourkela (KCN): Chairman NITRAA, Rourkela Chapter and Social Activist Bimal Kumar Bisi wrote to Union Railway Min-Aswini ister Vaishnaw and requested for opportunities for odisha based Architects. He says" What does one remember as one visits a capital city? The first memory for the majority of those arriving in the city is that of the Railway station. It is rare to find an Indian who has never travelled by train. Roadways are uncomfortable for long-distance journeys and flights are beyond reach for the majority of Indians. Railways move India and, in the process, integrate India. The flavour changes as Train takes a family from Northern India to Southern and from Eastern India to Western. Should we expect a Railway station to be just like INOX or a common High rise corporate mall? All INOXs are the same all Malls are the same. It's No more Hazrat Ganj of Lucknow Connaught place of of Kolkata or Marine drive of Bombay. Malls are the same everywhere. Once one enters a modern mall, it is impossible to know whether a person is in India or Spain. Just like highly standardized Pizzas, readymade clothes with standard sizes or perfectly identical artificial diamonds. There is an all-pervading monotonous uniformity. Product uniformity does offer economies of scale and should be there to bring down the costs. But capital city Railway stations which are supposed to be icons must have a uniqueness that should identify them with the place. They are the real gateway to the city and the change of flavour must create a symphony of unity in diversity for the traveller. Here comes the role of the architects. Does Odisha not have the local talent to develop Railway station buildings in Odisha? Odiya Architecture whether that of Sun Temple, Konark, or Lord Jagannath's Temple Puri, has a world-class uniqueadvancement. The Sundial carved in the wheels of a chariot is one of the highest examples of integration of science with art and spiritualism. Should we compare these with the Plastic shops, INOX type raw business structures that are nothing but the product of a mass produced product mix created by corporate Sales teams? The signature flavour of a cup of Dahi Pakhal or enchanting Rangobati beats? Does it not ring a Bell? The same applies to the Icons. The icons need not be historical temple architecture but must bring out what the best postmodern Odiya minds can imagine. Is it possible for the Delhi and Gurgaon- based Packaged Architects to bring the Odiya signature to the Iconic station structures? An architect whose visit to Bhubaneswar is limited to some business Hotel Room can only deliver a mass- produced packaged architecture, a concrete and glass boxed Pizza! Icons do not just mean concrete

is well beyond this. The functional station elements, in any case, are designed throughout the world based on the specialized formulae already developed. The Architect has to go beyond the arithmetic of design. Perhaps the best solution is to involve Architects of Odisha developing the signature facades of Odisha Railway stations. This will not only help create signature icons bringing out the specialty of the state but shall also develop skills and capacities in post- modern methods of Architecture, Engineering, and Construction management. The capabilities and abilities of those who created world-class icons deserve to be trusted again. No doubt the results will mesmerizing.With the capabilities, odisha architects can meet the challenges of conceptual oriental design which we presume can be made with the cost of around rupees 40 cr besides international exposure." Well, precisely. The Rani Of Jhansi was passionately dedicated to her kingdom. I don't see much of that dedication in the trailer. Much of it is devoted to displaying its leading lady's skills on horses and with swords. The trailer gives us an epic primer on 'Kangana Rides The Horse', 'Kangana Swats The Enemy', 'Kangana Bays For Blood', so on and so forth.

There is so much

of the talented actress' efforts to appear queenly, the trailer barely offers a glimpse of the impressive supporting cast, namely Danny Denzongpa, Atul Kulkarni, Suresh Oberoi and others who flit by in this steamroller view of a woman warrior's dayout binge. Threadbare thunder in a fancy teacup.

1. We have inherited from the British, a wonderful legal system. In doing so, the British was not doing us any charity. They needed a sound legal system for



the governance of their own affairs, the common law. The common law is largely founded on Roman law, and Ro-

man law reflects nothing but the thoughts of great philosophers such as Socrates, Plato, Aristotle, Cicero, Ulpian, et al. The doctrine of estoppel and res judicata is one of the cardinal principles on which the Roman law, nay, the common law -our law- is founded. Unfortunately, and unbelievably, the 'giants' among our lawyer fraternity seem to be ignorant of the basic principles or have deliberately acted contrary to the basic principles to the point where they have completely destroyed our legal system, nay, the very concept of democracy.Let me take the example of the Mullaperiyar dam.

The dam was constructed in the 19th century. It was expected to last for 50 years. Major leaks were observed in the late 1970s. The Kerala Government, based on expert advice, took the definite stand that the dam is not safe, that a new dam ought to be constructed in its place, and the old dam ought to be decommissioned. The Governments, namely, the Governments of the states of Kerala and Tamil Nadu and the Central Government were deeply concerned and were on the verge of reaching a unanimous decision to construct a new dam. While so, in 2000, a PIL came to be filed. With that, the Tamil Nadu Government took an adversarial stand, and the Supreme Court in 2006 held that the dam is safe and that even if it breaks the flood waters would flow in the natural course of the river to the Idukki reservoir, and that the Idukki reservoir would

be able to contain the entire flood

waters. The Government of Kerala found the judgment to be contrary to reason and an invitation for catastrophe. Taking into account the frightening implications of the breaking of the dam, the Kerala Government brought in a legislation limiting the storage capacity of the dam to 136 ft. The State of Tamil Nadu challenged the constitutionality of the Kerala legislation. Realising that no dam can remain in perpetuity and particularly a dam made of lime and surkhi, at time when dam technology was at its infancy, the Kerala Government made a budgetary provision for the construction of a new dam.

- In 2014 came the judgment of the 5judge constitution bench of then Chief Justice R. M. Lodha. The Supreme Court held that in 2006, a 3-judge bench had found that the dam is safe, and therefore, the question as to the safety of the dam cannot be re-agitated, for to do so is barred by the doctrine of res judicata. The Court rejected the plea of the Kerala Government for the construction of a new dam at its own cost on the ground that the Supreme Court had held the dam to be safe in 2006 and, therefore, the issue of safety cannot be re-agitated.
- A dam is not a static entity. Every fluctuation in the water level creates stress and strain on the dam structure. A dam, like all man-made structures, has a life. It cannot remain safe infinitely. The doctrine of res judicata is a legal fiction. It is founded on the realisation of Roman lawyers of the undeniable truth that no judge can assuredly ascertain the facts correctly, but that for the sake of finality and to avoid the scenario where parties to the same dispute reagitate the issues, even an erroneous decision of a Court ought to be accepted as truth.
- 5. For the doctrine of res judicata to apply, the Court should have jurisdiction of the

parties to litigation must be the same, the cause of action should be the same, the dispute should have been adjudicated on its merits, etc.

- 6. A dam is not a static entity. With the passage of time the structure deteriorates. The changes in the seismic activity of the area also affects the safety of the dam. The doctrine of res judicata has no application. Even assuming the dam to be safe in 2006, eight years down the line, it could not have been assumed to be safe in 2014. On a gross misconception of the doctrine of res judicata, the Supreme Court held that he dam is safe, because the Court in 2006 had held so and that decision is binding as res judicata. Res judicata is a concept which even a law student ought to know. Unfortunately, the legal giants who rule the roost failed to appreciate the true meaning of the term res judicata and the enormity of their error.
- Global warming has meant drastic changes in the monsoon pattern. The quantum of rainfall has substantially increased, so too, the density of rainfall at a given time. In 2006, even at the peak of the monsoons, the Idukki reservoir was only half full. Now, every monsoon, the shutters have to be opened. The Mullaperiyar dam is believed by many experts to be far more susceptible than it was in 2006. But the Kerala Government cannot construct a new dam because in 2014, that plea was rejected by the Supreme Court. The only saving grace is that, apparently to overcome the judgment of the Supreme Court, the Central Government has brought in the Dam Safety Act of 2021. But it is doubtful whether the Kerala Government will proceed to construct a new dam in the teeth of the judgment of the Supreme Court of 2014.
- 8. What made the Supreme Court make such a humongous mistake which may

endanger the lives of millions of citizens and the wiping out of the districts of Ernakulam, Alleppey and Kottayam. Many, including the Kerala Government, express the view that the dam is unsafe. Tremors can lead to breaking of the dam. The increase in seismic activity in the area over recent years is, therefore, another cause for concern.

- 9. No prudent man can remain in the blind faith that the dam will not break. On the contrary, one should prepare to meet any eventuality, namely, that the dam may give away in the coming monsoons. Sadly, nothing is done except the forming of a few committees titled 'Supervisory Committee, committee under the Disaster Management Act', etc.
- 10. Our country has come to be ruled by the judges through PILs, by "enacting laws" under Articles 141 and 142, as opposed to interpreting the law. All these aberrations are the outcomes of another manifest error, the "basic structure theory" which has meant the re-writing of elementary jurisprudence. To put it succinctly, before Kesavananda Bharti, only a person whose rights are infringed could have approached a Court. Today, busy bodies rule the roost, openly declaring that none of their legal -let alone fundamental- rights are infringed, but that the "basic structure" is infringed.
- 11. Who can correct these errors which have assumed gigantic proportions? There are thousands of judgments "laying down the law of the land" all relying on the basic structure theory. The judges, too, have profited immensely by the so-called basic structure theory. Using that alone, they invented the collegium system where judges appoint themselves (mostly their own kith and kin) and struck down the NJAC.

5 tonnes of lifesaving COVID-19 supplies arrive in Samoa

A planeload of medical equipment and supplies touched down in Apia on Monday to bolster Samoa's response to the COVID-19 pandemic. The goods were provided by the World Health Organization (WHO) for the Ministry of Health of Samoa and transported by the United Nations World Food Programme (WFP) through its Pacific Humanitarian Air Service, with funding support from the Eu-

ropean Union (EU). "They say that it is in times of crisis that your true friends are revealed, and WHO, WFP and the EU have shown themselves to be true friends indeed to Samoa – not just in this latest delivery of supplies, but in their ongoing tremendous support

for our COVID-19 preparedness and response," said Minister of Health, the Honourable Valasi Luapitofanua To'ogamaga Tafito Selesele. "This equipment and medical supplies will be used by Samoan health workers around the country as they continue to test and treat patients and to remain safe themselves as they save lives. Faafetai tele lava for your kind assistance."

Samoa detected its first community transmission of COVID-19 on 17 March 2022 after two years of being COVID-free. To date, the country has reported a total of 9,592 cases. However, with more than 92

percent of adults having received at least two doses of COVID-19 vaccines.

280,000 surgical masks, 248,300 gloves, 72,000 gowns, 30,000 N95 masks, 10,300 face shields, 3000 pulse oximeters and 50 oxygen concentrators for Samoa from WHO's regional stockpile. Further items



including oxygen concentrators and pulse oximeters also arrived on the plane to be sent by boat to neighbouring Tokelau.

"We knew we needed to get this equipment and supplies into health workers' hands here in Samoa, but getting it here was going to be a challenge, due to limited flights and inflated shipping costs. Thankfully, we spoke with our colleagues at WFP and, with support from the EU, they made this flight possible," said WHO Representative to Samoa, Dr Kim Eva Dickson.

UP Assembly: CM slams Mamata over Bengal poll violence, counters Akhilesh

LUCKNOW: Uttar Pradesh Chief Minister Yogi Adityanath slammed his West Bengal counterpart Mamata Banerjee over poll violence in her state and targeted Akhilesh Yadav, who heads the main opposition party back home, over his "false campaign" on farmers' issues.

Speaking on the motion of thanks on the Governor's address to the state legislature, Adityanath listed the achievements of his previous government, comparing them with the one led earlier by Akhilesh Yadav's Samajwadi Party. He hit out at Yadav for his reluctance to accept the "success" of the "double engine" government --- a reference to the BJP being in power both at the Centre and in the state. The "double engine", he said, "is working at triple speed".

He ridiculed the opposition leader for "blaming" the electronic voting machines for the SP's defeat in the recent assembly polls, which brought the BJP back to power in UP for a second term in a row.

"If they win, everything is alright. But if the BJP wins, there is some fault with the EVMs," Adityanath said.

"This is an insult to the people."

Without naming Trinamool Party leader Mamata Banerjee, Adityanath recalled her visit to the state during the UP campaign.

"A 'didi' from West Bengal came in support of the Samajwadi Party in the elections," he said, while attacking her government for the violence during the assembly elections in her state in

Female CEO's pay rose 26% in 2021, but ranks remain small

NEW YORK: Pay packages for the women who run S&P 500 companies jumped in 2021 as the economy recovered and stock prices and profits soared. Median pay for the women occupying the corner office rose to nearly \$16 million, according to the annual survey done by Equilar for The Associated Press. Still, experts say there's much more to be done to improve gender diversity in the corporate ranks and close the pay gap between men and women.

Jane Stevenson, vice chair, Board & CEO Services at organisational consulting firm Korn Ferry said while it is good that women CEO's pay rose, there is still a lot to be done.

"I think the danger is to look at those cases of CEOs making more their peers and see a message about the pay gap being closed, it's not," she said.

Of the 340 CEOs in the latest survey of S&P 500 companies, 18 were women, up from 16 in 2020. Profits for S&P 500 companies rose roughly 50% and the index gained about 27%.

Because the bulk of a CEO's compensation is tied to such performance, their pay packages ballooned after years of mostly moderating growth.

Female CEO median pay rose 26.4% in 2021 to \$15.8 million, with 15 of the 18 women CEOs in the survey seeing an increase.

Median means half made more than that level, and half made less. That was a bigger jump than that for male CEO's median pay, which rose 17.7% to \$14.4 million. The overall median pay increased 17.1% to \$14.5 million.

The few women who are CEOs of the largest US companies typically make more money than their male counterparts.

But last year they weren't close to the top of the leaderboard for pay packages.

Last year, the top-earning CEO was Peter Kern of Expedia Group, who received a pay package valued at \$296.2 million.

Lisa Su of Advanced Micro Devices was the highest-paid woman CEO for the third year in a row, but her compensation valued at \$29.5 million ranked just 22nd in the survey.

Su's pay rose 9% from last year.

That was partly due to stock and stock options awards, which totaled \$25.1 million as AMD's stock

Her base salary was about \$1.1 million.

Just behind her was Mary Barra, the CEO of automaker General Motors, whose pay jumped 25% to \$29.1 million, including a base salary of \$2.1 million and stock and stock options awards worth \$18.5 million. Jayshree Ullal, CEO of cloud computing company Arista Networks, saw the biggest jump in salary. Her pay more than doubled to \$16 million, mostly due to stock awards valued at \$15.4 million.

Arista's stock doubled in 2021 on strong demand for its cloud computing products.

The number of racially diverse CEOs is gradually

According to a survey of companies in the S&P 500 and Fortune 500 by executive recruitment firm Crist Kolder, six had Black CEOs in 2021, 40 had Asian American CEOs, and 20 had Latinx/Hispanic ex-

ecutives leading them. The Equilar survey includes only CEOs who have served at least two full fiscal years at their companies, in order to avoid the distortions of big sign-on

The companies must have filed proxy statements between Jan.1 and April 30.

The criteria left out some women named to the top job in the past two years.

Not included are CEOs such as Roz Brewer at Walgreens Boots Alliance, Jane Fraser at Citigroup, Linda Rendle at Clorox, Judith Marks at Otis Worldwide and Reshma Kewalramani at Vertex Pharma-

If the ranks of women CEOs are to grow, there needs to be a better pipeline to promote women leaders,

said Korn Ferry's Stevenson. "Pay tells a story. We have more stories of some women getting ahead," said Stevenson.

"It's great, but it does not a system make. What we do not have is a systemic path forward for women, generally speaking, in a sustainable way, to be on the path to top roles and top pay."

Alison Cook, a professor of management at Utah

State University who researches gender and diversity in the workplace, said there's been a recent push to get more women on boards, rather than in top Csuite roles.

That might help in the long run, she said.

"Hopefully the push into the board of directors translates into more women getting to the C-suite pipeline and available to be CEOs," she said.

The typical compensation package for chief executives who run S&P 500 companies soared 17.1% last year, to a median \$14.5 million, according to data analysed for The Associated Press by Equilar. The gain towers over the 4.4% increase in wages and benefits netted by private-sector workers through 2021, which was the fastest on record going back to 2001.

The raises for many rank-and-file workers also failed to keep up with inflation, which reached 7% at the end of last year.

CEO pay took off as stock prices and profits rebounded sharply as the economy roared out of its brief 2020 recession.

Because much of a CEO's compensation is tied to such performance, their pay packages ballooned after years of mostly moderating growth.

In many of the most eye-popping packages, such as Expedia Group's, valued at \$296.2 million and JPMorgan Chase's \$84.4 million, boards gave particularly big grants of stock or stock options to recently appointed CEOs navigating their companies through the pandemic or to established leaders they wanted to convince to hang around.

The CEOs often can't cash in on such stock or options for years, or possibly ever, unless the company meets performance targets.

But companies still must disclose estimates for how much they're worth.

Only about a quarter of the typical pay package for all S&P 500 CEOs last year came as actual cash they could pocket.

Whatever its composition, the chasm in pay between CEOs and the rank-and-file workers they oversee keeps widening.

At half the companies in this year's pay survey, it would take the worker at the middle of the company's pay scale at least 186 years to make what their CEO did last year.

That's up from 166 a year earlier.

At Walmart, for example, the company said its median associate made \$25,335 in compensation last

That means half its workers made more, and half made less.

That's up 21% from \$20,942 a year earlier and came as the company's average hourly U.S. wage rose from \$15.25 in March 2021 to more than \$17 cur-

That increase was bigger than the raise CEO Doug McMillon got, on a percentage basis.

But his 13.7% raise netted him a total package valued at \$25.7 million.

Anger is growing over such an imbalance.

Surveys suggest Americans across political parties see CEO pay as too high, and some investors are pushing back.

Workers are trying to organize unions across the country, and the "Great Resignation" has emboldened millions to quit to find better jobs elsewhere.

The U.S. government counted more than 4 million quits during April 2021 alone, the first time that hap-

The monthly number has since topped 4.5 million twice. "That is going to add a huge cost to corporate bottom lines, to have these kind of turnover rates," said Sarah Anderson, director of the global economy project at the progressive Institute for Policy Stud-

"They should be thinking about what kind of mes-

sage they're sending to those people, about whether they're really valued in their jobs," Anderson said. "When the guy in the corner office is making several hundred if not thousands of times more, that's

sending a really demoralizing message.' Gains for CEO pay had been slowing in recent years, with the median rise easing from 8.5% in 2017 to 4.1% in 2019.

It ticked back up to 5% in 2020, which was a complicated year because the pandemic shut down the economy and profits at many companies tanked.

For 2020, many companies rejiggered the intricate formulas they created to determine their CEOs' pay. The tweaks made up for losses caused by the pandemic, something many boards said was an extraordinary event outside the CEO's control.

Then came 2021.

Thanks to a reopened economy, super-low interest rates from the Federal Reserve and other factors, stock prices soared and the S&P 500 jumped nearly 27%, setting records through the year.

Earnings per share soared roughly 50%.

Throughout the year, CEOs had to navigate snarled supply chains and shortages of chips and other key materials that impacted businesses across industries, said Dan Laddin, a partner at Compensation Advisory Partners, a consulting firm that works with boards.

"All this led to a desire to really reward" executives, said Kelly Malafis, also a partner at Compensation Advisory Partners, "because the financial performance was there, and the view was that management teams were exceptional in navigating the situation and delivering results.

Last year's 17.1% leap for median pay of S&P 500 CEOs was the biggest since a 23.9% surge for 2010 compensation packages, according to the data analyzed by Equilar.

Consider Marry Barra, CEO of General Motors. Her industry was particularly hard hit by the shortage of computer chips, which snarled auto produc-

Even so, GM's board highlighted how the company still delivered record earnings before interest, taxes and some other items.

The automaker also accelerated development of its electric vehicles. Those are two of the factors that influence Barra's pay, and her compensation climbed 25.4% to \$29.1 million.

22 in the area of Shangi, North Kivu.

UN Under-Secretary-General for Peace Operations Jean-Pierre Lacroix, responding to a question by PTI on the attack on the UN mission and peacekeepers from India and other nations, said the M23 armed group has been active in the last couple of weeks in an area in eastern Congo.

"Indian peacekeepers, together with others coming from many other countries are involved in responding to the group and we appreciate that," he said.

Lacroix said MONUSCO has been playing a 'very proactive role' in countering the offensive of the M23.

"This is in keeping with our vision of a proactive peacekeeping, one that acts decisively to fulfil its mandate, particularly its protection of civilian mandate because the activities of the armed group have major consequences on the civilian population," he said.

Lacroix said the UN is following the situation very closely.

"We're also very much appreciative of the fact that in that particular area of eastern DRC, as well as in another region where the armed group Coopérative pour le développement du Congo (CODECO) is also active, MONUSCO has been "reacting in a way that has been proactive and that has resulted in protecting civilians, saving lives and also pushing back these armed group offensives," he said.

The Security Council stressed the importance of MONUSCO having the necessary capacities to fulfil its mandate and promote, including by taking additional measures as appropriate, the safety and security of the United Nations peacekeepers and its operations, pursuant to relevant Security Council resolutions. The Council members underscored that the primary responsibility for the safety and security of United Nations personnel and assets rests with host States and highlighted the importance of engagements and communications between MONUSCO and the Congolese Government.

The Security Council had also reiterated its strong condemnation of all attacks and provocations against MONUSCO.

Council members underlined that the deliberate attacks targeting peacekeepers may constitute war crimes under international law.

They called on the Congolese authorities to

swiftly investigate such attacks and bring the perpetrators to justice, and keep the relevant troop-contributing country informed of the progress.

The members of the Security Council expressed concern about the increase of armed group activity in the eastern provinces of Congo. They reiterated their condemnation of all

armed groups operating in the country, including the M23, CODECO, the Allied Democratic Forces (ADF), and the Forces démocratiques de libération du Rwanda (FDLR) and several other domestic and foreign armed groups.

They called on all actors to end violence and their violations and abuse of international human rights and international humanitarian law. The members of the Security Council welcomed the commitment of the signatories of the Peace, Security and Cooperation Framework to address the threat posed by all armed groups operating in the eastern Congo.

They called on all armed groups operating in the eastern Congo to participate unconditionally in the political process initiated by the Regional Heads of State Conclave on Congo in Nairobi, Kenya, and on eligible armed groups to lay down their weapons through the Disarmament, Demobilization, Community Recovery and Stabilization Programme (PDDRC-S).

The members of the Security Council expressed concern at the current humanitarian situation in eastern Congo, marked by a significant increase in the number of people in need of protection and humanitarian assistance.

They called on the government in Congo to address the underlying drivers of the current humanitarian situation and on partners to step up their support to the country in tackling these challenges.

The members of the Security Council recognised the efforts of the FARDC, including with the support of MONUSCO, in addressing the threat posed by armed groups in Congo.

They reiterated their full support for the stabilising action of MONUSCO and expressed their deep appreciation for MONUSCO's troop-and police-contributing countries.

Closer to the top of the rankings for CEO pay last year was JPMorgan Chase's Jamie Dimon, whose compensation package valued at \$84.4 million was the fifth-highest in the AP survey.

That was up 166.7% from a year earlier, and most of it came from an award of stock options valued at \$52.6 million. The board said it provided the options because of

its desire for Dimon, who is 66, to keep leading the company for significantly more years and a "unique inflection point in Mr. Dimon's tenure."

It also said the options weren't a part of his regular annual compensation and that he must wait at least five years to begin exercising them.

Even so, only 31% of investors at JPMorgan Chase's annual meeting of shareholders recently gave a thumbs up on Dimon's pay package.

The vote is only advisory, though, and doesn't force the company to make changes.

Last year, a median of 92.6% of shareholders approved what's called their "Say On Pay" vote in the AP's survey. That was down just a bit from 93.4% the year before.

The AP's and Equilar's compensation study included pay data for 340 CEOs at S&P 500 companies who have served at least two fiscal years at their companies, which filed proxy statements between Jan.1 and April 30.

Some high-profile CEOs are not included because they don't fit the criteria, such as Amazon's Andy Jassy and Twitter's Parag Agrawal.

The survey does not count changes in the value of CEOs' pension benefits and some other items in its totals for compensation

The order also said that legal action will be initiated against dealers or any other person found to be selling and supplying HSRPs in the state without being authorized by vehicle manufacturers.

As per the guidelines issued by the TC, HSRP would be affixed by the vehicle manufacturers (OEMs) and their authorized dealers only. Only the HSRP vendor authorized by the vehicle manufacturers (OEMs) shall supply the HSRPs only to their authorized dealers.

The vehicle owner will have to book for fitment of HSRP and make payment for the purpose through an online portal authorized by the OEM to maintain the transparency and to prevent excess charging from the vehicle owners.

The portal authorized by the OEMs will offer the facility to the vehicle owner for selection of any dealer, location and date for affixing of HSRP as per his convenience, it said.

The portal authorized by the OEM will have the capability to inform the vehicle owner status of the order placed for fitment of HSRP through SMS.

The OEMs or its authorized dealers shall display a board at a conspicuous place at their showroom indicating charges to be paid by the vehicle owner for affixation of HSRP and also on the HSRP portal to maintain transparency at all times.

The OEMs or its authorized vendor/dealer may offer the services to the vehicle owners for fitment of the HSRP where the owner resides or has his place of business on payment of extra charges subject to willingness of the vehicle owner. The authorized dealers after affixing the HSRP on the vehicle shall ensure that the laser code is updated in VAHAN por-

"The vehicle not having valid registration certificate and fitness certificate (for transport vehicle) and the vehicles having arrear tax due shall not be allowed to affix HSRP by OEMs or its authorised dealers," it said. The dealers will customize their portal accordingly.

All Regional Transport Officers (RTOs) have been instructed to comply with the order to ensure that HSRP are fitted on all motor vehicles registered prior to April 1, 2019 in a seamless manner.

The commissioner has directed the RTOs to convene meetings with the all dealers functioning under their jurisdiction to sensitize them about the modalities for fitment of HSRP on old vehicles within the scheduled date.


How Abramovich was forced to sell Chelsea in fall from grace

LONDON: Standing by the bar in a small Stamford Bridge hospitality suite was a figure who had had not been spotted at the stadium in three years: Roman Abramovich.

Last November, the Chelsea owner was back in London at his English Premier League club to host the president of Israel. There was no obvious security entourage around the Russian billionaire and little fuss, just close associate and Chelsea director Eugene Tenenbaum.

After making small talk with guests and posing for photos with President Isaac Herzog in front of the pitch, the party moved onto an afternoon tea event for around 50 people, with scones and cucumber sandwiches.

Abramovich was feted with speeches praising his work through Chelsea to campaign against antisemitism. It looked like the gradual reintroduction of Abramovich into



he preached, even as Putin framed the war as one of denazification, falsely called the Ukrainian leadership "Nazis" despite President Volodymyr Zelenskyy being Jewish, and areas were reduced to rubble by Russian bombing and shelling. Yad Vashem suspended its partnership Abramovich, as did the Imperial War Museum in London, where he funded a Holocaust exhibition and which hosted an event for him hours after the start of Russia's war on Ukraine.

It was only six days into the invasion when Swiss billionaire Hansjorg Wyss leaked that Abramovich was actually trying to quickly dispose of Chelsea and the club was publicly put up for sale.

> immediate hopes of returning to London were ended by the government. Sanctions and travel restrictions

placed on Abramovich, his assets were frozen, and Chelsea was allowed to operate only under the terms of a government-issued license until the end of May.

New match tickets couldn't be sold by Chelsea. Players couldn't be handed new contracts. Even merchandise stores had to close.

The job of finding a buyer for Chelsea was placed with the New York-based Raine Group merchant bank. An array of prospective investors went public, some seemingly more viable owners than others, before the bank produced a shortlist of four bidders in early April.

The sale ended where it began with Wyss. The Raine Group -- working with Abramovich's associates on the board leading Chelsea — eventually selected the group featuring Wyss and fronted by Boehly, part-owner of the Los Angeles Dodgers, with investment from Clearlake Capital.

The sale price was 2.5 billion pounds (\$3.2 billion), the most ever for a team in world sports, with the proceeds having to go to a foundation supporting Ukrainian victims of the war. Boehly also had to pledge to invest 1.75 billion pounds (\$2.2 billion) in the coming years in the teams and infra-

The final stage of the process encapsulated how laced in politics the process was with approval needed from the British and European authorities that sanctioned Abramovich, ensuring he would not profit from the sale.

It was an unceremonious end to his 19 years as owner.

After buying Chelsea for 140 million pounds in 2003, Abramovich ended up with nothing. Not even a return of the 1.6 billion pounds of loans he had to write off to allow the club to be sold and continue play-

It was never about money for Abramovich, though. More about status and winning trophies.

"In hindsight, especially with the public profile it would bring me, maybe I would have thought differently about owning a club," Abramovich was quoted as telling Forbes a year before losing control of Chelsea. "But, at the time, I just saw this incredible game, and that I wanted to be a part of that in one way or another."

No more, in England at least. Ultimately, though, the association with Putin that Abramovich spent so long trying to distance himself from cost him the ability to retain the ownership of Chelsea.

a more high-profile role around Chelsea again, attached to his social activism. There was, maybe, a British visa to be regained after he withdrew his application for

a renewal in 2018. Then everything rapidly changed from Feb. 24 when Russia invaded Ukraine.

Three months later, Abramovich is being replaced as Chelsea owner by a group fronted by American investor Todd Boehly, a prospect unimaginable when the oligarch was on the field in Abu Dhabi on Feb. 9 lifting the FIFA Club World Cup.

It would turn out to be the 21st and last men's team trophy in 19 years running the team his wealth transformed from being glamorous but only occasionally competing for the biggest trophies, into one of the most successful in European football.

Abramovich tried to cling onto Chelsea, even as anger over Russia's unprovoked aggression toward its neighbor intensified, backed not just by loyal fans but club greats including John Terry hailing him as "the best."

Within hours of the war beginning, Abramovich was accused in the House of Commons of having links to corrupt activity and paying for political influence in Russia. The demands grew for Abramovich to be sanctioned by the British government, which had already thwarted his efforts to regain the visa in recent years, according to a legislator.

Sensing the need to act, Abramovich offered cosmetic changes to the ownership on Feb. 26 with the pledge to relinquish "stewardship and care" of the club to its charitable foundation trustees.

They had not signed off on the plan, though, and the vague proposal did not quell the anger that a man accused of being so closely linked to Russian President Vladimir Putin could retain the ownership of a high-profile status symbol in the heart of London.

Another public play to shield his reputation from Putin's war came on Feb. 28 when Abramovich's PR pushed an apparent move for him to broker peace. Abramovich did not condemn the war, and he has yet to do so despite talking about the need to publicly condemn atrocities only two days before the invasion. The rare comments came in a statement launching a new partnership backing the Jerusalembased Holocaust museum.

"Yad Vashem's work in preserving the
