PM Narendra Modi and France President Emmanuel Macron to discuss host of key issues

NEW DELHI(KCN) : In their talks on Wednesday, Prime Minister Narendra Modi and French President Emmanuel Macron are likely to discuss mitigating the global economic consequences of the Ukraine conflict as well as ways to ensure cessation of hostilities in that country, diplomatic sources said. Modi, currently on a visit to Denmark, will have a brief stopover in Paris on his return journey where he will hold extensive talks with President Macron, who was re-elected to the top post over a week back.

The sources said discussions will also focus how France can continue to be India's "partner of choice" in its quest for becoming self-reliant in the field of defence manufacturing.

The talks will also explore ways to boost cooperation in areas of technology, space and energy, they said. The two leaders will discuss how to ensure cessation of hostilities in Ukraine and mitigate the global economic consequences of this conflict, the sources said.

They said another focus area of the talks would be to unitedly deal with the challenges in the Indo-Pacific. Modi and Macron are expected to explore ways to speeding up "positive agenda of solutions" in the region, the sources said.





The trailer of Indrajit Lankesh's Hindi language "Shakeela" doesn't hold much to impress. From using modern-

cliched film sets, it feels like a repackaging of Vidya Balan's film 'Dirty Picture' except that this version fails to bring the charm Vidya brought to the day Hindi music to screen.

The film, as described by the filmmakers of 'Shakeela', is "inspired by life events of a famous star Shakeela who predominantly starred in southern

cinema. It features Richa Chadha as the titular adult actor who was one of the biggest stars of the 1990s arriving from Kerala who went on to act in

several adult films in languages spanning Tamil, Telugu, Malayalam and Kannada, while Pankaj Tripathi is the male lead. The film is described to "portray the hardships of the actress as she had to face a lot of criticism, insults and betrayals from her own family members and the film fraternity who were influential in getting her films banned." The main reason for the success of

'Kinnarathumbikal', one of the films that catapulted her into the limelight, was solely her screen presence and energy, and with no other male lead in the movie.

The BJP is blamed

for its communal

Congress is desperate to become atmanirbhar

It is no secret for anybody with little sense of politics to understand that the Congress party is in deep trouble, slipping through the



slippery slopes of prospects in a country that it ruled for more than five decades. Compelled to go beyond its 'high command' culture,

many leaders in the party began to feel suffocated under a family which perhaps lost credibility. Modi's entry into national politics has almost toppled the hopes of survival of many in the grand old party, forcing them to turn a mirror on its own unquestionable high command. The G-23 grouping has not only been an accumulation of the downhearted old-timers but it sensibly wanted to lift the capsizing party from a total disappearance. The Prashant Kishor Plan, as what at least some in the party inner circle feel, is expected to work as a redemption formula that the party formally, though hesitant, would like to hold on as the last reed of hope. Why is the Congress hesitant to pull the chain for the strategist is because it has a natural tendency to comfortably snuggle into the memories of its past glory and the impact of the unquestionable influence of the Gandhi family on it - the impetus that the party cherished for ages with great pride, servitude and ecstatic satisfaction. The Kishor Magic that many leaders across party lines think, would work wonders, if given a chance. The beneficiaries of the celebrated political strategist of India, agree to what they call an invincible magic wand, that Prashant Kishor could swing for the Congress too, if not giving it a complete success suddenly, but capable to lift the ailing party

from its thickening insignificance.

Every such move of

revival made by the Congress should be presumably in the interest of the BJP too. For the saffron party, the emergence of local forces in different parts of the country may not always give goosebumps of delight and a silent giggle of satisfaction. No leader to the stature of a national eminence and ability to pull a crowd is visible in the party. Its complete dependence on the dynasty sidelined everybody, throwing it to the stage of severe political irreverence in the present political context. The way out is of course a revamp and the party leadership's gesture in this regard is indicative of the urgency.

This must be the reason that the dynasty is still perplexed and hesitant to do the course correction. The Congress party needs to know its traditional voters who, for generations, voted for the party unwavering on any political storm that could sweep seats to power giving it defeats multiple times. Disappointing the grassroot cadre and its voters for long would be more hazardous. The present context is that the party is insecure to strengthen the base, the grassroots, as the leadership itself is clueless on what the party would look like as a system minus the Gandhis. loans are also waived. In addition, cash assistance is given through "PM KissanSammanNidhi" scheme. In FY-2020, under MSP, Government had procured23 eligible crops barely 26 per cent by value. This might be below 15% of all crops. Despite this, unsold stock with FCI is about 32.0 million tons and 24.0 million tons with States. Debt of FCI has also exceeded Rs. 4.0 lakh crores incurring huge interest and storage cost. Hence, it is financially not feasible for Government to purchase entire food grain at MSP except for the PDS scheme, as being done now.

Despite all such assistance, there is perennial distress among farmers causing suicides and agitations. The key impediments are "low sale price of food grain" at farm gate due to surplus production and the exports are not so competitive every time except few years. Unlike industrial product, the production cycle of food grain is too long. But poor farmers don't have financial resources and storage capacity and wait for remunerative prices. Majority of food grains are sold at distress price which is much lower than MSP. Hence, farmers are demanding that; entire produce is sold at guaranteed MSP. Their demand is genuine. Private trade channel shall not purchase at MSP during crop arrival season. They have to store the stock and incur cost of storage and interest. Considering past market trend and surplus production don't ensure profit unless; the exports are liberally permitted. More so, the exports are not so competitive unless; the export incentives are available. The cost of logistics, capital, energy and other basic inputs in India are too high

private channel. For this, FCI has to play a vital role and Government should incur capital expenditures in building storage and logistics infrastructures for FCI from budgetary resources without burdening FCI for the repayment of capital cost. More so, Government should extend export incentives to FCI and private channel including processing industries. Fiscal burden due to export incentives shall be

gradually compensated by cutting down the farm input subsidy which, in fact, is not retained with farmers but passed on to consumers.

FCI must assist farmers for selling food grains through auction to private channels under its supervision. The floor price must be kept about 93-95 per cent of MSP. FCI should fix quality standards and provide testing facility to avoid any arbitrary deduction by purchaser on the quality ground. Unsold stocks must be essentially stored by FCI and the cheap loan may be extended to farmer up to 90 per cent of stock value at MSP price. Same can be refinanced by Banks to FCI at SLR rate. In absence of such stocking facility, the farmer is compelled to sell its produce at distress price to trade channel. This is the key recommenquality and loan amount. The validity period of such GR may be 5-6 months. GR must be tradable in the open market, e-



NAM and Commodity exchange. FCI must assist and charge nominal fee of 0.5 per cent of sale value. Interest and storage charges may be levied @ 9.0 per cent per annum on the stock value. That may be recovered from the ultimate buyer during delivery of goods. Balance money may be remitted to farmers. This will eliminate interest and storage cost of FCI.

Generally, the price of food grain increase still the next crop arrives. Thus, farmers shall get better price after availing storage facility, as normally done by trade channel. With prior consent of farmers, FCI may also purchase stock at MSP as per the needs of PDS scheme. By this, FCI shall not need separate buffer stock, as being done now. Thus, the debt burden on FCI shall substantially reduce.

ing debt, interest and storage charges. With above arrangements, the farmers might get about 95 per cent of MSP. Hence, in due course, MSP may be increased by 5-7 per cent. After stabilizing the system, there are fair chances for farmers getting higher price. FCI shall also be benefited since; its debt burden and storage cost shall reduce. Rather, it might earn gross profit in future years from service fee and storage charges. However, FCI should increase storage capacity and build marketing infrastructures. More so, it must disseminate market information to farmers.

In this process, the stock with FCI might increase due to excess production or poor market demand. In such situation, FCI must quickly export directly or through trade channels. Government must encourage export and be liberal in giving export incentives to compensate the loss of FCI and trade channel and processing industries. By this, the debt of FCI shall reduce and the storage capacity shall be available for fresh arrival of crop. More so, trade channel shall also be motivated to participate.

Simultaneously, India must promote food grain processing industries and trade channel near to FCI godown and share the logistic infrastructure for exports and onward marketing. A team spirit between FCI, Government, Processing Industries, Traders, Exporters and Farmers will certainly deliver desired outcome. States should also join this team. Farmers may be also pursued for crop diversion; that will reduce Agro-imports and enhance farmer's income. A composite plan will certainly resolve crisis and fetch rural prosperity and reduce urban migration.

Swabhiman Anchal: Once a Maoist citadel in Odisha, now a proud example of transformation

Cut-off area of Malkangiri district, now known as 'Swabhiman Anchal', was formed as a consequence of construction of two major reservoirs at Machhkund in 1960s and Balimela in 1980s. The reservoirs created a 60 km-long water channel that surrounded the 150-odd villages from three sides and left the inhabitants of the area with no access to the mainland.

Situated at the tri-junction of Odisha, Andhra Pradesh and Chhattisgarh with extremely inhospitable terrains, the area had practically no access for government officials also, and, thus, became truly cut-off. The region comprising 9 Gram Panchayats, is mostly inhabited by the Didayis, a Primitive Tribal Group. Because of its inaccessibility for security forces also, this area had become a bastion of CPI (Maoist). Difficult topography made matters more severe.

The Odisha Government realised that the Maoist

Since the entire area was physically separated from the mainland for decades; and there was no socio-economic development of the zone, disenchantment amongst the populace with the government was palpable. Over the years, the physical isolation and its strategic location being sandwiched between Andhra Pradesh and Chhattisgarh and also due to its difficult terrain and numerous water bodies and creeks, Naxals held sway in the area. If we look back, we can see that Malkangiri district was one of the worst affected districts in the State and Swabhiman Anchal had been the hotbed of Maoist violence. Since the turn of the century and till the inauguration of Gurupriya Setu, this district had seen almost 500 instances of Maoist violence with a little less than 100 security personnel getting killed. This spiral of violence coupled with inaccessibility had taken the 35,000-odd people of the area off the map of the State.

Sri Lanka government to provide cash to low-income families hit by economic crisis

COLOMBO: The Sri Lankan government on sistance to help meet payment requirements Tuesday announced that it will provide cash allowances ranging between Rs 3,000 and Rs

7,500 to low income families "severely affected" by the current economic crisis in the country.

The decision was taken in a Cabinet meeting held on Monday. World Bank assistance would be used for the purpose, trade minister Shehan Semasinghe said. Some 33 lakh families have been identified which will receive the money from May to July, he said.

"Low income families entitled to samurdhi (poor relief), elderly, kidney and disability allowances have been

severely affected by the current economic crisis in the country. The government has identified the need for immediate relief to these families and those others on the waiting list," Semasinghe said in a statement.

As per the statement, amounts ranging between Rs 3,000 to Rs 7,500 under various categories like elders' allowances, kidney patients allowances and disability allowances will be disbursed to low income families.

The world bank is facilitating financial and technical assistance to Sri Lanka. The cash transfer will be done only through bank accounts. Any eligible person who doesn't have an account will be informed to open one immediately by government officials concerned, the minister said in a tweet.

Quoting Central Bank Governor (CBSL) Nandalal Weerasinghe, the Daily News online portal in a report published last week said that the World Bank has agreed to provide Sri Lanka with USD 600 million in financial asfor essential imports.

Sri Lanka will offer over USD 300 million

ports of staple foods and fuel, leading to acute shortages and very high prices.

Months of lengthy blackouts and acute short-



out of the USD 600 million due from the World Bank to provide direct financial assistance for low-income families, Weerasinghe was quoted as saying in the report.

Meanwhile, Prime Minister Mahinda Rajapaksa's office has announced that China will grant 300 million Yuan to Sri Lanka to purchase medicine, food, fuel and other essentials.

The move comes after Rajapaksa's telephonic conversation with Chinese premier Li Keqiang earlier last month. Debt-ridden Sri Lanka's overall inflation surged to nearly 30 per cent in April from 18.7 per cent recorded in March, according to the official figures, as the island nation grapples with its worst economic crisis in decades.

Sri Lanka is in the grip of an unprecedented economic turmoil since its independence from Britain in 1948. The crisis is caused in part by a lack of foreign currency, which has meant that the country cannot afford to pay for im-

ages of food, fuel and pharmaceuticals have triggered widespread protests calling for the government's resignation.

According to the data published by the government's Census and Statistics Office, the overall inflation hit 29.8 per cent in April from 18.7 per cent recorded in March. The food inflation increased from 30.21 per cent in March to 46.6 per cent in April. Most food items have recorded price increases.

Sri Lanka needs at least USD 4 billion to tide over its mounting economic woes, and talks with international institutions such as the World Bank as well as countries like China and Japan for financial assistance have been going on.

India has agreed to extend an additional USD 500 million credit line to help Sri Lanka import fuel. India has already agreed to defer USD 1.5 billion in import payments that Sri Lanka needs to make to the Asian Clearing Union.

The BJP leaders said though the MLA lodged an FIR against the BDO first but no action was taken against him so far.

However, Mr.Panigrahi was arrested by the Deogarh Police on May 1 last from his official residence in Bhubaneswar on the basis of the FIR lodged by the BDO which is "unlawful, illegal and unconstitutional in the eye of the law" they said and requested the Governor to intervene in the matter.

Though several incidents of attack on BJP legislators have been reported in the recent past, no action has been taken against the culprits. However, Mr.Panigrahi, who had not assaulted the BDO, had been arrested without proper investigation, alleged the BJP lawmaker. He demanded arrest of the BDO for violating Book Circular 47 (a circular issued by Odisha government on observance of relationship between MP/MLAs and government servants). In the memorandum, the BJP leaders said, "Book Circular 47 is not being implemented in the field and the officers are very carelessly dealing with the MPs and state legislatures. It is seen that some officers are daring to ignore the Book circular- 47 at large for which MPs and MLAs are feeling humiliated."

They requested the Governor to instruct the State Government to direct all the public servants to follow the Book Circular- 47 leaf and bound for a conducive and congenial atmosphere between public servants and MPs / MLAs.

Rs 3644 crore will be spent on these four schemes.

At the event, Nirmal Nayak, a farmer from Kalahandi district, Baid Nayak from Balasore and Menaka Bhoi, a farmer from Sundargarh district, shared their experiences on how their farming activities have improved due to the major KALIA scheme.
