





The Reserve Bank of India (RBI)'s monetary policy committee (MPC) took the financial market by surprise



vesterday. A little over three weeks after the sixmember MPC voted unanimously to hold the policy repo rate at 4%, they changed course and increased it to

4.4% in an off-cycle meeting.

It's the first increase in repo rate since August 2018. RBI will separately increase the cash reserve ratio maintained by banks by half a percentage point to 4.5%. This is expected to suck out Rs 87,000 crore of liquidity. Monetary tightening is well underway now.

MPC was expected to nudge up interest rates later this year. The question therefore is, what triggered an unscheduled meeting to advance this? The answer is a combination of elevated inflation and the uncertainty around inflation's trajectory.

A volatile geopolitical situation has fuelled a surge in prices of many commodities. The pain has already shown up in India – retail inflation in March was 6.95%, led mainly by a jump in food prices. This surge in inflation has come at a time when even if aggregate demand is back at pre-pandemic levels, it's not yet robust. The abrupt turn in

monetary policy, therefore, was catalysed by a further apprehension.

The surge in fuel and food prices has come at a time when the price level of other items of consumption (core inflation) has remained high at around 6% for a year. MPC appears to fear the potential second-round impact of high commodity and food prices which occurs when firms raise sales prices and employees seek higher salaries to adjust to changing circumstances.

The Wholesale Price Index, or WPI, stood at 14.55% in March 2022 compared with 13.11% in February, according to data released by the Ministry of Commerce and Industry. The high rate of inflation in March, 2022 is primarily due to rise in prices of crude petroleum and natural gas, mineral oils, basic metals, etc owing to disruption in global supply chain caused by Russia-Ukraine conflict.

Beginning April 2021, the WPI inflation has remained in double-digit zone for twelve consecutive months. While inflation has seen an increase in the last couple of months with a rise of 1.59%, the food and commodity prices continue to harden. Additionally, the food Index increased from 8.47 percent in February 2022 to 8.71 percent in March 2022 due to the increase in the cost of cooking oil that touched a new peak.

However, the reason for the high rate of inflation is primarily believed due to the

The margins of companies across sectors may further face headwinds for at least next 2 quarters, owing to the Russia-Ukraine war as it continues to affect commodity and food prices, fresh set of restrictions if implemented due to the rising COVID cases can again be troublesome for the economy.

Therefore, the primary aim of an increase in repo rate at this juncture is to head off the second-round effects and preserve macro-financial stability. As yesterday's changes work their way through the economy's full spectrum of interest rates, borrowing costs on personal and home loans will rise. For savers in fixed income instruments, rates are set to increase.

The key takeaway from the announcement is the return of inflation as an important macroeconomic challenge. This will force RBI to prioritise fighting inflation over stimulating economic growth. It does shift the onus onto both GoI and states to adjust fiscal policy to adapt to the emerging situation.

For a start, taxes on pump prices of petrol and diesel need to be lowered to ease price pressure. Separately, agricultural policies need adjustments to ensure that food prices do not rise too high. The right fiscal policy will insulate the economy from a demand shock at this critical juncture.

RBI makes it clear inflation is now the big challenge, governments need to gear up to fight it.

The respect India at present is gaining is due to both the spiritual and political patronage that it was capable of for years. Spiritual it is, because we, as a country could deliver spiritual solace to a large number of global seekers with our inclusive ideals. Politically we are equally influential across the globe as a peace-loving nation that advocates for universal peaceful coexistence and brotherhood. Indeed, the aspects of influence that India is known for today, give it a special stature of recognition among countries of diverse interests and geopolitical aspirations. My sonal and many, for that matter, must have experienced the same

I thought to quote this at the backdrop of multiple disturbing clashes that began to rattle the country recently and India, with its global aspirations to emerge as a power, seems to be portrayed as standoffish and irresponsible when it comes to its ability to maintain equanimity as the diversity presses its nerves so hard. Agencies, foreign to the idea of India's cultural heritage are seemingly out to project the country as the most intolerant and a hostile destination devoid of peaceful coexistence. The western world always had a disparaging mindset on everything that politically India represented. The latest stroke has been from the United States Commission on International Religious Freedom (USCIRF). It made a comment on what it feels and identifies, that India according to the agency, is a tumultuous land with the minorities being strong-armed from practicing their religious faiths peacefully either by the state or by its religious majority. It also recommends India be identified as a Country of Particular Concern (CPC) which it probably tags with those countries where religious freedom is frequently offended. The USCIRF identifies Russia, China, North Korea, Saudi Arabia, Iran and Pakistan as the world's worst offenders of religious freedom. The spiritual values that India stood for ages never questioned the need of being in contradiction with other faiths. It always upheld the view of assimi-

lation and never did animosity come its way

that India offers to the world, uncondition-

terms because the basic tenets of India's spiritual wellbeing are based on diverse and pluralistic social engineering that it, from the ages of the sages, propagated with clarity and humility. Despite the belittling of the idea that India represents from different global platforms and some deliberate attempts from India too; there seems to be a spiritual essence emanating from the core of Indianness that keeps strengthening the country inexorably. Agencies, headquartered in America and elsewhere have been vigilant to mischaracterize the diversity that we have been successfully nourishing for long. Choosing to criticize a country based on intentionally selected issues that randomly lead to local skirmishes with a minority community at the receiving end; their intention surfaces with their studied silence on India when the majority community is persecuted by certain radicalized doctrines. This itself is evident from the fact that the main minority community has been flourishing in India while the country is blamed and debated worldwide by agencies and pseudo intellectuals painting its majority as an acrimonious sum. Pakistan and Bangladesh give us a gruesome picture of the minorities in those countries. They are being targeted, persecuted and forcefully converted and killed with their religious places desecrated and

destroyed and their population dwindling rapidly every passing day. The tendency that we are comfortable with, is to call the hostility in our neighborhood as a usual affair to the radicalized Islamic states. India is the country where the planet's largest human gathering takes place in the name of religion which indeed is the largest peaceful human gathering. The Kumbh mela is a perfect example of India's cultural heritage being displayed in its spiritual splendor seeking peace and prosperity for the entire humanity. Politically, India's independent stand on the Russia-Ukraine war was not disputed by the world. We could successfully convince the world the stand that we thought was right, without being judgmental and duplicitous on the pressure that the west and America put on us. This is emblematic to the sphere into which India has globally positioned itself as a responsible country. The binary that India is, in a largely polarized world is both, its spiritual and political might that it could successfully showcase in the last few decades gaining reverence. We are not to forget, the petty squabbles that we have been witnessing today and the international community took notice of, are the results of the suspicion that has gone deeper into the social psyche due to the centuries of conquests and political subjugations and misrepresentation of history. Compensate or pay fine: DGCA tells airlines wrongly denying boarding to passengers

NEW DELHI: Airlines are indulging in "unfair practice" of denying boarding to passengers even when they report for

The DGCA's email said, "It has come to the notice of this office that various airlines are denying

to comply with the 2010 regulation at the earliest opportunity available, preferably at the airport, if the passenger has re-

However, in the absence of enough volunteers, the airline can evade giving any compensation if the affected passenger -who has been denied boarding as the origiflight overbooked -- is given a ticket on a alternative flight that is departing within one hour of the original flight's departure.

The airline has to give an amount equal to 200 per cent of basic fare plus fuel charge in case the alternate flight is scheduled to depart within 24 hours of the original flight's departure.

The airline has to give an amount equal to 400 per cent of the basic fare plus fuel charge in case the alternate flight is scheduled to depart more than 24 hours after the original flight's departure, as per the regulation. In case the affected passenger does not opt for alternate

flight, refund of full value of ticket and compensation, equal to 400 per cent of basic fare plus fuel charge, has to be given, the regulation



Maoist citadel in Odisha, now a proud example of transformation

that the Maoist citadel could be

transformed into a well-administered area, not only by providing security, but through state intervention targeting the basic causes of discontent, disaffection, and maybe, despondency as

The Government also felt that the Maoists could hold sway over the area as the same had manifested in a social malaise which was no governance at all, thereby, no socio-economic development for several decades. As a matter of fact, the local population did not have any idea that there existed a government for the welfare of the people. This only got compounded as the Maoists took advantage of this with impunity and kept instigating the populace against the administration. Therefore, the State Government's vision revolved around making the local population have a feel of the government for their welfare and upliftment.

The first and the foremost task for the State Government undertook was to create access to the area which could only be approached through the water bodies by means of a steamer. Watershed moment

The Government expedited construction of Gurupriya Setu under heavy security. Then came the watershed moment in 2018 when Chief Minister Naveen Patnaik inaugurated the bridge and connected Swabhiman Anchal to the mainland. This bridge allowed security forces to get inside and plug the security vacuum that existed for decades. To bring about development and for any effective counter-insurgency strategy, it was imperative that first the area be cleared of Maoists and then some semblance of stability is brought with establishment of security camps to put in a system in place for development to be taken forward.

However, construction of Gurupriya Setu and connecting the cut-off area with the mainland was not enough. Since the entire area was physically separated from the mainland for decades; and there was no socio-economic development of the zone, disenchantment amongst the populace with the government was palpable. Over the years, the physical isolation and its strategic location being sandwiched between Andhra Pradesh and Chhattisgarh and also due to its difficult terrain and numerous water bodies and creeks, Naxals held sway in the area. They would inflict heavy casualties on the security forces whenever they ventured into the area and then disappear into obscurity. This is the reason why the entire top brass of Andhra Odisha Border Special Zonal Committee (AOBSZC) had made this their headquarters for a very long time. If we look back, we can see that Malkangiri district was one of the worst affected districts in the State and Swabhiman Anchal had been the hotbed of Maoist violence. Since the turn of the century and till the inauguration of Gurupriya Setu, this district had seen almost 500 instances of Maoist violence with a little less than 100 security personnel getting killed. This spiral of violence coupled with inaccessibility had taken the 35,000-odd people of the area off the map of the State.

Killing of 37 security personnel in 2008 and many other attacks on security forces were demoralizing for the administration. Even R Vineel Krishna, the then Collector of Malkangiri, was abducted while he was on way to attend a Janasampark Sivira in the cut-off area. Due to this security vacuum and perpetual threat of the Maoists, the inhabitants had no other option but to abide by the diktats of the Left Wing ultras. The hapless people had been caught in a vicious cycle here, where the causes and consequences fed on one another and together contributed towards denial of justice, security and life with dignity to the people. Prakash Singh and Ajit Doval, both illustrious police officers, in a paper wrote that the affected people do not have any ideological understanding or commitment to LWE but join the movement because of alienation, anger, fear or greed as was palpable here. In this backdrop, the Odisha Government realised that use of force could not be a panacea but providing basic services, like health, education, drinking water, roads etc., should be the primary objective. Naxalite ideology may be flawed but they had successfully struck a sympathetic chord with the people and convinced them that the administration was incapable of addressing their problems. Thus, mobilising the people against the depredations of the Naxals had to be an essential component of government strategy. As one can appreciate from the Punjab experience, once people are alienated and turn against the terrorists, the tide turns. The State Government, therefore, focused on addressing the deficient development and the unaddressed grievances of the people along with plugging the security vacuum.

It was also very careful to avoid any collateral damage through intensive security operations. With access to the area provided by Gurupriya Setu, things were not the same. The Government took it upon itself to provide for rapid development and bring about transformation in the area. Through its SETU (Socio Economic Transformation and Upliftment) Scheme, it provided electricity, drinking water, health services and schools in the area. A special package for the area was also announced. Ushering in socio-economic development was the motto.

Operation Swabhiman

Odisha Police on its part, in the month of January 2020, along with BSF, CRPF, COBRA personnel and also Andhra Police launched an ambitious operation, Operation Swabhiman, in the area. More than 1000 police personnel were deployed and an attempt was made to provide security at every nook and corner.

This week-long operation was primarily to focus on giving a sense of security to the local population. During this operation, however, many development works like construction of roads, ghat cutting between Jantapayi and Jodambo via the hills of Hantalguda, digging of bore wells etc., were taken up. It turned the tide and people got alienated against the Naxals. This had very positive and lasting impact on the populace to the extent that when Maoists came to Janturai and Jodambo villages to threaten the locals as to why they were supporting construction of road, the women folk took on the might of Maoists and pelted stones at them, forcing them to beat a hasty retreat.

In the melee that ensued, one Naxal lost his life and another was apprehended. This was the required spark and impetus which helped the Government make massive inroads and undertake developmental interventions in the area. As on date, not only has the Government provided security to all the 9 Gram Panchayats but also constructed roads, provided drinking water and health services, and introduced public transport in the form of Jana Seva Buses. Before this, in many parts, the only mode of transport was on the back of horses and mules. Now with the construction of roads, people can travel to their homes in their own vehicles or public transport. Livelihood intervention

The distance that could be covered in a day now can be undertaken in a couple of hours. Health centers have been opened and medical services are being provided at the doorstep after the introduction of ambulances. BSF now has put in place an ambulance in the reservoir as well.

At the same time, it was also important to wean people away from cultivation of cannabis which was a major source of livelihood. Through various schemes of the Government, people have been introduced to cultivation of turmeric and drumstick which is equally profitable. Few crores of fingerlings have been dropped into the reservoir for regenerating fishing. These steps have provided effective livelihood to the local inhabitants. Taking people away from cannabis cultivation has also hit the Maoists as they are unable to extort money from the villagers.

It is significant to mention here that the State Government did not have a myopic view of winning the area on the basis of force alone but by addressing issues like livelihood, drinking water, health and also educational requirements. At least 7,500 mobile phones were distributed in the area to the people to help them meet their educational and other requirements online during the lockdown period of COVID pandemic. With these interventions, development has reached the remotest corners of the area. The strategy of the Odisha Government in winning people's trust in a region that had a long history of neglect and injustice through rapid socio-economic development has paid dividends.

This is also buttressed by the fact that during the recently concluded 3-tier Gram Panchayat elections, voters of the area that had been the hot bed of the Naxals came out in huge numbers and participated in the electoral process. Swabhiman Anchal reported more than 77 per cent polling. This can also be viewed as a vote of confidence for the developmental initiatives of the Government. The region that was once considered a liberated zone for the Maoists, now, in true sense had become 'Swabhiman Anchal'. What has worked for the Government is that people participated in the development process to bring about tangible change in the area. The topography of the area that was once punctuated by landmine all over now is experiencing construction activities and deliverance of basic services. There is vibrancy in the air.

Swabhiman Anchal, through this transformation, can become the template, the model, for the rest of the country on how to redevelop a Maoist citadel.

L&T Infotech and Mindtree merge to become India's fifth largest IT services provider

BENGALURU: Larsen & Toubro (L&T) on Friday announced the merger between its IT services business units L&T Infotech (LTI) and mid-cap IT company Mindtree. The merged entity, which will be called LTI Mindtree, has now become the fifth largest IT services provider after TCS, Infosys, HCL and Wipro in terms of market capitalisation, as it stands at Rs 1.68 lakh crore.

Shareholders Mindtree will be issued shares of LTI at the ratio of 73 shares of LTI for every 100 shares of Mindtree.

LTI Chairman A M

Naik said, "This merger represents our continued commitment to grow the IT services business in line with our strategic vision. The highly complementary businesses of LTI and Mindtree will make this integration a 'win-win' proposition for our customers, investors, shareholders and employees."

L&T took over Mindtree in 2019 and owns 61% of the IT company. L&T owns about 74% stake in L&T Infotech. When L&T took over Mindtree, it was said that the latter will be run as a separate entity, distinct from LTI

Pharma dept suggests allocation of funds by institutes to promote startups

NEW DELHI: The Department of Pharmaceuticals has recommended the allocation of a fixed percentage of not less than 1 per cent of annual budget of institutes to fund and promote innovation and startup-related activities in the sector. In its common guidelines on pharmaceutical innovation and entrepreneurship for academic institutions, the Department of Pharmaceuticals (DoP) also said that institutes might take a fixed percentage of (2 per cent to 9.5 per cent) equity in startup/spin-off companies in return for the services and facilities they provide. In order to encourage innovation and research and to facilitate entrepreneurship in NIPERs (National Institutes of Pharmaceutical Education and Research), the DoP has prepared the 'common guidelines on pharmaceutical innovation and entrepreneurship' for academic institutions under its control, an official statement said. The guidelines have been prepared after considering the National Innovation & Startup Policy 2019, National IPR Policy 2016 and similar policies of other institutes, and departments, it added. "The policy aims to transform the academic research into innovative and commercially applicable technologies/products; build a strong ecosystem for nurturing creativity and entrepreneurial activities and contribute to the self-reliant India mission (Atmanirbhar Bharat)," the statement said.

It aims to encourage faculty/staff members and students to pursue entrepreneurship while formulating policies and fostering an ecosystem to generate ideas across disciplines that can be transformed into successful technologies, products, and services, it

For institutes, as per the guidelines, the availability of resources needs to be ensured for pre-incubation and providing common facilities as part of the institute's financial strategy for prospective inventors and entrepreneurs.

Budgetary provisions should be available in terms of allocation of a fixed percentage (such as not less than 1 per cent) of institute's annual budget for funding, promoting and supporting innovation and startup-related activities.

In return for the services and facilities provided, an institute may take a fixed percentage of (2 per cent to 9.5 per cent) equity in the startup/spin-off company, based on employee contribution, support provided and use of the institute's Intellectual Property (IP). According to the guidelines, the entrepreneurial initiatives shall be evaluated on a regular basis using well-defined impact assessment parameters such as IP filed, products developed and commercialised and number of employment generated, and startups created. To encourage students, relaxation in attendance should be provided to enable them to dedicate time for entrepreneurial activities, and they should be allowed to sit for the examination, even if their attendance is less than 75 per cent, it said, adding institutes should provide relaxation to the PhD students in terms of a semester/year break or more, if needed, to devote time on startup ventures.

CCHFW passes resolution terming WHO's modelling for India's COVID death estimate flawed

The WHO report was discussed at the 14th conference of the CCHFW on Friday.

According to the resolution, India has a robust, legally mandated, comprehensive system of death registration.

Under the Registration of Births and Deaths Act-1969, states and union territories document actual number of deaths in the country. The Union Health Ministry on Thursday strongly objected to the use of mathematical models by the WHO for projecting excess mortality estimates linked to the coronavirus pandemic in view of the availability of authentic data, saying validity and robustness of the models used and methodology of data collection are questionable.

India is likely to raise the issue at the World Health Assembly and other multilateral forums, sources in the ministry said.

India has been consistently objecting to the methodology adopted by the WHO to project excess mortality estimates based on mathematical models, the ministry said in a statement.

"Despite India's objection to the process, methodology and outcome of this modelling exercise, WHO has released the excess mortality estimates without adequately addressing India's concerns," it said.

India had also informed the WHO that in view of the availability of authentic data published through the Civil Registration System (CRS) by the Registrar General of India (RGI), mathematical models should not be used for projecting excess mortality numbers for India.

"India firmly believes that such robust and accurate data generated through Legal Framework of a Member State must be respected, accepted and used by WHO rather than relying on less than accurate mathematical projection based on non-official sources of data," the statement added.

The three-day conference of the CCHFW, an apex advisory body of the Ministry of Health and Family Welfare, began here on Thursday. It is being chaired by Union Health Minister Mandaviya.

Real Madrid gears for Champions League final against Liverpool with Atlético derby

BARCELONA: Real Madrid begins its countdown to the Champions League final against Liverpool by facing Atlético Madrid in a capital derby in the Spanish league.

Carlo Ancelotti's Madrid has mostly pride to play for on Sunday after it clinched the domestic league title in the last round.

Madrid has four league games remaining and the veteran Italian coach must perform the delicate balancing act of keeping his team in top competitive form while hoping to avoid any injuries to first-choice players in the runup to the Champions League final on May 28 in Paris.

When the league title was still on the line last weekend against Espanyol, Ancelotti started several bench players like rarely used striker Mariano Díaz and defender Jesús Vallejo. Madrid had no problem routing Espanyol 4-0 to wrap up a record-extending 35th league title. Madrid's fans are still savouring their team's dramatic 3-1 comeback win over Manchester City in the semifinals of the Champions League on Wednesday to win 6-5 overall. Rodrygo, a 21-yearold forward, emerged as the team's saviour with two goals in the final minutes to force extra time and give Karim Benzema the chance to earn and convert the winning penalty. "In this shirt we learn to always fight until the end and that's the way it was," Rodrygo said after he etched his name into Madrid's long history of comebacks, includ-

ing three straight in the Champions League this season against Paris Saint-Germain, Chelsea and now City.

"From right now, we turn our attention to Liverpool," Rodrygo said, with Madrid using its league games "to prepare for the final."

It's not known if Atlético's players will welcome Madrid with an honour guard for the new league champions before kickoff.

Atlético does have something to play for beyond the pleasure of beating its rival. Diego Simeone's side remains in a fight to guarantee a top-four finish to ensure it stays in the Champions League next season.
