

State Funds Medical Cyclotron

Bhubaneswar(KCN): Chief Minister, Naveen Patnaik has approved for State Government funding up to Rs. 150 crores, for establishment of a state-of-the-art Medical Cyclotron unit in the Tata Memorial Cancer Hospital being established in the NISER campus at Jatni. A Medical Cyclotron is necessary for production of radioactive isotopes required for critical imaging procedures such as the

ration with TMC, Bhabha Atomic Research Centre, Mumbai, Variable Energy Cyclotron Centre, Kolkata, Board of Radiation and Isotope Technology, Department of Atomic Energy and Atomic Energy Regulatory Board. The major roles of this international standard facility include: Production of medically useful radioisotopes, South East Asian regional facility for the Research and Development



PET scan for treatment of cancers and other critical ailments. Presently, Odisha has to obtain the isotopes on a daily basis from Hyderabad, Mumbai or Kolkata and as the isotopes remain effective for only a few hours, transportation time makes it reach limited to few centres. The proposed state-of-the-art Medical Cyclotron facility will be unique to the entire South East Asian region.

It will be operated by NISER in close collabo-

Disney's Marvel unit files lawsuits to keep rights to 'Avengers' characters from copyright termination

The legal document seeks "declaratory relief that these blockbuster characters are ineligible for copyright termination as works made for hire." Reportedly, if Marvel loses, Disney would have to share owner-

terminations from Ditko as well as Larry Lieber's (who worked at Marvel as a writer, too) estate. In August, the administrator Ditko's estate filed a notice of termination on Spider-Man, which first appeared in comic book form

law, authors or their heirs can reclaim rights once granted to publishers after waiting a statutory set period of time. According to the termination notice, Marvel would have to give up Ditko's rights to its iconic character in June 2023, reported The Hollywood Reporter.

Larry also filed termination notices to Marvel in May.

The heirs of the comic book creators (including Black Widow creator Don Rico) are being represented by Marc Toberoff, who had also represented Superman creators Jerry Siegel and Joe Schuster in an unsuccessful termination attempt against DC which saved off termination counterclaiming against Toberoff.

As per The Hollywood Reporter, Dan Petrocelli represented the publisher at that time and will be representing Disney for the new case.

Petrocelli has already filed several lawsuits against Lieber, Don Heck, Patrick Ditko, Don Rico and Keith Dettwiler. The cases will focus on the creation of famous comic book characters and who should be deemed the statutory

author. One of the complaints filed on Friday asserted, "Marvel had the right to exercise creative control over Lieber's contributions and paid Lieber a perpage rate for his work."

If the plaintiffs win, Disney would have to share profits with the others and hold on to at least a share of character rights as coowners.

As per The Hollywood Reporter, the termination provisions of copyright law only apply in the United States, allowing Disney to continue to control and profit from foreign exploita-

'Kanyadaan' an outdated ritual or important custom? Alia Bhatt's ad sparks debate

The bride, pretty, radiant and in red, sits in front of the sacred fire, her family, the groom and his parents around her, the love flowing like a balmy breeze.

And in that arguably most precious moment, she looks into the camera and asks, "why must a woman be commodified through the custom of 'kanyadaan? literally 'donating a daughter."

The ad for a lehenga brand featuring Bollywood star Alia Bhatt as the much-indulged daughter and granddaughter has fired debate on social media platforms and elsewhere on the age-old tradition of giving away the daughter.

Many term it Hindu phobic for casting aspersions on a ritual that is part of the warp and weft of society, others appreciate it for calling out the patriarchy that underscores the custom and there are those that feel it should have gone even further in its rejection.

"There is a growing number of young women who are beginning to think about the issue, especially as increasing number joins the workforce, has access to ideas (via social

media etc) that are critical of 'women as property' concept. This ad reflects that," sociologist Sanjay Srivastava told PTI.

In the 1.41 minute ad, Bhatt, the self-assured woman of today who also does a selfie pout with her father while at the 'mandap', recalls her lifetime of 'othering' in a monologue her fond grandmother saying she would one day go to her own home, her father not reacting when people called her "paraya dhan" (alien property) and her mother calling her a 'chidiya' which would fly away one day.

The Manyawar ad ends with the grooms' parent also joining in in the ritual (though it is unclear whether they too are giving away their son) and Bhatt's bride saying it should be 'kanyamaan' (respect for the girl child) and not 'kanyadaan', and asking, "Am I a thing to be given away?" Her angst finds a wide echo. Actor Dia Mirza, who decided to do away with the rituals of both "bidaai" and "kanyadaan" when she got married to businessman Vaibhav Rekhi, said they wanted the wedding to reflect their "beliefs and not outmoded ideas." "Neither of us believes that women are com-

modities to be given away or 'donated.' Women have agency, selfhood and can make decisions about their lives on their own so my wedding reflected exactly that by not including a ritual like 'kanyadaan'," the actor told

She even engaged a female priest for her wedding to emphasise gender equality.

"It is time for young couples to define how they want to get married and if their ceremony is truly representative of their personalities and love for each other," said the actor, who is also the United Nation's National Goodwill Ambassador from India.

Stop manipulating naive consumers with shrewd divisive concepts and advertising. Please stop mocking Hindus and their rituals."

One of the Twitter users echoed similar sentiments.

> "Our traditions are not regressive, mindsets surely are! Kanyadaan is a sacred tradition, where a father/ parent parts with their most precious and cherished daughter, a bittersweet emotional moment filled with hopes, promises and dreams,' the user wrote.

> Women's rights activist Shabnam Hashmi said the attacks on the ad "reflects the highly patriarchal mindsets of our society".

"It is a very progressive advertisement and raises important questions of women's dignity and equality," Hashmi told

Sociologist Shrivastava added that people reacted negatively because there is an increasing intolerance against anything that is seen to question 'Indian traditions'.

There were also those who felt the ad didn't go far enough.

'The idea should not be to perpetuate the custom but to break away from it," said a young woman, who welcomed the ad and the questioning of traditions but would have preferred that it didn't end with the parents of both sides taking part in it.

A radical break would have been more effective in sending out the message, she said. However, a debate reflects a churn.

And in that sense, any discussion is welcome, even if it has unlikely beginnings in an ad for a bridal lehenga.

A major attraction of the residential institutions (both general and technical) job oriented courses they offer. Day by day the number of government institutions have been decreased but the number of private institutions have been increased. Over the years the supreme court of India has interpreted the nature of educational institutions to be charitable and not for profit. There fore supernormal or illigal profits cannot be made by providing education. Again the supreme court has said the tution fee should always be affordable and education is not a business to earn profit as it upheld the andhra pradesh high court judgement to quash the state government's decision to enhance the tution fee in the medical colleges to 24 lakhs of rupees per annum. If a revenue surplus is generated it is to be used by the educational institutions for the purpose of its expansion and educational development. Non-government institutions should ensure that they do not become mere machines for producing graduates ,post-graduates, and proffessional degrees like their government counter parts. works allowing non-governments sector operations should be simplified. There should be deterrents for those who provide poor quality education and use the system to make profit. Both national knowledge commission and yashpal commission recommended that it is essential to stimulate private investment in higher education to extend educational opportunities. The yashpal committe also pointed out while private investment is high in the emerging areas of engineering, medical and management recommended that the private sector should not confine itself to the commercially viable sectors. Private higher education institutions are often accused of charging capitation fee from students in turn making them un-affordable. Fees stuctures of private institutions may be one reason for in accessibility of higher education. Exorbitant capitation fees in private institutions ranged from one lakh to ten lakh or twelve lakh of rupeesfor engineering courses, from 25 lakhs to 50 lakhs of rupees in medical courses from 10 to 12 lakhs of rupees for dental courses, from 10 to 12 lakhs of rupees fo management courses and graduates in science 1 to 2 lakhs of rupees. Due to limited seats in government institutions, private institutions have come as blessing in disguise for aspirations of millions of students. The private sector has been playing an influential and vital role in the field of education. People also do not care for high range of money for admission of their children. Their first choice private institution, whatever the fees may be. Private inistitutions competes in par with best government institution in providing high quality education. Increasing collaboration with foreign institution generally attracts stu-

ibility to raise re- dents for opting private institution instead of public institution. A major attraction of private institution is job oriented courses and another major attraction is safety I.e they take much care of the students. So parents choose for their children -private institution.

> Government on its parts should take role of establishing more university including proffessional colleges and universities for higher education bringing best talent out of india. The supreme court of India ruled that the fees charged by private unaided educational institution to charge reasonable surplus. 

Govt amends Aadhaar rules; supporting documents may be updated 'at least once' in 10 years

NEW DELHI: The government has amended Aadhaar regulations, specifying that supporting documents may be updated "at least once" by Aadhaar holders on completion of 10 years from enrolment date.

The updation would ensure "continued accuracy" of Aadhaar-related information in the Central Identities Data Repository (CIDR), according to gazette notification issued by Ministry of Electronics and IT.

"Aadhaar number holders may, on completion of every 10 years from the date of enrolment for Aadhaar, update their supporting documents in Aadhaar, at least once, by submitting Proof of Identity (POI) and Proof of Address (POA) documents so as to ensure continued accuracy of their information in the CIDR, in such manner as may be specified by the Authority from time to time," it

The changes have been made by tweaking the Aadhaar (Enrolment and Update) Regulations. Want of Aadhar card makes Karnataka man reunite with family after 25 years

Last month, the Unique Identification Authority of India (UIDAI) -- the government agency that issues Aadhaar numbers -- had urged people to update identification and residence proof documents, if they were issued the unique ID more than 10 years back but had not updated their details since then.

Accordingly, to provide facility to Aadhaar holders in this regard, the UIDAI has developed a new feature of 'update document'.

This feature can be accessed online through the myAadhaar portal, and myAadhaar app or residents can visit any Aadhaar enrolment centre to avail of the facility.

The new feature permits Aadhaar number holders to revalidate details by updating the POI (containing name and photo) and POA (containing name and address) documents.

While 134 crore Aadhaar numbers have been issued till date, just how many Aadhaar holders will have to update their information after UIDAI's latest move, is not known immediately.

Last year, about 16 crore updates of various kinds took place.


In a statement issued last month, UIDAI had said, "Any person who had got their Aadhaar made 10 years back and not updated the information in any of the subsequent years are being requested to do document updation".

Taliban ban women from parks and funfairs in Afghan capital

KABUL: The Taliban have banned Afghan women from entering the capital's public parks and funfairs, just months after ordering access to be segregated by gender.

The new rule, introduced this week, further squeezes women out of an ever-shrinking public space that already sees them banned from travelling without a male escort and forced to wear a hijab or burga whenever out of the home. Schools for teenage girls have also been shut for over a year across most of the country.

"For the past 15 months, we tried our best to



arrange and sort it out -- and even specified the days," said Mohammad Akif Sadeq Mohajir, spokesman for the Ministry for the Prevention of Vice and Promotion of Virtue. "But still, in some places -- in fact, we must say in many places -- the rules were violated," he told AFP late Wednesday.

"There was mixing (of men and women), hijab was not observed, that's why the decision has been taken for now." The news was met with dismay by women and park operators -- who invested heavily in developing the facilities. "There are no schools, no work... we should at least have a place to have fun," said one mother, who asked to be identified only as Wahida, as she watched her children play in a park through the window of an adjoining restaurant.

"We are just bored and fed up with being at home all day, our minds are tired," she told AFP. At the next table, Raihana, 21, who is studying Islamic law at university, shared her disappointment after arriving at the park to spend the day with her sisters.

"We were very excited... we are tired of staying at home," she said. "Obviously, in Islam, it is allowed to go out and visit parks. When you have no freedom in your own country, then what does it mean to live here?" Idle attractions



Kolkata(KCN): The 16th Asian Conference of Diarrhoeal disease and Nutrition (ASCODD 2022) is going to be organised between November 11 & 13 November, 2022 at Rajarhat, Kolkata by the ICMR-National Institute of Cholera and Enteric Diseases, Kolkata. The programme of ASCODD 2022 is going to commence tomorrow morning with inauguration and will be attended by approx.450 delegates from India and abroad over the next three days.

The theme of the conference is "Prevention and control of Cholera, Typhoid and other enteric diseases in low and middle-income countries through community participation with respect to the SARS-CoV-2 pandemic." Diarrhoeal disease is still a major killer covering Bangladesh, India, Thailand, Nepal, Sri Lanka, Pakistan, Indonesia and Philip-

Cholera and Typhoid together cause 23 million episodes and 300,000 deaths globally, mostly in countries with limited resources. The bulk of the problem is in Asia and Africa and during humanitarian crises globally. In addition, antimicrobial resistance (AMR) has appeared as one of the major public health problems, endangering the efficacy of useful drugs in the treatment of a range of infectious diseases. The vicious cycle of infection and re-infection process results in malnutrition with devastating effect on the gut environment with growth faltering and growth retardation in young children.



among the under five children in LMIC (Low Middle income countries). It is targeted to provide a platform for the interdisciplinary forum of researchers, practitioners and Scientists to present and to discuss their innovations, disease trends, techniques and its applications.

The use of effective vaccination programmes targeting high-risk populations in hotspot regions as well as during humanitarian crises are useful and cost-effective addition to control measures for both cholera and typhoid fever. Considering the rapid spreading nature of the causative organisms and continuing AMR complications, global elimination of cholera and typhoid are possible with vaccines through a multi-sectoral public health approach. For these purposes, the available oral cholera vaccine and the typhoid conjugate vaccines are affordable and effective, but needs further investigation to prevent and control diseases by 2030.

The conference programme focuses on the latest issues in enteric infections, nutrition, policy, and practice. 50 per cent of rated Indian companies getting profitability boost from weakening rupee: S&P

NEW DELHI: S&P Global Ratings on Thursday said about half of the Indian companies that it rates are getting a boost in their core profitability from rupee depreciation.

"Much of our rated India corporate portfolio has sizable US-dollar-linked revenue and, therefore, is not exposed to rupee depreciation. This

encompasses entities in the IT, metals, and chemicals sectors. About half of the firms we rate are getting an EBITDA boost from currency weakening," the US-based rating agency said in a report.

EBITDA or earnings before interest, taxes, depreciation and amortization is a measure of a company's operating profitability.

Releasing the list, Union minister Bhupendra Yadav said the BJP has changed as many as 38 sitting members, claiming that most replacements have been made with the consent of the incumbents.

The party named its candidates for 84 of the 89 seats which will go to the polls in the first phase on December 1 and 76 of 93 candidates going to the polls in the second phase on December 5.

Union ministers Yadav and Mansukh Mandaviya were joined by Gujarat BJP president C R Patil at a press conference here as Yadav named the

senior leaders from former cniei Vijay minister Rupani and former deputy chief minister Nitin Patel, have opted out of the contest and had written to the party leadership to this effect.

S&P said domestically-driven sectors, such as telecom, are also well placed to withstand the rupee depreciation due to their hedging policies.

> "Bharti Airtel has swapped half the principal outstanding dollar debt--and all its interest expense--on this debt over at least the next 12 months," S&P said.

Information technology firms, like Wipro, Infosys, and HCL Technologies that export services denominated in dollars, but whose costs are largely in rupee, are clear winners. "Local metals firms such as Vedanta Resources are also getting an earnings gain. The company has guided that annual EBITDA will rise by about USD 50 million every time the Indian rupee (INR) drops Re 1 against the dollar," S&P said.

It said infrastructure entities are most exposed to currency risk among Indian corporates and renewable players in particular have high CAPEX spending and a heavy reliance on dollar debt.

"Still supportive onshore funding environment has also helped Indian companies manage the weaker offshore funding markets. Key onshore benchmark rates have risen about 200 basis points in the year to date, less than that seen in many offshore markets. This has made local markets an attractive alternative source of capital. This will give rated issuers a funding option to repay offshore bonds coming due through 2024," S&P added.

DGFT notifies norms for export incentives on rupee receipts

To tame inflation, the Reserve Bank has hiked key policy rates by 190 basis points since May, taking interest rates to a three-year high of 5.90 per cent.

In the report titled 'Asia-Pacific's Strong-Dollar Problem: Inconvenience Today, Headache Tomorrow', S&P said Asia-Pacific is in the middle of a set of rapid interest rate hikes coming out of the US.

"We expect the macro pressures to build on regional foreign-exchange rates, as apparent in widening current account deficits emerging in many countries. Firms that have difficulty passing on their higher input costs, including currency impact, to their customers, are more vulnerable," said S&P Global Ratings credit analyst Simon Wong. "On the other hand, firms that proactively hedge their currency mismatch and those with material US dollar revenue and local costs are more resilient," he added.



The back-to-back boundaries off Curran through mid-wicket region and similar shot over extra cover for a one-bounce boundary of Jordan's deliveries were the only three convincing shots from the India skipper. Not even the slog sweep for four off Rashid looked like he was in control and the final outcome wasn't certainly what people expected in a big-ticket game from Rohit.

Pandya came to India's rescue and changed the
