

# dia -Russia trade leapfrogging despite R war on 75th year of establishment of Diplomatic Relationship

New Delhi: A special session on 'India – Russia Economic Relations and Perspectives of Cooperation with the Eurasian Economic Union' was



organised by 121 years old Merchant Chamber of Commerce (MCCI) on Friday 18th November 2022 in Kolkata. The Special Session was addressed by Alexey M. Idamkin, Consul General, The Consulate General of the Russian Federation in Kolkata . Mr. Maxim Aleshin, Senior Consul and Ms. Ekaterina Lazareva, Head of Protocol of The Consulate General of the Russian Federation in Kolkata were present. Mr. Zha Liyou, Consul General of China in Kolkata, Ms Acharapan Yavaprapas, Consul General and Mr. Pichaya Lapasthamrong, Consul of Thailand in Kolkata attended the Session.Mr. Daniel Sim, Consul of Australia in Kolkata, was present.

Shri Rishabh C. Kothari, President, MCCI in his welcome address said that the trade turnover between India and Russia witnessed an unprecedented growth in the first half of the fiscal year 2023 reaching over US\$ 11 billion, showing a likelihood of achieving the trade goal of US\$ 30 billion

### by 2025.

India's shift in sourcing oil from the Middle East to Russia has given much of the impetus to trade this fiscal and Russia's offer of supplying crude at a cheaper rate has been the prime reason for India to look at Russia. At present more than two thirds of trade happens in fertilizer and hydrocarbon, raw material supplies but there are more opportunities to broaden the economic cooperation.

The two countries are engaging themselves in synchronization of the payment systems with the Russian Mir in India and the Indian RuPay in Russia. Such mutual recognition of payment system will lead to strengthening of business ties and Russia's move to give Indian Rupee the status of a trade currency will give India an edge in trading terms worldwide. The Eurasian Economic Union consisting of five member states - Russia, Belarus, Kazakhstan, Kyrgystan and Armenia may well form an economic union and a common market on the lines of the European Union. Better business with Russia can open enhanced trading lines with them and the currency synchronization or the Rupee functioning as a trade currency may give India a strong business foot print in the Eurasian Zone.

Alexey M. Idamkin said that mutual trust and amicability has not diminished between India and Russia in recent times. He reminded the audience that Russia had stood by India during the Indo – Pak war in 1971, the Kargil conflict and other difficult times. India-Russian friendship has withstood the test of time. India does not want to join the current Western sanctions against Russia and the two countries continue to give a shoulder to each other.

India and Russia continue to strongly cooperate on defence issues with real time communication between the two sides. The two countries continue to cooperate in space exploration, among other significant areas. In West Bengal Russian equipment were being used for underground mining and it was in the areas of MSME that Russia was collaborat-

#### ing with the state.

Mr. Idamkin agreed to Mr. Kothari's view that the volume of trade between India and Russia will reach USD 30 billion by 2025. He said the volume of trade in the first six months of the current fiscal has been worth \$18 billion. Russian exports of hydrocarbons form a significant portion of bilateral trade and in fact, Russia has increased oil exports to India six fold year-on--year in this year. Although overall bilateral trade between India and Russia was increasing Mr. Idamkin expressed concern over the trade imbalance between the two countries.

He mentioned about the JVs between the two nations in the areas of refinery, steel and fertilizer, nuclear energy and said that both India and Russia would not only continue with their relationship but will build upon it.

On announcing Rupee being a trade currency Mr. Idamkin said that negotiations were fast progressing though he could not comment anything specific on the issue. Both India and Russia have opened a number of Vostro accounts in their respective countries.

The five countries that have formed the Eurasian Economic Union (EEU) could give India a better trade opportunity with a formation of a common market, which is evolving. EEU was US\$2 trilion market.

Alexey M. Idamkin announced that three day Russian Cultural Festival will be organised in Kolkata on November 23, 24, 25, 2022 at Rabindra Sadan. Festival is organised by Ministry of Culture Russian Federation, Embassy of Russian Federation in Republic of India in collaboration with Indian Council for Cultural Relations to celebrate establishment of 75 years of diplomatic relationship between Russia & India.

Mr. Rajendra Khandelwal, Committee Member MCCI in his vote of thanks said that Mr. Idamkin was the longest serving Russian diplomat in Kolkata and termed India and Russia as all weather friends.

Five companies of the Central Armed Police Force (CAPF) have been deployed to maintain law and order during the by-election. In addition, an adequate number of state police forces have also been deployed.

The State Government has declared that polling day i.e. December 5 will be a public holiday and polling day and counting day as 'dry day'.





Don't confuse Milk with Mylk and Malks, All You Need to Know About Non-Dairy Milk Alternatives

Milk has been an unquestioned staple food of the Indian diet since centuries. It is the first food that is received by any mammal after birth. It is a nutrient-dense food of highly



bioavailable nutrients at a very low cost. Milk is considered almost a complete food. These days we hear a lot about nondairy milk alternatives, like oat milk, almond milk, rice milk, soy milk,

pea milk, coconut milk and many more which

educate the consumer to differentiate betwee vegan and the dairy product. Terms like 'extract' or 'beverage' were recommended to be used in place of 'milk' for almond, soy, oat milk etc.

Selection and consumption of any product as part of one's diet are preference-based. If a person is changing his/her food habits by replacing milk and milk products with plantbased dairy alternatives, one needs to consider the real differences between milk and nondairy milk alternatives in terms of health benefits, nutrients contents, calories, added sugar, other ingredient, as well as the price. Most non-dairy milks are compared to cow's milk, which has a strong nutritional package. One cup of milk (1% milk) has 110 calories, 2.5g fat (1.5g sat fat), 8g protein (more than a hard boiled egg), 12g carbohydrate, 12g sugar, 0g fiber along with it it has 300 mg of bone building calcium and 400 mg of potassium including thiamin (vitamin B1), vitamin B6 and zinc that work in concert with other B vitamins like pantothenic acid to help convert your food into energy and magnesium, which also helps to build strong bones. Plus, milk has selenium, which works with vitamin A to help maintain a healthy immune system. The carbohydrate present in milk is lactose on the other hand to make PBB more palatable, manufacturers often adds sugars in the form of cane sugar, rice syrup and more. While one cup of plain cow's milk contains 12 grams of sugars, all of it comes from naturally occurring lactose, which is digested more slowly and keeps your metabolism more stable over time than refined sugars. The glycaemic index (GI) is a value used to measure how much a specific food increases blood sugar level. The GI of cow milk is much lower than that of PBB. Hence, to reduce the intake of processed sugar and subsequently achieve low blood glucose levels, one should opt for real milk. Some people blame milk sugar lactose, as part of our population may be lactose intolerant. Dairies do provide low lactose milk so also lactose free milk. Another alternative is to use, fermented milk products like curd, yogurt, buttermilk, etc, where almost 25 per cent of the lactose is hydrolysed. Further lactose is a natural sugar (more specifically, a disaccharide composed of glucose and galactose) found in milk, galactose generated out of lactose is required

brain for development. Cow milk is higher in

energy and fat compared to PBB. The energy content of PBB is primary ingredient specific, mainly oil and sugar, while the milk fat comprises numerous types of fatty acids. Short-chain and medium-chain fatty acids present in bovine milk exhibit various regulatory and signaling functions in the human body. Cow milk contains over six times the amount of protein present in almond, rice, and coconut-based beverages. The quality and the digestibility of protein present in cow milk is higher in comparision to protein present in PBB. Proteins are categorized as either complete or incomplete, chiefly based on their amino acid composition. In fact, proteins that contain the "nine" essential amino acids (not produced by the human body) are considered to be "complete." All animal proteins contain all nine essential amino acids, this includes milk, milk proteins and anything derived from milk. However, nearly all plant proteins lack one or more amino acids that make it incomplete, except for soy protein. It is essential to note that cow milk is naturally rich in many micronutrients, which its counterpart PBB lacks and therefore, it is fortified with plenty of micronutrients. The calcium added to foods is different from the calcium that is naturally occurringi in whole foods like milk. There may be differences in how your body absorbs it, and it may not have the same health impact as the mineral found naturally. Cow milk is a recognised source of bioavailable calcium, that has an essential role in bone health. The medical science had already highlighted the importance of iodine for normal cognitive function, thyroid function, growth in children and regular skin maintenance. Cow milk is a rich source of iodine, that is again negligible in fortified PBB. While there have been many studies on cow's milk and how it affects bone health and heart disease risk, there's very little research into plant milks because most haven't been around for as long. Another propaganda which the manufacturers of PBB making to attract the elite consumers is the environmental concerns related to dairy farming. They try to highlight the issues like, dairy cattle produce more greenhouse gas emissions and require more land and resources than plants and claim that production of milk alternatives is a more sustainable and environmentally-friendly practice. Differences do exist even when it comes to the various alternatives to plantbased milk. For instance, almond milk needs excessive water (It requires an estimated 15 gallons of water to grow just 16 almonds). Furthermore, each plant source also impacts soil health and farming communities differently. Today, the majority of crops are cultivated in a way that causes degradation of soil and impacts soil biodiversity, and the water cycles negatively. Practices like crop monoculture, intensive agriculture, tilling, and usage of synthetic fertilizers, herbicides, and insecticides are collectively responsible for environmental damage. Non-dairy milk does contain additives. Additives like guar gum and tapioca starch are ingredients often added to plant-based milks to give them the creamy body that milk has. These thickening agents are generally recognized as safe, but another thickener, carageenan, may be linked to inflammation according to some research. Dairy proteins have a very clean, neutral and mild, milky flavor, while PBB can be grassy, earthy and have a beany flavour. These offflavors usually create a need for flavourmasking agents, while dairy comes with far less requirement of such additives. When it comes to recipes unlik milk all PBB are not created equal so one can cook and bake with non-dairy alternatives but the results may vary and one have to often search for cooking tips and instructions. Plant-based dairy alternatives aren't cheap, costing almost three times the price of cow's milk and other dairy products (such as yoghurt) while nutrient density in them is very low. The product's high cost gives the impression that it may be healthier, but the truth is the other way. This shows that cow milk is superior in nutrition, taste and is economical too. Probably no dairy is against PBBs and respects the consumer's choice. However, using the term milk, taking advantage of brand equity of milk and at the same time blaming milk does not look sensible and is purely a game of misguiding and confusing the consumers. This should stop, and national and international legislation should be followed in the interest of the consumers. Milk is nutritionally superior as compared to PBBs. An appeal to consumers is that health must always be on top while making food preferences.

are called Plant Based Beverages. The manufacturers of these PBB (Plant Based Beveges) are trying to misguide and confuse consumers through systematic wrong marketing, using the dairy term 'Milk' or 'Malks' for non-dairy beverages. People perceive plant based milk to be healthier alternative to milk since it has less calories, taste delicious and sweet. It's important to note, however, that eliminating nutrient-rich food groups, like dairy, may not only be unnecessary, it could also impact diet and health. The major problem in changing lifestyles these days is following trends while overlooking scientific facts.

Food Safety and Standards Authority of India (FSSAI), an apex body for all matters related to food safety and standards in India defined milk as" The normal mammary secretion derived from complete milking of a healthy milch animal, without either addition to that or extraction therefrom, unless otherwise provided in these regulations and it shall be free from colostrum". These plant-based alternatives are typically made by soaking the legume, nut, grain or other main ingredient, then pressing and straining the liquid and finally adding optionally some vegetable oil, flavors, vitamins, and minerals. On 21 July 2020, FSSAI has published a draft notification, which classifies plant-milk as analogue, an imitation product designed or structed to mimic or offered with non-dairy substitutes as an alternate to animal milk and its products. The draft notifications also prohibits the use of dairy terms that are phonetically similar (Mylk, Malks etc) or have a similar spelling in the nomenclature of the non-dairy product. Simply put, FSSAI does not want to share the word 'milk' with the country's plant-based milk producers. Furthermore, such products would need to have a label that says, "THIS IS NOTADAIRY

# **Cabinet clears port policy**

Bhubaneswar: In an aim to bring more investment to the port sector, the State Cabinet on Friday approved 17 proposals including holistic Odisha Port Policy 2022.

The Policy has been formulated by the Department of Commerce & Transport for the holistic development of the entire maritime ecosystem of Odisha.

This policy aims to provide comprehensive guidelines for integrated development of non-major ports and inland waterways of Odisha, said Chief Secretary Suresh Chandra Mahapatra.

This policy shall facilitate the promotion of private sector investments into the maritime sector of the state, helping Odisha emerge as a favoured investment destination, promoting the idea of kalinga advantage and providing employment opportunities to the youth of Odisha, he said.

Currently, the State has 14 notified non-major ports, out of which the ports at Dhamra and Gopalpur are already functioning, while the ports at Astaranga and Subarnarekha Mouth (Kirtania) are currently under construction.

This policy seeks to aid and promote development of ports and port-led industrial development through improved port linking infrastructure.

The policy also promotes other maritime ventures such as coastal shipping, promotion of marine tourism, multipurpose harbours, introduction of sea-plane connectivity, promotion of facilities and creation of infrastructure for ship building, ship breaking and related activities.

Greater focus has been placed on adoption of latest technology and creating sustainable maritime development along the Odisha coast.

Similarly, the Cabinet led by Chief Minister Naveen Patnaik has also approved PRARAMBH- the Odisha State Policy for Children, 2022.

The policy envisions the best interest of children by means of a blueprint which focuses on children's right to survival, protection, physical health, including mental health, upholding the right to education, participation and other milestones required to achieve their optimal development.

For this policy, and in line with UNCRC, childhood includes the period from conception till 18 years of age. The policy will further strengthen the state's commitment to achieve

Bali(KCN): Prime Minister Narendra Modi assured the G-20 grouping on Wednesday that "India's G-20 presidency will be inclusive, ambitious, decisive and action-oriented."

Addressing the closing session of the G-20 summit in Bali, Indonesia, during which India symbolically assumed the presidency of the G-20, Mr Modi said, "It is a proud occasion for every Indian to assume the G-20 presidency." He added that India will "organise G-20 meetings in different cities and states" so that "our guests will get a full experience of India's amazing diversity, inclusive traditions and cultural richness." India will formally assume the G-20 presi-

He added: "Global development is not possible without women's participation. We have to maintain priority on women-led development even in our G-20 agenda. Without peace and security, our future generations will not be able to take advantage of economic growth or technological innovation. Tender worth Rs 221.43 crore with maintenance cost of Rs 3.35 crore has been approved for Hadua Medium Irrigation Project, which is contemplated for integrated development of Narasinghapur, Baramba and Tigiria block of Cuttack district. The project envisages a reservoir across Hadua river near village Kharod in Cuttack district with construction of a 387 m long and 43.825 m height concrete dam besides a central Ogee crest spillway as proposed.

It is a very auspicious coincidence for India that we are assuming the responsibility of the G-20 presidency on this holy island of Bali. India and Bali have an age-old relationship."

Mr Modi further said: "The sense of ownership over natural resources is giving rise to conflict today and has become the main cause of the plight of the environment. For the safe future of the planet, sense of trusteeship is the solution. LiFE, i.e., 'Lifestyle for Environment' campaign, can make a big contribution to this. Its purpose is to make sustainable lifestyles a mass movement. The need today is that the benefits of development are universal and all-inclusive. We have to extend The Prime Minister pointed out: "In India, we



are making digital access public, but at the international level, there is still a huge digital divide. Citizens of most developing countries of the world do not have any kind of digital identity. Only 50 countries have digital payment systems. Can we take a pledge to-

gether that in the next ten years we will bring digital transformation in the life of every human being, so that no person in the world will be deprived of the benefits of digital technology?"

Detailing India's successes, Mr Modi said, "India's experience of the past few years has shown us that if we make digital architecture inclusive, it can bring about socio-economic transformation. Digital use can bring scale and speed. Transparency can be brought into governance. India has developed digital public goods whose basic architecture has inbuilt democratic principles."

Citing the example of India's Unified Payment Interface (UPI), he said, "Last year, over 40 per cent of the world's real-time payment transactions took place through UPI. Similarly, we opened 460 million new bank accounts on the basis of digital identity, making India a global leader in financial inclusion today. Our open source CoWIN platform made the biggest vaccination campaign in human history, a success even during the pandemic."

### Rising interest rates will help Indian banks post healthy profits in FY23: S&P

CHENNAI: The rising interest rates will enable Indian banks to continue posting good profits during the remaining part of FY23, according to S&P Global Market Intelligence.

In a report on the Indian banking sector, S&P Global Market Intelligence said five of the six biggest banks by assets in India reported an increase in net income for the fiscal second quarter that ended September 30, 2022.

"Banks took advantage of the higher interest rate environment to bolster their net interest margins, while previous efforts to reduce their non-performing assets resulted in lesser loan loss provisions, their recently released earnings reports showed," the report notes.

The fiscal second-quarter results of the private sector, as well as public sector banks, were "picture perfect," said Tusharika Aggarwal, research analyst, Asia-Pacific dividend forecasting at S&P Global Market Intelligence.

"I remain fairly confident in the bank's earnings for the rest of the year. The interest rate hikes, although the quantum will decline, would still benefit Indian banks. And because credit growth is increasing, so

### Rupee falls 37 paise to close at 81.63 against US dollar

MUMBAI: The rupee depreciated by 37 paise to close at 81.63 (provisional) against the US dollar on Thursday, tracking the strength of the American currency in the overseas markets and a muted trend in domestic equities. Forex traders said the American currency strengthened after strong US retail sales data pointed to resilient consumption adding room for tighter policy by the US Federal Reserve.

At the interbank foreign exchange market, the local unit opened at 81.62 and later witnessed an intraday high of 81.45 and a low of 81.68 during the session. The domestic unit finally settled at 81.63 against the American currency, registering a fall of 37 paise over its last close.

On Wednesday, the rupee depreciated by 35 paise to close at 81.26 against the US dollar.



US retail sales posted the biggest increase in eight months in October. UK inflation number came in

half came to 20.4 per cent, compared to 13.9 per cent for public sector banks.

The central bank expects gross domestic product growth at 7 per cent in the current fiscal year ending March 31, 2023, and to ease to 6.5 per cent in the next fiscal year, dampened by further monetary tightening in the central bank's fight to control inflation.

According to the report, though the RBI had hiked its benchmark lending rate by 190 basis points to 5.90 per cent since May, a further hike in the interest rate may not be steep since inflation may have peaked.

National University of Singapore for computer engineering he spoke to this reporter that it makes him happy and proud that he could represent his country on this global platform and spread awareness on significant societal issues and present a sustainable solution.

After winning an international award for Thermal Floater, he felt amazed and told "I was so delighted that I didn't know how to feel, and as soon as the adrenaline hit me, I screamed with joy because it was the first time I had won at such a level. I am now confident to give a sustainable solution to climate issues." Sparsh has an impressive way to mitigate climate change by using thermal energy.

He was a student of Radiant International School, Patna, and has an inquisitive mind said that while he was in grade 12th he developed his idea.

He says "I came from the rural area where power outages are regularly recurring, often 2-3 hours per day. Moreover, there is a shortage of coal, and power outages which last as long as 6-8 hours per day. I tried to do something about it and find a solution to the problem. After much research, however, I realized that existing solutions are often inefficient, expensive, unavailable, or require very large areas of space." "After lots of failures initially, I succeeded in my project, the Thermal Floater, the device that efficiently converts thermal energy from the Sun into electrical energy using a complex system to generate electricity up to 10 kWh per day while still keeping a small form factor. It has a modular design and can easily be connected with similar modules to create an array for supplying power to utility and off-grid facilities. It generates electricity by using the temperature difference created by the Sun's heat and the water it floats on" he added. On asking why people do not take climate change seriously. He says "there are a few key factors that play a role. It can be difficult for people to wrap their heads around the scale of climate change and its potential impacts. It can be hard to believe that something so significant could be happening right under our noses, especially when the changes are gradual and not always immediately noticeable. this threat, with the main objective of creating a "counter-terrorism sanctions regime". He said that this system established by the United Nations has successfully curbed to some extent, the actions of countries that make terrorism a state-funded enterprise, but it has to be further strengthened, made more rigorous, and transparent.

Union Home Minister said that our first commitment should be cooperation with transparency and all countries and organizations must pledge complete transparency in sharing intelligence in a better and more effective manner. He said that we have to fight this war against terrorism and terrorist groups, in every geographical space, in every virtual space. Shri Shah said that there have been many instances when, under the guise of other motives, some organizations promote terrorism and radicalization at the national and international levels. He noted that it has also been found that these organizations tend to become the medium of financing terrorism. Shri Shah said that recently, the Government of India has banned an organization that conspired to radicalize the youth and push them towards terrorism and that every country should identify and take stringent action against such organisations.

Shri Shah said that some countries, their governments and their agencies have made 'Terrorism' their State Policy. He said that in these Terror havens, it is necessary to shackle their unrestrained activities along with a strict economic crackdown and all the countries of the world will have to make up their minds on this, rising above their geo-political interests. Shri Shah said that we observe that some countries repeatedly support terrorists and those who harbour terrorism, but, terrorism has no international boundaries, so all countries should think beyond politics and cooperate with each other. He said that at the same time, all countries will have to agree on one common definition of 'terrorism' and 'terror financing', because it is an issue of the protection of our citizens, and their human and democratic rights, it should not become a political issue. Union Home Minister said that terrorists understand information technology and cyberspace very well and they also understand the sensitivity of the public and tend to exploit them. He said that cyberspace today has become a major battleground in the fight against terrorism. Shri Shah said that there have also been multiple changes in Weapons Technology too and these 21st-century lethal technologies and drone technologies are also accessible to terrorists now. He said that the growing links of terrorism with organized crimes such as narcotics, crypto-currency, and hawala, have increased the possibility of terror financing manifold. Shri Shah said that the primary goal of this conference is to identify various channels and ideate a practical and workable roadmap against terror financing, identifying its various channels. He stated that according to an estimate by the IMF and the World Bank. criminals around the world launder around 2 to 4 trillion dollars every year. And a major part of it goes to fuel terrorism. Shri Shah said that considering the quantum and challenges, the agencies and authorities working in the areas of counter-terror and terror financing, have to adopt a long-term strategy. Shri Shah drew the attention of the delegates towards some priority issues,

How they qualified: Saudi Arabia finished first in Asia zone qualifying Group B

Key player: Winger Salem al-Dawsari, nicknamed "Tornado", is participating in his second WC after the 2018 tournament in Russia, where he scored the deciding goal in a 2-1 win over Egypt. He has also notched goals in the 2019 Asian Cup and the 2021 Olympic Games in Tokyo. During qualifiers, the 31year-old saved them from a humiliating loss to Yemen MEXICO (13th in FIFA ranking)

Best World Cup performance: Quarter-finals in 1970 and 1986

Honours: Eight CONCACAF Gold Cups, 1999 FIFA Confederations Cup, 2012 Olympic gold medal How they qualified: Finished second in the North, Central America and Caribbean region final qualifiers

Key player: Guillermo Ochoa - The 37-year-old is the Mexican national team's most capped goalkeeper and holds the record at his Club America for the most games without conceding a goal. Easily recognisable with his curly hair and headband, Ochoa spent three seasons with French side Ajaccio before being chosen as Mexico's first-choice goalkeeper at the 2014 World Cup.

POLAND (26th in FIFA ranking)

Best World Cup performance: Third place in 1974, 1982

Honours: Olympic champions in 1972

How they qualified: Finished second in European qualifying Group I. Defeated Sweden 2-0 in playoff

Key player: Robert Lewandowski is one of the greats of Polish football. The country's record appearance maker and goalscorer, Lewandowski will hope to fare far better than in Russia four years ago when he drew a blank in the group stage and Poland made an early exit. He has picked up at Barcelona where he left off at Bayern Munich following eight prolific, record-breaking seasons with the Germans. The reigning two-time winner of the European Golden Shoe has also won the Best FIFA Men's Player award the past two years. **GROUP** D
