Ever since Naveen Patnaik came to politics and formed the regional political outfit – Biju Janata Dal (BJD), he has never encountered any problem in winning elections. He and his party continued to rule over Odisha for over two decades.

However, the on-going by-election in Padampur Assembly segment in Bargarh district, seems to be a tough job for the regional political party as it has turned out to be a "prestige" issue after its defeat in Dhamnagar by-poll. While BJD lost the Dhamnagar seat

said late Bishnu Charan Sethi was popular and therefore, his son Suraj won the by-poll. This particular statement of the BJD President may be for record's sake, but the fact remains that the regional party lost to a national party. BJP had won 23 assembly seats and 8 Lok Sabha seats in the 2019 general elections. But, what is a matter of concern is that the BJP won the seat in Dhamnagar despite the best efforts of the BJD. BJP's Suraj stopped the BJD's winning spree, thus giving a clear message that the Naveen party can also be defeated if it lacks the regional identity.

The BJD, which is deeply rooted in Odisha winning five general elections since 2000, is different from other political parties as its rivals like BJP and Congress are national parties. One dead, two injured with critical condition at Barbil in a road accident



Barbil(KCN):One person died in a fatal road accident near Serenda on Barbil-Joda main road under Barbil police station of Keonjhar district in Odisha late night yesterday while two others are being referred to Barbil hospital in critical condition. The deceased

have been identified as Akhita Sadanand of Joda area while the others have been identified as Harsh Shankar and Lokesh Pawar. According to information, these three youths were traveling in a Mahindra TUV bearing number OD09-P-3489 when they collided head-on with Hiva truck. As a result, Ashi Savananda died on the spot and two others were trapped inside the vehicle in a critical condition. It is said that the TUV vehicle was running at a high speed and the driver lost the control and rammed the Hiva which was coming in opposite direction. The vehicle was completely crushed and its air bag was also ruptured in the accident. On receiving the information, Barbil police, ambulance and fire brigade reached the spot and rescued three people from there and brought them to Barbil community health center. There, the doctor declared Sadananda dead and referred Harsh Shankar and Lokesh to Cuttack Medical College after first aid treatment. While some people say that the accident happened due to speeding and taking the wrong route. The police seized the vehicle and conducted an investigation. On the other hand, it has been reported that the body of Sadanand has been handed over to the family members after

into the trap of mundanity and indifference, into routine and repetition. Maara is pretty much the film equivalent of 'Follow the white rabbit'. That's perhaps why during a conversation between Maara and a thief (Alexander Babu), you can see a neon sign in the background that reads 'White Rabbit'. The usual response to such a call is to cite a lack of financial security, and while that is a reason to be empathetic about especially given the enviably cushy workfree existence Paaru seems to be leading

it seems to be saying... notice the almost mystical beauty of existence. It's also likely that this is why the film's many shots are lit as they are, with many faces often aglow, as though in the presence of a halo.

This is why the coincidences in this film become palatable. The central idea at the heart of this film is of two lonely souls in search of each other. Take note of that inexplicable attraction little Paaru feels as she sees a speeding train from within her bus. Or take note of that instinctive smile from Maara as he steps into his room,

Maara himself, as he does many times in this film, underplays this notion that he's a mystical being. It's his understandingand you will see it from his eyes when he's engaged in conversation with every single character that each of us is magical, as are our stories.

In this film with performances that range from great to overthe-top, I loved Mouli in particular, who plays Vellaiya, an old man consumed by his unrequited love. Watch him in that scene with Paaru as he brings to her an old photo of his beloved, another scene with Paaru as she tells him about Meenakshi; watch his eyes grow wide in surprise, and almost well up under the weight of decades mourning. of Ghibran's background music and Thamarai's evocative lyrics add so much to such scenes as well. It's wonderful that films like Maara are able to offer elderly characters like Mouli's as much purpose and are able to see them for the individuals that they are, instead of simply as a crutch for a lead character. Of course, much of this credit must go to the original film, Charlie.

In a world that is in a tearing hurry, at a time when films and stories are designed to be rapid for fear of making audiences impatient, films like Maara come as a welcome relief. In this film, at least two important exchanges between Vellaiya and Paaru, and later, between Maara and Kani—happen as wood slowly burns to ember, as tender faces are lit by the warm glow of a fireplace. It's for such moments that I'll remember this film, even if some inconsistent performances and some synthetic moments stop it from being truly great. Nevertheless, it's a film that has heart and that encourages empathy towards those around us, and if possible, to note that magicality doesn't need to be

Treating unexplained investments as income u/S 69-Part 2

5. Conclusion primarily on imaginative basis and conjectures deleted: In the case of CIT v. Lalit Bahsin



290 ITR 245 (Del.), assessee purchased a ticket of Calcutta Stock Exchange for Rs.50,000. The AO took the value of the ticket at Rs. 11.5 lakh on the basis of the prevailing market price and added Rs 11

lakh as unexplained investment. Delhi High Court deleted the addition on the ground that AO arrived at conclusion primarily on imaginative basis and conjectures rather than on the basis of any record or books of account and hence deleted the addition.

6. No basis of making the estimated addition: In Omega Estates v. ITO106 ITD 427 (Chennai) AO relying on some letters given by the assessee to prospective buyers mentioning rate of flats at Rs.1,250 per sq. ft calculated sale receipts of all flats at the said rate. The Chennai Bench of ITAT held that since the revenue could not prove that actual consideration was more than that recorded by the assessee and since books of account had not been rejected, there was no basis of making the estimated addition.

7. There has to be evidence to support Revenue's case: In Amarjij Singh Bakshi (HUF) v. ACIT 263 ITR (AT) 75 (Del.) a search was conducted at the premises of one Mr. A and the agreement between the assessee and Mr A. was found pertaining to sale of 9.16 acres of land. the consideration mentioned in the agreement was Rs. 7.07 crore as against the consideration of Rs.23.5 lakhs declared by the assessee. AO added the difference Rs. 6.83 crore u/s 69B. The court held that the provisions of the Indian Evidence Act are not strictly applicable to the proceedings under IT Act but the broad principles of law of evidence apply to such proceedings. Notings on loose sheets of paper are required to be

s u p p o r t e d / collaborated by other evidence. A

distinction also needs to be drawn between slips of paper or loose sheets found from the possession of the assessee and similar documents found from a third person. In case the statement of the third person is recorded or relied upon then such statement undoubtedly has to be confronted to the assessee and he is to be allowed an opportunity of cross examination. Delhi ITAT Bench said that the entire addition was based on the document found but there was no evidence to support Revenue's case that a huge figure over and above the figure booked in the records and accounts changed hands between the parties and thus no addition could be made.

Need for corroborating evidence to 8. make addition: In M.M. Financers (P) Ltd. v. DCIT [2007] 107 TTJ 200 (Chennai) a search was conducted at the premises of MR a business associate of the assessee and an unsigned MOU was found reflecting the purchase price of a land at Rs.2.4 crore whereas the disclosed value was Rs.91 lakh. AO added the difference as income of the assessee. ITAT Bench, Chennai held that since the MOU was found at the premises of MR and not at the premises of the assessee and that AO had not found any corroborating evidence from any seized material and since there was no evidence of payment of money other than Rs. 91 lakh, addition was not justified. Similar view has been expressed in Chintan Jadavbhai Patel v. ITO [2017] 79 taxmann.com 302 (Gujarat); Pr. CIT v. Phonenix Datatech Services (P.) Ltd. [2017] 77 taxmann.com 294 (Delhi), R. Ramachandran Nair v. DCIT [2017] 78 taxmann.com 110 (Kerala).

9. Addition can not be made merely on ground of document found at premises of assessee: In Manohar Lal Rattan Lal v. DCIT [2004] 91 TTJ (Asr) 737 an addition was made solely on basis of a copy of agreement indicating large consideration, found and

seized by the Department. ITAT Amritsar Bench

deleted the addition holding that since the signature of the assessee, i.e. the purchaser was not on the document no addition can be made merely on the ground that the said document was found at the premises of the assessee. Moreover the seller of the property was not examined. Hence no addition can be sustained.

10. Where Agreement for purchase of property was not signed and none of the buyers or buyers were examined: In Rajendra Kumar Garg v. DCIT [2000] 67 TTJ (Del) 347, sale consideration of a property was recorded in the books at Rs. 9.3 lakhs but the assessee declared during the search the sale consideration at Rs. 38 lakhs. However in an Agreement to sell, found in search, the consideration was stated at Rs. 1.10 crore. The Delhi ITAT Benh directed the AO to compute the income by taking sale consideration at Rs. 38 lakhs and not one crore as the agreement was not signed and none of the buyers or proposed buyers were examined by A.O. and the department did not get the property valued to establish its real value.

11. Addition cannot be made if agreement was not signed by the buyer and the deal had not materialsed: In Smt. Saroj Kumari L/H of Late Smt. Dampati Devi (Decd) v. ACIT [2004] 91 TTJ (Asr) 733a search was carried out at the premises of a firm Lachman Dass Jaspal Singh, Mansa. In the course of the search an agreement between Smt. Dampati Devi and Shri LachmannDass for sale of a property at Rs. 188000 was found. The above property was acquired by Dampati Devi at Rs. 33750. The legal heir of Late Dampati Devi argued that the agreement was not signed by the buyer and had not materialsed. But AO added the same in the hands of the seller also on the ground that the purchaser had accepted the addition in his hands u/s 69 of the entire amount of Rs. 1,88,000. ITAT Amritsar Bench held that the sole basis of addition was that Lachmann Das (the purchaser) agreed to the addition and on that fact alone addition cannot be made.

12. Statement in search made by assessee, Retraction after a period of two years, may be rejected as an afterthought: In Thiru S. Shyam Kumar v. ACIT [2018] 99 taxmann.com 39 (Madras), a search was conducted in the business premises of the assessee wherein certain loose slips were recovered, which showed several entries pertaining to cash and cheque transactions in respect of purchase of a property. Before Assessing Officer, assessee had given statement accepting the on-money payment. Accordingly, the Assessing Officer treated on-money payment as undisclosed income of the assessee. On appeal before Commissioner (Appeals), assessee retracted from its statement given before the Assessing Officer and took a stand that the slips were only dumb sheets and there was no connection with the purchasing of residential property. The Commissioner (Appeals) dismissed appeal of the assessee holding that retraction was vague and a clear afterthought. The Tribunal also dismissed appeal of the assessee. On appeal it was held the notings are clear and it is not any scribbling, which shows the figures and also shows whether the payments were in cash or in cheque. The retraction made by the assessee, after a period of two years, was rightly rejected as an afterthought. The case on hand is not a simple case of relying upon some scribbling and notings, but a case where the entries, which were clear and legible, were taken into consideration by the Assessing Officer. The correctness of which was examined by the Commissioner (Appeals) and further examined by the Tribunal. Thus, the assessee has not made out any good ground to interfere with the order of the Tribunal. (Contd.)

China unrest: Testing time for President as protesters chant 'Step down, Xi Jinping'

A little over one month after Xi Jinping reaffirmed his iron grip on power during the 20th National Congress of the Communist Party of China (CCP), an acid test confronts his leadership as protests have erupted over the past two weeks against the draconian restrictions imposed by the regime to curb the spread of Covid-19. Maybe, it's too early to compare the ongoing protests to the 1989 student-led Tiananmen Square protests which was precipitated by the death of a pro-reform CCP leader, but how it would pan out, the coming weeks would reveal.

Even as the stringent policy, amplified by lockdowns, against Covid-19 enforced by the regime left the people frustrated, the new locally transmitted cases reported on Wednesday stood at 31, 444, which is reported to be the highest daily figure since Covid-19 was first detected in the cenLast week, workers at Apple iPhone maker Foxconn's Zhengzhou plant clashed with riot police amid their protest in support of multiple demands including pending payments. Following this mass exodus of hired employees at the plant was reported by the media.

Earlier, migrant workers in the southern Chinese metropolis of Guangzhou crashed through lockdown barriers and marched on the streets.

There has also been an outpouring of grief on social media over the death of a four-month-old baby whose father reportedly said her medical treatment was delayed for 12 hours because of curbs enforced by the government.

policy Surrounding a makeshift memorial of candles, flowers and placards, the crowd held up blank sheets of white paper – in what is traditionally a symbolic protest against censorship - and chanted, "Need human rights, need freedom."

According to The Guardian, a 32-year-old mother of two killed herself in a quarantine centre in Guangzhou earlier this month after she was tested positive and separated from her husband. The news story, reported by respected financial publication Caixin, was quickly scrubbed from social media. However, The Guardian quoted social scientist Prof Chung Kim-wah as saying that the protests "demonstrate that people have lost patience with the unreasonable [Covid] measures and are questioning their effectiveness", but added that the unorganised protests are not a strong enough force to confront the government. He noted that if minor adjustments are made, protesters typically give in. "This makes bottom-up changes very difficult, if not impossible,"

Protests over China's COVID controls spread across country

BEIJING: Protests against China's pervasive antivirus controls that have confined millions of people to their homes spread to Shanghai and other cities after complaints they might have worsened the death toll in an apartment fire in the northwest. Shanghai police used pepper spray against about 300 protesters, according to a witness. They gathered Saturday night to mourn the deaths of at least 10 people in an apartment fire last week in Urumqi

President Xi Jinping's government faces mounting anger at its "zero-COVID" policy that has shut down access to areas throughout China in an attempt to isolate every case at a time when other governments are easing controls and trying to live with the virus.

That has kept China's infection rate lower than the United States and other countries. But the ruling Communist Party faces growing complaints about the economic and human cost as businesses close and families are isolated for weeks with limited access to food and medicine.

Some protesters were shown in videos shouting for Xi to step down or the ruling party to give up power.

Party leaders promised last month to make restrictions less disruptive by easing quarantine and other rules but said they were sticking to "zero-COVID." Meanwhile, an upsurge in infections that pushed daily cases above 30,000 for the first time has led local authorities to impose restrictions residents complain exceed what is allowed by the national government.

The fire deaths in Urumqi triggered an outpouring of angry questions online about whether firefighters who needed three hours to extinguish the blaze or victims trying to escape might have been obstructed by locked doors or other controls. Authorities denied that, but the disaster became a focal point for public anger about anti-disease restrictions, ruling party propaganda and censorship.

In Shanghai, protesters gathered at Middle Urumqi Road at midnight with flowers, candles and signs reading "Urumqi, November 24, those who died rest in peace," according to a participant who would give only his family name, Zhao.

Zhao said one of his friends was beaten by police and two were pepper-sprayed. He said police stomped on his feet as he tried to stop them from taking his friend away. He lost his shoes and left barefoot.

According to Zhao, protesters yelled slogans including "Xi Jinping, step down, Communist Party, step down," "Unlock Xinjiang, unlock China," "do Shanghai, Nanjing, Chengdu and Chongqing in the southwest and Urumqi and Korla in Xinjiang.

A video that said it was shot in Urumqi showed protesters chanting, "Remove the Communist Party! Remove Xi Jinping!"

Protests in Xinjiang are especially risky following a security crackdown against Uyghurs and other mostly Muslim ethnic minorities that has included mass detentions.

Most protesters in the videos were members of China's dominant Han ethnic group. A Uyghur woman in Urumqi said Uyghurs were too scared to take to the streets.

"Han Chinese people know they will not be punished if they speak against the lockdown," said the woman, who asked not to be identified by name for fear of retaliation. "Uyghurs are different. If we dare say such things, we will be taken to prison or to the camps.'

Two Urumqi residents who declined to be named for fear of retribution said large-scale protests occurred Friday night. One of them said he had friends who participated.

The AP pinpointed the locations of two of the videos of the protests in different parts of Urumqi. In one video, police in face masks and hospital gowns faced off against shouting protesters. In another, one protester spoke to a crowd about their demands. It was unclear how widespread the protests were.

Xi has defended the strategy as an example of the superiority of the Chinese system compared with the United States and other Western countries, which politicized the use of face masks and had difficulties enacting widespread lockdowns.

But support for "zero-COVID" has cratered in recent months, as tragedies sparked public anger. Last week, the government of the central city of Zhengzhou apologized for the death of a 4-month old girl who was in quarantine. Her father said his efforts to take her to a hospital were delayed after ambulance workers balked at helping them because he tested positive for the virus.

The Uyghur woman in Urumqi said she had been unable to leave her apartment since Aug. 8, and was not even allowed to open her window. On Friday, she and her neighbors defied the order, opening their windows and shouting in protest. "No more lockdowns! No more lockdowns!" they

screamed, according to the woman.

Public health director Dr Niranjan Mishra said this is a comprehensive plan covering the entire gamut from Hepatitis A, B, C, D and E, and the whole range from prevention, detection and treatment to mapping treatment outcomes."As part of the programme, hepatitis screening and treatment are going on in all districts with a focus on people below poverty line, underprivileged, migrants, transgenders, labourers and high risk population, including elderly persons, pregnant and lactating



their city had been won back, but lamented that they couldn't stay.

"It is sad that we are leaving our home," said Yevhen Yankov, as a van he was in inched forward. "Now we are free, but we have to leave, because there is shelling, and there are dead among the population."

Poking her head out from the back, Svitlana Romanivna added: "We went through real hell. Our neighborhood was burning, it was a nightmare. Everything was in flames."

Emilie Fourrey, emergency project coordinator for aid group Doctors Without Borders in Ukraine, said an evacuation of 400 patients of Kherson's psychiatric hospital, which is situated near both an electrical plant and the frontline, had begun on Thursday and was set to continue in the coming days.

Ukraine in recent days has faced a blistering onslaught of Russian artillery fire and drone attacks, with the shelling especially intense in Kherson. Often the barrage has largely targeted infrastructure, though civilian casualties have been reported. Repair crews across the country were scrambling to restore heat, electricity and water services that were blasted into disrepair.

Russia has ratcheted up its attacks on critical infrastructure after suffering battlefield setbacks. A prominent Russian nationalist said Saturday the Russian military doesn't have enough doctors, in what was a rare public admission of problems within the military.

In the capital Kyiv, President Volodymyr Zelenskyy oversaw a busy day of diplomacy, welcoming several European Union leaders for meetings and hosting an "International Summit on Food Security" to discuss food security and agricultural exports from the country. A deal brokered by the U.N. and Turkey has allowed for safe exports of Ukrainian grain in the Black Sea amid wartime disruptions that have affected traffic.

"The total amount we have raised for 'Grain from Ukraine' is already about \$150 million. The work continues," Zelenskyy said in his nightly TV address. "We are preparing up to 60 ships. All of us together do not just send Ukrainian agricultural products to those countries that suffer the most from the food crisis. We reaffirm that hunger should never again be used as a weapon."

CII urges RBI to moderate pace of interest rates hikes

NEW DELHI: India Inc has begun to feel the adverse impact of RBI's interest rate hikes of 190 basis points in the current financial year, industry body CII said on Sunday, as it urged the central bank to consider moderating the pace of its monetary tightening ahead of the forthcoming policy.

CII's analysis of results of 2,000-odd companies in the second quarter (July-September 2022) shows that both the top-line and bottom-line have moderated on a sequential and annual basis.

Thus, moderation in the pace of monetary tightening is the need of the hour, it argued.

Further, with rising global risk aversion adversely impacting our foreign capital inflows, CII stated that it poses challenges for financing India's current account deficit.

In fact, the country needs to keep a watch on capital flows across all three buckets -- foreign direct investment (FDI), NRI flows and foreign portfolio flows (FPI).

High focus only on FPI numbers may not always provide a complete picture, it cautioned.

CII stressed that the incipient signs of domesticrecovery need to be preserved to help accelerate movement towards a normalised growth scenario. "As in the past, the RBI should use all the weapons in its arsenal to ensure that while through its actions inflationary expectations are well anchored, it should in no way muzzle the growth impulses," it said. The rate-setting Monetary Policy Committee (MPC) of the RBI will announce its interest rate decision in the first week of December. under a U.N.-brokered deal but have still been far short of pre-war levels, driving up global prices.

"Today, we stand united in stating that hunger must never again be used as a weapon," Scholz said in a video message. "That is why we cannot tolerate what we are witnessing: The worst global food crisis in years with abhorrent consequences for millions of people – from Afghanistan to Madagascar, from the Sahel to the Horn of Africa."

He said Germany, with the U.N.'s World Food Program, will provide an additional 15 million euros for further grain shipments from Ukraine.

Scholz spokes as a cross-party group of lawmakers in Germany are seeking to pass a parliamentary resolution next week that would recognize the 1930s famine as "genocide." Last year Ukraine and Russia provided around 30% of the world's exported wheat and barley, 20% of its corn, and over 50% of its sunflower oil, the U.N. has said.

Russia says 'fortifying' annexed Crimean peninsula as Ukraine reclaims Kherson region In a post on the Telegram social network on Saturday, Kyiv Mayor Vitali Klitschko said more than 3,000 specialists for a local utility continued to work "around the clock" and had succeeded in restoring heat to more than more than 90% of residential buildings. While about one-quarter of Kyiv residents remained without electricity, he said water serviced had been returned to all in the city. The scramble to restore power came as Bel-

gian Prime Minister Alexander De Croo met Saturday with Zelenskyy in Kyiv.

they have a common agenda for the country while BJD is totally focused and committed to the interest of Odisha alone.

The regional party guaranteed the people to upkeep the state's art, culture, heritage, language and all other aspects of life. Women back BJD as the Naveen government takes stringent actions against those involved in heinous crimes against women and children. However, the same commitment was not seen after the 2019 elections and BJD, according to public perceptions, became an unofficial ally of the Narendra Modi-led NDA government at the centre. Be it demonetization or amendment of the MMDR Act, Odisha's BJD supports the Modi government and in the process has acquired the fame of being a "trusted friend" of the BJP-led government.

This is not all, of late after 2019 general elections, the BJD also stopped its "Central Negligence" cry and never hit the streets even as the Union Government failed to control price-rise. In the pre-2019 era, one saw BJD leaders Sanjay Das Burma and Ananta Narayan Jena protesting in streets of the capital city after the Centre raised paltry sums on petrol or cooking gas. These activities on the streets give a clear message to the people that the BJD as a regional party has been fighting for the common people and is worried over the price rise and unemployment. The regional party even remained silent when the centre decided to impose GST on "Chuda", "Mudhi" and even raised the GST to 18 per cent on kendu leaf trade. Of late, Naveen ahead of the Padampur by-poll has written to the Centre to withdraw GST on kendu leaf on which about 8 lakh poor families depend.

While the party MLAs and MPs are clueless about the BJD's "devoted support" (even offering a RS seat to BJP candidate) and refraining from the central bashing policy, many fear to raise the issue. An interesting episode of the BJD's policy of not opposing the BJP government came to the fore when State Agriculture Minister, Ranendra Pratap Swain openly said at the Baramunda ground meeting that he has been restricted from speaking on the issue. The television channel showed the video-clip as to how a senior party functionary rushed to Swain at the dais while he

According to CII, domestic demand is recovering well as mirrored by the performance of a host of high-frequency indicators.

However, the prevailing global 'polycrisis' is likely to impinge on India's growth prospects too.

"Given the headwinds to domestic growth mainly emanating from the global uncertainties, the RBI should consider moderating the pace of its monetary tightening from the earlier 50 basis points," the industry body stated.

While CII is cognisant of the fact that RBI's interest rate hikes of 190 basis points so far in this fiscal have been warranted to tame inflationary pressures, the corporate sector has now started to feel its adverse impact, it said.

However, given the sticky core inflation at around the 6 per cent mark, the RBI could consider hiking the key interest rates by an additional 25 to 35 basis points to tame inflation, it suggested.

It pointed out that notwithstanding the recent moderation noted in the CPI headline print in October 2022, inflation continues to remain outside RBI's target range for 10 consecutive months.

With a yawning gap existing between credit and deposit growth, an additional rate hike will incentivise savers, thus providing an impetus to deposit growth and helping narrow the credit-deposit wedge, the Confederation of Indian Industry (CII) said.

The PM said the outbreak of the COVID-19 pandemic in a big country like India was terrifying.

"The whole world faced such a terrifying pandemic. If someone gets sick at our home, we take four to five years to come out of it (financial effect). We faced the pandemic in such a big country. But the way we came out of it, the entire world is amazed. They are not able to understand how it happened," Modi said.

"Factories got closed; people had to go back to their villages. In such circumstances, our first concern was there should be enough food for poor people; a child of a poor should not go to sleep without food. So we have been providing free ration to 80 crore people for the last three years," he said.

"Secondly, to fight the pandemic, vaccination was crucial. Even now, many countries are struggling to vaccinate their entire population. We have given more than 200 crore doses of anti-coronavirus vaccine. After two doses, we provided a booster dose also free," Modi said.

The prime minister said that the Digital India campaign has brought about a revolution in the country. If the Congress was in power, your mobile bill could have been around Rs 4,000 to 5,000 per month, which is minimal now. "We made data affordable," he said. Speaking on the Pradhan Mantri Awas Yojana (PMAY), he said that in the past, specifications of houses built under government schemes were set by the people sitting in Gandhinagar or Delhi.

"But we changed the rules. How can a person sitting in Delhi know what is the requirement of a tribal person who is in poultry farming? We said that you should trust our people as nobody will build an inferior quality home for themselves," the prime minister said. attempted to speak against the Centre and its alleged negligence towards Odisha.

The change of stand by the BJD seems to be affecting its image as a regional party, which is the core strength of the party and basis to win the trust of the people. "What is left in BJD if it loses its regional identity and rubs shoulders with BJP leaders in Delhi? In the era of social media, it is difficult to hide reality from the people even living in remote corners of the state. People now realize everything and it is difficult to tell them that BJD has no such cordial relations with BJP," a senior lawmaker said.

The senior BJD leaders who used to remain silent for long, realized that during the election campaigning in Dhamnagar, the BJD did not raise the issue of central negligence and also the price rise. Therefore, voters did not see any difference between the two rival parties and Suraj could win the election out of the BJD's policy.

However, of late, the BJD in its Legislature Party meeting on November 24, has resolved to raise the issue of central negligence in the Assembly. However, the decision was mostly to counter the opposition Congress and BJP which has announced to corner the governing party in the House over the woman blackmailer's sextortion racket, farmers' plights and others.

Though the BJD, may be due to political compulsion and to counter the opposition, has decided to raise central negligence issues, was yet to keep it in its agenda in the on-going Padampur by-poll campaign. The senior party leaders, who contributed to formation of BJD as a regional party, however, privately opined that the people must be convinced that the Naveen's party is different from national parties and is committed to the interest of Odisha alone.

FIFA World Cup: Varane's return lifts French mood even higher

DOHA: Kylian Mbappe's goals took defending champion France into the knockout round of the World Cup. Raphael Varane's return gave the French camp an added reason to celebrate.

The pre-tournament injury blues are fading, Les Bleus are feeling upbeat again and looking like one of the tournament favorites. Mbappe's two goals in Saturday's 2-1 win

against Denmark helped the French become the first defending World Cup champions to reach the round of 16

since Brazil in 2006. France's night was made even better by the return of Varane to the center of defense. It was the elegant defender's first game since limping off in tears after sustaining a hamstring injury playing for Manchester United on Oct. 11.

There were genuine fears his World Cup might be over, or that he wouldn't be fit enough to play in Qatar. But his 88th appearance for Les Bleus went smoothly.

"I'm very happy, very satisfied to be here. I've worked very hard and I enjoyed it a lot," Varane said after the game. "It's always special to play at a World Cup, to play for your country. I'm making the most of it." His calming presence, exceptional reading of the game and strong heading ability were on display at Stadium 974, where he played alongside Dayot Upamecano.

Varane lasted 75 minutes without any apparent discomfort, before coach Didier Deschamps gave him a breather ahead of table-topping France's final Group D game

Wednesday against Tunisia.

With France already through, it's a low-pressure match that gives Deschamps an opportunity to test another central defensive partnership with Varane alongside Ibrahima Konate — who played in the 4-1 win against Australia.

Then Deschamps can decide which pairing he prefers for the round of 16.

It was a relief for Deschamps to see Varane come through a physical encounter un-



scathed, even more so because he has so many stars missing. Ballon d'Or winner Karim Benzema; key midfielders Paul Pogba and N'Golo Kante; central defender Presnel Kimpembe, left back Lucas Hernandez, and forward Christopher Nkunku were all ruled out of the World Cup by injuries.

So it would have been a crushing blow for Deschamps to lose Varane, his best defender when France won the 2018 World Cup and a hugely-respected member of the squad.

Italy take doubles to edge USA in Davis Cup quarter-final

PARIS: Fabio Fognini and Simone Bolelli cruised to victory in the deciding doubles as Italy beat the United States 2-1 their Davis Cup quarter-final in Malaga on Thursday.

"I am really happy, I am here with my 'brother'. We played really well," said Fognini, after the pair beat Jack Sock and Tommy Paul 6-4, 6-4.

Italy, shorn of their two top players, world number 15 Jannik Sinner and 16th-ranked Matteo Berrettini, eliminated an American team led by ninthranked Taylor Fritz and Francis Tiafoe, who is in the top 20.

Lorenzo Sonego, ranked 45th, opened the tie by coming from a set down to beat Tiafoe 6-3, 7-6 (9/7).

Fritz levelled when he survived a tough first set to beat Lorenzo Musetti 7-6 (10/8), 6-3.

That set the stage for the first doubles match of the week. The first two quarter-finals were both settled after the two singles rubbers.

Fognini and Bolelli, the 2015 Australian Open champions, broke in the ninth game of the first set and the seventh game of the second to win.

Italy, the only one of the eight nations in Malaga whose football team is not at the World Cup, were roared on by strong support.

"I'm really proud of my team and of this crowd," said captain Filippo Volandri.

"It's like we are in Italy! All the players did an unbelievable job. Even Matteo who couldn't play because of injury is here and Jannik is supporting from home." USA captain Mardy Fish did not enjoy his Thanksgiving. "No doubt that was a tough day." he said. "No doubt that they were the better team today." "Their doubles, they played phenomenally well. They're a great team."

On Saturday, Italy, whose only Davis Cup title came back in 1976, will face 2019 runners-up Canada or three-time winners Germany.

Jan-Lennard Struff, ranked a lowly 152 in the world, gave Germany the lead in their quarter-final with a stunning 6-3, 4-6, 7-6 (7/2) win over 18th-ranked Denis Shapovalov.

Struff has now defeated the Canadian six times in nine meetings and on Thursday survived an 18-ace barrage from the left-hander.



Later, Felix Auger-Aliassime, the highest-ranked man in Malaga at six in the world, levelled the quarter-final with a 7-6 (7/1), 6-4 win over Oscar Ôtte, Germany's 65th-ranked player.

Auger-Aliassime unleashed 15 aces and 21 winners, converting the only break of the contest in the seventh game of the second set. The tie will be decided in the doubles when Kevin Krawietz and Tim Puetz face Shapovalov and Vasek Pospisil. Krawietz and Puetz won the decisive doubles in the qualifying round earlier this year as Germany defeated France, Belgium and Australia. On Friday, two-time champions Croatia face Australia, who have won the Davis Cup on 28 occasions, in the first semi-final.
