Behind the Art: Why is Picasso's Girl Before a Mirror worth about \$179.4 million and what does the painting really mean?

Worth 179.4 million dollars, Girl before a Mirror is yet another masterpiece by the father of Cubism Pablo Picasso. Created in 1932, the



painting depicts Picasso's mistress and his favourite muse Marie-Thérèse Walter. Currently housed in the collection at the Museum of Modern Art in New York City, USA, this painting is

known for its complex symbolism and hidden meanings that critics still decipher now. But why did Picasso paint this and what significance does it hold?

revealed to the world his secret affair with Marie-Thérèse Walter

during his marriage to Olga Khokhlova. Girl before a Mirror was reportedly Picasso's favourite portrait of his mistress. They first met when she was 17 and Picasso was 45. He introduced himself by saying "You have an interesting face, I would like to do a portrait of you". And he did just that for years. He even purchased a country house 45 miles northwest of Paris in 1930 so he could house his mistress there and be with her on weekends. Many of Marie-Thérèse Walter's portraits are very sexually charged and portray the intense love affair they had. Picasso's wife eventually left him and he

had a daughter with Marie-Thérèse Walter in 1935. But was it just the face of Marie-Thérèse Walter that attracted Picasso or was it the intense love he had for her that made him paint her in front of a mirror?

roughly in bright yellow paint. In the reflection, she appears to be older, her face sunken. Picasso has showcased how mortality is linked with humans. The background of the painting is signature Picasso style – full of vivid diamond patterns. The painting is often likened to a stained-glass window or cloisonné enamel due to the complex arrangement of colours and lines in it. Picasso used the main elements of Cubism to


the 1920s and 1930s. Why is it considered a masterpiece?

What makes this painting so well-liked and expensive is the fact that it shows how Picasso departed from traditional painting techniques such as tonality and consistency in the representation of the subject. He instead showed his mistress using flat blocks of colour covering an entire spectrum. There is also little use of light and dark that is needed to convey the volume of the objects. Picasso focussed on the two-dimensional nature of the canvas and paint. The painting also showcases the fullness of the woman's anatomy and her fertility through the curvilinear lines and circular shapes. Several art critics claim that this captures Picasso's outlook on women. Picasso has merged one of the most pervasive cultural myths about women inherited from the nineteenth century, the polarity between virgin and whore, archetypes that haunted Picasso from his earliest years. Some historians perceive the painting to showcase Death. It is said that Picasso may have been influenced by a painting belonging to a friend, an image of Death holding up a mirror to a woman. Picasso also liked to combine the topics of sex and death in his artworks such as his other famous painting Les Demoiselles d'Avignon (1907). Girl Before a Mirror remains one of the best works of Picasso. Another reason why millions of visitors travel each year to see this painting in person is the style in which the woman is shown. It bears a connection to traditional African art and this is no coincidence as we are well aware of the artist's admiration for work from that region. Cubism was perhaps Picasso at his best, both in terms of abstraction and also bright palettes. Whilst he worked in other ways, this approach seems to have struck the strongest chord with the public. Art prints of this painting are a popular buy among visitors and even though Girl before a Mirror was completed nearly a century ago, it still feels entirely fresh and modern. This underlines how ahead of time Picasso was and how no one has ever since compared to his artistic skills as a Cubist painter.

He had established his reputation as an essential artist and was focusing on his 22-year-old mistress and muse Marie-Thérèse Walter. 

'Emmys So White': Netizens call out award show for 'fake diversity' has undoubtedly failed

Los Angeles: The 73rd Primetime Emmy Awards concluded on a disappointing note on Monday.

been trending all over Twitter since morning. "Black host, Black announcer hell even Black music. We doing everything but win. #Emm-ysSoWhite," a social media user wrote while condemning Emmys 2021. 'Lovecraft country

won nothing tonight and 98% of the winners were white despite the amount of black talent around #EmmysSoWhite," a netizen tweeted.

This time Black performers had a strong showing at the event. But all efforts went in vain when nominees of colour failed to win most categories.

Not Garbage but a reality

In an article titled "Why Global Hunger Index is a Statistical Garbage" published in "The Times of India" on 30 October 2022,



Swaminathan Anklesaria Aiyar dubs the Global Hunger Index report as Statistical Garbage. But the index has been published since 2006, not this year.

Those who are opposing it for ranking India abysmally have never spoken or written a single word against this index in the past even when National Food Security Act was enacted during the UPA regime.

Since its beginning, India has never had a good ranking, though worsened in the present regime. But never BJP nor the Swaminathan S Anklesaria Aiyar has criticised this index. Why suddenly, there is criticism of this Index, simply because our intellectuals and many media have lost independent thinking. S Anklesaria Aiyar argues that India has little hunger but substantial child malnutrition. He says that ", the simple truth is obfuscated by the Global Hunger Index (GHI). This cannot be true since 75 per cent of rural and 50 per cent of urban families get 35 kg of grain per month at just Rs 2-3/kg. Tamil Nadu gives 35 kg of rice free. No country does better. GHI does not measure hunger, yet calls itself a hunger index to sensationalise matters. This makes headlines but is statistical garbage".

The government argues that it is doing its job by providing free grain (five kilos of rice or wheat and one kilo of dal) to 60 per cent of the population, or over 80 crore people under Pradhan Mantri Garib Kalyan Ann Yojana (PMGKAY). Why Centre extended Pradhan Mantri Garib Kalyan Ann Yojana (PMGKAY) for another three months (October 2022-December 2022). The answer can only be that they are hungry, and need it. That is why are so many Indians queueing up each month for free rations.

Further, people's purchasing power should be enhanced in such a way that they can afford

to buy food grains from the market. The government is financ-

ing this scheme by not raising resources by taxing rich/corporates but by imposing GST on food items and higher excise taxes on petroleum products. What government gives to the poor through this scheme, takes out more through indirect taxes which ultimately

impoverishes poor and hungry people

Further, the government is government should not forget that as per the World Bank, nearly 5.6 crore Indians have been pushed into extreme poverty during the Covid pandemic. According to UNDP's Multidimensional index, 16.4 per cent in 2019/21 in India are multidimensionally poor which translates into the largest number of poor people at 22.8 crores, the same as what the hunger index shows. According to Hunger Index, 22.43 crore people in India are considered undernourished out of the total 82.8 crore people undernourished globally.

It is true that India made some improvements between 2000 to 2014. But overall, other countries have improved more than India. As a result of which India is abysmally placed. While the government is rejecting this report should contemplate that not in this index only, in almost all indexes such as human development, global happiness index, and UN sustainable development Index India is abysmally placed., India is behind 141 countries in terms of per capita income

But the Indian government fails to differentiate between hunger and undernutrition or undernourishment. The above data is on undernutrition and undernourishment but not on hunger, though the name is given as the hunger index. According to the UN's Hunger Report, hunger is the term used to define periods when populations are experiencing severe food insecurity—meaning that they go for entire days without eating due to lack of money, lack of access to food, or other resources. Hunger is the distress associated with a lack of food.

Yes, this index deals with undernutrition, and undernourishment. The threshold for food

Undernutrition is one aspect of malnutrition. Malnutrition refers more broadly to both undernutrition and overnutrition (problems with unbalanced diets). Malnutrition refers to deficiencies, excesses, or imbalances in a person's intake of energy and/or nutrients. The term malnutrition covers 2 broad groups of conditions. One is "undernutrition"which includes stunting (low height for age), wasting (low weight for height), underweight (low weight for age), and micronutrient deficiencies or insufficiencies (a lack of important vitamins and minerals).

Overnutrition as part of malnutrition is reflected through overweight, obesity, and dietrelated noncommunicable diseases (such as heart disease, stroke, diabetes, and cancer). But Undernutrition goes beyond calories to signify deficiencies in energy, protein, and/ or essential vitamins and minerals. Undernutrition makes children in particular much more vulnerable to disease and death.

But Undernutrition goes beyond calories to signify deficiencies in energy, protein, and/ or essential vitamins and minerals Food security relates to food availability, access, and utilization. When a person always has adequate availability and access to enough safe and nutritious food to maintain an active and healthy life, they are considered food secure. It measures food security across most countries of the world. It was first published in 2012, and is managed and updated annually by The Economist's intelligence unit.

Those parameters are Nutritional standards, Urban absorption capacity, Food consumption as a share of household expenditure, Food loss, Protein quality, Agricultural import tariffs, Diet diversification, Agricultural infrastructure, Volatility of agricultural production, Proportion of population under the global poverty line, Gross domestic product per capita (US\$ PPP), Presence of food safety net programs, Access to financing for farmers, Public expenditure on agricultural R&D, Corruption, Political stability risk, Sufficiency of supply, Food safety.

Pollution affects Beauty

The rising air Pollution has become a buzzword nowadays and is affecting the normal functioning of life due to toxic air and a heavy blanket of smog. Airborne pollutants on human skin can contribute to skin aging, atopic dermatitis, skin discoloration,



eczema, psoriasis, and acne and can be absorbed through the skin into the body, causing a wide range of diseases. While pollution takes a toll on the environment and health but it also affects natural beauty very adversely. Pollution breaks down collagen and oxidizes the lipid layer in the skin, which

impairs skin barrier function. Smog particles result in dehydration, sensitivity, uneven skin tone, dullness, acne, and premature aging.

Highly toxic air containing smoke, soot, acid, and other pollutants severely affects the skin by draining away skin moisture which leads to allergies and pigmentation spots on the forehead and cheeks on dry and rough skin.

The toxic haze hanging in the sky cause uneven skin tone, accelerated ageing, wrinkles, and black spot on the face

Among the other organs of the body, the skin is also one of the first to bear the brunt of air pollutants, which not only attack the skin's surface but also lead to an accumulation of toxins. In fact, they are potent skin irritants. There are both long and short-term effects of pollutants. Chemical pollutants cause oxidation damage and this can lead to the manifestation of premature ageing signs on the skin, like wrinkles, loss of elasticity, dark patches, spots, etc. Chemical pollutants also disrupt the normal balance of the skin and scalp, leading to problems like dryness, sensitivity, rashes, acne, ir-

For oily skin, cleansing milk or face wash may be used. For oily skin, also use a facial scrub after cleansing. Look out for products with ingredients like sandalwood, eucalyptus, mint, neem, tulsi, aloe vera, etc., when you buy cleansers. The anti-toxic and tonic properties of such ingredients have helped in clearing the skin congestion and eruptions that result from exposure to chemical pollutants. Aloe vera, for example, is also a powerful moisturizer and an anti-oxidant. So are ingredients like apricot kernel oil, carrot seed, wheatgerm oil, etc. the skin needs to be protected. It suits all skin types and increases the skin's moisture retention ability too.

The hair also needs frequent washing if one regularly travels long distances for their work. Pollutants also collect on the scalp. Shampoo, hair rinses, serums, and conditioners help to restore normal balance if they contain ingredients like amla, Brahmi, Triphala, bhringaraj, and henna. They also coat the hair and form a protective cover. Mix one teaspoon each of vinegar and honey with one egg. Massage the mixture lightly into the scalp. Leave on for half an hour and then wash the hair. Rinse well with wa-

Or, give the hair hot oil therapy. Heat pure coconut oil and apply it to the hair. Then dip a towel in hot water, squeeze out the water and wrap the hot towel around the head, like a turban. Keep it on for 5 minutes. Repeat the hot towel wrap 3 or 4 times. This helps the hair and scalp absorb the oil better. Leave the oil on overnight and wash your hair the next day.

The impurities and pollutants can also affect the eyes, causing burning or redness. The eyes should be washed with plain water several times. Soak cotton wool pads in chilled rose water and use them over the eyes as eye pads. Lie down and relax for fifteen minutes. This really helps to remove fatigue and brightens the eyes.

My advice is while rely on healthy eating, drinking water, and regular exercise to keep your skin healthy. Making the right choices about our skincare regimen is an equally or even more important part of a successful beauty routine.

It's a rough deal for your skin, but there are plenty of ways to care for it in the face of pollution.

Stage set for bypolls in Mokama, Gopalganj, Adampur, Munugode, Gola, Dhamnagar, Andheri East

eyes are on the bypolls for seven seats in six states, ahead of voting on November 3. Their results hold symbolic importance for political parties. Chief ministers and other senior leaders made last-minute appeals to voters on Tuesday for their support in Mokama and Gopalganj of Bihar, Adampur of Haryana, Munugode of Telangana, Gola of Uttar Pradesh and Dhamnagar of Odisha.

In Andheri (East) of Maharashtra, the BJP has pulled out of the race after the Shiv Sena faction led by Uddhav Thackeray fielded the wife of its deceased MLA Ramesh Latke from the constituency. Rutuja Latke is expected to

score an easy victory in the election which is the first after the recent split in the Shiv Sena following a rebellion by Eknath Shinde, who replaced Thackeray as the Maharashtra chief minister. The counting of votes will take place on November 6. **BIHAR**

Bihar's Mokama and Gopalganj by-elections will be the first electoral contest after the Nitish Kumarled JD(U) snapped ties with the BJP in August and again joined hands with the RJD.

The seats were held by the RJD and the BJP respectively. Chief Minister Nitish

Kumar urged voters of Mokama to support Neelam Devi, the RJD candidate and wife of his former protégé Anant Kumar Singh whose disqualification has necessitated the by-election.

Kumar made the appeal in a video message after he stayed away from the campaign due to an injury.

"I have not been able to come myself, but I appeal to all people of Mokama to ensure a massive victory of Neelam Devi, the Mahagathbandhan candidate who is contesting on the RJD's hurricane lamp symbol," Kumar added.

Deputy CM and RJD heir apparent Tejashwi Yadav, however, led from the front and addressed several rallies.

Anant Kumar Singh was disqualified earlier this year upon conviction in a case relating to the recovery of arms and explosives from his residence.

The BJP has nominated from the seat greenhorn Sonam Devi, wife of a local muscleman Lalan Singh who has been opposing Anant Singh. In Gopalganj, BJP has fielded Kusum Devi, the wife of deceased party MLA Subhash Singh.

The RJD has fielded Mohan Gupta, while Indira Yadav, wife of Lalu Yadav's brother-inlaw Sadhu Yadav, is contesting as Bahujan Samaj Party (BSP) candidate.

Bhubaneswar (KCN): Adolescent girls from different districts of Odisha interacted with a team of representatives from various countries on their journey as champions to End Child Marriage in Odisha

Twenty girls interacted with international visitors in Bhubaneswar and shared their stories of courage and determination, with many of them having resisted meetings at the anganwadi centers.

The girls also asked questions to the team on gender inequality in western countries, the value of education as the only path to success and about the minimum age of marriage in other countries.

"While education is important, a person can learn through experiences as well," said Isabelle Solon Helal, Deputy Director, Global Affairs Canada. She

said children can volunteer with their communities, take up a sport, learn a new craft and add more dimensions to their education which needn't only be through schools and colleges.

Ritika Dhall, Assistant Director, Gender Equality, Norad from Norway said gender inequality is often hidden. It may show in difference in salaries in men and women even though they do the same work. "We need to work around the world to ensure equality is understood and practiced," she said.

Launched in 2016 the Global Programme to End Child Marriage covers 12 countries - Bangladesh, Burkina Faso, Ethiopia, Ghana, India, Mozambique, Nepal, Niger, Sierra Leone, Uganda,

Global Programme promotes the rights of adolescent girls to avert child/early/forced marriage and pregnancy and enables them to achieve their aspirations through education and alternative pathways. It supports households in demonstrating positive attitudes, empowers girls to direct their own futures, and strengthens the services that allow them to do so. The adolescent girls shared their stories of courage and journey as peer leaders and also asked questions to the visitors. "My parents wanted to me to get married when I was 15-years-old. I was scared of the consequences if I refused. But I spoke to Anganwadi didi and together with district administration officials, they convinced my parent not to go ahead with the marriage. They helped me to enrol in the Industrial Training Institute where I learnt tailoring. Today I earn Rs 8,000 a month and proudly support my family," said Malati Pujari from Nabarangpur. Suprava Subhadarshini Behera, 16 years, from Kandhamal is training to be an electrician. Like Malati, her marriage was fixed in July this year. She too reached out to the anganwadi worker and with her help could stop her marriage. Both the girls, like many others in the state, have been benefitting from the Advika initiative that teaches life skills to adolescents through weekly



Yemen and Zambia. It is the first United Nationsled joint initiative designed with a focus on promoting the rights of adolescents to delay marriage, supporting adolescents to realize their rights by engaging with communities, and strengthening systems that deliver critical services to adolescents, including health and education. In Odisha UNICEF and UNFPA, through support

In Odisha UNICEF and UNIFPA, through support from GPECM, work across all 30 districts to promote life skills for adolescents, improve overall well-being including sexual and reproductive health and build more capacity within the government systems to prevent child marriage and build linkages to skilling and livelihood opportunities. The programme also promotes positive behaviour changes and social norms to empower girls and provide equal opportunities to girls and boys.

Prior to the interaction with the adolescents, the donors visited Ganjam and Gajapati districts to understand the joint work between UNICEF and UNFPA on ending child marriage by interacting with multiple partners, adolescents, community members including Panchayat representatives and women's groups. They also interacted with the District Task Force on ending child marriage and adolescent empowerment.

Our aim is to keep 'Arjuna's eye' on inflation: RBI Governor

MUMBAI: The Reserve Bank of India wishes to concentrate on inflation in the same way as Arjuna focussed on hitting the eye of a revolving fish in the epic Mahabharata, Governor Shaktikanta Das said on Wednesday.

"No one can match the prowess of Arjuna, but our (RBI's) constant effort is to keep an Arjuna's eye on inflation," Das said at the annual FIBAC conference of bankers here.

The remarks come at a time when inflation is ruling high and RBI will soon be explaining to the government about the reasons for overshooting the inflation target for nine consecutive months.

Probably hinting at various factors which influence his own fight against inflation, Das said Arjuna would have assessed the speed at which the fish was revolving, the prevailing wind conditions, the intensity of the ripples in the pool of water below and the noise levels in the king's court while aiming t the fish.

Satyajit Das: No way back for emerging markets now, India may at best muddle through

Das also defended RBI's strategies in the recent past amid criticism over price rise.

He said the country would have had to pay a heavy price if RBI had begun tightening earlier than when it did, hinting that the process of recovery had to take root in the economy first.

Das also said that RBI's rate-setting panel will be meeting on Thursday to formulate a reply which will detail the circumstances that led to missing the inflation target and the corrective measures it plans to undertake. Further, the governor said RBI chose to utilise the flexibility available in the monetary policy framework to tolerate a slightly higher inflation which was within the 2-6 per cent target range to ensure that overall economy remained resilient and financial stability was maintained.

Russia rejoins wartime deal on Ukrainian grain exports

Turkish President Recep Tayyip Erdogan said Russian Defense Minister Sergei Shoigu informed Turkey's defence minister that the deal for a humanitarian grain corridor would "continue in the same way as before" as of noon Wednesday.

Erdogan said the renewed deal would prioritize shipments to African nations, including Somalia, Djibouti and Sudan, in line with Russia's concerns that most of the exported grain had ended up in richer nations since Moscow and Kyiv made separate agreements with Turkey and the U.N. in July.

Poor nations hinge on Ukraine-Russia grain deal U.N. humanitarian chief Martin Griffiths said Monday that 23% of the total cargo exported from Ukraine under the grain deal went to lower or lower-middle-income countries, which also received 49% of all wheat shipments.

Ships loaded with grain departed Ukraine on Tuesday despite Russia halting its support for the agreement, which aimed to ensure the safe passage of critical food supplies meant for parts of the world struggling with hunger. But the United Nations had said vessels would not move Wednesday, raising concerns about future shipments.

The United Nations and Turkey brokered separate deals with Russia and Ukraine in July to ensure Africa, the Middle East and parts of Asia would receive grain and other food from the Black Sea region during Russia's eight-month-old war in Ukraine. Ukraine and Russia are key global exporters of wheat, barley, sunflower oil and other food to developing countries where many are already struggling with hunger. A loss of those supplies before the grain deal was brokered in July surged global food prices and helped throw tens of millions into poverty, along with scaring energy costs:

The grain agreement brought down global food prices by about 15% from their peak in March, according to the U.N. Losing Ukrainian shipments would have meant poorer countries paying more to import grain in a tight global market as places like Argentina and the United States deal with dry weather, analysts

After the announcement of Russia rejoining the deal, wheat futures prices erased the increases seen Monday, dropping more than 6% in Chicago.

At least a third of the grain shipped in the last three months was going to the Middle East and North Africa, and while a lot of corn was going to Europe, 'that's the traditional buyer for Ukraine corn. It's not like that was so unusual," Joseph Glauber, a senior research fellow at the International Food Policy Research Institute in Washington, said. He added that more wheat was going to sub-Saharan Africa and Asian markets that have become increasingly important buyers of Ukrainian grain.

Ukraine under 'cloak of darkness'
In Ukraine on Wednesday, thousands of homes in the Kyiv region and elsewhere remained without power, officials said Wednesday, as Russian drone and artillery strikes continued to target Ukraine's energy infrastructure. Kyiv region Gov. Oleksiy Kukeba said 16,000 homes were without electricity and drones attacked energy facilities in the Cherkasy region south of the capital, prompting power outages.

Although power and water were restored to the city of Kyiv, Kuleba didn't rule out electricity shortages lasting "weeks" if Russian forces continue to hit energy facilities there. In a Telegram post, he accused Russian forces of trying to prompt a serious humanitarian crisis

Power outages were also reported in the southern cities of Nikopol and Chervonohryhorivka following "a large-scale drone attack," Dnipropetrovsk Gov. Valentyn Reznichenko said. The two cities are located across the Dniper River from the Zaporizhzhia Nuclear Power Plant, Europe's largest nuclear facility. Russia and Ukraine have for months traded blame for shelling at and around the plant that U.N.'s nuclear watchdog warned could cause a radiation emergency.

Kremlin's attacks continue

Continued Russian shelling across nine regions in southern and eastern Ukraine resulted in the deaths of at least four civilians and the wounding of 17 others between Tuesday and Wednesday, according to the office of Ukrainian President Volodymyr Zelenskyy. The shelling also pounded cities and villages retaken by Ukraine last month in the northeastern Kharkiv region, wounding seven people.

Russian fire damaged a hospital, and apartment buildings in the Donetsk region city of Toretsk. Donetsk Gov. Pavlo Kyrylenko said Wednesday that Ukrainian and Russian forces continued to fight for control of the cities of Avdiivka and Bakhmut, both key targets of a Russian offensive in the region.

In southern Úkraine, Russian-installed authorities in the occupied Kherson region relocated civilians some 90 kilometres further into Russian-held territory in anticipation of a major Ukrainian counteratack to recapture the provincial capital of the same name. Russian forces dug trenches to prepare for the expected ground assault. The Kherson region's Kremlin-appointed officials on Tuesday expanded an evacuation area to people living within 15 kilometres of the Dnieper River. They said 70,000 residents from the expanded evacuation zone would be relocated this week, doubling the number moved earlier.

AirAsia sells remaining stake in AirAsia India to Air India

NEW DELHI: Malaysia's AirAsia on Wednesday said it has entered into a pact with Air India to sell its remaining stake in budget carrier AirAsia India. Tata group and the Malaysian entity-owned AirAsia India started flying in June 2014.

In a statement, AirAsia Aviation Group Ltd said it has entered into a share purchase agreement to sell the remaining equity shares held in AirAsia India to Air India. It did not provide any specific details. AirAsia India was a joint venture between Tata Sons and Air Asia Investment Ltd. Tata Sons had an 83.67 per cent stake and the latter owned a

16.33 per cent shareholding.
In June, the Competition Commission of India approved the proposed acquisition of the entire shareholding of AirAsia India by Air India.

Group CEO of AirAsia Aviation Group Bo Lingam said that since 2014, "when we first commenced operation in India, AirAsia has built a great business in India, which is one of the world's biggest civil aviation markets".

"We have had a great experience working with India's leading Tata Group. This is not the end of our relationship but the beginning of a new one as we explore new and exciting opportunities to collaborate and enhance our synergies moving forward," he said.

Further, he said, the pandemic has allowed it to reexamine the priorities and "we felt that it was best suited for AirAsia to develop an Asean-only business".

In a new move, NADA to CHENNAI: In what could be a first, the National Anti-Doping Agency (NADA) has acted against a coach for administering a prohibited substance to an athlete. The NADA found athletics coach Mickey Menezes violating its Anti-Doping Rule 2021 and has banned him for four years from coaching/training. It has also fined the coach Rs. 50,000. The coach had already been suspended by the Maharashtra Athletics Association after trainee, Kirti Bhoite, alleged he had given her a banned substance that led to a letics Association after trainee, Kirti Bhoite, alleged he had given her a banned substance that led to a positive dope test during the Khelo India Youth Games in Guwahati in 2020. This newspaper reported the infraction in May 2022. The NADA too initiated proceedings against the coach on May 12, 2022, for the administration of the prohibited substance to the sprinter (Kirti) and complicity (under NADA Anti-Doping Rule 2021 Article 2.8 and 2.9 — see below). According to the order, NADA invoked clause ADR 2021, 10.3.3 and read with rule 10.12, and banned him for four years. A fine was also imposed

The coach, however, did not appear before the NADA's Anti-Doping Disciplinary Panel (ADDP) on the day of the hearing. "The hearing was attended by Yasir Arafat, a NADA law officer. The coach did not appear before the hearing panel," said the order. Menezes, however, had filed a written submission. In his reply he said that "he (coach) has mission. In his reply, he said that "he (coach) has recommended supplements to the parents of the trainees and purchased those supplements for athletes on a payment basis. He (coach) has purchased supplements such as proteins, amino acids, energy driple and pro workouts."

The coach said that the supplier had informed him about the new product, which "is beneficial for sprint athletes and is also completely dope free". Accordathletes and is also completely dope free". According to the order, "he was under bonafide belief that the product was dope free". He also said he was "in shock" when he learned about Kirti's positive test. What seems more intriguing is that the supplier then changed his statement. "The supplier said that the product gets washed out in 10 days. He also said that the product was completely dope free..." He went on to say that "he was only intending to give her supplements which are dope free and only to enhance her strength through these supplements." He said it was the fault of the supplier and "he had no intention to give a supplement which was not

dope-free to Kirti or to any other athlete." However, the ADDP comprising Dr Bikas Medhi, Charu Pragya (chairman) and Kalyan Chaubey found that his conduct was an anti-rule violation. The order said the coach is a former athlete and must be aware of antidoping rule violations. "The ADR cast the duties on the athlete support personnel to be knowledgeable of any comply (sic) with Anti-Doping Rule."

Kirti, who was handed a four-year suspension by the ADDP, got a reduced two-year sanction after an appeal on the ground that "she has not consumed any prohibited substance intentionally, rather it was the fault of her coach".

any prohibited substance intentionally, rather it was the fault of her coach". Interestingly, there has been a major change in the way NADA has been tracking and testing athletes this year. Top players are being tested and even hearings are getting over within three months. If they find a discrepancy in the ADDP ruling, like in the case of Asian Games gold medallist MR Poovamma, they shall appeal and get sanctions imposed. With the Anti-Doping Act in force, the NADA will have more power especially to search and seize, but get more power, especially to search and seize, but getting top athletes in its net is something positive.
