Bhubaneswar(KCN): Chief Minister Naveen Patnaik on Tuesday announced interest-free loan upto Rs 5 lakh for the women self-help group (WSHGs).

Till now, the State Government was providing interest-free loan upto Rs 3 lakh to the SHGs.

The announcement will be implemented retrospectively from April, 2022 and this move would benefit around 70 lakh women associated with six lakh self-help groups.

Describing this as a revolutionary step, the Chief Minister said that through this enhancement, the Mission Shakti groups can establish themselves as Small

and Medium Enterprises. The lakhs of SHGs can take big loans to start big business, he

He said that women are playing pivotal roles in the transformation of Odisha. Today's decision will play a major role in empowering them and strengthening the local economy, Patnaik said.

Stating that the goal of the state government is to make Mission Shakti members as small and medium entrepreneurs, the Chief Miniswould be able to establish themselves as successful entrepreneurs.

As per the promise made by the state government, businesses worth Rs 4000 crore to the Mission Shakti groups in the last 3 years, the CM said.

Rs 3 lakh to encourage the Mission Shakti groups, Patnaik said that the state government has provided Rs 500 crore of interest to the bank accounts of four lakh SHGs in this programme.

Describing Mission Shakti as an innovative

initiative towards women empowerment, the Chief Minister said that it has brought together 70 lakh mothers of the state through 6 lakh Self Help Groups.

To take the movement further, the state government has set up a separate Mission Shakti department and all SHG programs are being implemented through this

As per information that two of the assailants returned to the BRPL road on a bike while the other two ran away through the hills in front of the house. Two of his relative Benudhar Apat and Dayanidhi Apat accused villagers for the incident. According to Dayanaidhi, they remain aloof from the villagers because of some political reason and the entire villagers are against him after election. suspects that the people of the village may be behind the murder. However dead bodies are taken to Barbil CHC for autopsy.

# Knowingly or unknowingly, two movements are paralyzed, Panchaytraj and SHG

Two movements in India are hijacked first and then paralyzed to keep poverty as it is and to



carry out sustain scrupulous capitalists' economic policies.

1. Decentralization of political and economic power through three-tier Panchayat Raj where the power

narrated in state list and union list are to be given some more power and authorities to panchayats especially mines, forest and revenue, should have come to panchayat by now to the list of Panchayat Raj for decentralized people friendly development.

2. Self Help Groups, (SHGs) with their own registered social banks should have in their own control on savings, accumulated capital and on the staffs, for planning, implementation and development of their own business so that the individual poor member would have turned out just from wage earners to owner of small units of business and enterprises, being part of a supply chain of any of the local raw material or produces available in their localities.

These two movements and empowerment process were started and fought by civil society organizations from the day of independence. In 73rd constitutional amendment Panchayati Raj came in to force and SHG came in to force under NABARD's initiative in 1986-1987 and under Swarn Jayanti Gram Swarozgar Yojana (SGSY) by government of India in 1999. In 1993 Reserve bank Of India allowed SHGs to open savings bank accounts in the bank.

Today, I see panchayats the constitutionally elected body with few schemes, are left with, without work or minimal work for five long years. They are believed to be unused mass or appendix of political process of India. Still, larger mass of the country believes, including students of political science and law that, assemblies of states and parliament are only the right bodies for legislation as well

#### Vande Bharat to hit global tracks in futur

It is indeed delightful and a matter of pride for all indians to know that the Indian railways is planning to export semi high speed Vande Bharat trains by 2025-26 to Europe, South America and East Asia and to make these 'made in India' trains export ready, railways aim to clock 10-12 lakh kilometres on 75 Vande Bharat trains over the next few years. According to the railways the ecosystem to export trains has to be created over the next two to three years. The department is already on its track to manufacture 475 Vande Bharat trains in the next three years and once these run successfully there will be confidence in global markets about the product.

Vande Bharat Express trains have already already grabbed national and international attention for its speed, quality, durability and are economical. Quicker acceleration, hitech CCTV, automatic sliding doors with retractable coach footsteps and contemporary passenger amenities like onboard infotainment, GPS based passenger information system and zero discharge vacuumbased bio-toilets plus various other facilities make it passenger friendly.

The trains are modelled like the famous German ICE 3, Japanese Shinkansen and the Italian Pendolino trains. It has been designed to suit the Indian conditions.

The railways are planning to launch ten new Vande Bharat trains by Independence Day next year which will be connecting forty cities in India. #### AI becoming a boon in cardiology

Researchers found that clinicians who most frequently followed an Artificial intelligence (AI) tool's recommendations were twice as likely to diagnose low ejection fraction (EF) perfectly, a sign that the heart is not functioning as well as it should.AI is poised to revolutionise medicine. Kolkata and campaigned against noise pollution and the crackling sound of microphones. Many mocked them but none of them lost faith or

despaired.

The chairman along with a few officers of the board opened the control room during the puja and urged the people to call the control room of the board if anyone is embarrassed by the noise pollution. A new era has begun in the discharge of duties of the Pollution Control Board. On April 1, 1996, Hon'ble Justice Shri Bhagwati Prasad Banerjee delivered a historic judgment on the issue of noise pollution control. Then everything is in a running history.

Shri Bhagwati Prasad Banerjee in implementing his judgment in 1997 ordered that whoever uses a microphone in a free zone must install a sound limiter so that the sound limit never goes beyond the tolerable limit. Webel of the state government has been given the responsibility in this regard. The High Court order of 1997 has been echoed several times in judicial orders regulating noise polbeen implemented. Recently, the highest level officials of the Environment Department and Pollution Control Board have been arranging the purchase of sound limiters and the organizers of various festivals are being asked to install sound limiters with microphones. But the surprising thing is that there is no inquiry as to whether sound limiter is installed in the microphones used in all the fairs or festivals which are celebrated by government initiatives all over West Bengal.

If it is mandatory to install sound limiter in the case of private events, then it is natural to ask why sound limiter should not be installed on microphones in government fairs or political gatherings or meetings. In such a situation, our request is to immediately issue a government notification saying that microphones with sound limiters must be used in all fairs or festivals organized by the government.

All political parties need to be called and made aware of their responsibilities and duties in complying with the Noise Pollution Control Act. It should be remembered that the law is equal for all. If sound limiters are used in government functions and political gatherings, then naturally there will be a favorable situation in implementing the law in private initiatives as well.

With the tweet, he used the hashtag '#RejectBJP' to urge people not to vote for the party.

There were media reports about two deaths in Gujarat's Junagarh due to spurious liquor.

district after consuming hooch.

Hitting out at the BJP in Gujarat, Kharge asked, "Why is every section of Gujarat -- youth, farmers, women, small businessmen, Dalits, tribals, and the backward classes -- are suffering." Gujarat demands answers and accountability for the last 27 years of BJP rule, the Congress national president said.

LONDON: Fewer than half the people in England and Wales consider themselves Christian, according to the most recent census — the first time the country's official religion has been followed by a minority of the population.

Britain has become less religious — and less white — in the decade since the last census, figures from the 2021 census released Tuesday by the Office for National Statistics revealed.

Some 46.2 per cent of the population of England and Wales described themselves as Christian on the day of the 2021 census, down from 59.3 per cent a decade earlier. The Muslim population grew from 4.9 per cent to 6.5 per cent of the population, while 1.7 per cent identified as Hindu, up from 1.5 per cent.

More than 1 in 3 people — 37 per cent — said they had no religion, up from 25 per cent in 2011. The other parts of the U.K., Scotland and Northern Ireland report their census results separately.

BUCHAREST: NATO Secretary-General Jens Stoltenberg reaffirmed the military alliance's commitment to Ukraine on Tuesday, saying that the war-torn nation will one day become a member of the world's largest security organization.

Stoltenberg's remarks came as U.S. Secretary of State Antony Blinken and his NATO counterparts gathered in Romania to drum up urgently needed support for Ukraine aimed at ensuring that Moscow fails to defeat Ukraine as it bombards energy in-

frastructure. "NATO's door is open," Stoltenberg said. "Russia does not have a veto" on countries joining, he said in reference to the recent entry of North Macedonia and Montenegro into the security alliance. He said that Russian President Vladimir Putin "will get Finland and Sweden as NATO members" soon. The Nordic neighbours applied for membership in April, concerned that Russia might target them next.

"We stand by that, too, on membership for Ukraine," the former Norwegian prime minister said. 'At the same time, the main focus now is supporting on Ukraine, ensuring

that President Putin doesn't win, but that Ukraine prevails as a sovereign nation in Europe."

In essence, Stoltenberg repeated a vow made by NATO in Bucharest in 2008 — in the same sprawling Palace of the Parliament where the foreign ministers are meeting this

vows to aid Ukraine 'for as long as it takes'

Even so, Ukraine will not join NATO anytime soon. # power distribution woes: NTPC chief

NEW DELHI: Privatisation is not the only solution to problems being faced by many power distribution utilities or discoms in the country as many state-owned entities are running efficiently and making a profit, NTPC Chairman and Managing Director Gurdeep

Singh said on Tuesday.

The union government has been taking initiatives to privatise the discoms.

But since electricity is in the concurrent list of the Constitution of India, the union government could take steps to privatise discoms in the Union Territories only.

Some states including Gujarat, Odisha, and West Bengal have privatised the power distribution.

Participating in a panel discussion at ENRich 2022 organised by KPMG, Singh said, "I don't know whether privatisation is the only solution. But yes, it is one of the solutions." He said private discoms are running efficiently and making a profit and also mentioned that at the same time there are state-owned discoms which are running efficiently and also making profits.

"I had been closely associated with them

(discoms). There is not only one solution to a problem (of discoms)."

About the addition of renewable energy and phasing out coal-based thermal power plants, he opined that coal is going to stay while the NTPC will do everything to increase nonfossil fuel-based electricity generation.

> 'Our (NTPC's) growth is going to be more and more on the renewable side but we should never forget that we (NTPC) are a national utility. Our prime responsibility is that power is available and affordable and within that (framework) how we can make it much cleaner and reener. I think this is the only mantra which

really keeps guiding us," he stated. He stated that the NTPC still supplies onequarter of the electricity in the country.

"I keep telling my team that we have gone up in this (supply proportion). How we can go up in the renewable component in that (our supply proportion). But that does not mean that we are going to shut down any coal-based plants," he added.

He also stated that he has no hesitation to share that even decommissioning the coalbased plant is still a little far away.

"But we will have to do that. There is no other way. But we should not be in a hurry. What we have to do is to bring flexibility and what we should be working at is that how can we reduce emissions...we have to always keep our feet on the ground while having ambitions to fly high," he said.

What happened before Iran v. US?

Two days before the match, some social media handles of the US football federation doctored Iran's flag for a time period. They claimed they did it to stand in solidarity with the protesters in Iran following the death of Mahsa Amini. In retaliation, Iran wanted FIFA to expel US from the World Cup.

Did the US team say anything? In the prematch press conference, US coach Gregg Berhalter apologised. However, that wasn't the end of it. Iran's journalists (the context is their players have been asked a lot of questions about the protests back home from journalists from other countries as the players have seemingly supported these protests by refusing to sing the national anthem and so on) decided to question both Berhalter and captain Tyler Adams. Berhalter was asked about the presence of a vessel in the Persian Gulf. Adams was asked about 'representing a country that has so much discrimination against black people'.

What did Adams say? "... there's discrimination everywhere you go. One thing that I've learned, especially from living abroad in the past years and having to fit in in different cultures and kind of assimilating to different cultures, is that in the U.S. We're continuing to make progress every single day."

Any other thing that has happened? Iran coach Carlos Queiroz actually asked English media Afghanistan and all the women alone?" Players of almost all western European nations have been asked about the rainbow armbands (federations decided to wear them to stand in solidarity of the LGBT community in Qatar but backed out after FIFA threatened sanctions). Germany protested in a unique way by placing a hand over their mouths but didn't repeat that in their second match against Spain.

Did Germany say why they stopped?

Nope. But Ilkay Gundogan, who has a Muslim heritage, said he was 'proud' that Qatar is hosting the World Cup. It's significant because he's one of the first from a western country to express these views. "My point of view is now the politics are finished. Qatar is very proud, very proud to host it, also first muslim country, I come from a muslim family, the muslim community is proud, now it is about enjoying and celebrating football," he said.

What's in store in the next few days?

There will likely be another round of wire play after the match between Iran and US. But Serbia v. Switzerland is another hot button match. At the 2018 event, these two sides clashed. Swiss goal-scorers Granit Xhaka and Xherdan Shaqiri celebrated with a doubleeagle celebration. It's a nationalist symbol in Albania. This relates to historical political tensions in the Balkans and it didn't go down well in Serbia.

According to the report, as many as 49 per cent of male cricketers say that they would consider rejecting a national contract for a bigger domestic contract. While the likes of Trent Boult and Martin Guptill have recently asked out of the contract with New Zealand Cricket, that close to half the athletes willing to do the same feels like the tip of the iceberg.

That the international schedule is getting skewed with every FTP could have a significant role to play in it as well.

And it does not come as a surprise. Freelancing could be the future for many cricketers, especially for those who don't represent a financially wealthy cricketing body. As many as 82 per cent of the current players are not in the traditional market with just contracts at home — 42 per cent are hybrid (home and overseas) and 40 per cent are in the free agency market (with no contracts at home). For example, Singapore's Tim David, who now plays for Australia, has taken part in as many as seven overseas leagues in a year. Afghan trio — Mohammed Nabi, Rashid Khan and Mujeeb Ur Rahman — play in six. New Zealand's Glenn Phillips played as many as 59 domestic league matches in 2021 alone. That said, the interesting statistic as per the

report is this. Despite the 49 per cent willing to forgo national contracts, 80 per cent seem to favour contract security over playing in different competitions. And it seems like this stems from the lack of say they have in their rights as a player. There are concerns over late and non-payment from the leagues as well. 54 per cent of the players feel insecure or very insecure about their cricket employment and 46 per cent say their relationship with the board is poor or very poor. 44 per cent believe they do not have a clear voice in the future direction of the game.

This brings the focus on the rights and employment concerns of the players with the governing bodies. 13 per cent say they have been made to feel uncomfortable by their respective boards for being a member of a players' association. And this is at a time when many cricketing bodies do not have an actively participating players' associa-

In India, while the domestic pay of players has gone up, they seem to have fared negatively when it comes to domestic contracts, role of players' association in negotiating the contracts and player welfare development programmes in players' welfare assessment. However, with BCCI being the richest and most powerful cricketing body, the way IPL will evolve over the next few years is going to be the central point around which the transition of cricket unfolds.

As New Zealand skipper Kane Williamson said recently ahead of a bilateral series, which was scheduled to be played after a high-octane T20 World Cup, it is a moving landscape. And it's going to be important to learn and understand how it looks over the next few years.
