As she had no formal training, she could not be financially independent. Again with the help of NGOs, she took training and today manages accounts at Shakti Café, a recently opened outlet of Monginis bakery managed by the girls run by CCI.



Culture of Odisha – Explore the Varied and Ancient Heritage of Utkala Region



Odisha is a cultural treasure trove, with ancient monuments, archaeological sites, indigenous arts, sculpture, dance, and music. It is the 8th largest state in terms of land and the 11th largest in terms of people. The state is home to India's 3rd largest number of Scheduled Tribes. It is bordered on the north by West Bengal and Jharkhand, on the west by Chhattisgarh, on the south by Andhra Pradesh, and on the southwest by Telangana. Along the Bay of Bengal, Odisha has a 485-kilometre (301-mile) coastline. Utkala is another name for the region, which is featured in India's national song "Jana Gana Mana." Lets take a deep look in to the culture of Odisha and it's heritage.

History of Odisha

Odisha's early history can be traced back to references in ancient literature such as the Mahabharata, Maha Govinda Sutta, and a few

stood. Only a few educated people speak English.

Women in Odisha wear many varieties of saris, which enhances their natural beauty. Kataki Sari, Sambalpuri Sari and Salwar Kamiz are popular women's outfits in Odisha. Dhoti is a popular traditional attire for males in Odisha. During the festival and other customary festivals, they also wear Kurta and Gamucha.

Many of its people use the lost wax process to create boxes, sculptures of Gods and Goddesses, and lamps.

The black stone sculpting art of Khiching in the Mayurbhanj area, which has a long history and a regal past, is one of the most wellknown crafts. Khiching is also recognized for its spectacular temple of Maa Kichakeswari Devi, which attracts a large number of tourists because it is constructed entirely of black stone and is adorned with exquisite decorations that are unique to the state!

Most of Odisha's arts have received international acclaim, and Papier Mache is one of them. The art involves the use of discarded cloth, natural fibers, and papers and is practiced in practically every region of the state. Ikat, also known as Bandha, is a textile art form in which patterns are formed by dyeing cotton or silk before weaving the fabric. Though it is available in a variety of locations, Sambalpur is a popular destination for this type of art. While Ikat works may be found all over India, single ikat, double ikat, and a combination ikat of both warp and weft threads are very popular in Odisha.

est handcraft, is a type of silver filigree work popular in Cuttack. This highly accomplished art form dates back over 500 years and is expertly performed by local artists.

Pattachitra is a traditional painting based on Hindu mythology that is one of Odisha's oldest and most popular art forms. Raghurajpur village in Puri is well-known for its artists, and it's fascinating to note that practically every family has at least one member participating in the art form.

Palm Leaf Painting, also known as Talapatra Chitra in Odisha, is an old style of art. This is regarded as one of the sacred art forms in the state.

Odisha is also known for its sand sculptures. Sand Art is clearly one of the world-famous artworks that can be found in Puri, Odisha. In fact, the state conducts an International Sand Art Festival every year.

The appliqué work is a frequent thing in every dwelling, street, and shop in Pipli, a tiny village located near Puri. In the hamlet itself, visitors may watch the process of creating umbrellas and canopies, as well as see the finished products. Artists weave small mirrors on the applique motifs to make it more eyecatching!

Dokra is a very old style of craft that originated approximately 4500 years ago. It is cur-

Architecture of Odisha

Culture of Odisha is characterized by a plethora of temples and monuments. These temples are proof of the region's beautiful architecture. The first monuments were constructed in the third century B.C. The lion capital of an Ashokan pillar, now in the State



Museum, and the fragment of an Ashokan pillar, converted into a Shiva Lingam and ensconced in the Bhaskaresvara temple in Bhubaneswar, tell eloquently of Odisha's previous splendor. The second phase of Odisha art is represented by the rock-cut caves of Khandagiri and Udaygiri, as well as inscrip-tions documenting Kharavela's brief but eventful rule in the first century B.C. The Naga and Yaksha images discovered in Bhubaneswar are from the post-Kharavela period. During the seventh to thirteenth centuries A.D., Odisha was at the pinnacle of her creative grandeur, the Temple Architecture in Odisha. The temples of Orissa have a distinct design that has evolved through time to include a more complicated plan, highly ornamental plastic figurines, and higher sikharas. (To be continued)

We have tried to make it as close to Forrest Gump as possible, but it's an Indianised version. Atul Kulkarni (scriptwriter) and Advait Chandan (director) have made a few changes, and we hope the audience loves it. The Hollywood version had a few adult scenes, but since we wanted to make a family film, we decided to do away with them. We wanted to retain the innocence of the character from the original version.

Did you actually grow a beard for the role?



I grew my beard six inches long. It took me almost six months. I met a Sardar at my gym and liked his look. I told him I wanted to have this look for my next film. I did grow a beard but also used extensions.

Your son Junaid gave screen tests for the film. What happened?

Junaid studied theatre at the American Academy of Dramatic Arts and did plays for a year. I told Advait to shoot a few test scenes with him for the film to see if he could handle it. We made him Laal Singh Chaddha and he shot for two weeks. That helped us gauge what Junaid had learnt at school. He was so good as the character that I was in a dilemma if Junaid should do the film. I showed (the tests) to all my close friends who don't give any leeway to my work. Only two people said no--Atul (Kulkarni) and Aditya Chopra. They said that since it was an episodic film, a newcomer should not do it. It's a star vehicle, which is why it was Tom Hanks who played the role in the original.

How did you convince yourself for the role? I prepped for the film, but it stayed in my mind that Laal is an innocent and pure character. are working with after 12 years, audition for her role. Why so, and how was it working together again?

I watched her for the first time in Kabhie Khushi Kabhie Gham and I loved her. Then I did 3 Idiots and Talaash with her. She gets into the character completely and is a fantastic actor. She has never given a screen test, but she agreed for this one because we wanted to see how she would look in the film. After we did a reading with her, both Advait and I realised that she was perfect for the role.

What qualities of Laal have impressed you? He is innocent, doesn't complain, and knows how to leave the past behind. If anyone speaks ill of him, he keeps quiet. He knows that you can't rewind the past. A lot of us don't accept that. Even if he feels bad, he just moves on with life. His mother has taught him that. My relationship with my Ammi has been the same. That's why I could relate to the film. I have learnt a lot in life because of her. Are you doing Kiran Rao's next film, Lapata

Ladki? I gave a screen test for it, but she rejected me. Both of us felt that I was not the right fit for the role. I was also busy with Laal, so we

decided that if she cannot find anyone, I will be there as a backup.

Have you ever faced rejections in your career? I don't like rejections; they upset me. I was rejected from a Hindi play during my They wanted chorus players.



Do you plan to launch Junaid soon? He doesn't want me to launch him. He is making his own career.

Bridge the Gender Divide to Build an Inclusive & Equal Society

10th October is the 10th anniversary of the International Day of the Girl .Girls are change-makers. Girls are driving good and growth around the world. They are a



fundamental source of transformational change for gender equality, and technology is a crucial tool to support their work, activism and

leadership. Our Indian society is still largely male dominated, and women are often looked down upon. A home is no home, which does not have a daughter. It is only because of our mothers that we live today. Inequality about girl child is a vast problem which includes many areas like inequality in education, nutrition, legal rights, medical care, protection, honour, child marriage and so many. India loses an average of 7,000 girls every day through abortions because of a traditional preference for sons. Abortions have also resulted in a severely skewed gender ratio in India, where there are only 927 females for every 1,000 males - far lower than the worldwide average of 1,050 females. In our country, female literacy rate is still 53.87% and one third of the youngster girls are malnourished. Our Constitution entitles women to equal opportunities and rights, but in some parts of the land the rate of female foeticide was high and the gender ratio terribly Vinod Chandrashekhar Dixit

In India the population of girls has been decreasing. We need to understand that girls are our fortune. Socio-economic empowerment of women is essential for making informed decisions and for change of the mind sets. A healthy male-female ratio is a social need. While female foeticide is bad in itself, the fact that millions of girls are "missing" in India has profound human and social implications. A stronger law to deal with those resorting to sex-selective abortions needs to be enacted. The reasons for high number of incidence of female foeticide in India include a deep rooted traditional son preference, continued practice of dowry and concern for safety of the girl child and exploitation and abuse of women and girl children. In order to curb female foeticide and improve the sex ratio, a strong a multi-pronged strategy that includes legislative measures, advocacy, awareness generation and programmes for socioeconomic empowerment of women is needed. According to a study in India by an Indo-Canadian team of researchers, about 5,00,000 female foetuses have been aborted annually. This estimate appears to be closer to the truth. Atrocities against women are on the rise, and female foeticide is one of the most brutal of

them all. Despite a slew of laws to prevent female foeticide and schemes to encourage families to have girl child, the ratio is declining. Female foeticide is a shocking practice that has grown in the last few decades. Although the media and the government have made attempts to highlight the negative impact of pre-natal sex identification and selective abortion, the practice continues as reflected in the declining sex ratio.

There's a huge deficit of women because families fear the cost of raising a daughter. It is a commonly practiced tradition (despite being outlawed) that the bride's family pays a large sum of money to the groom's family at the wedding. Plus, women are generally not seen as bread-winners and or allowed to inherit wealth like men in some states. Sex-selection is now spreading to rural areas as the technology gets cheaper and enforcement of the law remains ineffectual. The imbalance in sex ratio may increase violence, including rape, against women. With many men remaining unmarried, prostitution will increase substantially. Media exposes of doctors providing sex-selection services and offering to abort girls are commonplace, but they have little overall impact because demand is too strong. Doctors and radiologists conducting, or soliciting parents for, sex determination tests can be imprisoned up to five years and

Despite rising levels of education, gender awareness and stringent pro-women laws, change has been slow and violence against women is increasing. Visionary leadership, stringent implementation of laws and a united effort to discourage dowry are the need of the hour. Educational programmes encouraging parents to view daughters as no less valuable than sons need to be mounted. Time has now come to formulate an action plan to launch a campaign to change the mindset of people and to promote female child birth rate

We Indians call our nation mother India and are great devotees of Mother Goddess in various manifestations. But is this devotion and respect for the country limited to only a few words or do well actually implement these values. No, we all are openly playing a double standard game with our country. One way we say mother India and the other way we are continuously destroying the valuable gift of nature, a girl child. The sex ratio imbalance is a serious issue and finding a solution has to start with making the girl child valuable.

Egg, Nature's Multivitamin Capsule & Super Food

The egg ('aG a' in Sanskrit) appeared very early in Hindu mythology as one of the first elements of its cosmogony. As per Hinduism the egg constitutes

(hiranyagarbha) in the ocean of life (prana). It remained dormant for a year. Then it broke open into silver and golden shells. The silver part became the earth, the golden part became the heaven. The space between the two became the mid-region. Its outer skin became the mountains, the inner membrane is the clouds and mist. The veins are the rivers. The fluid within is the ocean. The birds eggs have been valuable foodstuffs since prehistory in both hunting societies, and more recent cultures where birds were domesticated. The chicken probably was domesticated for its eggs (from jungle fowl native to tropical and subtropical Southeast Asia and Indian subcontinent) before 7500 BCE. Where as the wild Asian fowl from which domesticated chickens are descended typically lay about a dozen eggs each year during the breeding season, several millenia of selective breeding have produced domesticated hens capable of laying more than three hundred eggs each annually, and to lay eggs year round. The most commonly used eggs are those from the chicken, duck, and goose. Smaller eggs, such as quail eggs, are used occasionally as a gourmet ingredient in Western countries. Eggs are a common everyday food in many parts of Asia, such as India, China and Thailand. As per the Economic Survey report, 2021-22, with production of 122.11 billion eggs in the year 2020-21, India stands third in the world in egg production. Eggs offer a moderate calorie source (about 150 kcal/100 g), a protein of excellent quality, great culinary versatility and low economic cost, which make eggs within reach to most of the population. Eggs are also relatively rich in fat-soluble compounds and can, therefore, be a nutritious inclusion in the diet for people of all ages and at different stages of life. In particular, eggs may play a particularly useful role in the diets of those at risk of low-nutrient intakes such as the elderly, pregnant women and children. Additionally, it must be mentioned that eggs can be consumed throughout the world, having no use restrictions on religious grounds. Egg is one of the most affordable and easiest sources of good quality protein. An average Japanese eats 340 eggs per year, Chinese consume 300 eggs per capita. Despite the fact that India being the third largest producer of egg in the world so also the Indian Council of Medical Research (ICMR) has recommended consumption of 180 eggs per year for every individual, the per capita consumption of eggs in India is just 91. In India though egg is easily available all most everywhere, requires no special storing facility, easy to cook and affordable, a large portion of the population don't have a habit of consuming egg on daily basis. There are many myths that go around

having no scientific backing which restrict a

lot of people from enjoying maximum benefits from egg consumption. Let's discuss some of them.

There is a belief among the masses, particularly among the people who poromote vegan food habits that, since egg is capable of producing a complete chick, it has got life within it, so egg consumption is just against law of nature (this is equivalent to kiliing a life form). Hens ovulate for the same reason female humans do, to reproduce. In chickens, the ovary is a cluster of developing ova, or yolks. Female human ovaries also contain developing eggs. In women, a mature egg is released from the ovary once a month. If the egg becomes fertilized, it attaches to the wall of the uterus and begins to form an embryo. If the egg is not fertilized, it is eliminated. This happens roughly two weeks before menstruation (the shedding of the uterine lining), a similar process operates in the female chicken body. Although chickens do not menstruate (and thus their eggs are not "chicken periods" as is sometimes asserted), they are able to create and pass much larger eggs relative to their body size that we consume. Much to contrary belief, All most all the eggs available in the market are unfertilized. To make a chick, a hen has to mate with a rooster. Farms which breed hens for edible eggs keep roosters away from them so that this fertilization process is not completed. Therefore you are safe and in no way you are hindering the natural process of life. Some people think that eating raw eggs provide more nutritional benefits than boiled or other cooked form form of egg and there is also a question that "is it safe to eat raw eggs or not". Like most of the foods, eggs undergo some loss of nutrients on cooking. In comparision to boiled or processed egg the raw egg has 33% more omega-3, 36% more vitamin-D, 33% more DHA, 20% more biotin, 20% more zinc and 23% more choline. As per experts these advantages of extra nutrient in raw eggs are very little when we look at their downsides. Problems with eating raw eggs are their poor digestibility, less protein absorption, risk of bacterial infection (Salmonella), and it may block the absorption of protein. Since the macronutrient profile of eggs remains the same - be it raw or cooked, both contain the same amount of protein and fats. Hence It is not a good strategy to prefer raw eggs over cooked once. Since egg is loaded with cholesterol it is a common assumption that, egg consumption can increase the risk of heart disease. However the fact is something else, cholesterol is often labeled as good or bad. Good cholesterol refers to HDL (high-density lipoproteins), and bad cholesterol refers to LDL (low-density lipoproteins). Lipoproteins help carry cholesterol through the bloodstream. HDL, or good cholesterol, helps your body flush out bad cholesterol, improving your heart health. LDL, or bad cholesterol, can cause plaque build up in your arteries and increase your risk for heart disease. The cholesterol in eggs does not have any significant effect on blood cholesterol level. In fact, they are packed with beneficial bioactive compounds that is High-density lipoprotein (HDL) is good cholesterol. It removes other types of cholesterol from the blood. Many studies have now been conducted in healthy people which reveals that

coronary heart disease. In order to have a healthy heart it is far more important to ensure to raise our HDL by eating fiber-rich foods and lower our LDL by limiting saturated and trans fats in our diet. Often, people who prefer brown eggs do so because they believe brown eggs are healthier and more natural than white eggs. However, the truth is that all eggs are nutritionally very similar, regardless of their size, grade, or color. However, scientists have compared eggs with brown shells to those with white shells to see whether there's any difference. Several studies have found that shell color does not significantly affect egg quality or composition. This means that the color of an egg's shell doesn't have much to do with how healthy it is. The only real difference is the pigment in the shell. It is a common question among the people that, if a future mom eats eggs, her child will suffer and face an allergy? This is, in fact, just a myth. An egg is a universal source of protein, vitamins, minerals, and amino acids. Eggs have many nutrients which are beneficial for pregnant women. So, it's recommended to eat eggs during pregnancy. Also, there is no research to support this belief that, one should delay the introduction of eggs into the diet of children until after one year of age to reduce the risk of an allergy forming. There's no evidence that dietary restrictions after six months of age have any additional benefits in avoiding allergies. It is a universal fact that, 2% of children are allergic to eggs, and one must careful about it. It's okay to give babies eggs (preferably boiled) as soon as they turn 7 months. You may start with a little quantity of it and observe your child's reaction. If the allergy doesn't occur within 4 days, everything's fine. Most people do have the opinion that it is not advisable to consume egg in old age. As per research findings that increased levels of macular pigment are related to a decreased risk of age-related macular degeneration. The pigments, called xanthophylls, act as both filters and antioxidants and protect people over age 60 from developing macular degeneration. Evidence suggests, macular xanthophylls, described above, are made of the same compounds that cause egg yolks to be yellow. Eating eggs (preferably organic from free-range chickens) can actually help decrease your chances of developing the age related macular degeneration. It is a misconception that eating eggs in summer can be unhealthy. According to experts it is completely okay to have eggs in summer, though in moderation. They are important and provide different vitamins and minerals to keep your energy level high. Eggs have a tendency to produce heat in our body and can cause indigestion and discomfort. Eggs may cause heat in the body, but if eaten in moderation may prove to be excellent wholesome foods. It had happened multiple times, that videos and posts regarding plastic eggs being sold in the market running riot on social media and create a lot of confusion and panic among the general public. Random samples are being lifted from markets in all such occasions and tested at different government food safety laboratory by Food Safety and Standards Authority of India (FSSAI) officials and found it to be safe. As per FSSAI officials, plastic eggs or artificial eggs is a myth due to the fact that there is no technology to

produce a artificial/ plastic egg that would perfectly resembles a natural egg. The rumours about plastic egg which came into circulation time to time on social media feeds, has been hurting the poultry industry as it detests people from consuming eggs so the National Egg Coordination Committee (NECC) officials in a public appearance made it clear that, it is impossible to qualify a plastic egg as a natural egg and challenged the citizens to submit a plastic egg to NECC and get Rs1,000 each for such eggs.

Eggs are of particular interest from a functionality point of view and considered as a superfood. Functional foods are characterized by containing nutraceuticals or compounds that are known to protect against chronic disease. Based on this definition, eggs are a natural functional food because they contain highly bioavailable carotenoids, lutein and zeaxanthin, and they are a good source of choline. Lutein and zeaxanthin are potent antioxidants that have been shown to decrease systemic inflammation, fatty liver disease and atherosclerosis in animal studies. Choline has been reported to protect against hepatic steatosis. Further, choline has a role as a neurotransmitter and has been shown to increase memory and protect against Alzheimer's disease. In addition, eggs are an excellent source of protein, with all the essential amino acids, which has been demonstrated to preserve muscle strength and decrease appetite. Nowadays, foods are not intended to only satisfy hunger and to provide necessary nutrients for humans, but also to prevent nutrition-related diseases and improve physical and mental wellbeing of consumers. However, human nutrition in developed and developing countries is characterized by an excessive intake of protein, cholesterol, saturated fatty acids (SFA), n-6 polyunsaturated fatty acids (PUFA), calories or sodium, whereas consumption is deficient in n-3 PUFA, fiber and antioxidants. These imbalances are partly responsible for the high incidence of both obesity and the onset of chronic or degenerative non-transmissible diseases, from which cardiovascular diseases (CVD) are the leading cause of mortality and morbidity globally. In order to improve public health, nutritional experts and related organizations, has persistently recommended a reduction in the intake of foods that are related to the occurrence of chronic diseases, and am increased consumption of fruits and vegetables, grains, legumes, low-fat dairy products, lean meats and fish, especially fatty fish species that are high in n-3 PUFA. Owing to the persistence of these recommendations, there is a high degree of awareness of this problem in the populations of developed and developing countries. But the problem is that people's are very much reluctant to change their food habits. Eggs are conventional foods across all culture and people are very much accustomed to it. So it is high time, we must made the public sufficiently aware about the various health benefit of eggs and food items prepared from it and made them perceive egg as a functional food.

ICAR-CIFRI takes Measures to Save Dolphins getting Extinction from Ganga River Basin

Kolkata(KCN): Dolphins are the ideal ecological markers of a healthy aquatic ecosystem. On August 15, 2020, the "Project Dolphin" was launched by the Prime Minister Shri Narendra Modi to include both river dolphins and marine dolphins in its conservation programme. Because of the significance of dolphins, the Union Minister for Environment Shri Bhupendra Yadav declared October 5 the "National Dolphin Day", to be observed annually to raise awareness for the conservation of dolphins. He announced while presiding over the 67th meeting of the Standing Committee of the National Board for Wildlife in New Delhi.

Meanwhile, the National Mission for Cleaning Ganga (NMCG) project Principal Investigator, who is also the Director of ICAR-CIFRI, Barrackpore, Dr Basanta Kumar Das disclosed that India's waters are home to about 30 species of marine mammals, including river dolphins. The Gangetic River dolphin (Platanista gangetica) lives only in the Ganga-Brahmaputra systems, while the Indus River dolphin (Platanista minor) is only found in the Indus system, which includes the Sutlej, Ravi, and Beas rivers. He also emphasised the Gangetic dolphin's importance as an indicator species for the Ganga ecosystem, whose vulnerability to changes in water quality and flow offers information on the general condition of the ecosystem and other species in that ecosystem.

The International Union for Conservation of

Nature's Red List listed Indian Dolphin as endangered. "Due to multiple threats, including pollution, water diversion, habitat fragmentation, and by catch, the Ganges River dolphin is seriously threatened. Dolphins in India face numerous challenges, so spreading knowledge about them is crucial," said Dr. Dibakar Bhakta, an institute scientist who coordinating the programmes.

Recent data (2017-18) shows that the estimated Ganges River dolphin in the Ganga River basin, along with tributaries, stands around 2644, and in the Brahmaputra, along with its tributaries, stands at 987.

On October 5, 2022, ICAR-CIFRI, Barrackpore organised campaigns at four different places namely Farakka, Nabadwip, Tribeni, and Balagarh on the bank of river Ganga under Namami Gange Programme. More than 200 personnel including active fishers, social activities, and students residing on the banks of the river participated in the publicity campaign. Locals were also made aware of various river conservation measures through the awareness and sensitization programme, such as refraining from using pesticides on agricultural and horticultural lands along the river, reforestation of the riverbank to prevent bank erosion, refraining from discarding plastic and other trash in the river, releasing enough water from dams and barrages, maintaining riverine biodiversity using scientific fishing gears and more.

NATO cautious to avoid war, struggles with dual challenge

has been treading a fine line, as an organisation, providing only non-lethal support and defending its own territory to avoid being dragged into a wider war with a nucleararmed Russia.

Individual allies though continue to pour in weapons and ammunition, including armoured vehicles and air defence or anti-tank systems. They're also training Ukrainian troops, building on the lessons NATO has taught Ukraine's military instructors since Russia annexed the Crimean Peninsula in 2014.

But as the Russian missile strikes across Ukraine this week demonstrated, this is not enough.

NATO defence ministers were taking stock on Wednesday of the supply effort so far and debating ways to encourage the defence industry to ramp up production in short order. "Allies have provided air defence, but we need even more. We need different types of air defence, short-range, long-range air defence systems to take (out) ballistic missiles, cruise missiles, drones, different systems for different tasks," NATO Secretary-General Jens Stoltenberg said.

"Ukraine is a big country, with many cities. So we need to scale up to be able to help Ukraine defend even more cities and more territory against horrific Russian attacks against their civilian populations," Stoltenberg told reporters before chairing the meeting at NATO headquarters in Brussels. At the same time, national military stocks and arsenals are being depleted. Some countries are growing reluctant to provide Ukraine with more when they are no longer entirely sure that they can protect their own territories and airspace.

The issue, as one senior diplomat put it, is: "how do we arm Ukraine without disarming ourselves?" The diplomat spoke on condition of anonymity because the discussions involve collective security concerns.

For the defence industry, predictability is paramount. Companies need long-term orders and certainty before they commit to extending production lines.

But no one is sure how long the war in Ukraine will last, making it difficult to know how much equipment is needed.

Still, Putin's attack on a sovereign country without provocation, and his threats to use nuclear weapons to defend seized territory, have made many allies neighbouring Russia and Ukraine jittery.

So the United States and its partners want to boost weapons production by sending clear signals to industry, as they pool resources and send Ukraine the hardware that it needs, all while ensuring that no major gaps appear in national stockpiles. War crimes investigations have long been underway in towns where mass graves were found, along with other evidence of atrocities, after they were liberated from Russian occupation.

In Lyman, a city in the eastern Donetsk region, forensic workers pulled several bodies from a mass grave on Tuesday, part of an arduous effort to piece together evidence of what happened under more than four months of Russian occupation.

Regional Gov. Pavlo Kyrylenko said the bodies of 32 Ukrainian soldiers have been exhumed so far from one mass grave.

The tempo of the war in the last month fanned concerns that Moscow might broaden the battlefield and resort to using nuclear weapons in Ukraine.

As Ukraine's counteroffensives in the east and south forced Russia's troops to retreat from some areas, a cornered Kremlin ratcheted up Cold War-era rhetoric.

Russian Foreign Minister Sergey Lavrov said on Tuesday that Moscow would only employ nuclear weapons if the Russian state faced imminent destruction. Speaking on state TV, he accused the West of encouraging false speculation about the Kremlin's intentions. Russia's nuclear doctrine envisions ?exclusively retaliatory measures intended to prevent the destruction of the Russian Federation as a result of direct nuclear strikes or the use of other weapons that raise the threat for the very existence of the Russian state?, Lavrov said.

In Brussels, NATO Secretary-General Jens Stoltenberg said the 30-nation military alliance would hold annual war exercises testing the state of readiness of its nuclear capabilities next week as scheduled.

Asked whether it was the wrong time for such exercises, Stoltenberg replied: ?It would send a very wrong signal now if we suddenly cancelled a routine, longtime-planned exercise because of the war in Ukraine.? Stoltenberg said Putin's nuclear rhetoric was ?irresponsible? but he believes ?Russia knows that a nuclear war can never be won and must never be fought?. NATO as an organization does not possess any nuclear weapons. They remain under the control of three member countries ? the US, the UK and France. The G-7, leaders which held the emergency meeting in response to Monday's attack, said the ?indiscriminate attacks on innocent civilian populations constitute a war crime? and reaffirmed their ?commitment to providing the support Ukraine needs to uphold its sovereignty and territorial integrity?. The pledge appeared to come in response to Kremlin warnings that Western military assistance, including training Ukrainian soldiers in NATO countries and feeding real-time satellite data to target Russian forces, increasingly made Ukraine's allies parties to the conflict. Kremlin spokesman Dmitry Peskov said continued US weapons deliveries to Ukraine would prolong the fighting and inflict more damage on the country without changing Russia's objectives. As Russian forces pounded three districts around the Zaporizhzhia Nuclear Power Plant overnight, Ukraine's state nuclear operator said Russian forces kidnapped the plant's deputy human resources director. Russians previously detained the facility's general director and released him following pressure from International Atomic Energy Agency Director General Rafael Mariano Grossi.Grossi met with Putin on Tuesday in St. Petersburg and urged him to agree to a ?safety and security protection zone" around the occupied plant to prevent shelling from causing a radiation disaster.

Putin, for his part, has warned NATO against deeper involvement in Ukraine.

In recent weeks, as power and gas bills spiral and Europe struggles to decrease its dependency on Russia for energy, apparent acts of sabotage damaged two major pipelines once meant to bring natural gas to Germany.

The Polish operator of the Druzhba -- or "Friendship" -- oil pipeline, one of the world's longest pipelines and which originates in Russia, said on Wednesday that it had detected a leak underground near the city of Plock in central Poland.

The line supplies crude to Belarus, Ukraine, Poland, Austria and Germany.

Stoltenberg said that following the apparent sabotage of the Nord Stream pipelines between Russia and Germany, NATO has "doubled our presence in the Baltic and North Seas to over 30 ships, supported by maritime patrol aircraft and undersea capabilities."

It's a small comfort, given that about 8000 kilometres (nearly 5,000 miles) of oil and gas pipelines crisscross the North Sea alone. Systems, networks and grids are impossible to watch 24/7. Even the resources of energy companies, national authorities and NATO may not be enough to keep guard.

NATO's aim, for now, is to better coordinate between these actors, to better gather intelligence and improve the way it is shared, and watch over facilities, with aerial and undersea drones and other surveillance equipment. No responsibility has been established for the pipeline incidents. But NATO is also trying to be clear in deterring Russia.

"Any deliberate attack against allies' critical infrastructure would be met with a united and determined response," Stoltenberg said ahead of Wednesday's meeting.

He declined to say what kind of response that might be, or whether an accumulation of such hybrid attacks might trigger NATO's collective defence clause -- Article 5 of its founding treaty -- which ensures that an attack on any one ally would be met with a response from them all.

?Attacks targeting civilians and objects indispensable to the survival of civilians are prohibited under international humanitarian law.?

The IAEA said Grossi would return to Kyiv for another meeting with Zelenskyy.

NEW DELHI: India gave a good account of their enormous depth as a young and inexperienced side stunned a strong South Africa unit by seven wickets in third ODI here on Tuesday to secure a memorable series win.

Earlier put in to bat, South African batters failed to impress, falling like ninepins. Quinton de Kock (6) was the first to perish as he half-heartedly cut the ball to top-edge it to Avesh Khan at backward point, giving

Tennis Australia keeps out of Djokovic's visa application

MELBOURNE: Novak Djokovic won't get official support with lobbying from Tennis Australia should he seek to enter the country for the first major of 2023, a year after he was deported because he was not vaccinated for COVID-19.

The 21-time Grand Slam champion wasn't allowed to defend his Australian Open title last January after a tumultuous 10-day legal saga that culminated

with his visa being revoked on the eve of the tournament eventually won by Rafael Nadal. Djokovic originally was granted an exemption to strict vaccination rules



der to play in the Australian Open but, after travelling to Melbourne believing he had all his paperwork in order, the exemption was rejected by the Australian Border Force.

"It is not a matter we can lobby on. It is a matter that definitely stays between the two of them," Australian Open tournament director Craig Tiley said Wednesday at a launch for the 2023 event, referring to Djokovic and the Australian government. "And then, depending on the outcome," Tiley added, "we would welcome him to the Australian Open.' Being deported made Djokovic subject to a possible three-year exclusion period that prevents the granting of a further temporary visa, although the Australian Border Force in January said any exclusion period "will be considered as part of any new visa application and can be waived in certain circumstances.'

The ABF said each case is assessed on its merits. Australia has changed its border rules and, since July 6, incoming travellers no longer have to provide proof of COVID-19 vaccinations.

Tiley was heavily criticized for his role in the confusion that led to the then top-ranked player in men's tennis landing in Australia believing he was exempt from strict laws for unvaccinated travellers, then being questioned by border officials for hours at Melbourne Airport before being held in immigration detention.

The main source of confusion was the exemptions granted to Djokovic and some others by the state government and Tennis Australia to participate in the tournament -- despite regulations requiring all fans, officials and players to be vaccinated for COVID-19 -- which ultimately still needed to be assessed by border security officials.

Djokovic was allowed to practice at Melbourne Park after some initial success in a court of law, but Australia's Immigration Minister Alex Hawke ultimately used discretionary powers to cancel Djokovic's visa on character grounds, stating he was a "talisman of a community of anti-vaccine sentiment."

A recent winner of tournaments in Israel and Kazakhstan, Djokovic can apply to new Immigration Minister Andrew Giles to reconsider his visa status.

Tiley, who is also the Tennis Australia chief executive, said he met with Djokovic in London last month during the Laver Cup and believes the Serbian star holds no bitterness about the saga. But Tiley stressed that the pair spoke only gener-

ally about Djokovic's visa situation.

"He said that he would obviously love to come back to Australia but he knows it's going to be an ultimate decision for the Federal Government and he accepts that," Tiley said. "If you notice, he is playing a lot of tennis at the end of the year in anticipation and hopes there is a successful outcome with his application. But that is up to him."

A review of the episode that made global headlines has led to Tennis Australia outsourcing visa applications by players and their entourages to a company specializing in immigration matters.

Tiley said the Australian Open had no plans to follow the lead of Wimbledon, which banned Russian and Belarusian players from competing this year because of the invasion of Ukraine.

Ronaldo to defend himself after improper conduct charge

MANCHESTER: Cristiano Ronaldo will defend himself against an improper conduct charge brought by the English Football Association.

The Manchester United forward was charged following an incident with a fan after a game against Everton in April. Footage caught on



camera appeared to show Ronaldo knocking a phone out of the hand of a supporter as he made his way to the locker room following United's 1-0 loss.

He was later cautioned by police and last month the FA confirmed that the Portugal international had been charged with a breach of Rule E3. "We spoke about that," United manager Erik ten Hag said Wednesday. "He will not accept it."

Rule E3 relates to the general behaviour of participants, stating they must not bring the game into disrepute "or use any one, or a combination of, violent conduct, serious foul play, threatening, abusive, indecent or insulting words or behaviour.'

The case will be determined by an FA hearing.

Ronaldo returned to Goodison Park for the first time since the incident in United's 2-1 victory on Saturday — scoring the winner,

which was his 700th career club goal. He could start when United hosts Omonia Nicosia in the Europa League on Thursday after spending much of the season on the bench.

With speculation about Ronaldo's longterm future, ten Hag

"I want to support him as good as possible," ten Hag said. "So we have a certain demand on players, what we expect from him in cer-tain positions on the pitch and what L do as tain positions on the pitch and what I do, as with other players, is I want to get the best out of them.

"He is getting in better shape now and I am happy with that, so he can contribute more to the squad and I'm sure he will do." Ten Hag also added that Ronaldo's physical

condition has been an issue this season.

"In the start, it was definitely the case," ten Hag said, "and it's proven once again no one can miss pre-season."
