### Target for Arms Export Regularization of 57K Employees contractual recruitment

"Self-reliance & secured borders are central to making India a powerful nation," said Raksha Mantri Rajnath Singh at an event in New Delhi on October 15, 2022. The Raksha Mantri, in his address, echoed the Government's unwavering resolve to transform India into one of the most powerful nations by 2047, asserting that Ministry of Defence (MoD) is leaving no stone unturned to achieve Prime Min-Narendra ister Modi's vision of 'Aatmanirbhar Bharat'.

Citing the example of recently-commissioned INS Vikrant, which contains 76 per cent indigenous content, he stated that India has the ability and capability to manufacture modern weapons and platforms. confidence that the country will start manufacturing mod-

> ern and effective water, land, sky and space defence platforms in the next ten years. The Raksha Mantri

appreciated the fact that due to the steps taken by the Government in the last few years, defence exports have seen a massive jump. "There was a time when India only exported defence equipment worth Rs 1,900 crore. The figure today has crossed Rs 13.000 crore. We have set a target of Rs 1.75 lakh crore of defence production by 2025, including Rs 35,000 crore worth of exports. We are well on course to achieve the target," he said.

Terming border area development as another aspect at the core of the Government's vision, Shri Singh said that all efforts are being made to increase connectivity with far-flung areas to further strengthen the preparedness of the Armed Forces and linking the country with people residing in the region. Bhubaneswar(KCN): On the eve of his Birth Day, Chief Minister Naveen Patnaik on Saturday announced a gift for the 57,000 contractual employees, who were demanding regularization of their service



for a long time. The Chief Minister has announced complete abolition of the contractual recruitment system in the State Government. This decision was taken at the State Cabinet meeting held here this evening.

Addressing the people, Patnaik said, in the year 2000, when he got the opportunity to serve Odisha, the post-super cyclone situation and the fragile financial conditions were biggest challenges for him. The State was running

on overdraft and the government was dependent on the Reserve PM favors speedy

Bank of India (RBI) for wage and means, said Patnaik, adding, "It was indeed a black period for the Odisha economy. The state exchequer was empty. There was tremendous pressure on our

economy. We were lagging behind in various fields including health, education, infrastructure, agriculture, irrigation and many others." At that time his priority was to bring improvement in all these sectors within limited resources. With this condition, his Government stopped recruitment completely, he said.

"We were forced to abolish government posts and it was very painful for me. The youths of my state were running from pillar to post for employment with the government. I was really very sad,"

said the Chief Minister. Patnaik said he was always worried forwhen would the situation improve and when would the children get regular recruitment in the State Government? With the blessings of Lord Jagannath, the support of people, bet-

ter financial management and good governance, the situation started to improve slowly.

"The contractual recruitment system started in 2013. It was, too, a difficult decision for me. Now our economy has improved significantly. Odisha has created a new identity for itself in the field of development in the country," he pointed out.

Last year, the State Government had substituted the contractual recruitment posts with initial appointees. Today, the state cabinet has decided to abolish the contractual system of recruitment permanently, he announced. Even today, he men-

tioned, there are no regular recruitments in many states and they are still continuing with the

the era of contractual recruitment has come to an end, added the CM. He also informed that the notification will be issued on Sunday. More than 57,000 employees will be benefited from this move. The government will spend approximately Rs 1300 crore per annum. "This decision brings early Diwali for their family members. Today, Odisha is moving ahead with confidence. A strong and empowered Odisha. This is a golden moment in the history of Odisha," said Patnaik. BJD Organisational Secretary Pranab Prakash Das, Prasanna Acharya, Debi Prasad Mishra, Ranendra Pratap Swain, Prafulla Samal, Similarly, the BJP's National General Secretary Arun Singh had earlier sent a list of party's star campaigners to the Chief Election Commissioner Rajiv Kumar for the upcoming by-poll.

Odisha BJP President Samir Mohanty along with three Union Ministers- Dharmendra Pradhan, Ashwini Vaishnaw, and Bisweswar Tudu will campaign for the party candidate Suryavanshi Suraj Sthitaprajna, son of Bishnu Charan Sethi.

BJP Vice-President Baijayant Panda, LoP Jayanarayan Mishra, and senior leaders Sunil

## Fresh push to parallel road project in Bhubaneswar

BHUBANESWAR(KCN): In a fresh push to the parallel road project on Jayadev Vihar-Nandankanan stretch of the State Capital, the Forest department has given nod for diversion of forest land on a 1.7 km stretch. Officials of Forest and Environment department said the department has given nod for diversion of 10.18 hectare (around 25 acre land) of the Chandaka Wildlife Division following identification of a similar patch of land for compensatory afforestation.

Tulasadeipur under Bhubaneswar tehsil of Khurda was earmarked and transferred in favour of the Forest department in August this year after declaring it as Tulasadeipur protected forest for compensatory af-

hectare in size," said a forest official from Chandaka.

He said the patch has been identified in lieu of land diversion for a 200 feet wide road over a length of 1.790 km from Rail Vihar to Hatiasuniforestation. The Ekamrakanan park

According to NBJK, with the above mentioned equipment it will be possible to provide smooth access of Ophthalmic meditients in Gaya and two adjoining districts Nawada and Jehanabad in Bihar, which currently do not have any Ophthalmic hospital at no charge or low cost for the poor except for hospitals run by NBJK.

The GGP Scheme was established to assist local NGOs in developing countries in responding various development needs in a prompt and complete manner, even though on a comparatively small scale. As a donor, the Consulate General of Japan in Kolkata has supported more than US\$ 4.7 million to numbers of NGOs in eastern 4 states; Bihar, Jharkhand, Odisha and West Bengal for the last more than 2 decades to fight against various challenges at the grassroots level. opment Authority (BDA). It envisages developing two roads parallel to the existing stretch from Jayadev Vihar to Nandankandan for decongestion of traffic.

The left parallel road from Xavier Square will be connected to Chandaka Square via Patharagadia and the Institute of Mathematics. The 13 km road, estimated to cost around Rs 92 crore is being constructed in seven stretches. Work on one of the stretches has already been completed and the remaining are in progress.

Similarly, the 6.25 km right parallel road from Acharya Vihar to Patia Big Bazaar, is proposed to be constructed at a cost of Rs 239 crore. Both the projects are moving at a snail's pace owing to a host of problems including land acquisition, forest diversion and other issues. BDA secretary Kabindra Kumar Sahoo said efforts are on to clear land hurdles to complete the right side road at the earliest.

Bhubaneswar(KCN): State Cabinet headed by Chief Minister Naveen Patnaik on Saturday approved tenders of Rs 1553 crore for execution of mega piped water supply projects in rural areas of 11 Blocks in four Districts. Apart from the abolition of the contractual recruitment system, the Cabinet has approved eight other proposals of the Departments of Skill Development and Technical Education, General Administration & Public Grievances



and Pacnhayati Raj & Drinking Water. Briefing the media, Chief Secretary Suresh Chandra Mahapatra said that the Cabinet approved the tenders for construction of major piped water supply projects in 4 districts. The Cabinet has approved a tender worth Rs. 395.43 crore for execution of Mega Piped Water Supply projects to provide safe drinking water in Nayagarh District out of JJM funding, said the Chief Secretary. By execution of the projects, 1,54,594

Similarly, tender for the third PWS project worth Rs 456.51 crore has been awarded to provide drinking water to 4,16,886 people of 356 villages under 63 GPs of 4 Blocks of the Khurda district.

Moreover, the State Cabinet has approved the tender amounting to Rs. 248.91 crore for execution of PWS projects to provide safe drinking water in Kalahandi District out of JJM funding.

By execution of the projects, around 1,26,328 people of 155 villages under 36 GPs of 2 Blocks of the District will be benefited. Mahapatra added that the Cabinet also approved waiver of rent of SDC and SDECs for the period from March, 2020 to October 2020 due to Covid-19 pandemic.

Rules for Odisha Group-B, C, and D Posts (Repeal and Special Provisions)-2022; Amendment of Odisha Heads of Department of Recruitment and conditions of service of Junior Assts, ASOs, SOs Rules-2019; Combined Technical Service recruitment examination Rules; and, Combined post-graduate level recruitment examination for specialist posts service Rules-2022 have been approved by the Cabinet.

Cooperative Societies (PACS) provide around 60 per cent of the total crop loans disbursed in the state. Almost the entire paddy procurement operations and procurement of other agricultural produce are done by these PACS," he said. With this, 2063 PACS in State have come under the Core Banking Solution platform.

Speaking on the initiatives of his government in strengthening cooperatives in the state, he said that the government has been providing share capital assistance to the Co-operative Banks and PACS in order to build up a strong capital base for them. The Government is also



providing interest subsidy support to the farmers.

He further said that core banking solutions and computerised operations of PACS have been included as important interventions under the 5T charter of the State Government.

Congratulating the new Banking Assistants, who joined the Government on Friday, he advised them to follow the 5T initiative as it carries special significance for the cooperative sector.

Speaking on Odisha State Warehousing Corporation (OSWC), he said, it provides logistic support for storage of food grains for distribution under PDS and other welfare

As many as 384 Banking Assistants were inducted in 15 District Central Co-operative Banks in presence of the Chief Minister.

> Notably, the Cooperative Banks and PACS provide banking and credit services to the people at the grassroots level. The PACS and LAMPCS disburse crop loans for seasonal agricultural operations to the farmers through Kisan Credit Cards and to the tenant farmers, sharecrop-

pers, oral lessees etc. through Self Help Groups and Joint Liability Groups. The government is facilitating disbursement of crop loans up to Rs.1 lakh free of interest, thanks to overdrive of Principal Secretary Cooperation, Mr.Chadha.

Credit support is also provided to the farmers for asset creation in agriculture under farm mechanization, land development, horticulture, animal husbandry, fishery etc. In addition, farmers in the State avail the services of inputs supply like seeds, fertilizers, pesticides along with marketing of their agricultural produce viz. paddy, oilseeds and pulses through these PACS and LAMPCS.

### 'Joker' review: Solid filmmaking, messy poli-

In many of its seedy street side shots, Todd Phillips's Joker focuses on a theatre and clearly shows the titles playing. There is Zorro the Gay Blade, which came out in 1981, a time that seems closer to the mood this film is going for – the late 70s and impending Reagan era vibe of New York that it lends Gotham City. But the more interesting title it shows is probably

Ace in the Hole. Is it the Billy Wilder film? It's a film that hints at media manipulation and Joker insists on a

kind of manipulation by everything from TV, press to upbringing and economic condition that drives Arthur Fleck (Joaquin Phoenix) to become the murderous eponymous character.

Ace in the Hole was also one of Wilder's famous critical and commercial failures. Failure and rejection are important driving forces in this film that's more honest and focused on its visual splendour than it is on the condition and circumstances that create the space

for a turn like that of Arthur Fleck's to Joker. Also, who refers to Harvey Dent as "ace in the hole"? Heath Ledger's Joker in The Dark Knight.

# **Representation in tax matters**

The art of effective representation is very important, a professional to succeed as well as taxpayers for making proper representation in his case. It has become more relevant in Faceless Assessments and Faceless Appeals. There are no separate approaches in the art of representation before the I.T. authorities, appeals before CIT (Appeal) or Tribunal or any other forum. Broadly we feel that the art of



representation is not confined only to the IT authorities or the Court, but anywhere in life, in any discussion forum. Wherever you are, it is the same quality, it is the same approach, which can bring you success. The person making the representation before the A.O., CIT (Appeal) or other Appellate Authorities should keep in

mind the following aspects which may help in making an effective representation:

- Give due importance to FACTS, furnish Paper Book 1. in appeals: The first suggestion, is to work hard on your matter. The stakes involved in tax disputes are normally very large and in many cases, very intricate facts are involved. One must master the facts. While making representation narrate the facts first, straightaway do not jump to law. The importance of facts in the case should never be under-estimated. Facts are lifeline of the case and the entire edifice is built on the facts of a case. Therefore, one must study the facts extremely well and narrate relevant facts chronologically before the authorities in the first instance. As pointed by Bertrand Russell "The degree of one's emotion varies inversely with one's knowledge of the facts - the less you know, the hotter you get."
- 2. Statement of facts in appeal: The Statement of facts furnished in first appeal i.e. before the CIT (Appeals) have to be enclosed with the appeal before the ITAT. Therefore one need to be very careful in preparing the Statement of facts at the time of first appeal itself. Sometimes while filing the first appeal, some taxpayers or professionals commit blunder by not preparing and

#### submitting the statement of facts or they mention the same

"as per Assessment Order". In Statement of facts, one is supposed to mention as to what papers/ documents/ books of account were submitted or produced or explained or what points were argued; or whether compliance was properly made on all occasions. One must properly go through the text of the assessment order and point out if it contains some observations, which are factually erroneous. While making compliance of the requisitions made in a Faceless scrutiny assessment also, it is advisable to make written submission and enclose with it the requisite documents and evidences. It is advisable to submit the relevant documents in the form of a paper book even before the CIT (Appeals) so that it is easier to prepare a paper

book to be filed before the ITAT. Furnish affidavit, wherever necessary: Wherever supporting evidence is not possible or not available, an affidavit should be furnished before the authorities. The same is usually accepted unless the authority has any material to controvert the statements contained in such affidavit. Where a fact is alleged, which cannot be borne out by, or is contrary to the record, it should be stated clearly and concisely and supported by a duly sworn affidavit. In this

- context following decisions are also relevant: Mehta Parakh & Co. v. CIT 30 ITR 181, 187 (SC) -The importance and relevance of the averments made in the affidavit cannot be brushed aside without really having any material to contradict the same. It is matter of common knowledge that even in Courts the affidavits are furnished and relied upon. It was held that rejection of an affidavit filed by an assessee was not justified unless the assessee had either been cross examined or called upon to produce documentary evidence in support of the affidavit sworn by him.
- L. Ŝohanlal Gupta v. CIT [1958] 33 ITR 786 (All.) -The Tribunal was not entitled to reject the Affidavit filed by the assessee on the mere ground that he had produced no documentary evidence; if it was not accepted as sufficient proof, the assessee should have

been called upon to produce documentary evidence or he should have been cross

examined to find out how far his assertions in the affidavit were correct. [also refer - Malwa Knitting Works v. CIT [1977] 107 ITR 379 at page 381 (MP)] CIT v. Lunar Diamonds Ltd. [2006] 281 ITR 1 (Del.)

- The assessee had filed an affidavit stating that it had not received the notice and the High Court sustained the order of the Tribunal, which had held that under these circumstances, the burden was upon the Department to prove that notice was served upon the assessee within the prescribed time. The Department had failed to prove its case in this regard. The Tribunal was right in setting aside the order of assessment. No substantial question of law arose from its order.
- Baban Singh v. Jagdish Singh AIR 1967 SC 68 d) Where a false affidavit is shown, the offence would fall u/s 191 and 192 of the Indian Penal Code 1860. Hence an affidavit has to be considered as a piece of evidence. 4.
  - Get acquainted with the latest law and decisions: It is also vital for succeeding in a case to get acquainted with the latest law and decisions. The decisions on tax matters are now abundant and for reading and mastering these, hard work is imperative. It is advisable that in addition to tax magazines like ITR, Taxman, CTR, ITR (Trib.), ITD, etc., one should also take benefit of the case laws or gist of case laws, available online magazines like taxmann.com as well as relevant websites. It is very convenient to search decisions or circulars or notifications on any issue or any section or a specific decision by using the search facility offered by websites. For representing the case properly, it is advisable that -
  - The decisions proposed to be referred to should be read fully and not only the head note.

Refer the decisions in favour as also those against and try to distinguish as to how a case which is against you, can be distinguished from the facts of your case. Remember, in ITAT one has to face departmental representative (D.R.), who would obviously like to refer to the case in favour of the department. So get prepared for all possible cases which may be cited by the ld. D.R.

- In addition to the book containing case law, you will do well if you can also furnish a copy of the relevant decisions mentioning the citation. It is further advisable to provide to the appellate authorities **the gist of the** portions of the decisions, which you are relying upon, otherwise it is really difficult for the appellate authorities
- to remember the para which is relevant in a case. Don't forget to mention if the case is covered by decision of ITAT or a Court in the case of appellant himself. Provide a copy of such decision, which is likely to be followed by the appellate authority. Even if your case is fully covered by some other decision of the Supreme Court, jurisdictional High Court or any other High Court or ITAT, categorically refer the same. That makes the hearing shorter and helps in succeeding on the issue
- If an identical matter is pending on the same issue on a question of law in the Supreme Court or in the High **Court** in case of the appellant, this should be pointed out to the A.O., CIT (Appeals) or ITAT giving particulars of the same then the assessee may furnish a declaration u/s 158A that if the A.O. or the appellate authority, as the case may be, agrees to apply in the relevant case the final decision on the question of law in the other case, he shall not raise such question of law in the relevant case in appeal before any appellate authority or in appeal before High Court or the Supreme Court. This provision of section 158A has been enacted for avoiding repetitive appeals in the same case for different assessment years and it should be used for reducing litigation expenses.
- 5. Don't make haste, proceed carefully observing the **mood of the** authority: Some new professionals, proceed in the ITAT as well as before other authorities with great haste. It does not serve the purpose, because unless the authority is listening to you carefully and following your arguments, the fast pace only satisfies yourself, but does not take you anywhere. # **Global Hunger Index: India ranks 107** of 121 nations, behind Pakistan, Nepal

New Delhi: India ranked 107 out of 121 countries in the Global Hunger Index 2022 with its child wasting rate at 19.3 per cent, being the highest in the world.

The Global Hunger Index (GHI) is a tool for comprehensively measuring and tracking hunger at global, regional, and national levels. With a score of 29.1, the level of hunger in India has been labelled "serious".

In Asia, Afghanistan with a rank of 109 is the only country behind India.

Neighbouring countries - Pakistan (99), Bangladesh (84), Nepal (81) and Sri Lanka (64) have all fared better than India.

In 2021, India ranked 101 out of 116 coun-

"Possible solutions and the scale of investment required are known and quantified. Rather, the problem lies in policy implementation and the lack of political will in the world," it said.

Activists and politicians have hit out the government for India's ranking. Sitaram Yechury, Secretary-General of the Communist Party of India (Marxist) said the government must take responsibility for this era of darkness India has been brought to in 8.5 years.

South Asia, the region with the world's highest hunger level, has the highest child stunting rate and by far the highest child wasting rate in the world, the report said.

"India's child wasting rate, at 19.3 per cent, is the highest of any country in the world and drives up the region's average owing to India's large population," it said.

India, Pakistan, and Afghanistan each have child stunting rates between 35 and 38 per cent, with Afghanistan's rate being the highest in the region.

Undernourishment prevalence rose in India from 14.6 per cent in 2018-2020 to 16.3 per cent in 2019-2021. This translates into 224.3 million people in India being undernourished out of the total 828 million people globally. Child wasting which is a strong predictor of mortality among children under five years of age also worsened from 15.1 per cent in 2012-16 to 19.3 per cent in 2017-21. India, however, noted improvement in two parameters of child stunting from 38.7 per cent in 2012-16 to 35.5 per cent in 2017-21 and child mortality from 4.6 per cent in 2014 to 3.3 per cent in 2020.



The GHI said stunting disparities between districts were particularly pronounced in India.

"The example of India shows the importance of considering the subnational context when designing programs and policies to target child stunting. Researchers investigated the factors that contributed to a decline in stunting in four Indian states between 2006 and 2016: Chhattisgarh, Gujarat, Odisha, and Tamil Nadu," it said.

The report said the researchers found thatstunting fell mainly in response to improvements in the coverage of health and nutrition interventions, household conditions (such as socioeconomic status and food security), and maternal factors (such as mothers' health and education).

"While improvements in household conditions were the most important factor for each of the four states, the second most important factor varies by state. As the authors conclude, this variability across states indicates the need for contextualized policy and programmatic initiatives to help focus the efforts in the sectors that need the most attention for continued decline in stunting," it said. The GHI said the world is facing a serious setback in efforts to end hunger with conflict, the climate crisis and the economic consequences of the COVID-19 pandemic, compounded by the war in Ukraine ? are major

Expired drug kills 10 child leukemia patients in Yemen

CAIRO: At least 10 child leukemia patients in Yemen have died, and dozens more left seriously ill, after being administered expired doses of a cancer treatment in the rebel-held capital, medical officials was and workers said on

Friday. Yemen's ruinous conflict, now entering its eighth year, has caused one of the world's worst humanitarian crises and killed in excess of 150,000 people. The children were aged between three and 15 and died at Sanaa's Kuwait Hospital after being injected with old doses of smuggled medicine at a number of private clinics, the rebel-run Health Ministry said a statement in Thursday. ### Giant of skies -- Airbus A380 -- lands in Bengaluru

BENGALURU: On Friday evening, the world's largest passenger aircraft, which flew in from Dubai, touched down at the Kempegowda International Airport with 231 passengers on board at 3.37 pm, creating an epochal moment in aviation history. The superjumbo Airbus A380 flew announced its arrival in Bengaluru with a big group of Emirates staff on board. The commercial launch will start on October 30. Flight EK 562 took three-and-a-half hours to complete its journey from Dubai International Airport, landing smoothly on the Southern Runway of KIA. BIAL airport operator accorded a "follow me" welcome with three yellow cars guiding the flight to the parking lot.Bengaluru will only be the second airport after Mumbai to have received this Superjumbo flight with a seating capacity of 493, which is 45% more than the Boeing 777. Speaking about its features, an Emirates spokesperson said, "The aircraft is 72.7m long, weighs over 510 tonnes and stands at 24.1m tall." Corporate Affairs Nirmala Sitharaman said India has projected growth rate of 7 Percent for the Indian Economy.

While participating in Joint World Bank-

International Monetary Fund (WB-IMF) Development Committee (DC) meeting during the Annual Meetings 2022 in Washington DC, she said however, we remain concerned about the global economic outlook and geopolitical environment.

Sitharaman Smt. stated that the Food and Energy Crisis rightly paper identifies energy efficiency as the "first fuel of choice". Similarly, reducing crop loss and food waste should also be the "first intervention

of choice" to ensure food security.

The Finance Minister urged the World Bank to avoid a unidimensional view of subsidies and to differentiate between distortive subsidies and targeted support to the vulnerable households.

The Raksha Mantri termed North-East as the arm of India which was ignored for a long time after independence. He asserted that the progress of the North-East has been one of the major focus areas of the Government, led by Prime Minister Shri Narendra Modi, since the beginning as the region is crucial for the economic, social, political and strategic development of the country.

"Our greatest achievement in the last 8.5 years has been the restoration of peace & prosperity in the North-Eastern states. Since 2014, there has been about 80-90 per cent reduction in violence incidents in almost every state of the North-East. Most of the extremist organisations have either been rooted out or have surrendered and joined the mainstream. Armed Forces (Special Powers) Act has been removed from 80 per cent of the areas. This was made possible as now there is peace, stability and durability in the region," Shri Singh said. The Raksha Mantri described connectivity with the North-East as another achievement of the Government in the last 8.5 years. He stated that air, road and rail connectivity infrastructure has been strengthened and there is now a direct link with the region. He termed the Union Cabinet approval of Prime Minister's Development Initiative for North East Region (PM-DevINE) as a testament to the Government's commitment towards progress of the Northeastern states. The progress of the North-East region is pivotal to making a strong, prosperous and self-reliant 'New India' as envisioned by the Prime Minister, he said. Shri Singh commended Prime Minister Shri Narendra Modi under whose leadership the country's economy has become more dynamic and stronger. He added that the number of start-ups in the country has increased manifold to 75,000 from just 400 in 2014. Of these, more than a 100 are known worldwide as unicorns due to their valuation of \$1 billion, he said. "Today, most of the countries are facing the problem of slowdown in economy. International Monetary Fund (IMF) has projected its global GDP growth rate to be 2.9 per cent in 2022-23. While India's growth rate has been underestimated, it is still pegged at 6.1 per cent. the laws which have been going on from the time of slavery", Shri Modi added. The Prime Minister also pointed towards reviewing the existing laws of the states while focusing on Ease of Living and Ease of Justice for the people.

The Prime Minister noted that the delay in serving justice has come across as the biggest challenge and the judiciary is working with utmost seriousness in this direction. Throwing light on the mechanism of alternative dispute resolution, the Prime Minister suggested that it has been put to good use in the villages of India for a long time and can now be promoted to the state level. "We have to understand how to make it a part of the legal system at the local level in the states", Shri Modi added.

Recalling the time when he was the Chief Minister of Gujarat, the Prime Minister said that the then government had introduced the concept of evening courts. He further explained that cases which were less serious in terms of sections were taken up by the evening courts which resulted in the resolution of more than 9 lakh cases in Gujarat in recent years. The Prime Minister also highlighted the emergence of Lok Adalats that have led to the disposal of lakhs of cases in various states and reduced the burden of the courts. "People living in the rural areas have benefitted immensely from this", he added. Noting the responsibility of the ministers in formulating laws in the Parliament, the Prime Minister remarked that if there is confusion in the law itself, it is the common citizens who have to bear the brunt of it in future, no matter the intentions. He further added that ordinary citizens have to spend a lot of money and run around from post to pillar to get justice. He said, "When the law comes to the understanding of the common man, then its effect is something else."

Drawing examples from other countries, the Prime Minister noted that when a law is made in the Parliament or Legislative Assembly, it is prepared to explain it in detail within the definition of law, and secondly to draft the law in a language that can be easily understood by the common man. The timeline of the execution of the law is also determined and the law is reviewed again in the new circumstances. "Local language plays a big role in the legal system for ease of justice. Academic ecosystem will also have to be created for the youth in the mother tongue. Law courses should be in mother tongue, our laws should be written in simple language, digital libraries of important cases of High Courts and Supreme Court should be in local language", he added. "When the judicial system grows along with society, it has a natural tendency to adopt modernity. As a result, the changes that take place in society are also visible through the justice system" Shri Modi said. Putting the spotlight on the integration of technology in the judicial system, the Prime Minister pointed out the emergence of e-courts and virtual hearings and the promotion of e-filings. Shri Modi further added that these systems will get a major boost with the arrival of 5G in the country. "Every state will have to update and upgrade its systems. It should also be an important goal of our legal education to prepare it according to technology", he added. Recalling the joint meeting of Chief Justices of High Courts where the Prime Minister had raised the issue of undertrial prisoners, he urged the dignitaries to work towards speedy trials for the disposal of such cases. The Prime Minister further added that state governments should work with a humane approach regarding undertrial prisoners so that the judicial system moves forward with human ideals. "A sensitive justice system is essential for a capable nation and a harmonious society", Shri Modi added. Underlining the supremacy of the Constitution, the Prime Minister said that the Constitution is the origin of the judiciary, legislature and executive. "Be it the government, Parliament, our courts, all three are, in a way, the children of the same mother. So even though the functions are different, if we look at the spirit of the constitution, there is no scope for argument or competition. Like the children of a mother, all three have to serve Maa Bharati, together they have to take India to new heights in the 21st century", the Prime Minister concluded. ### China censors rare anti-Xi protest ahead of Communist Party congress

BEIJING: China's internet censors removed on Friday virtually all references to reports of a rare protest in Beijing that involved banners denouncing President Xi Jinping and the country's Covid policies. Beijing is on high alert against any dis-



ruption to a landmark Communist Party meeting that begins on Sunday, where Xi is expected to secure a historic third term. Incoming parcels and subway commuters have been subjected to additional security checks, and armies of volunteers have been deployed in every neighbourhood to report anything out of the ordinary.

But video footage and photos that spread online on Thursday appeared to show a defiant protester draping two hand-painted banners with slogans criticising the Communist Party's policies on the side of a bridge in Beijing.

"No Covid tests, I want to make a living. No Cultural Revolution, I want reforms. No lockdowns, I want freedom. No leaders, I want to vote. No lies, I want dignity. I won't be a slave, I'll be a citizen," one banner read.

The other banner called on citizens to go on strike and remove "the traitorous dictator Xi Jinping".

Other images showed a person in a hard hat standing on the bridge behind the banners, as well as smoke rising from a fire on the bridge and police rushing to remove the banners.

There was no sign of the banners or their writer when AFP journalists arrived at the scene of the reported protest Thursday.

There appeared to be an elevated police presence around the site but locals said they had not seen the banners being unfolded.

Public protests are extremely rare in the Chinese capital and those who defy Beijing's strict security apparatus face serious punishment.

By Friday morning, Chinese social media censors had blocked posts and keywords related to the protest, including "Sitong Bridge", the name of the overpass where the slogans appeared to have been displayed.

Search results for the keyword "Beijing" on the popular Weibo platform were restricted to just verified accounts on Friday, instead of the usual torrent of regular users' posts about the capital.

Even phrases that referred obliquely to the protest, including the hashtag "I saw it", returned no results by Friday afternoon.

"I saw it" was one of the last hashtags with which Weibo users discussed the incident in veiled references early Friday, with one user posting: "I saw it, I will not forget it."
