NEW DELHI(KCN): Prime Minister Narendra Modi greeted Congress leader Mallikarjun Kharge on his election as party president on Wednesday and wished him a fruitful tenure.

"My best wishes to Shri Mallikarjun Kharge Ji for his new responsibility as President of @INCIndia. May he have a fruitful tenure ahead," Modi tweeted.

Kharge was elected Congress president, defeating Shashi Tharoor in an electoral contest, the sixth in the party's 137-year-old history. The Karnataka leader will formally take over as the party's president on October 26. He will be the first party president from outside the Gandhi family in 24 years.

Culture of Odisha – Explore the Varied and Ancient Heritage of Utkala Region

Culture-of-Odisha-Architecture

The Sun Temple in Konark is the crowning achievement of the Orissa style. It is the last



phase of temple construction in Orissa. It was constructed in the 13th century A.D. by Narsingha Deva of the Ganga Dynasty. It is known as the Black Pagoda and is dedicated to Surya, the Sun God. It portrays Time – the Sun God moving across the sky, shaped like a Ratha or chariot drawn by seven gorgeously caparisoned horses in motion. The temple's outer walls are adorned with magnificent sculptures of dancers in various stances, musicians, lions, horses, elephants, and other animals depicting all aspects of life.

Architecture of Odisha Jagannath Temple

A ruler of the Ganga Dynasty built the Lingaraja temple in the 11th century AD. It has all of the characteristics of an Orissa



temple. It has a vimana and a Garbha Griha and is enclosed in a quadrangular enclosure. The shikhara, a lofty ribbed curvilinear spire that curves in at the top and is crowned by an amalaka or great rounded block of stone, is built over the garbha griha. The golden vaseshaped Kalasa with a trisul stands on top of this. The sanctuary is built on a foundation of beautiful mouldings. Niche projections of Ganesh, Parvati, and Kartikeya adorn the lower half of the wall on three sides.

Puri's Jagannath temple is a grander version of Lingaraja's temple. It was constructed in the 12th century AD and includes a 65-meterhigh tower.

Religion of Odisha

Odisha is home to Hinduism, Islam, Christian-



ity, Buddhism, and Jainism, among other reli-

gions. However, Hinduism is the ma-

jority religion in Odisha. Despite the fact that all other religions have adherents, Odisha boasts the biggest concentration of Hindus among Indian states. Odisha is a nation of religious tolerance, and people of many sects and faiths coexist peacefully, often within the same hamlet, and used to share all of the festivals.

Music and Dance of Odisha

Odisha has a long and illustrious musical cul-



ture. Odisha's rich musical legacy is reflected in the figures of dancers and musicians carved on old temple walls. Odissi music is a classical genre that combines all of the elements found in Hindustani and Karnatic music. Odissi sangita is a synthesis of four types of music, namely dhruvapada, chitrapada, chitrakala, and panchal, as detailed in two treatises produced in the early nineteenth century, namely Sangita Sarani and Sangita Narayana. Jayadev, the saint-poet, renowned composer, and illustrious maestro of classical music, is responsible for most of it.



The Odissi dance, which is choreographed to the best music of Odisha, is claimed to be an attempt to approach God and experience ultimate happiness. As a result, the devadasis, who used to dance to the recital of hymns and bols of talas, kept this dance alive. The Odissi dance emerged from the millennia-old Mahari dance form, which was once performed by devadasi dancers known as maharis at the shrine of Lord Jagannath in Puri. It was afterwards promoted as Odisha's classical dance genre. Late Kavichandra Kalicharan Patnaik and Padma bhusan recipient Kelu Charan Mahapatra are among the masters who elevated the dance form to international prominence. To name a few, there's Padmashree Pankaj Charan Das, and Deba Prasad Das.

In the world of Odisha music and dance, Chhau is a popular dance genre in addition to classical Odissi. It's a warrior dance performed to the accompaniment of indigenous instruments. Today's highly stylized Chhau dance adheres to the essential principles of Bharat

Festivals of Odisha

Odisha is a melting pot of cultures, including Aryan, Dravidian, and Adivasi. The majority of the state's festivals highlight some aspect of their cultures and honour their faith throughout the year. There are several festivals that are widely celebrated, but the celebrations are unique to each place. The Rath yatra is the state's most well-known festival, during which a massive chariot or rath is driven across the state, particularly in Puri, where devotees worship Lord Jagannath. Durga Puja is celebrated all around the state, but especially in Cuttack. Kali Puja, also known as Diwali, is observed in many parts of Odisha. Cuttack's Bali Yatra, held on the full moon day of Kartika, recalls the splendor of Odishan traders in the past. At Baripada, the Chaitra Parva, a Chhou dance festival, is held.

Cuisine of Odisha

Odiya cuisine uses a variety of locally obtained vegetables, grains, pulses, dairy products, and seafood, as well as fewer spices and oil.



Khechidi (rice, lentils, and ghee), Palau (vegetables, dry fruits, and spices), Kanika (sweet rice dish made with dried fruits and ghee), Ghee rice, and Pakhala (watered rice served with curd and stir-fried vegetables) are some of the famous rice dishes in Odisha. The vegetable and spice-laden Dalma, the plain and uncomplicated Dali, and the delectable and flavorful Besara are just a few of the mouthwatering lentil meals. Santula is a vegetable stew made with onion, garlic, and green chilies in a skillet. Khajuri khata, Amba khatta, Ouu khatta, dhania-patra, and pudina-patra chutneys are some of the state's well-known chutneys used as condiments in Odishan cuisine. Dahi baigana, a curd and brinjal dish, is a delicious side dish with a tangy, flavorful, and sweet-sour flavour.

Cuisine of Odisha

When it comes to sweets, Odisha has a wide variety of desserts, including cheese-based Chhena Poda, Chhena Jhili, Rasamalai, and Chhena Gaja, as well as flour-based Pheni, Jilapi, Malpua, and Kheera Gaja. Pitha, or indigenous cakes, are popular in Odisha.

The kitchen of Puri's famous Jagannath Temple is said to be the world's largest, with a thousand chefs working around 752 woodburning clay hearths known as chulas to feed over 10,000 people every day. Offerings are



made to the presiding deities in temples around the region. The Jagannath Temple's prasad is well-known, and it is known as Maha Prasad, which means "largest of all prasads." It is known as chhappan bhog since it has 56 recipes.

Tourism of Odisha

With a 485-kilometre-long coastline, mountains, lakes, natural biodiversity, and rivers,



tourism in Odisha is one of the most important contributors to the state's economy. Odisha is one of India's most important tourism destinations, offering a diverse range of tourist attractions including wildlife reserves, beaches, temples, monuments, the arts, and festivals.

Occupation of Odisha

In Orissa, agriculture is the most common occupation. Agriculture and agriculture-related businesses employ over 76% of the entire



working population. In addition, the state is a big producer of fish. Because of the favourable industrial climate in the state, the state has seen an increase in industrial activity.

Development of Mines and Minerals regulated under the Act and Rules

The Mines and Minerals are the relative terms if there are mines, there are minerals. What is a mine? Mine means a passage dug in the earth for extracting minerals and the in-organic substance naturally occurred are minerals. As per the Chamber Dictionary, mine means "a place from which minerals are dug". Minerals means "a substance produced by the process of in-organic nature". As per Halsbury (4th Edition) Vol.20, para 407, page 189 mine means an excavation or system of excavations made for the purpose of, or in connection with, the getting, wholly or



substantially by means involving the employment of persons below ground, of minerals (whether in their natural

state or in solution or suspension) or products of minerals.

products of minerals. As per Bohuvier Law Dict., mine means an excavation made for obtaining minerals from the bowels of the earth. Under the Government of India Act, 1935 the regulation of mines and development of minerals was divided between the Central Legislature and the provincial legislature. In the VIIth Schedule of the Constitution of India, Entry 54 of the Union List deals with the regulation of mines and minerals development to the extent to which such regulation and development under the control of union is declared by the parliament by law to be expedient in the public interest. Entry 23 of the State List i.e. List II of the said schedule (Provincial Legislative List) that deals with the regulation of mines and minerals development subject to the provisions of List I with respect to regulation and development under the control of Union of India. The term "regulation" has to be read in this context in which it has been used. As per Advanced Law Lexicon, "regulation" shall mean a regulation made by President under Article 240 of the Constitution and shall include a regulation made by President under Article 243 thereof and a regulation made by the Central Government under the Government of India Act, 1870 or the Government of India Act, 1915 or the Government of India Act, 1935. The section regulation means any regulation of the Bengal, Bombay or Madras code or regulation as defined in the General Clauses Act, 1897 or in the General Clauses Act of a State. It is pertinent to mention here that the word "regulation" as used in Entry 54 of the Union List stated supra cannot but the said to have broad impact encompassing all facts not only specifically mentioned in the Entry itself but it is inclusive of its inherent implications thereto as well. In this context, the judgment of the Hon'ble Supreme Court in the case of Saurashtra Cement & Chemical Industries Limited & Anr. Versus Union of India & Ors., (2001) 1 SCC 91, has been categorically dealt the term "regulation" in para 30 of the said judgment. In the said paragraph it has been stated that in Corpus Juris Secundem (Vol.76, Page 615) the word

"regulation" has been defined as a

rule or an order prescribed for management or governance. In the said judgment, the Appellants-Petitioners had challenged the constitutional validity of Section 9(3) of the Mines and Minerals (Regulation and Development) Act, 1957. The provision under Sub-Section 3 of Section 9 (3) of the said Act contemplates that the Central Government may by notification in the Official Gazette amend the second schedule so as to enhance or reduced the rate at which the royalty shall be payable in respect of any mineral with effect from such date as may be specified in the notification. Provided that the Central Government shall not enhance the rate of royalty in respect of any mineral more than once during any period of three years. The Supreme Court after hearing a batch of appeals and writ petitions was please to uphold the validity and dismissed all these appeals and writ petitions modifying the rate of interest from 18% yearly, rest to 9% simple interest. The necessity of Central Legislation of Mines and Oilfields and Mineral Development was increased and was highlighted during the Second World War with the result the important minerals had to be controlled under the Defence of India Act, 1939 and it was also felt a uniform policy of mineral development was essential to economic and industrial progress. Therefore, after independence the Government of India set out a policy that is called Industrial Policy Resolution of April 1948. The said policy was proposed to pursue the industrial field. The industrial resolution included minerals amongst the industries whose location had to be governed in the light of economic factors of All India importance which required a genuine and considerable investment or a high degree of technical scheme, consequently the same had to be subject of central regulation and control. Resultantly the legislature of the dominion of India enacted on September 8, 1948, the Mines and Minerals (Regulation Development) Act, 1948 and the Act was brought into force on October 25, 1949. The substantial object of the said Act was to regulate mines and oilfields and mineral development on the lines contemplated in the Industrial Policy

Resolution of April 6, 1948. Subsequently the Central Government by exercising the powers conferred under Section 5 of the 1948 Act made the Mineral Concession Rules, 1949 for regulating the grant of prospecting licenses and mining leases for minerals and other mineral oil and natural gas. The said rules came into force on October 25, 1949. After the commencement of the Constitution No.M-II-155(92) dated October 29, 1951, the word "provincial" was substituted by the word "State". In the year 1957 for developing the mines and minerals, the parliament decided that the regulations and development of mines and minerals should feature by themselves in a separate Act. Accordingly the parliament on 28th

December, 1957 enacted the Mines

Minerals and (Regulation Development) Act, 1957. The title of 1948 Act was amended accordingly which was brought into force on June 1, 1958 by notification dated May 29, 1958. The validity of the said Act has been taken into account in the first judgment of the Hon'ble Supreme Court i.e. D.K. Trivedi & Sons Versus State of Gujarat 1986 (1) SCR 479. After 1957 the legislative competency of the State Legislature to enact law on the regulation and development of mines and minerals was challenged in The Hinger-Rampur Coal Co. Ltd. & Ors. Versus The State of Orissa & Ors. 1960 (2) SCR 537, the validity was taken into account. While dealing with the contention the Supreme Court held "the jurisdiction of the State Legislature under Entry 23 is subject to the limitation imposed by the latter part of the said entry. If the parliament by its law has declared that the regulation and development of mines should in public interest, be under the control of the union, to the extent of such declaration, the jurisdiction of the State Legislature is excluded. In other words, if a Central Act has been passed which contains a declaration by parliament required by Entry 54, and if the said declaration covers the field occupied by the impugned Act, the impugned Act would be ultra vires, not because of any repugnance between the two statutes but because the State Legislature had no jurisdiction to pass the law. The limitation imposed by the latter part of Entry 23 is a limitation on the legislative competence of the State Legislature itself."

The interpretation of the regulation has been categorically dealt by the Hon'ble Supreme Court in the judgment State of Tamil Nadu Versus Hind Stone Etc., (1981) 2 SCR 742. The two judge bench has interpreted the word "regulation" whether it includes prohibition. The Mines and Minerals (Regulation and Development) Act, 1957 was enacted in the public interest to take under the control the regulation of mines and development of minerals. The provisions under the Act particularly under Sections 4A, 17 & 18 of the Act, 1957 that the rule making authority under Section 15 has not exceeded its powers in banning leases to view such a rule made by the subordinate legislating body as a rule made to benefit itself merely because the State Government happens to be a subordinative legislative body but to take too narrow a view of the functions of that body. The Supreme Court has also taken a view referring to the above said judgment in D.K. Trivedi and sons & Ors. etc. etc. Versus State of Gujarat & Ors. etc. etc. (1986) 1 SCR 479 held that sub-section (1) of Section 15 of the Mines and Minerals Development Act, 1957, is constitutional and valid and the rule making power conferred thereunder upon the State Government does not amount to excessive delegation of legislative powers to the executive. To take into account the legislative history and practice when considering the validity of a statutory provision or while interpreting a legislative entry is

well established "Principle of construction of statute".

The Section 13A and Section 15 of the Act empowers the Central Government and the State Government respectively to frame the rules. Section 13A of the Act contemplates that the Central Government may by notification in official gazette make rules for the grant of prospecting licenses or mining leases in respect of any materials underlying the ocean within the territorial waters or continental shelf of India. Similarly, Section 15 of the Act empowers the State Government to make rules by notification in the official gazette for regulating the grant of quarry leases, mining leases or other mineral concessions in respect of minor minerals and for purposes connected therewith. On September 12, 1972, Mines and Minerals (Regulation & Development) Act, 1957 was amended by Act No.56 of 1972. By the said Act, Section 4-A was introduced in the Act which reads as follows:

"4-A. (1) Where the Central Government, after consultation with the State Government is of opinion that it is expedient in the interest of regulation of mines and mineral development so to do it may request the State Government to make a premature termination of a mining lease in respect of any mineral, other than a minor mineral, and, on receipt of such request, the State Government shall make an order making a premature termination of such mining lease and granting a fresh mining lease in favour of such government company or corporation owned or controlled by government as it may think fit.

(2) Where the State Government, after consultation with the Central Government, is of opinion that it is expedient in the interest of regulation of mines and mineral development so to do, it may, by an order, make premature termination of a mining lease in respect of any minor mineral and grant a fresh lease in respect of such mineral in favour of such government company or corporation owned or controlled by government as it may think fit." Further in the year 2015, some provisions of the Mines and Minerals (Development & Regulation) Act, 1957 were amended. As per the said amendment, there were substantial changes made in Section 10 in regard to the application for prospecting licenses for mining leases, rights of existing concession-holders and applicants and grant of mining lease in respect of notified minerals through auction. In addition to the amendment in the 1957 Act, there are many rules have been amended in the year 2015 and thereafter also for regulating the extraction of minerals in the interest of the economy of the nation and in future the provisions of the said Act may be amended if the situation so arises for the economic prosperity of the nation. The Hon'ble Supreme Court in various judgments relating to the Mines and Minerals dealing with various issues has passed many historic judgments since 1951.

Mobile medical teams will render the services regularly to displaced persons at their place of shelter and in marooned villages. Contingency plans will be prepared to open Medical Relief Centers (MRC) at strategic places to be done by CDM & PHO immediately, as per the action plan.

All the Ambulances 108/102 / RBSK vehicles of different health institutions of

the districts are kept in readiness for management of emergency situations. The healthcare authorities will have to submit a situation every day by 6 pm to State headquarters.

Notably, the IMD said that the cyclonic circulation lies over north Andaman Sea and neighbourhood since yesterday. Under its influence, a low pressure area is likely to form over southeast and adjoining east central Bay of Bengal during next 24 hours.

It is likely to move e s t northwestwards and concentrate into a depression by October 22 morning over Central Bay of Bengal. It is very likely to intensify further into a cyclonic storm over west central Bay of Bengal during subsequent 48 hours, it said.

However, the Met department neither predicted the possible path or intensity of the cyclone nor issued any warning for Odisha. It has advised fishermen not to venture into deep areas of west central adjoining northwest Bay of Bengal from October 22 morning. If the cyclone forms, it will be named as Sitrang, a name given by Thailand.

Xi Jinping swears by Marxism to make China first modern socialist country

BEIJING: Poised for record third five-year term and perhaps for life, Chinese President Xi Jinping's high-voltage Marxist rhetoric on Sunday with a vow to make China a modern socialist country has raised hackles at home and abroad that the Communist giant, which for decades relegated the ideology to the background, could be taking the turn to the extreme left.

"From this day forward, the central task of the Communist Party of China (CPC) will be to lead the Chinese people of all ethnic groups in a concerted effort to realise the Second Centenary Goal of building China into a great modern socialist country in all respects and to advance the rejuvenation of the Chinese nation on all fronts through a Chinese path to modernisation," Xi said in his marathon speech at the key Congress of the party on Sunday.

"Only by taking root in the rich historical and cultural soil of the country and the nation the truth of Marxism flourish here," he told the over 2,300 delegates of the week-long 20th Congress, which is due to confirm his unprecedented 3rd five-year term to make him the only leader after the party founder Mao Zedong to continue in power after 10-year

Xi, 69, who came to power in 2012, has raised the ideological bar of the CPC, which earlier relegated the ideology to the backseat for the last three decades.

China emerged as the second largest economy after the US during this period riding on the success of opening up and economic reforms initiated by Deng Xiaoping, ending Mao's disastrous tryst with extreme Marxist-Leninist communist ideology.

Deng, who succeeded Mao after his death in 1976, ended the founder's ideological obsession and advocated a new theory of Socialism with Chinese Characteristics under which CPC remained all but a Communist party by

portance of Marxist ideology bluntly at a CPC conference in 1981 with a cryptic remark "let's dispense with the theory", which became a buzzword for the party leaders.

His successors Jiang Zemin and Hu Jintao followed his lead, rapidly expanding the role of the market in the Chinese domestic economy and embracing a foreign policy that

In the following years, it practised a policy of reform and opening up advocated by Deng attracting massive foreign investments to revive the country, which went bankrupt under

Deng, who is widely regarded as the father of China's economic rise, dismissed the immaximized China's participation in a global economic order led by the United States.

"Xi has brought that era of pragmatic, nonideological governance to a crashing halt," Australia's former prime minister Kevin Rudd, who is widely regarded as the foremost expert on China, wrote recently in the Foreign Affairs journal.

"In its place, he has developed a new form of Marxist nationalism that now shapes the presentation and substance of China's politics, economy, and foreign policy," he said.

"Xi has pushed politics to the Leninist left,

economics to the Marxist left, and foreign policy to the nationalist right," Rudd said. Xi has "reasserted the influence and control the CPC exerts over all domains of public policy and private life, reinvigorated stateowned enterprises, and placed new restrictions on the private sector", Rudd said in his write-up ahead of the CPC Congress.

Meanwhile, Xi has "stoked nationalism by pursuing an increasingly assertive foreign policy, turbocharged by a Marxist-inspired belief that history is irreversibly on China's side. In short, Xi's rise has meant nothing less than the return of Ideological Man?, he said. Cai Xia, who worked as a professor for 15 years at CCP's Central Party School in Beijing, said Xi, a devoted student of Mao, is eager to leave his mark on history.

The Central Party School which was headed by Xi himself when he was the Vice President taught ideological subjects to the CCP cadre at various levels.

"And because previous reforms failed to place real checks and balances on the party leader, Xi has succeeded. Now, as under Mao, China is a one-man show," Cai, who migrated to the US after her retirement and turned adissident, wrote in the Foreign Affairs journal.



Kharge was elected unopposed to the Rajya Sabha from Karnataka in June 2020 and was the 17th Leader of the Opposition in Upper House until recently, ahead of his resignation from the post to contest the Congress' Presidential election. He had succeeded Ghulam Nabi Azad as LoP in February last year.

He was several times seen as a top contender to become the Chief Minister in Karnataka, but could never occupy the

"Why do you keep saying Dalit again and again? Don't say that. I'm a Congressman," Kharge has said several times in the past, whenever the Dalit CM topic cropped up with him as the contender. Sober by temperament and nature, Kharge has never landed in any major political trouble spot or controversy.

Born in a poor family at Varavatti in Bidar district on July 21, 1942, he did his schooling and BA as well as Law in Kalaburagi. He was into legal practice for some time before plunging into politics.

He is a follower of Buddhism and is the founder-chairman of Siddharth Vihar Trust that has built the Buddha Vihar complex in Kalaburagi.

Married to Radhabai on May 13, 1968, they have two daughters and three sons. One son, Priyank Kharge is a MLA and a former Minister in Karnataka.

A vocal critic of the Narendra Modi-led government, Kharge's elevation to head the Congress is expected to give a boost to the cadre amid hopes that it would unify the party leadership in the state that goes to Assembly polls by April next year.

European football model 'unsustainable', says new CEO of Super League promoter

PARIS: The new CEO of the company promoting the Super League, German businessman Bernd Reichart, says European football must hold talks to reshape its future and warns it is "becoming unsustainable" under the current system.

Reichart, the 48-year-old former boss of the RTL media group in Germany, was on Wednesday appointed head of A22

pared to shape their own future and to consider what the new landscape could look like," he said.

"Football can do better, clubs should be able to lead such a dialogue and be entitled to propose new alternatives, free from threats, sanctions or exclusion (from) competition as happened in the

past."

"The football ecosystem is becoming unsustainable, the pandemic has accelerated this trend, the system is broken," he added.

Closed shop 'off the table'

Launched by some of Europe's top

clubs in April 2021, the Super League's plan to shake up European football fizzled out amid the fury of many supporters and the threat of political ac-

The prospect of a closed competition for Europe's elite angered fans in particular, but Reichart said a new approach meant that would no longer be the case. "One of our key messages is permanent membership is off the table, and we want to discuss on the basis of an open competition based on sporting merit."

Three of the clubs -- Real Madrid, Barcelona and Juventus -- continue to campaign for the Super League. A dispute over an alleged abuse of a dominant position by UEFA is to be settled in early 2023 by the European Court of Justice.

UEFA president Aleksander Ceferin defiantly claimed in May the Super League there is consciousness that the (status project was "over once and for all or at least for 20 years", but Reichart remains

"You might get suspicious if somebody tells you again and again something is dead," said Reichart, a specialist in media and sports rights who also previously worked for the Spanish media group Atresmedia.

"That is not going in the right direction," said Reichart.: "I'm pretty convinced fans will not like the 2024-2027 format, which has clear weaknesses, a huge number of additional matches, and the same old last 16 where the Champions League is getting really interesting and exciting, when we are in spring."

Top-ranked Iga Swiatek beats Vekic to win San Diego title SAN DIEGO: Top-ranked Iga Swiatek over-

came a challenge from qualifier Donna Vekic on October 16 to win the San Diego Open title with a 6-3, 3-6, 6-0 victory.

characterised as an ideological crisis. The Internet, he said, was an existential threat to the CCP, having caused the party to lose control of people's minds" and cracked down on bloggers and online activists, censored dissent and strengthened China's "great firewall" to restrict access to foreign websites, she said.

"The effect was to strangle a nascent civil society and eliminate public opinion as a check on Xi," she said.

Chinese political experts on the other hand said Xi's "theoretical innovation" of the CPC has global significance as it offers countries around the world a new growth model.

Shen Yi, a professor at the School of International Relations and Public Affairs of Fudan University, told China's state-run Global Times that "the concept of Chinese modernisation was raised for the first time as one of the most important conclusions the CPC made from its past experiences."

Shen said that as there is no ready-made development path or mode for China to directly copy or imitate, China has finally concluded a Chinese path to modernisation after more than a hundred years of exploration and construction since the Revolution of 1911, providing a completely new alternative.

It also provides a third choice for all developing countries in the world which are searching for or struggling with their development modes with the wish to both realise
