MYKOLAIVKA(KCN): Ukraine's President Volodymyr Zelensky said Sunday that Lyman, a key town located in one of the four Ukrainian regions that Russia annexed, was "cleared" of Moscow's troops.



### GANDHI AND SHASTRI JAYANTI OBSERVED AT DAV, KALINGA NAGAR No Naming; Only Criticism

Bhubaneswar(KCN): 29 September, 2022 could be a memorable day for the politicians in Odisha as both the ruling BJD and Opposition BJP held separate congregations. There were many similarities and differences in both the events as well. The Opposition Bharatiya Janata Party (BJP) which was all along considered as a friendly opposition attempted to give a message to the people that they meant business and were really interested to fight against Naveen Patnaik's Biju Janata Dal (BJD).

BJP National President Jagat Prakash Nadda addressed the party leaders twice urging them to take the party's message to the nook and corner of the state. Though initially it was



While the BJP's 2-day event at Janata Maidan was all hot and noisy, there was calmness and tranquility in the BJD camp at Baramunda Ground. The party leaders were categorically instructed not to open mouth against the BJP and the Central Government even as Nadda and BJP leaders lashed on the regional party. Take the instance of Minister Ranendra Pratap Swain who openly said that he has been instructed not to speak against the centre. Rajya Sabha MP Sasmit Patra and Sanjay Dasburma raised the issue of central negligence even as BJD Vice-President and Minister Pramila Mallick was vitriolic at some point of time.

## **Aqua Assess of Similipal**

Bhubaneswar(KCN): The State Government has decided to assess the water yield capac-



ity of various ecosystems in the Similipal area and its impact on cropping patterns and livelihoods of the people living in the vicinity.

The Agriculture and Farmers' Empowerment Department through Institute on Management of Agricultural Extension

(IMAGE) is going to conduct a study of the Similipal biosphere comprising around 17 blocks and around 1650 villages. The Department is all set to rope a private agency for the job, sources said here on Friday.

The objective of the study includes mapping of various ecosystem services within the Similipal bio reserve impacting water yields both at surface and subsurface level; influence of various meteorological factors, topography, soil and aquifer type, human interference and hydrologic factors on water yield capacity of various ecosystems; effects of climate change on catchment water yield including surface, lateral and groundwater and impact of spatially distributed hydrological status on cropping pattern and farm livelihoods of the farming communities inhabited in the landscape.

The study would also identify key adaptation strategies to restore, manage and protect the water yield of the ecosystems.

This study will help in mapping of various water yield ecosystems and related information for the Similipal landscape. It would also find the impact of water yield ecosystems on agriculture, environment, and livelihoods of the people.

It would identify and suggest agronomic, vegetative, management and other mechanical measures for water conservation and analysis of Spatio-temporal availability of surface and sub-surface water in the study area during monsoon and non-monsoon periods.

Further, the study would also help mapping of different farm-based livelihoods undertaken by communities depending on water availability, the sources said.

## **Railways move more Freight**

New Delhi(KCN): Indian railways has recorded best ever September Monthly freight loading of 115.80 MT in Sep'22. The in-

against 668.86 MT achieved in 2021-22 i.e. an incremental loading of 67.83 MT, with a growth of 10.14 % over same period last year. The freight NTKMs (Net tonne kilometers) have increased from 63.43 Billion in September '21 to 69.97 Billion in September'22 registering a growth of 10.3 %. The cumulative NTKMs in the first Half of the year have also grown by 17.1 % The sustained efforts of Indian Railways to increase supply of Coal to Power houses, in close coordination with Ministries of Power and Coal, has again been one of the key features of the freight performance in the month of September. The loading of Coal (both domestic and imported) to Power Houses has increased by 6.2 MT in September, with 42.00 MT Coal being moved to Power houses as against 35.8 MT last year, i.e. a growth of 17.3%. Cumula-tively, in the first Half of the year, IR has loaded more than 64.53 MT extra coal to Power Houses as compared to same period of last year, with a growth of more than 29.3%.



cremental loading in the month of September has been 9.7 MT i.e. a growth of 9.15% over the previous best Sep-

tember figures achieved in 2021.With this, Indian Railways has had 25straight months of best ever monthly freight loading. The Railways has achieved an incremental loading of 6.8 MT in Coal, followed by 1.2 in Iron Ore and 1.22 MT in Balance other goods, 0.4 MT in Cement & Clinker and 0.3 MT in Fertilizers. Increase in automobile loading has been another highlight of Freight Business in FY 2022-23 and 2712 rakes have been loaded in FY 2022-23 till September as compared to 1575 rakes during the same period of last year i.e. a growth of 72.2 %. The cumulative freight loading from 1st April'2022 to 30th September'2022 has been 736.68 MT as

## Free Rice for 3 Months

Bhubaneswar(KCN): Following extension of



the Pradhan Mantri Garib Kalyan Ann Yojana (PMGKAY), State Government has extended distribution of rice on free of cost to the beneficiaries covered under its own State Food Security Scheme (SFSS) for a period of another three month.

Chief Minister Naveen Patnaik on Saturday directed concerned officials to extend distribution of additional 5 kg of rice per month free of cost to beneficiaries of the SFSS from October 2022. The benefit of 5 kg free rice was earlier extended for the beneficiaries of the State Food Security Scheme from December, 2021 to March, 2022 and again for another six months (April to September, 2022).

About 9.05 lakh beneficiaries of 2.92 lakh families covered under the scheme will be benefited from this move. For this purpose, the state government will distribute 13,575 tonnes of rice from the state pool with an expenditure of Rs.49 crore from its own fund, it said.

This will facilitate beneficiaries enrolled in the State Food Security Scheme to remain at par with beneficiaries under National Food Security Act (NFSA), source said.

Notably, the Union cabinet on September 28 had approved the proposal to extend the free food grains distribution scheme under the Pradhan Mantri Garib Kalyan Ann Yojana (PMGKAY) for three more months i.e. October to December 2022.

Under the PMGKAY, the Centre also provides an additional five kilograms of rice or wheat per month to beneficiaries of the NFSA over and above their usual monthly quota for free. second occasion catching the BJD and its strategy makers unawares. The BJP President, during his two-day visit, has given a clear message that the saffron brigade would fight against its former ally ahead of the 2024 elections for the Lok Sabha and State Legislative Assembly.

However, Mr.Nadda, in his speeches never took the name of Naveen Patnaik though he targeted the BJD Government and held his dispensation responsible for all the odds in Odisha. At the same time, Nadda was also cautious in using his words while raising corruption issues and avoided to denounce the mining irregularities which the BJP has often reviled in the Assembly. BJP MP Aparajita Sarangi also raised the issue recently. Nadda refraining reference to Mining irregularities, obviously gave a different signal to the state. He did not mention names of Ministers who were allegedly accused in murder cases.

Nevertheless, there should be no doubt that the BJP has changed its strategy. Strong words like "Ukhad ke phenk do", "BJD Mukt Odisha", "Duplicate Government" and "Thappa" in central schemes were used by Mr.Nadda, but not a single word against Naveen Patnaik. It was "No Naming, Only Sham Criticism", pointed out a veteran political observer.

Everybody including JP Nadda is aware that Naveen Patnaik is the USP of BJD and he is the lone source of energy for the highly successful regional party. BJP leaders also know that the BJD will continue to remain in power as long as Naveen Patnaik's image remains pristine. As an opposition, particularly since 2009, the BJP has failed to make a scratch on Naveen's image which is considered as the "political inefficiency" of the saffron party. In a nutshell, both the opposition parties like BJP and Congress, came to nothing by diat the top of its voice on issues like corruption, lawlessness, ministers' involvement in murder cases, rise in crime against women and many others.

The BJD senior leaders now seriously consider that the regional party chief needs to think of a new strategy before the elections. If the BJD leaders raise the core issues like price rise and central negligence during the election time, it may give a different message and people may think what forced the BJD not to raise the issue as and when it was relevant. "Raising issues against BJP only during the election campaign may not be accepted by the people as the regional party continued to remain silent all along," pointed out a senior leader.

The political analysts opine that the parties clamour over issues continuously and finally blow them up during the election campaign. But, in the case of BJD, the general impression is that the regional party does not care for the suffering and plight when it matters and only takes shelter under them in election campaigns.

It is, however, a fact that BJD has a well-oiled election machinery with money, media and men at the grass root level. This apart, the regional party goes to elections while in power. Still, the party's stand must be clear ahead of elections. Keeping in view the past activities like sending a BJP candidate to Rajya Sabha, supporting all the bills and initiatives of the Modi government, a general impression was created across the state that Naveen was no longer maintaining "equal distance" to both the BJP and Congress, but was right leaning.

This doubt among the people should be cleared ahead of the polls, feel BJD insiders. And if anyone may clear the doubt in the minds of voters about Naveen's true intentions, it is none other than Naveen himself.



## Compulsory Tax Audit Penalty can't be imposed in which cases Part 2

#### (Contd from 26.9.2022)

Consequences for failure to get the accounts audited or not furnishing



audit report in time: The failure to get accounts audited within specified date u/s 44AB or failure to furnish audit report one month before the due date of filing return of income u/s 139(1) or 142(1)(i)may attract penalty u/

s 271B, which shall be lower of the following -

- half per cent of total sales, turnover or (i) gross receipts, or
- (ii) Rs. 1,50,000/- w.e.f. asst year 2011-12. 10. What happens when assessee gets his accounts audited u/s 44AB within prescribed time, but files belated return enclosing the report of Tax Audit: W.e.f. asst. year 2020-21, the due date of furnishing tax audit report is one month before due date of furnishing return of income. Even when tax audit report was to be furnished within due date of furnishing return of income or even with return of income, furnishing audit report with belated return was subject to penalty under sec. 271B.
- 11. In case auditor's report u/s 44AB is prejudicial to assessee: It has been held in Rajkot Engineering Association and others v. Union of India 162 ITR 28 (Guj.) that in view of clarification made by Union Government in Reply affidavit of Under Secretary in Finance Ministry that opinions given by CA are not binding either on assessee or on A.O., it cannot be said that assessee will be c) prejudiced by qualified opinion given by tax auditor in a given case. Assessee may be required to persuade AO that there was no justification for qualified opinion or that there were valid and compelling reasons for assessee for his failure or omission to satisfy an auditor. We hope that **concerned tax** authorities will not approach the matter in a strictly technical manner so as to make a best judgment assessment and/or to levy penalty merely because there is a qualified report of an auditor. The authorities should adopt

to show cause notice issued by if the A.O.

assessee proves that there was reasonable cause for said failure, penalty u/s 271B shall not be imposed. Penalty u/s 271B is not automatic - CIT v. Ramkrishna Stores 253 ITR 175 (Cal.); CIT v. Haryana Agro Services [2005] 279 ITR 113 (P&H). Therefore, it is advisable to submit written explanation before concerned officer giving cogent reasons for delay and relevant evidences like doctor's certificate or proof of strike, lock out etc. should also be submitted.

# andhian outlook : A brief synop

IF PHILOSOPHY IS WISDOM, MAHATMA GANDHI WAS AMONG OUR foremost philosophers. He had the wisdom of Socrates, the humility of St. Francis of Assisi, the mass appeal of Lenin, the saintliness of the ancient Indian rishis and the profound love of humanity of the Buddha. He was a revolutionary who was committed to the overthrow of all forms of tyranny and social injustice



but who never bore illwell towards anyone, who led a mighty movement against British imperialism but never allowed the movement to be accompanied by hatred, rancour or resentment against Englishmen. He was not an intellectual in the

conventional sense of the term. He was not an academic philosopher propounding his philosophy in a precise, dry and formal manner. It would not be difficult to find inconsistencies and contradiction in some of his statements. He was supremely consistent in his devotion to truth. He was like the ancient sages, an earnest seeker after truth, a spiritual explorer or a scientist experimenting all his life to discover truth and apply it to the practical problems facing man. His sources of inspiration were not confined to his country or to his religion. His respective mind was open to various influences. From his very childhood he was brought into contact with religious and moral ideas. He studied the Ramayan, the Bhagabata, the Vaishnava poets of Gujarat and the popular writings of the Jains. During his stay in England he studied Buddhism and the Gita, met Quakers and Missionaries, read the Upanishads in translation, 'Ruskin's unto this last,

theosophist literature and books on Islam. He was also profoundly impressed by Thoreau

and Tolstoy. Thoreau taught him that it was more honorable to be right than to be law-abiding-a revolutionary concept, which inspired his philosophy of passive resistance. Tolstoy's The Kingdom of God Within You taught him how man could liberate himself and control ill through suffering.

Gandhiji was thought his life a God-conscious, God-fearing man. He never passed thought the valley of doubt and darkness. Nothing could shake his confidence and faith in God and His Scheme of life. God with him was not an abstraction or a mere metaphysical concept, but an intensely felt reality. Belief in God was with him a question of faith and conviction. He needed no arguments to establish God's existence. His whole being was permeated with God-consciousness; his heart vibrated with it. Gandhiji was no mystic who communicates with God in his trances or in moments of ecstasy but a man of action not living, in forests and meditating on eternal verities, but living amidst men, engaged in an epic struggle against alien rule. He had, however, the ability to withdraw himself from the life of excitement and meditate even amidst action. The Mahatma described God in various ways. God to him was kind, just and loving, who always responded to pra & love.

He was truth and love. A logical corollary to give belief is that the Universe is organised on moral principles and that it presents a harmonious design, there being no contradiction for inconsistency in the laws of nature and moral and spiritual principles. Gandhiji's faith in God was not shaken when he beheld nature read in truth and claw, when he saw

earthquake, floods and other natural calamities overwhelming man and causing infinite suffering. If

God was truth, love, benevolent and justice Ghandhiji asserted, man who was fundamentally moral and spiritual an image of God. Not a naked ape, not one with a divided nature, but a fraternity of spiritual beings.

Mahatma Gandhi's bold affirmation of faith in God, in the moral nature of the universe, in human society as an association of kindred souls and in free will may be criticized by the modern cynics on the ground that no valid intellectual grounds have been offered, but none can dispute the fact that his faith leads to a way of life which is in complete harmony with the needs of the times. If God is love or truth, there can be no bar to the realization of God through diverse ways. Religion does not divide people, unless it is understood in the sense that it is a matter of dogma, a church, a holy book; it emphasizes the fundamental unity of the human race. The Gandhian way is the way of universal love and tolerance, of profound reverence for all great religious which are so many ways of apprehending the reality and identifying ourselves with its purposes. Distinctions of race, nationality and sect have no room in Gandhian ethics. Patriotism is not enough. A truly religious man does not restrict his allegiance to any country or nation. His loyalty is to the whole of humanity. He acknowledges all great religious as embodying the truth and therefore, worthy of deep reverence. Mahatma Gandhi was an admirer of all religious-Hinduism, Buddhism, Jainism, Sikhism, Islam, Christianity and others. This does not mean that he accepted everything they preached. "He does not mouth the name of the Founder of Christianity", "writes Will Durant in his appreciation of the Mahatma, but he acts as if the Sermon on the Mount were his perpetual guide". If God is truth and if truth is God, then there is nothing which stands in the way of persons of various religious affiliations coming together on the same platform as seekers after truth. Even an earnest atheist trying to explore the reality is a truly religious man. What is repugnant to the Gandhian way of life dogmatism, fanaticism, intolerance, selfishness? Mahatma Gandhi was a secularist in the sense that he was against any discrimination between citizen and citizen on grounds of religion, sect or caste. But he firmly believed that a State or Society would be stable only to the extent to which it was based on ethical and spiritual ideals.

The Mahatma was the greatest exponent of Satyagraha-soul force, non-violence, noncooperation. He condemned the use of force; he hoped to win even his enemies by love, suffering and sacrifice. Underling his faith in Satyagraha was his conviction that no man, however tyrannical, can long withstand the pressure of the soul force, Gandhiji's followers, however, were not all confirmed pacifists, Non-Violence with many of them was more a matter of expediency.

The Mahatma was a kind of philosophic anarchist who believed in voluntary organization on co-operative lines. He was opposed to highly centralized states. He stood for village autonomy with a federation of village republics. He hated everything that degraded man-untouchability, inferior status for women, child marriage.

The Mahatma was neither a capitalist nor a Socialist. He propounded the theory of the rich classes being the trustees of the national wealth. He preferred the method of Satyagraha and moral persuasion as a mean of achieving a truly classless society of kindred souls to State action.





RM: Going by some studies, India's overall OTT business is expected to reach \$7 billion by 2027. Are we on the right track to reach there?

Mohta: The OTT industry is definitely on the right

track, while we can't really comment on the num-ber, as we are a singular OTT, but the ecosystem is definitely progressing. Ever since the lockdown there

have been gigantic leaps in terms of rise in user base, with more and more people discovering the true po-tential of the platform, OTT industry is definitely on the rise. Taking our case into consideration, hoichoi really started flourishing during the lockdown, but our highest direct subscription month has been Au-gust 2022

Mohta: I think the term vernacular OTT or regional OTT is redundant at this point. We're all Indian OTT platforms, and as for 'hoichoi', we call ourselves a global OTT platform as there are over 250 million

Bengalis across the globe, whom we provide with quality entertainment in their own language. However, having said that, languages other than Hindi and English are gaining more recognition and acceptance at present. During the lockdown, audiences were exposed to content across genres and languages, which led to a discovery that should have happened way before. But, better late than never. Good content traverses across language and geographical barriers and that I think is the primary reason behind the growth of vernacular OTT platforms. RM: At what rate hoichoi is growing- both in terms of subscription and in terms of revenue? How many years did you take to break even?

Mohta: Over the past year, hoichoi has seen a 50 per cent growth in direct subscriptions with a 20 per cent increase in streams in the post lockdown pe-riod. There has been a 31 per cent rise in watch time, 40 per cent rise in monthly active users, 30 per cent rise in international subscriber base and hoichoi continues to have one of the highest refresh rates in India for a single language.

Besides experiencing the aforementioned growth, hoichoi, is now a PnL profitable business as of August 2022. This month has been momentous in another regard as well, as it is the highest direct subscription revenue month for the platform across all three of its user base regions, namely - India, Bangladesh and International markets, all of which contributing over 100 per cent increase in growth RM: What would you attribute hoichoi's success story to?

Mohta: Undoubtedly our viewers. As a platform we've always made our audiences the crux of everything. From having a very strong and effective customer service and feedback cycle in place, to incorporating the changes that were asked for. We act promptly when it comes to addressing feedback. We also ensure that our audiences have enough and more options, which is why we schedule at least one original release every alternate week and one or more acquired content each week, to keep our at the end of the day storytellers, and whoever helps us tell a quality story in the best way, we go with them.

RM: Is there any initiative on your part to help and promote new, upcoming directors/filmmakers, artists?

Mohta: Hoichoi always promotes new faces and talents across its platform. From foraying into experimental genres and formats, hoichoi doesn't shy away from giving new directors and filmmakers a chance. For instance, one of top titles at present Karagar, is by a new and super talented director -Syed Ahmed Shawki. So yes, its a platform for talent and storytelling and endless entertainment.

RM: OTT platforms should thrive on subscription based fees or ad revenues or both- what is your take on this?

Mohta: This depends on the platform and their tar-get audience primarily. While SVOD works for some, hybrid revenue earning works better for the other. There's no set formula that works for all OTT platforms

RM: Do you see any threats in the wake of large global players and large Indian corporations coming into the field?

Mohta: Not really, our vision and TG is very different. We are a global OTT platform that aims to entertain audiences in their native language. hoichoi chooses to create content in Bengali only and while the titles are available in other languages as well, our primary audience is Benaglis across the globe. So, while there are other players in the market, our market is very different and we are doing our best to be the best in that space.

RM: Do you think even in the news segment, OTT is the future?

Mohta: OTT is the future for all forms of audio visual content, doesn't mean that other platforms are obsolete, but just that the overlap is inevitable and audiences these days want choices, so the more options they have, the better. They might want to consume news on the television, in print format, as an online article or even on OTT. Hence, OTT might not be THE future, but it definitely is a part of it. RM: Any plans to go national, going forward? Mohta: We already are a national OTT platform. Regional is a tag that we do not associate with, as there are over 250 million Bengalis across the globe, that makes us global and not just national. So yes, we've always been a national/global OTT platform. Also, hoichoi has its bases in both India and Bangladesh making it a global OTT platform.

Russian court approves annexation

With Russian losses mounting, experts have warned that President Vladimir Putin could turn to nuclear weapons to defend territory -- an option floated by a Putin ally.

Chechen leader Ramzan Kadyrov said Saturday that Russia should consider using "lowyield nuclear weapons" after Moscow's troops were forced out of Lyman.

Putin staged a grand Kremlin ceremony on Friday to celebrate the annexation of the four Ukrainian territories: Donetsk, Kherson, Lugansk and Zaporizhzhia, following referendums denounced as void by Kyiv and its allies.

Despite condemnation from the West, Russia's Constitutional Court on Sunday recognised as lawful the annexation accords signed by Putin with the Moscow-backed leaders of the four Ukrainian territories. The annexation treaties will be considered by Russia's lower house of parliament, the State Duma, on Monday, according to Duma speaker Vyacheslav Volodin.

The four territories create a crucial land corridor between Russia and the Crimean Peninsula, also annexed by Moscow, in 2014. Together the five regions make up around 20 percent of Ukraine.

Kyiv has also called for the immediate release of the chief of the Moscow-held Zaporizhzhia nuclear power plant, condemning his "illegal detention" by the Russians. ALSO READ | 'N-Talk shows not all is going well for Russia' Ihor Murashov was leaving the plant Friday when he was detained and "driven in an unknown direction" while blindfolded, Ukraine's nuclear agency Energoatom has said.

will work and achieve," Vaishnaw said.

According to the Department of Telecommunication (DoT), 5G technology is expected to deliver ten times better download speed than that of 4G and up to three times greater spectrum efficiency.

IIT Hyderabad professor Kiran Kuchi, who is heading the 6G development project, said that the institute has been granted some of the patents that will help create 6G standards and the process is on to apply for new patents as the technology advances.

"A normal cell site (mobile station) is divided into 3 sectors or zones. In 6G we are seeing there will be a single large cell with no sectors. It will be connected to a super cell. There will be multiple radios on a single cell which will enhance spectral efficiency as well as network speed," Kuchi said.

He said that it takes 10 years for a technology to mature and IIT Hyderabad has already started patenting technologies that are expected to play an important role in forming standards for 6G.

IIT Hyderabad was among the institutes that created the Indian 5G technology standard, 5Gi.

Kuchi said that some versions of the 5Gi are already part of new mobile phones and the final version of 5Gi will be available soon.

## 174 dead after fans stampede to exit Indonesian soccer match

Malang (Indonesia): The death toll from panic at an Indonesian soccer match climbed to 174, most of whom trampled to death after police fired tear gas to dispel riots Saturday, making it one of the deadliest sports events in the world.

Riots broke out after the game ended Satur-

Grieving relatives waited for information about their loved ones at Malang's Saiful Anwar General Hospital. Others tried to identify the bodies laid at a morgue.

Indonesia's president Joko Widodo expressed his deep condolences for the dead in televised remarks Sunday.

Disappointed after their team's loss, thousands of supporters of Arema, known as ?Aremania,? reacted by throwing bottles and other objects at players and soccer officials. Fans flooded the Kanjuruhan Stadium pitch in protest and demanded that Arema management explain why, after 23 years of undefeated home games, this match ended in a loss, witnesses said.

The rioting spread outside the stadium where at least five police vehicles were toppled and set ablaze amid the chaos. Riot police responded by firing tear gas, including toward the stadium's stands, causing panic among the crowd. Tear gas is banned at soccer stadiums by FIFA.

Some suffocated and others were trampled as hundreds of people ran to the exit in an effort to avoid the tear gas. In the chaos, 34 died at the stadium, including two officers, and some reports include children among the casualties.

?We have already done a preventive action before finally firing the tear gas as (fans) began to attack the police, acting anarchically and burning vehicles,? said East Java Police chief Nico Afinta in a news conference early Sunday.

Youth and Sports Minister Zainudin Amali also expressed his regret that ?this tragedy happened when we were preparing for soccer game activities, both national and international level.?

Indonesia is due to host the 2023 FIFA U-20 World Cup from May 20 to June 11, with 24 participating teams. As the host, the country automatically qualifies for the cup.

?Unfortunately, this incident has certainly injured our soccer image,? Amali said.

Ferli Hidayat, local police chief of Malang, said there were some 42,000 spectators at the game Saturday, all of whom were Aremanias because the organizer had banned Persebaya fans from entering the stadium in an effort to avoid brawls.

The restriction was imposed after clashes between supporters of the two rival soccer teams in East Java's Blitar stadium in February 2020 caused a total of 250 million rupiah (\$18,000) in material losses. Brawls were reported outside the stadium during and after the semifinal round match of the East Java Governor's Cup, which ended with Persebaya beating Arema 4-2. Despite Indonesia's lack of international accolades in the sport, hooliganism is rife in the soccer-obsessed country where fanaticism often ends in violence, as in the 2018 death of a Persija Jakarta supporter who was killed by a mob of hardcore fans of rival club Persib Bandung in 2018. Saturday's game is already among the world's worst crowd disasters, including the 1996 World Cup qualifier between Guatemala and Costa Rica in Guatemala City where over 80 died and over 100 more were injured. In April 2001, more than 40 people are crushed to death during a soccer match at Ellis Park in Johannesburg, South Africa.

More than 300 were rushed to nearby hospitals to treat injuries but many died on the way and during a treatment, Afinta said.

East Java's Vice Gov. Emil Dardak told Kompas TV in an interview Sunday the death toll has climbed to 174, while more than 100 injured people are receiving intensive treatment in eight hospitals without any charge, 11 of them in critical condition.

Indonesia's soccer association, known as PSSI, has suspended the premier soccer league Liga 1 indefinitely in light of the tragedy and banned Arema from hosting soccer matches for the remainder of the season.

Television reports showed police and rescuers evacuating the injured and carrying the dead to ambulances.

## India U-17 women's football team to take on WSS Barcelona in final prep game ahead of World Cup

India's last match against Andorra U-17 was called off owing to bad weather and they will be back in action after a three-day gap. Coach Dennerby feels that not playing a match did not impact a lot as he utilized the time in training.

"We could not play our last game due to bad weather against Andorra but it did not affect a lot. We got time for intense training in between. Now we are looking forward to the game today which will be our last match of the tour," said Dennerby.

Currently, the team which is together for about six months now, is in Spain having played one match against Sweden where they lost 1-3 and will be facing WSS Barcelona Club today before

returning to India on October 4, 2022. Dennerby is delighted to have the camp in Spain and said, "I am happy for this long camp in Spain which was much needed for the players. Our six months preparations went on with our plan, which included strength and conditioning training along with technical and tactical training.

"We have just one more game before we enter the field in India and begin our World Cup cam-paign against the USA. The girls are ready and motivated to give their all today," he concluded. These friendlies have been planned as part of the team's preparation for the upcoming FIFA U-17 Women's World Cup, which is scheduled to take place in India from October 11 to October 30.
