

"After Vijayadashami, there will be Vijaya in Karnataka. We are proud that Sonia Gandhi has come to walk on the streets of Karnataka. We are coming to power in the state, and BJP is on the way to shutting its shop," said DK Shivakumar.

Day 29 of the 'Bharat Jodo Yatra' began with flag hoisting at 5:30 am at Exhibition Grounds, Mysuru, where Bharat Yatris joined in Dasara celebrations.

"The march resumed after an hour's bus ride to padayatra start point near Mandya. Congress President will join around 800 am," tweeted senior Congress leader Jairam

Ramesh this morning.

The Padyatra (march) is covering a distance of 25 km every day. The march was aimed to cover as many as 12 states in five months. It will be in Karnataka for 21 days before moving north.



Struggling with Dark Circles? DIY masks to nourish it and keep it from wrinkling

Dark circles are tough to get rid of and they tend to make one look tired, stressed, and old. It can be caused by sun exposure, stress, ageing, lack of sleep, allergies and even genetics.

Even though you can simply conceal dark circles, it is better to treat the problem area directly using natural ingredients.

Here are homemade eye masks you can try.:

Tea bags mask

Tea bags, including green tea, black tea, and many other herbal teas, are an excellent treatment for dark circles under the eyes. For five to ten minutes, place some used tea bags in the refrigerator. Then place wet tea bags over your eyes for ten to fifteen minutes. One of the finest natural treatments for dark circles around the eyes.

Take 2 green tea bags and add a few drops of rosewater to them using a

into a refrigerator for about 5 minutes before placing them on your eyes. Due to its higher flavonoid content, green tea can help reduce the appearance of under-eye bags greatly. Do this once a week The lack of oil and you shall see the results soon Potato & cucumber mask

Juice from the cucumber and potatoes should be mixed equally. Apply it around your eyes and gently press it into your skin with your ring finger. After fifteen minutes, rinse it off with normal water. The potato juice has spot-lightening abilities that will help to lighten the dark circles beneath your eyes, while the cooling cucumber juice will refresh the area's parched skin.

Kesar & milk mask------

Apply cotton wool pads soaked in the kesar and milk mixture under the eyes or use them as eye pads for 30 minutes. This will help in reducing dryness and tone the skin around the eyes.

Milk & Turmeric Eye Mask Mix one tablespoon turmeric with

milk or buttermilk in a small bowl. Apply the mixture

onto your under-eye area (avoiding the eyes). Leave on for 10 minutes, and wash it off with clean fresh water

Rose water mask

Make two solid square pads out of cotton wool. Soak them in chilled rose water. Now, lie down, close your eyes, and place the wet pads over them. Aim to leave them on for 15 minutes. Rose water can make you feel incredibly relaxed in addition to tightening and toning your skin.

: Grate one whole cucumber and squeeze the juice out of it. Mix one teaspoon of rose water into the juice and mix well. Dip a cotton pad in the mixture. Keep the dipped cotton pads under the eyes for 30 minutes. Remove the pads and rinse them off. Follow up with a nourishing eye cream. . Also, you can freeze the mixture in an ice tray and rub the ice cubes around your eyes to reduce puffiness in a jiffy.

UNHRC adopts resolution against Sri Lanka's rights record; India abstains from voting

GENEVA: India on Thursday abstained on a draft resolution in the UN Human Rights Council in Geneva on promoting reconciliation, accountability and human rights in Sri Lanka which was adopted.

While abstaining, India stressed that it will

work with Sri Lanka and the international community to attain the related objectives of legitimate aspirations of Tamils of Sri Lanka and prosperity for all Sri Lankans.

The draft resolution on --Promoting reconciliation, accountability and human rights in Sri Lanka' was adopted at the 51st Session of Human Rights Council in Geneva, with 20 nations voting in favour in the 47member Council, seven against, including China and Pakistan, and 20 ab-

stentions, including by India, Japan, Nepal and Qatar.

The 20 countries that voted in favour of the resolution included, the United Kingdom, the United States, Argentina, Finland, France, Germany, Mexico, the Netherlands, Paraguay, Poland, Republic of Korea and Ukraine.

In a statement during the adoption of the resolution, Ambassador Indra Mani Pandey, Permanent Representative of India to UN & other International Organizations, said that while India has taken note of the commit-

ments by the government of Sri Lanka on issues of implementation of the commitments in the spirit of the 13th Constitutional Amendment, meaningful devolution and the early conduct of provincial elections, "we believe that the progress towards the same

has stepped up and provided unprecedented assistance to the people of Sri Lanka to face the challenges of the recent economic crisis.

"In finding a lasting and effective solution for peace and reconciliation in Sri Lanka, lic officials and stands ready to assist and support independent impartial and transparent efforts in this regard".

The resolutions on promoting reconciliation, accountability and human rights in Sri Lanka were previously moved in Geneva in 2012,

> 2013, 2014, 2015, 2017, 2019, and in 2021.

Sri Lanka had expressed opposition to the resolution as a violation of its sovereignty other than in 2015 when they cosponsored the resolution.

According to the Lankan government figures, over 20,000 people are missing due to various conflicts including the three-decade brutal war with Lankan Tamils in the north and east which claimed at least 100,000 lives. The Tamils alleged that thousands were mas-

Why haven't we wiped out world's deadliest virus(Rabies) in India

"Rabies" word is derived from the Latin word "rabere," which means to be mad, to rage, or to rave. It is probably the oldest recorded infection affecting humans, first documented



in Babylon in 2300 B.C. Rabies is a viral zoonotic disease present in more than 150 countries and poses a real threat to about 2.5 billion people worldwide. Every year more than

59,000 people in the world die of rabies. It remains an under-reported, neglected disease ranking 10th biggest cause of death due to infectious diseases globally by the World Health Organization (WHO). Rabies virus can be found worldwide in domestic animals (dogs, cats) as well as in wildlife (e.g. foxes, racoons, mongoose, skunks and bats and the humans are only accidental hosts. Humans become infected when bitten or scratched by a rabid animal.

Despite Pasteur's discovery of the rabies vaccine 131 years ago, and the post-exposure treatment available, rabies continues to cause significant human mortality in Asian, South American, African, and Eurasian countries. While dogs are the major vectors of transmission of this disesase in Asian countries, transmission by bats and other animals poses a significant threat in America, Africa, and Eurasia. Only a few countries (Japan, United Kingdom, Australia, New Zealand) have managed to completely eradicate the disease, mainly thanks to their geographical isolation and excellent governmental initiatives to control rabies. Unfortunately, in Africa and Asia it still poses a huge public health threat. Rabies in India is still not a notifiable disease, therefore the exact figure of rabies bites in remains unknown. As per the report of some organisations working in the field of rabies control in India, out of more than 59,000 human deaths globally due to rabies, approximately 95% occur in Asia and Africa itself and almost one-half of the global burden that is 20 000 human lives, are lost annually due to rabies in India. In India, high incidence of rabies is mainly due to bites by stray and wild animals. The predominantly agrarian rural community livies in close contact livestock. The chances of interaction of livestock with stray and wild animals is high and humans are directly or indirectly exposed to the deadly virius in that context. There is higher incidence of a dog bite in urban India also and it is mainly due to uncontrolled stray dog population and poor waste management system. This means that the animal bite incidence is dynamic and context-related and, hence different strategies

to be deployed in different contexts.

Strategies like Animal Birth Control-Anti Rabies Vaccination (ABC-ARV) have yielded good results in well defined urban territories in metros and other urban areas but are unlikely to be very effective in rural areas where boundaries are ill-defined, animal

Oral vaccination may be a good strategy to be adopted in rural areas where census and tracking of stray and wild animals is difficult and accepted strategies of ABC-ARV may be logistically very difficult. Another common practice in rural as well as urban India is the practice of dumping solid waste, including animal carcasses, at common mounds on the outskirts of the villages and cities. This invites stray dogs and wild animals to the vicinity of human residence and increases the possibility of rabies transmission. Hence solid waste management, including disposal of animal carcasses, needs to be an important component of stray dog population control. Though are several reasons for continued human rabies deaths in India like uncontrolled canine population, the insufficient vaccination programme, inefficient or nil waste management system but it has been demonstrated in multiple research studies that the major cause for India's poor position in rabies elimination is rooted in low public awareness about the disease. In India rabies is a disease of low public health priority. The government and healthcare authorities seem to know where the problems lie and are gradually addressing them, but the process to improve the statistics remains slow. The Indian government needs to take the rabies like tuberculosis, malaria, and HIV but India's deaths caused by rabies would be radically reduced, if only a tenth of that sum was spent on raising awareness about rabies

Community leaders and veterinary doctors can play a great role in raising education and awareness of the community as many individuals rely on their advice and visit them regularly in case of dog bite and other such incidence. Introducing syllabi regarding rabies and appropriate wound management in school may be a cost-effective way of raising awareness against this deadly disease. Countries like Sri Lanka, Malawi, Indonesia and the Philippines have incorporated rabies awareness in their school curricula to boost their rabies control efforts and have found good results. The incorporation of rabies education into school curricula is not simply a one-time educational event, but rather a sustained effort as information becomes disseminated throughout countries and regions each year without need for recurrent monetary resources. The state of Karnataka and Sikkim in India have also introduced information about rabies in school curricula recently. Resourceful individuals and other change agents in the society can create their own educational material on and posters regarding rabies control and elimination and distribute it in their neighborhood and share it on social media to create awareness. Events partispation at all level.

India accounts for nearly 50% of the global rabies mortality and it is mainly due to people's deep-rooted cultural and religious beliefs connected with dog bites and rabies, poorly functioning health and civil registration system, misplaced faith on traditional medicine systems and home remedies hinder the use of appropriate and timely medical interventions to prevent rabies and most importantly less public awareness about the disease. There is no organised national rabies control programme in India. Rabies control is generally confined to small urban pockets, with minimal intersectoral co-ordination. India need to implement a nation-wide, multisectoral rabies control initiative. In addition to public health surveillance. animal census and implementation of dog licensing rules, other targeted interventions for control and eradication of rabies in India must include efficient waste management, animal birth control and antirabies vaccination and most importantly it must include wide spread public awareness about the deadly disease rabies.

Check illegal foeticide

Sex determination tests on pregnant women have been illegal in India for years. Sex determination



tests, and preference for sons result in the selective termination of pregnancy. The widespread use of illegal tests to determine the sex of an unborn child is fuelling a rise in female

foeticide cases in India. India banned sex determination tests in 1994, as the gender balance became increasingly skewed. Indian laws do not, under any circumstance, allow sex determination tests to be undertaken with the intent to terminate the life of a fetus developing in the mother's womb, unless there are other absolute indications for termination of the pregnancy as specified in the MTP Act of 1971. The Medical Termination of Pregnancy Act, 1971 (MTP)[1] Act, which

prohibits abortion, was enacted with a view towards

containing the size of the family. However, in some

cases the desire for a small family may have outweighed the desire

for a child of a specific gender, leading to abortions where the sex of the fetus was different from that desired by the family. In India, where aborted female foetuses have contributed to a nationwide gender imbalance, it's illegal for doctors to reveal the sex of an unborn child. But with boys still often far more valued than girls, a lucrative business thrives underground. Though, sex determination tests through techniques such as ultrasonography and amniocentesis are banned in India, female foetuses are still commonly killed in some regions where a preference for sons runs deep. Under the Indian Penal Code, causing an abortion, even if caused by the pregnant woman herself, is a criminal offense, unless it is done to save the life of the woman. The offense is punishable by imprisonment for a period of three years, by fine, or by both. The PNDT Act mandates that all ultrasound facilities must be registered and

medical practitioners must maintain records of every scan of a pregnant women. It states that

pre-natal diagnostic techniques can be used only to detect "genetic abnormalities or metabolic disorders or chromosomal abnormalities or certain congenital malformations or sex-linked disorders". There were concerns that ultrasound technologies were being used to determine the sex of the unborn child and abort the female foetus, so the 1994 law made it illegal for medical practitioners to reveal the sex of a foetus. It is clear that sex determination and female foeticide continue because of insufficient monitoring of medical practitioners. It is observed that most parents celebrate the birth of a son, considered to be their family pride. The birth of a daughter can be a time of embarrassment and even mourning as parents, especially the poor, look toward the immense debts they'll need to take on to pay for marriage dowries. The focus on foeticide has been conveniently forgotten. Nothing is done to check illegal foeticide & hence in ground reality, the one who is involved in foeticide & sex determination moves scot free. According to experts, the problem isn't with the Act but with its implementation. There is poor monitoring of ultrasound clinics. Such clinics are required to maintain records of the scans they conduct but the violators are often let off with a fine. On going through sex ratio at birth – the number of girls born per 1,000 boys – in India fell from 945 in 1991, to 927 in 2001, to 914 in 2011, according to census data. Government had failed in enforcing the law with a huge lobby working in favour of sex selection. In order to minimize the possibility of foeticide and infanticide, it is now the need of the hour to bring a change in the PNDT Act by making it compulsory for all pregnant women to undergo a scan at government hospitals for sex determination of foetus.

Committee, that the Justice Department launched the review of the FBI's disciplinary database in 2020 following an Associated Press investigation into sexual misconduct allegations involving at least six senior FBI officials.

The follow-up review found 665 FBI employees, including 45 senior-level officials, resigned or retired between 2004 to 2020 following a misconduct probe but before a final disciplinary letter could be issued, according to a letter this week from Grassley to FBI Director Christopher Wray and Attorney General Merrick Garland.

It was not clear how many of those cases involved sexual misconduct.

Grassley's office, which declined to make the whistleblower or underlying documents available to protect the person's identify, said that was the kind of information it was still seeking but estimated the number could be in the "hundreds".

"It's been alleged to my office that the data involved an element of sexual misconduct, which comports with the purpose of the review that was done because of the Associated Press article," Grassley wrote in his letter that was first shared with the AP."

Asked for its response, the FBI said it intended to respond to the oversight committee first.

It declined to comment specifically on the whistleblower's allegation or to provide its own tally of disciplinary cases and how many of them involved sexual misconduct.

It instead issued a statement saying it has a zero-tolerance policy toward sexual harassment.

"The FBI looks critically at ourselves and will continue to make improvements. The bottom line is, employees who commit gross misconduct and sexual harassment have no place in the FBI," it said.

The AP investigation in December 2020 identified at least six sexual misconduct allegations involving senior FBI officials over the prior five years ranging from unwanted touching and advances to coercion.

It found that several senior FBI officials have



avoided discipline -- quietly transferring or retiring with full benefits-- even after claims of sexual misconduct against them were substantiated.

In one case, an FBI assistant director retired after the inspector general's concluded that he had harassed a female subordinate and sought an improper relationship with her.

In its statement, the FBI said that since establishing a working group just days after the AP story was published, the bureau has implemented a series of changes, including a 24/7 tip line with a licensed clinician where employees can report abuse, and a working group of senior executives to review policies and procedures on harassment and victim support. Grassley asked in his letter for updates on other changes recommended by the Justice Department, including that it fast-track investigations to reduce the chance an accused employee could become eligible for retirement and leave the FBI before a probe can be completed.

The FBI noted that it cannot legally prevent someone from resigning or retiring.

"It is infuriating that we are left with little disciplinary recourse when people leave before their case is adjudicated," the statement said.

David J.Shaffer, a Washington attorney who represents several victims of sexual misconduct in the FBI, called on lawmakers to examine how often the bureau opens internal investigations against women who come forward.

"The most serious abuse of the FBI disciplinary system is to retaliate against the very women who complain by starting investigations against them after they report sexual misconduct," he said, "thereby discouraging reporting in the FBI due to fear of retaliation."

Tracy Walder, a former FBI agent who left the bureau in 2006 after she filed a sexual harassment complaint, said she believes such misconduct is pervasive and is glad it is finally being taken seriously.

"I do not believe that the entirety of the FBI behaves this way. In fact, there are many excellent agents. However, because of the way I was treated, I feel a sense of shame and What if?' And this behaviour has been allowed to continue for decades."

So far this season, Lyon is in seventh place despite getting off to a strong start by racking up 13 points in the first five games. But those opponents — Ajaccio, Reims, Troyes, Auxerre and Angers — are all in the bottom half of the standings.

When the competition improved, the results turned bad. Lyon didn't earn a point in its last four games against Lorient, Monaco, Paris Saint-

Germain and Lens — all teams in the top 10. Defense was the main issue last season. Lyon conceded 51 goals in 38 league games, more than any other team in the top half of the standings. That problem hasn't gone away this season.

Lyon lost the spine of the team within a few months when midfielder Bruno Guimaraes joined Newcastle in January and Brazil playmaker Lucas Paqueta went to West Ham in August. Belgium defender Jason Denayer

was also allowed to leave on a free transfer in the offseason.

The current backline looks inexperienced with right-back Malo Gusto and centre-back Castello Lukeba both 19. Lyon has also taken a risk by relying on an ageing Jerome

Boateng, who hasn't played yet and has already missed seven games because of injury.

Boateng's absence has led Lyon coach Peter Bosz to play Thiago Mendes in the heart of the defence. A defensive midfielder normally, Mendes has struggled in the centre-back position, making an error that led to a goal against Lorient and conceding a penalty against Lens.

Lyon didn't create any decent chances and had no shot on target against Lens.

"It's unacceptable," Lyon midfielder Maxence Caqueret told Amazon Prime video. "We must work even harder, we must be much more ruthless and show much more desire on the field."

To boost the offence, Lyon brought back Alexandre Lacazette despite his poor scoring form at Arsenal. The French striker notched only four goals in the Premier League last season.

Surprisingly, Bosz gave Lacazette the nod over Moussa Dembele even though the latter was the club's top scorer last season with 21 league goals. Lacazette has started every game while Dembele was handed only one start.

"Of course, we can do better," Bosz told Amazon Prime video. "That is not Lyon. We must be higher in the standings."
