Principal Secretary Finance, Vishal Kumar Dev has issued detailed guidelines for all the Departments to prepare their supplementary proposals expeditiously and in accordance with the preSustainable Development Goals (SDGs) through faster reduction of poverty, increasing farmers' income by crop diversification and direct benefit transfers, providing piped drinking water to all, making available quality affordable health care facilities, enabling quality education & skill development, and providing quality physical infrastructure for improving

Recently, Odisha organised National Road Safety Short Film Festival, 2022 a first-ofits-kind event in the country. There was an overwhelming response for the festival. A total of 230 entries were received in 6 languages from 8 States. The top films are being screened in the movie theatres across the State to create awareness about road safety. With an aim to make roads in Odisha 100% road signage compliant, the Transport Department has started a unique initiative of road signage audit. Audit of 3059 KMs of NH and SH in the state has already been completed and the report has been submitted to the stakeholders for necessary rectification. Further, an additional 5000 km road audit has been proposed.

The Integrated Traffic Management System (ITMS) project is implemented in Sundargarh District covering the municipal areas of Sundargarh, Rajgangpur and Birmitrapur. Soon the command-and-control centre for CCTV/ ANPR will be functional and the footage will be monitored continuously for issuing echallans to the traffic violators.

As per Supreme Court Committee guidelines, the State Government is working towards construction of truck terminals and comprehensive Trauma System Care.

Road Safety training is being provided to Engineers, commercial drivers, traffic police personnel, highway engineers and planners in a systematic process through a well-planned training calendar.

## CLASSIFIED Plea filed seeking injunction against movie 'Adipurush' claiming inaccurate portrayal of Hindu gods

NEW DELHI: A plea has been filed in a court here seeking an injunction against the upcoming movie "Adipurush", alleging it has depicted Hindu gods in an "unwarranted" and "inaccurate" way in its promotional video.

The matter has been listed for hearing before senior civil judge Abhishek Kumar on Mon-

The plea filed by advocate Raj Gaurav on Fri-

Hanuman in a very unwarranted and inaccurate way in the teaser or promotional video of their upcoming movie Adipurush," the plea claimed. While the traditional picture of Lord Ram was that of a serene and calm person, who believed in forgiveness, the defendants in the promotional video had shown him as "atrocious, revengeful and angry", wearing a leather strap and modern footwear made of

panzees", the plea alleged.

"That prima facie the teaser or promo of the movie is so atrocious wicked and diabolical that it along with the pursuant movie which is to be released on January 12, 2023, should be outrightly banned in its present form in the interest of religious feelings, sentiments and aspirations of Hindus of India and elsewhere," the plea said.



day sought a permanent and mandatory injunction against defendants - producer Bhushan Kumar and director and co-producer Om Raut - alleging they had manipulated the basics of the epic Ramayana.

"The defendants have hurt the religious, cultural, historical and civilizational sentiments of the plaintiff and other Hindus by the depiction of Hindu gods Lord Ram and Lord leather, the plea alleged.

The plea further claimed that Lord Hanuman was depicted in an "atrocious manner", wearing leather straps all over his body and his appearance was against the description in the religious verse of Hanuman Chalisa.

Also, the character of Ravan, a staunch Brahman, was "awfully cheap and appalling", while the vanar sena was shown as a "whoop of chim-

Therefore, the court could grant ex parte and ad interim stay of the movie in its present form along with a permanent injunction restraining the defendants from depicting Lord Ram and Lord Hanuman as shown in the promotional video, the plea said.

It also sought directions mandating the defendants to remove the promotional video of the movie from all social media platforms.

# Compulsory Tax Audit Penalty can't be imposed in which cases Part 3

14. Reasons which have been held as



"reasonable causes" for delay in furnishing tax audit report by different courts:

Delay a) completion of audit of earlier year caused delay in completion of audit shall be

treated as reasonable cause irrespective of fact whether delay in the audit of earlier year was for reasonable cause or without a reasonable cause or whether or not penalty was levied in earlier year -ACIT v. Kamlesh R. Agarwal (HUF) [2006] 100 TTJ (Ahd.) (TM) 194.

- Delay due to illness of accountant -Karthika Enterpreneurs v. ITO [1993] 45 ITD 70 (Coch.); CIT v. Ramkrishna Stores 253 ITR 175 (Cal.)
- Delay due to the accountant left services and partners not competent to complete accounts - CIT v. Ashoka Dairy [2005] 279 ITR 32 (P&H): 200 CTR (P&H) 211.
- Delay due to illness of accountant, who ultimately expired, could be considered a reasonable cause for delay in furnishing tax audit report- CIT v. Ramakrishna Stores 253 ITR 175(Cal.): 172 CTR (Cal.) 525.
- Delay due illness of partner who was looking after the accounts - Asst. CIT v. Deshraj & Co. [1996] 55 TTJ (Ahd) 38; Sibonarayan Patro & Bros. v. ITO [1996] 54 TTJ (Ctk) 644.
- Delay due to bona fide belief that section 44AB was not applicable based on legal opinion - Buildwell Construction Co. v. ITO [1995-96] 27 BCAJ 231 (Mum).
- Assessee a transport booking agent, arranging commercial vehicles /trucks for various parties from the market for carrying goods to different places and charging normal commission from truck owners which was shown in the P & L a/ c as commission income. The assessee had **bona fide belief** that receipts are not the turnover. Whatever freight is charged from parties by assessee is paid to the individual truck owners who actually carried the goods. Assessee's position is similar to that of Kuchha Arhatia and the turnover is only the commission received from truck owners and supplier of goods.

Hence, in view Narayan Jain Circular

No.452, dated17.3.1986, assessee was not required to get its accounts audited u/s 44AB. Further, since assessee was under a bona fide belief that freight receipts were not its own receipts and it was not liable to get its accounts audited, no penalty u/s 271B could be levied – ITO v. Bindra Ban Bansi Lal [2001] 78 ITD 228 (Asr): [2004] 90 TTJ (Asr) 747. Similarly where assessee transports from own truck and engages truck of other transporters and gets commission, the proceeds collected for other transporters are not the turnover of assessee - Paras Transport Co. v. ITO 92 TTJ (Agra) 607.

- h) Assessee filed audit report but did not enclose P & L a/c, Balance Sheet or other annexures. No malafide intention could be established. It is a technical fault -Gavs Laboratories Pvt. Ltd. v. DCIT [2004] 90 TTJ (Del.) 307; ITO v. B.R. Spinners Pvt. Ltd. 91 TTJ (Chd.) 437.
- i) Delay due to bona fide belief that turnover of dealing in shares made on behalf of several buyers and sellers in the capacity of sub-broker was not includible for determining applicability of section 44AB and A.O. not initiating penalty proceedings for the earlier years - R. Wadiwala & Co. v. Asst. CIT [2001] 72 TTJ (Ahd.) 34.
- Assessee having 3 proprietorship concerns but got his accounts audited for only one concern under a bonafide belief that proprietorship concern in which turnover exceeds Rs.40 lakhs is only to be audited. No willful default on the part of the assessee - ACIT v. Dr. K. Satish Shetty [2009] 310 ITR 366 (Kar.).
  - However Delhi Bench of the ITAT in the case of ACIT v. Smt Bharti Sharma [2010] 6 ITR (Trib.) 48 (Del.) has held that penalty in such cases is to be restricted to half a per cent of turnover of business whose accounts have not been audited and not of the whole business.
- Assessee entitled to deduction u/s 80P was under bonafide belief that he is not required to get tax audit of accounts in view of deduction u/s 80P. No penalty is to be imposed - CIT v. Iqbalpur Cooperative Care Development **Union Ltd.** [2009] 23 DTR (Uttarakhand) 60: [2009] 179 Taxman

- financer, financed Rs. 1.44 crore and received a gross interest of Rs. 1.85 lakhs. On the basis of an opinion published by the Bombay Chartered Accountants Society wherein it was opined that in case of banking business, gross receipts will be considered for determining the requirement of tax audit and amount of money lent is not to be taken into account. The assessee did not get his accounts audited. No penalty is to be imposed - ITO v. Sachinam Trust [2010] 320 ITR 445 (Guj.).
- m) It has been held that "reasonable cause" or "sufficient cause" should receive a liberal construction so as to advance substantial justice when no negligence nor inaction nor want of bona fide is imputable to the party - Dinabandhu Sahu v. Jadumoni Mangaraj AIR 1954 SC 411; Addl. CIT v. Dargapandarinath Tuljayya & Co. [1977] 107 ITR 850 (AP)(FB); Collector, Land Acquisition v. Mst. Katiji & Ors. [1987] 167 ITR 471 (SC).
- 15. If income of a person is below taxable limit but his turnover exceeds Rs. 1 *crore:* The object of audit u/s 44AB is only to assist the assessing officer in computing total income of an assessee in accordance with provisions of the Act. Therefore, even if income of a person is below taxable limit of a particular year, he will have to get his accounts audited and to furnish such report u/s 44AB, if his turnover in business exceed Rs.1 crore.
- 16. In case of a person whose income is specifically exempt in Income-tax Act : In Asst. CIT v. India Magnum Fund [2002] 74 TTJ (Mum) 620, Income of the assessee was exempt u/s 10(23D). It was engaged in business of shares and securities. In order to claim refund on account of TDS it had to file its return of income. On receipt of the return the A.O. imposed penalty u/s 271B for nonfurnishing of audit report u/s 44AB as the turnover of business exceeded the specified limit (which was Rs.40 lakhs during that year). Mumbai "A" Bench of ITAT observed that section 44AB becomes operative only when there is computation of profits and gains of business or profession as a part of total income and that it would be inapplicable if there is no computation of total

income or, for that matter, no computation of profits and gains of business or profession as a part of computation of total income, hence provisions of section 44AB do not apply in relation to incomes enumerated in Chapter III and held the assessee was not liable to obtain any audit report u/s 44AB.

17. Whether tax audit is required in speculation business where delivery of shares or units has not been taken or *made:* In the case of Babulal Enterprises v. Asst. CIT [1999-2000] 31 BCAJ 788 (Mum), the total turnover of the assessee was Rs.3.99 crores but physical deliveries of shares did not take place and only the difference in price was settled on the basis of contract notes. Mumbai "B" Bench of ITAT held that as per the Sale of Goods Act, 1930, the delivery of goods is must to constitute sale and since delivery did not take place, transaction cannot be regarded as sales or turnover. Similar view was expressed in yet another case of Growmore Exports Ltd. v. Asst. CIT [2001] 72 TTJ (Mum) 691; [2001] 78 ITD 95 (Mum) and **Banwari** Sitaram Pasari HUF v. ACIT [2013] 240 ITD 320 (Pun.).

In context of section 80HHC while interpreting the word "turnover", Mumbai bench of ITAT in Royal Cushion Vinyl Products Ltd. ITA No. 7859/Bom/ 1992 held that where no delivery of shares take place, no turnover can be envisaged.

18. Whether an agriculturist having no income other than agriculture is required to get his accounts audited where his agricultural sale proceeds exceed Rs.1 crore: No, since generally an agriculturist is having no taxable income, he is not required to file his Income tax return, the question of his furnishing audit report along with return does not arise.

19. Where a Chartered Accountant has been approached for audit at the last moment and the Chartered Accountant is of the opinion that it is not practical to complete the audit within the specified date: A Chartered Accountant should not accept an audit which he cannot complete within the specified date. (Concluded)

deals with uncertainties but from various facts a presumption is drawn which remains intact unless it is proved contrary. Though presumption is based on indirect evidence, the same is treated inevitable and unimpeachable unless it is overcome by contrary proof. The term "presumption" is final about the existence of a fact in question. As per the judgment of the Hon'ble Supreme Court of India in the case of Izhar Ahmad Khan Versus Union of India AIR 1962 SC 1052 the term "presumption" in its largest and most comprehensive signification, may be defined to be an inference, affirmative or dis-affirmative of the truth or falsehood of a doubtful fact or proposition drawn by the process of probable reasoning from something proof or taken for granted. The Hon'ble Supreme Court of India has also dealt the issue of presumption in the case of Suresh Budharmal Pallani Versus State of Maharashtra (1998) 7 drawn only from the facts and not from other presumption by a process of probable and logical reasoning.

It is relevant in a criminal case on the part of the court to follow the rule of caution while relying upon an evidence led against an accused on presumption. In the case of Kashmira Singh Versus The State of Madhya Pradesh, 1952 SCR 526 the three judge bench of the Hon'ble Supreme Court has held that the rule of caution is that "save in exceptional circumstances" one accomplice cannot be used to corroborate another, nor can he be used to corroborate a person who though not an accomplice is no more than one. It is not proper or desirable for the prosecution to examine a witness the magistrate who recorded the confession. Presumption in law of evidence may be a rule indicating the stage of shifting of the burden of proof from certain fact or facts, a court can draw an inference that would remain intact unless such presumption or inference is either disproved or dispelled. In the case of M. Naringa Rao Versus State of Carpets (2009) 2 SCC 513 are

The term "presumption" is used to designate an inference affirmative and dis-affirmative of the existence of a fact conveniently called the presumed fact as held at para 15 and 18 in the case of Kumar Exports Versus Sharma

use of which the courts are enabled and entitled to pronounce on an issue notwithstanding that there is evidence or insufficient evidence. Under the Evidence Act all presumptions must come under one or the other class of the three classes mentioned in the Act, namely, (1) "may presume" (rebuttable), (2) "shall presume" (rebuttable), and (3) "conclusive presumptions" (irrebutable). The term "presumption" is used to designate an inference, affirmative or disaffirmative of the existence of a fact, conveniently called the "presumed fact" drawn by a judicial tribunal, by a process of probable reasoning from some matter of fact, either judicially noticed or admitted or established legal evidence to the satisfaction of the tribunal. State of A.P. Versus C. Uma Presumption literally means "taking true without as examination or proof".

Applying the definition of the word "proved" in Section 3 of the Evidence Act to the provisions of "Presumption is an inference of a Sections 118 and 139 of the Act, it becomes evident that in a trial under Section 138 of the Act a presumption will have to be made SCC 337 that presumption can be court is only applying a process of that every negotiable instrument made drawn for consideration and that it was executed for discharge of debt or liability once the execution of negotiable instrument is either proved or admitted. As soon as the complainant discharges the burden to prove that the instrument, say a note, was executed by the accused, the rules of presumptions under Sections 118 and 139 of the Act help him shift the burden on the accused. The presumptions will live, exist and survive and shall end only when the contrary is proved by the accused, that is, the cheque was not issued for consideration and in discharge of any debt or liability. A presumption is not in itself evidence, but only makes a prima facie case for a party for whose benefit it exists."

> The adverse inference in rare case can be drawn in respect of allegations not traversed but there is no general rule that adverse inference must always be drawn whatever the facts and circumstances there may be. The Supreme Court of India in most of the judgments has held that presumption

of fact "is an inference as to the existence of one fact from existence of some other facts unless the truth of such inference is disproved". As per the provision under Section 114 of the Evidence Act, 1872 presumption is a rule of evidence unless it is disproved while dealing a case of abduction and murder, the Supreme Court of India in the case of State of West Bengal Versus Mir Mohammad Omar & Ors., (2000) 8 SCC 382 has held at para 33 as under: "Presumption of fact is an inference as to the existence of one fact from the existence of some other facts, unless the truth of such inference is disproved. Presumption of fact is a rule in law of evidence that a fact otherwise doubtful may be inferred from certain other proved facts. When inferring the existence of a fact from other set of proved facts, the court exercises a process of reasoning and reaches a logical conclusion as the most probable position. The above principle has gained legislative recognition in India when Section 114 is incorporated in the Evidence Act. It empowers the court to presume the existence of any fact which it thinks likely to have happened. In that process the court shall have regard to the common course of natural events, human conduct etc. in relation to the facts of the case." As per Advanced Law Lexicon Dictionary (4th Edition) the "presumption of legal knowledge" or knowledge of the laws of the State in every citizen is a positive rule of law and applies to all cases where acts are knowingly done which are expressly forbidden by law and gives rise to a conclusive presumption or criminal intent. As per the said dictionary "presumptive evidence" consists in the proof of minor or other facts incidental to or usually connected with the facts sought to be proved which when taken together inferentially establish or prove the fact in question to a reasonable degree of certainty. Therefore, in the interest of justice under Section 114 of the Indian Evidence Act, 1872 the court is empowered to presume the existence of certain facts for passing an appropriate order unless they are disproved. The relevant Section 114 is reproduced as under:

activities under AWP-2022-23 include procurement of modern ammunition, adequate logistics support to armed forces, training for State police force, community policing, additional fortification of police posts and rehabilitation of LWE cadres.

The fund provision of `85.85 crore for AWP-2022-23 is 50 per cent more than 2021-22. The AWP-2021-22 was rolled out with a budget outlay of around Rs 50.56 crore. The funds for AWP 2022-23 would be shared by both the Central and State government on 60:40 sharing basis.

The Chief Secretary said community mobilisation and confidence building activities should be intensified in the LWE infested pockets. He directed officials to stay connected with people and community, be aware of their concerns and raise their confidence level. Steps should be taken to provide better alternative livelihood activities to people and promote education of children in the affected pockets.

"People's confidence and participation would go a long way in rooting out LWE activities from the suspected pockets," Mahapatra added. As per a release issued by the office of the Chief Secretary, LWE activities are well under control in the State. Swabhiman Anchal in Koraput district, once considered to be the epicentre of Maoists is now free of LWE with enhanced developmental interventions in the area.

Well planned intelligence based actions are being taken to counter the extremists. DGP Sunil Bansal, Additional Chief Secretary Home Sanjeev Chopra, Special Secretary, Home Santosh Bala and intelligence wings participated in the deliberations.

#### **Nobel Peace Prize to activists** from Belarus, Russia, Ukraine

ttee for honouring Bialiatski, with the spokesman calling its choices in recent years so politicised that Alfred Nobel got tired of turning in his grave.

Asked whether the Nobel Committee was intentionally rebuking Putin, whose 70th birthday is Friday, Reiss-Andersen said the prize was not against anybody but for something.

This prize is not addressing President Putin, not for his birthday or in any other sense, except that his government, as the government in Belarus, is representing an authoritarian government that is suppressing human rights activists, she said.

It was the second straight year that Putin's repressive government was implicitly rebuked with the prize. It was awarded last year to Dmitry Muratov, the editor of independent Russian newspaper Novaya Gazeta, and Philippine journalist Maria Ressa, for their efforts to safeguard freedom of expression. Both have struggled in the past year.

This year the prize comes amid the largest war in Europe since World War II, a conflict that has displaced millions from their homes, destroyed cities and killed a still undetermined large number.

"We are talking about two authoritarian regimes and one nation fighting a war and we would like to highlight the importance of civic society," Reiss-Andersen said.

Bialiatski was one of the leaders of the democracy movement in Belarus in the mid-1980s and has continued to campaign for human rights and civil liberties. He founded the non-governmental organization Human Rights Center Viasna.

He was detained following protests in 2020 against the re-election of Belarus' President Alexander Lukashenko, a close ally of Putin. He remains in jail without trial and faces up to 12 years in prison if convicted.

"Despite tremendous personal hardship, Mr. Bialiatski has not yielded one inch in his fight for human rights and democracy in Belarus," Reiss-Andersen said, adding that the Nobel panel was calling on Belarusian authorities to release him.

Exiled Belarus opposition leader Sviatlana Tsikhanouskaya, visiting Paris, told The Associated Press she felt honoured and delighted that Bialiatski was among the laure-

For sure, it will attract more attention to (the) humanitarian situation in our country, she said. Tsikhanouskaya, whose husband is also imprisoned, said Bialiatski is suffering a lot in punishment cells in Belarus.

Memorial was founded in the Soviet Union in 1987 to ensure the victims of communist repression would be remembered. It has continued to compile information on human rights abuses and track the fate of political prisoners in Russia. The country's highest court ordered it shut down in December, the latest move in a relentless crackdown on rights activists, independent media and opposition supporters.

Tatyana Glushkova, a board member of the Memorial Human Rights Defense Center, said she and her colleagues were "very, very happy to have the importance of their work recognized.

Glushakova said one of the reasons the Kremlin views Memorial as a threat is because Memorial understands the parallels between Putin's regime and the Soviet regime ... Stalin's regime. And it makes these parallels published and informs everyone about how all these regimes are similar.

She also noted that some previous Nobel Peace Prize winners were heads of state, but in modern Russia working for peace, it's not the work of the state, it's the work of civil society, and the fact that Memorial was awarded the prize this year highlights that.

Glushkova said the award was handed to the group on the day when it once again had to appear in court in Moscow this time on a case related to its office building in central Moscow.

The Center for Civil Liberties was founded in 2007 to promote human rights and democracy in Ukraine during a period of turmoil in the country.
