

## PRESIDENT OF INDIA HOSTS PRESIDENT OF TANZANIA

**New Delhi:** The President of India, Smt Droupadi Murmu received H.E. Dr Samia Suluhu Hassan, the President of the United Republic of Tanzania at Rashtrapati Bhavan today (October 9, 2023). The President also hosted a banquet in her honour.

Welcoming the President of Tanzania at Rashtrapati Bhavan, the President recalled India's centuries old friendship with Tanzania, which is based on a rich history of cultural and trade relations between our people, and our shared struggle against colonialism. The President said that the presence of the Indian diaspora for over 200 years in Tanzania is



testimony to Tanzania's warm hospitality and inclusive culture.

The President was pleased to note that under the leadership of President Hassan, our bilateral relations have grown considerably in

recent years. There has been comprehensive progress in all areas, including in bilateral trade, investments in key sectors of Tanzanian economy, development partnership, defence, and maritime cooperation.

The President said that Tanzania is India's biggest development partner in Africa. She expressed confidence that in the coming years, the newly opened IIT Madras Zanzibar campus will become a technical

education hub in Africa. The President noted that as countries of the Global South with similar goals and challenges, today we are supporting each other in international platforms, and advocating for the priorities of the developing world, including for reform of multilateral organizations. In this context, she expressed satisfaction that the African Union was made a permanent member of the G20 during India's Presidency.

Both leaders agreed that elevation of the India-Tanzania relationship to a 'Strategic Partnership' during this visit would benefit the people of both countries.

## Assembly Election Schedule For 5 States Announced



**New Delhi(KCN):** The Election Commission of India has announced the dates for Assembly election in five states to be held next month. The poll body announced the dates for elections in Madhya Pradesh, Chhattisgarh, Rajasthan, Telangana and Mizoram. Mizoram will go to polls on November 7 while Chhattisgarh will vote in two phases — on

November 7 and 17. Elections will be held in Madhya Pradesh on November 17, Rajasthan on November 23 and Telangana on November 30. The results will be declared on December 3. The BJP-ruled Madhya Pradesh will elect legislators from 230 constituencies while the Congress-governed Rajasthan Assembly

comprises 200 seats. In Telangana, the ruling Bharat Rashtra Samithi will face off against BJP and the Congress over 119 Assembly seats. In the 90-seat Chhattisgarh assembly, Congress is all set to fight the BJP while both the parties will attempt to get a foothold in the 40-seat Assembly of Mizoram, currently led by the Mizo National Front.

## Odisha CM Launches 'Drink From Tap' Scheme



**Bhubaneswar(KCN):** Odisha Chief Minister Naveen Patnaik on Monday launched the 'Drink From Tap' scheme in 149 suburbs of five metropolis areas and 13 cities of the state at a programme organised at the Lok Seva Bhawan here.

Launching the facility on the third anniversary of the scheme, the Chief Minister said that 24X7 'Drink From Tap' scheme will be effective in Rairangpur,

Birmitrapur, Rajgangpur, Champua, and Nimapada from Monday. In addition, this drinking water scheme will be available in several suburbs in Brahmapur (37), Bhubaneswar (27), Cuttack (21), Rourkela (20), Sundargarh (17), Besnagar (6), Khurda (4), Jatni (3), Hinjilikat (3), Ladbil (2) and Joda (1) and four each in Keonjhar and Anandpur from today.

An additional 12 lakh people in these areas

would be benefitted from the implementation of the scheme. The 'Drink From Tap' scheme aimed at providing clean drinking water to every family is being implemented in mission mode. The 'Drink From Tap' scheme was started in 12 pilot zones of Bhubaneswar and Puri in September 2020. In 2021, Puri became the first city in the country to get a drink from a tap facility.

## Decent Attire Must For Devotees Visiting Puri Srimandir From New Year



**Puri(KCN):** The Shree Jagannath Temple Administration (SJTA) has decided to implement a 'decent attire rule' for devotees entering Srimandir in Puri from the 1st of January 2024.

The decision was taken today during a Niti Sub Committee meeting held under the chairmanship of SJTA Chief Administrator Ranjan Kumar Das. In this meeting, discussions were held on rituals to be conducted at Srimandir during the Kartik month and the wearing of

decent clothes by devotees inside the 12th-century shrine. The attire of the devotees who come to the temple should be modest. This order will be strictly enforced from January 1 next year.

"Devotees will be

allowed into the shrine. During the meeting, the Niti sub-committee also held discussions on rituals to be held at Srimandir during the lunar eclipse and the Holy month of Kartika. Education should be such that the child develops a global outlook of loving the whole world. In the era of Global Village, there should be a uniform educational system all over the world. The uniformity of world education is the biggest need of this era. Dr. Kofi Annan, former Secretary-General of the United Nations, had said, "The twentieth century has been the most bloody and violent century in human history."

In the twentieth century, two world wars, the attacks by two atomic bombs on Hiroshima and Nagasaki and the widespread devastation in the world took place; all this havoc has happened due to narrow nationalism. The Russia-Ukraine war has been going on continuously for about one and a half years, for which our education is the most responsible. Schools in all the countries of the world teach the children of their respective countries to love their country, but do not teach them to love the whole

world. If the world remains safe, all the countries will also remain safe and then the individual will also remain safe. Western educationist John Dewey has written, "The teacher is always the prophet of God for the child, who is the one who brings entry

within, hence he does not want anything for himself, he is not ambitious, he does not base his teachings on the basis of position or power." It does not create a means to achieve anything; true culture is not based on engineers and technicians, but on

individuals. In the present times, the role of teacher may have changed, but the importance and responsibility of personality-building has become even more relevant, because without the development of all-round ability, it is corruption-free, and has become a nation of beautiful minds, then I strongly feel that there are three major social members who can make a difference, and they are father, mother and teachers." into the true kingdom of God." Like a creator, a teacher fills the void created by the society through building future generations of the society, or tries to fill this void. If his responsibility is lacking, then he cannot be forgiven.

A teacher is like a gardener who decorates a garden with flowers of different colours, who inspires the students to walk with a smile even on the thorns. The criteria of a true teacher presented by J. Krishnamurti reveals the greatness of his personality, "A true teacher is rich from

teachers. Today's education, however, has become a business, rather than a mission. Many teachers and schools have started bidding for their knowledge. If we look at the present world perspective, the tradition of Guru-disciple is getting tarnished somewhere. Every day we listen to numerous reports of misbehaviour, assault and indiscipline by teachers. World Teachers' Day is an occasion when we work to refine the fading tradition and ideal education of teachers and to create responsible

According to Swami Vivekananda, all-round development means - being big in heart, high in mind and great in action. For this, it is expected that there should be not only an educational revolution, but also a teachers' revolution.

My mother and I had Post Office Savings Accounts and for us, Post Office was the bank. We had very few banks in Puri those days and those were a bit far from our place. Post Office was in our vicinity. There was a provision that a school student can open an account on furnishing a certificate from the Headmaster and I did so to open an account in the Station Road Post Office to save my scholarship amount. Later, my mother joined me. I don't remember if my sister had one.

Those were the days of our courtship in 1981. My fiancee, now my wife, urged that we should have a joint

savings account. We first went to the State Bank. They wanted several documents which we did not have.

We came back and approached our dear Post Master brother S a m a n t a C h a n d r a s e k h a r Mahapatra. He was a writer and translator too. 'Yes', he said and we opened a joint Post Office Savings Account there. The only rider was, you can deposit individually, but withdraw on joint signature of both in the withdrawal form. I was an emerging writer, used to get a lot of letters by post in my college days. So, I used to go to Post Office almost every day, it was on my way to college. All the Postmen became my intimate friends.

Alas, these days writing a letter has become a dead art form. I developed my

## Shielding Whistleblowers: Safeguarding Anti-Corruption Crusaders



"It is time to clean the air, punish the guilty and protect the whistleblowers" – Tony Leon Good Governance is crucial in combating corruption, promoting social growth, and fostering economic development. Corruption can be curbed by implementing measures like participation, transparency, accountability, and integrity in administration. The right to Good Governance is a fundamental citizen's right. Whistle-blowers play a pivotal role in exposing corruption and maladministration. These individuals bring forward malpractice claims within an organization, often after unsuccessful attempts to address the issues internally. However, whistle-blowers fear reprisals and hesitate to report corruption without legal protection. Therefore, enacting laws that safeguard and

protect these anti-corruption crusaders is essential. In India, the Whistle-blowers Bill of 2011 was passed to establish a mechanism for receiving complaints about corruption or misuse of power, conducting inquiries, and providing safeguards against victimization. Such legislation is necessary for any country striving to eradicate rampant corruption.

### Importance of Whistleblowing :

Whistleblowing promotes accountability by allowing individuals to disclose misconduct while protecting them from repercussions. It applies to all organizations, public and private, fostering transparency and accountability. Whistleblowing brings to light instances of corruption, exposing them to scrutiny. It encourages surveillance among organization members, effectively combating corruption. Internal members are better equipped to detect irregular behaviour and provide compelling evidence due to their proximity to the "crime scene." Governments play a vital role in

creating an environment where anyone can report wrongdoing without fear. Protecting whistleblowers and facilitating their access to authorities is crucial in fulfilling this responsibility.

obtain written complaints of corruption or misuse of office. The resolution, known as the Public Interest Disclosure and Protection of Informers (PIDPI) Resolution, was partially amended in 2014, authorizing Chief Vigilance Officers as the designated authorities for specific government departments. Parliament later passed the Whistleblowers Protection Act (WPA), 2011 (Act No.17 of 2014), establishing a mechanism for receiving complaints and safeguarding against victimization. The WPA aimed to encourage citizens, including public servants, to report corruption or misuse of office. The journey towards protecting whistleblowers began with a draft bill initiated in 1993 by Mr N. Vittal, the then Chief Vigilance Commissioner. The Law Commission's 179th Report in 2001 recommended a law to protect whistleblowers, leading to the proposed bill on "Public Interest Disclosure and Protection of Informers." The murder of Satyendra Dubey in 2003, after exposing corruption in the National Highway Authority of India

(NHAI), triggered public and media outrage, demanding the enactment of a whistleblower-blower bill. The Supreme Court, in response to the writ petition (C) no. 536/2003, directed the establishment of machinery to address complaints from whistleblowers until a law was enacted. A resolution was notified in April 2004, designating the Central Vigilance Commission (CVC) to receive corruption complaints from central government employees. The RTI Act was enacted in 2005 to enhance transparency and accountability in Governance, and the Second Administrative Reforms Commission recommended the enactment of a specific law to protect whistleblowers in 2007. Progress on the bill remained stagnant until 2010, when the Public Interest Disclosure and Protection to Persons Making the Disclosures Bill was introduced in Parliament. The cabinet approved the bill in June 2011, and it was renamed The Whistle Blowers' Protection Bill, 2011, by the Standing Committee on Personnel, Public

Grievances, Law, and Justice. After amendments, the bill was passed by the Lok Sabha on December 27, 2011. These legislative efforts aimed to ensure the safety and support of whistleblowers, acknowledging their critical role in combating corruption and upholding the principles of transparency and accountability.

**WPA: An ineffective tool in India:** The whistleblower's Protection Act (WPA) in India, despite its intent to safeguard whistleblowers, has been criticized for its shortcomings. One major issue is that the WPA does not cover the private sector, which was a significant recommendation of the Second Administrative Reforms Commission. This omission leaves whistleblowers in private organizations vulnerable and without legal protection.

Furthermore, the WPA provides for only one authority at the Central and State levels to receive complaints of wrongdoing. International best practices suggest that multiple sources should be empowered to receive and inquire into

undermines accountability but also endangers the very individuals who strive to uphold integrity and transparency in the nation's governance systems. Urgent reforms are imperative to fortify the WPA and ensure the safety and empowerment of whistleblowers.

The government's failure to enact standalone legislation dedicated to protecting whistleblowers further exacerbates the problem. The corrupt practices within the executive branch and the greed of bureaucrats for power and money have left whistleblowers in a vulnerable position. They are like artists who possess the knowledge and desire to unveil the complete picture of truth but are denied their hands or the right to claim protection. This denial of protection only serves to further the insecurities faced by whistleblowers and emboldens wrongdoers.

# Lab Grown Diamond is catalyzing Diamond Industry evolution in India

**Kolkata (PARTHA ROY):** Diamond industry in India is undergoing evolution with introduction of Lab Grown Diamond (LGD) in large scale in Gems and Jewellery market.

"Diamond Conclave" was organised by Indian Chamber of Commerce (ICC) on Saturday, 7th October 2023, on the theme Diamond Vision 2030 in Kolkata.

ICC Diamond Conclave was attended by Shri Pankaj Parekh, Regional Chairman – East, Gem & Jewellery Export Promotion Council; Shri. Sachin Jain, Managing Director, DeBeers India; Shri. Russell Arunkumar Mehta, Managing Director, Rosy Blue (India) Pvt. Ltd.; Shri Ghanshyam Dholakia, Founder & Managing Director, Hari Krishna Exports Pvt. Ltd.; Shri. Rajesh Rokde, Vice Chairman, All India Gem & Jewellery Domestic Council; Shri Vinod Bamalwa, Chairman, ICC Expert Committee on Jewellery & Lifestyle; Mr. Suvankar Sen, Co-Chairman, ICC National Expert Committee on Jewellery & Lifestyle and Dr. Rajeev Singh, Director General, ICC, and large no. of Diamond traders and jewellers from across the country.

The Conclave deliberated on various aspects of diamond trade including diamond wholesale as well as retail markets economics, introduction of Lab Grown Diamond in large scale, competition between Natural diamonds versus Lab Grown Diamonds, price differential between Natural Diamond and Lab Grown Diamond, fast changing market scenes, integrating and synergizing diamond manufacturing & trade and gold jewellery manufacturing & trade for sustainable Business practices in long term, diamond "certification"

processes, changing macro trade practices including introduction of e-commerce platforms, impact of social and cultural value changes and perceptions, impact of urban and rural population mobility, mobility of financially empowered young generations and others.

Traditionally, Natural diamonds are marketed as high value, rare products which are billions of year old and not easily accessible. Natural diamonds are bought by customers on the basis "trust" on family jewellers. Natural diamonds are gifted as a symbol of treasured emotional relationship and become part of family heirlooms.

However, diamond manufacturing and trade economics is fast changing with introduction of Lab Grown Diamonds.

Introduction of Lab Grown Diamonds (LGD) made accessibility of diamonds easy. LGDs are manufactured in large scale at reasonably low cost. LGDs are sold at much lower price than Natural Diamonds most of the time in jewellery market. Huge price difference exist between Natural Diamonds and Lab Grown Diamonds.

Introduction of Lab Grown Diamonds expanded diamonds market in general, as well as shifted diamonds from niche market to mass market.

Lab Grown Diamonds are chemically and optically identical to natural diamonds.

In terms of certification and grading, Lab Grown diamonds go head-to-head with natural ones and come out indistinguishable in every which way.

Shri Vinod Bamalwa, Chairman, ICC Expert Committee on Jewellery & Lifestyle said, "....From the ancient Golkonda mines to the



present day manufacturing hub in Surat, India has played a vital role to the global diamond industry for centuries. Today, ... India exports diamond jewellery to the entire world including USA, Europe and Middle-East etc. This Industry has expanded greatly. Today, India has reached a leadership position in the number of gems and jewellery segmented industries. This industry is composed of over 85 percent MSMEs. With over 5 million workers, it has a massive economic impact on the nation. India has the potential to play a bigger role in the global diamond industry in the future. One of the primary challenges is that the sector is unorganised. The need of the hour is high quality infrastructure, technology, finance and logistics for the industry to reach greater heights....One district one product scheme has potential to significantly improve the local economy and lead to creation of more jobs."

Shri Rajeev Singh Director General of ICC said "....Diamond has a huge aspirational value. It is given as a pledge of love and a symbol of commitment."

Shri Sachin Jain, Managing Director, DeBeers India, said, "..... to continue the growth, we need to look at long

term goals for the consumption of natural diamonds. The industry's growth has also increased from 6 % to 10.5 % between 2019 and 2023. Moreover, capital investments are also seen....We need to work together to grow in this industry."

Shri Russell Arunkumar Mehta, Managing Director, Rosy Blue (India) Pvt. Ltd. said, "We are looking towards domestic market in the country as the next big market.... And there are initiatives afoot to excite consumer demand".

Shri Ghanshyam Dholakia, Founder & Managing Director, Hari Krishna Exports Pvt. Ltd said, "It is the right time for the industry to grow. It is our responsibility to retain the authenticity of the industry." Shri Dholakia stressed on building "trust" in market place with customers as a long term sustainable Business strategy and practices.

Shri Pankaj Parekh, Regional Chairman – East, Gem & Jewellery Export Promotion Council, said, "Post-pandemic there has been a surge in exports of studded jewellery probably owing to the re-pricing of diamonds that has led to pulling down the values of exports. ....Kolkata is the jewellery hub of India. Nonetheless, along with domestic consumption, we ought to focus more on exporting studded

Shri Rajesh Rokde, Vice Chairman, All India Gem & Jewellery Domestic Council, said,

".... If we merge gold and diamond, the results will be good. Moreover, if we need to sell diamonds to every person, then we need to bring trust and transparency within the diamond business and create a code of conduct."

Shri Suvankar Sen, Co-Chairman, ICC National Expert Committee on Jewellery & Lifestyle said

"The Government of West Bengal is providing a space of about 2,500 to 3,000 sq

ft along with machineries and instruments that pledge an investment of INR 1 crore to train technicians. The Gem and Jewellery Skill Council of India is taking the responsibility of the training.

Such a programme is already running in Mumbai. The industry needs collaborations to run training programmes to develop skill."



# SOP For Body Disposal

**Bhubaneswar(KCN):** The Bhubaneswar Municipal Corporation (BMC) today issued a standard operating procedure (SOP) regarding the disposal of the 28 unidentified dead bodies of Bahanaga train tragedy victims.

Speaking to reporters here, Bhubaneswar Municipal Corporation (BMC) Mayor Sulochona Das said that they are prepared to dispose of the unclaimed bodies and they have informed their decision to the authorities of the AIIMS, Bhubaneswar. "However, we have to wait for a day or two to dispose of the bodies as the AIIMS authorities will hand them over to us in the presence of a CBI representative," she said.

It is worth mentioning here that the CBI is



currently investigating the triple train tragedy that killed over 290 persons.

The Mayor informed that the unclaimed bodies would be cremated at Bharatpur crematoriums.

The BMC has decided to provide two to three dead body carriers for the smooth transportation of bodies from AIIMS to the cremation ground.

"The Director, AIIMS shall hand over the 28 unidentified dead bodies lying in the

mortuary of AIIMS, Bhubaneswar to the Health Officer, BMC following existing rules, procedures, rituals, guidelines of State/ Central Government and NHRC for cremation of the bodies," read the SOP.

The BMC Health Officer will receive the dead bodies at AIIMS, Bhubaneswar and maintain records of the same. Communication expert of the civic body will make videography starting from receiving

of the dead bodies at AIIMS, Bhubaneswar till cremation of bodies for record purpose and submit it to the authority.

The Assistant Health Officer, BMC will receive the dead bodies at cremation ground at Bharatpur and maintain records of the bodies. Adequate manpower will be deployed for smooth cremation of the bodies under the direct supervision of cremation in-charge

officer. All 28 bodies are preserved in special containers at the All India Institute of Medical Sciences (AIIMS), Bhubaneswar.

According to the AIIMS, Bhubaneswar, authorities, 81 bodies were stored in the special containers and there were 110 claimants for them. As of date, 53 bodies have been handed over to the relatives of the deceased after matching their DNA samples. However, there were no claimants for 28 bodies.

The tragic train mishap involving Coromandel Express, Yashwantpur-Howrah Express and a Goods train occurred at Bahanaga Bazar on June 2, 2023. Over 290 people were killed in the tragic train accident.

## Like Bihar and Rajasthan, conduct caste-based survey in Odisha, demands PCC chief Sarat Pattanayak

**Bhubaneswar(KCN):** The Odisha Pradesh Congress Committee (OPCC) on Monday demanded a full-fledged caste-based survey in the state so as to know the present socio-economic status of different caste groups.

Speaking to reporters here, OPCC president Sarat Pattanayak said when the Bihar government has completed the caste survey process and Rajasthan chief minister Ashok Gehlot on Saturday last ordered for the similar exercise, Odisha's ruling Biju Janata Dal (BJD) must not dither to act on the demand.

"We have been demanding since long a caste-based survey in Odisha so as to get a complete socio-economic picture of our

population. However, the Naveen Patnaik government is just dilly-dallying over the issue. If the BJD shows no interest to conduct the caste-based survey, we will do it after coming to power in the state in 2024," said Mr Pattanayak.

The OPCC chief reiterated his demand for convening a one-day special session of Odisha Legislative Assembly to pass a resolution for conducting caste-based survey.

"The Naveen Patnaik government must immediately convene a special session of the Odisha Legislative Assembly and pass a unanimous resolution for caste-based survey as it was done in Bihar. The Bihar government published the caste census report Gandhi Jayanti. The

survey will not only consider one's caste but also one's economic status. This will help the government make plans and policies for the development of all caste groups," said Mr Pattanayak.

In fact, the Bihar government's recent caste survey report reveals that Other Backward Classes (OBCs) and Extremely Backward Classes (EBCs) constitute more than 63 per cent of the population of Bihar.

"While in Bihar, they have now a clear picture of various caste groups, in Odisha we don't have any. Only one half-hearted survey was recently conducted by Odisha OBC Commission and its report says the state has only 43 per cent OBC people. This report is highly erroneous as no door-to-door survey was

# Clinical India make winning start to World Cup campaign

**Chennai:** India put up a clinical show against Australia in Chennai on Sunday (October 8) to get their World Cup campaign off to a winning start. India's spin trio of Ravindra Jadeja, Kuldeep Yadav and R Ashwin posed problems on a surface that was on the slower side to keep Australia to 199 before KL Rahul and Virat Kohli starred in the chase.

It wasn't a straightforward chase for India by any stretch. For a side that was reduced to 5/3 in their last World Cup game in 2019, an encore was in store at Chepauk. Ishan Kishan failed to make use of his

opportunity in place of Shubman Gill by chasing a wide delivery to get caught at slip in the very first over. More misery was in store in the second over of the chase when Josh Hazlewood caused havoc by dismissing both Rohit Sharma and Shreyas Iyer for ducks to stun the crowd and the dressing room. India could have been in more trouble had Australia capitalised on an opportunity provided by Kohli a few overs later when he miscued a pull shot. Unfortunately, Mitchell Marsh failed to grasp the chance following which Kohli was a lot more subdued in his approach. At the

end of the powerplay, India had only 27 on the board but slowly started asserting themselves, adding 53 in the next ten. While India's spinners had a field day, Adam Zampa and Glenn Maxwell quite couldn't recreate the same impact. Cameron Green was taken out of the attack by Kohli who clipped him for successive boundaries and Rahul was positive against Zampa in his first over, fetching three boundaries. Post that, the duo were content rotating the strike and scoring predominantly at four runs an over, which was also the required rate. Once the two batters

edged closer to the target, they started to free up a little more and in that process, Kohli fell for 85 to give Hazlewood his third wicket. Rahul then almost helped himself to a century before narrowly missing out by

four runs. Earlier in the day, India's spin trio rattled Australia big time in the middle overs, triggering a collapse that saw Australia get bowled out for just 199. Marsh edged one behind to slip to depart for a duck very early but post that, David Warner and Steve Smith steered the innings by batting watchfully on a tricky surface. Smith was severe against anything that was bowled either too full or too short like

Hardik Pandya found out and India's decision to bring on Ashwin early didn't work either. After 15 overs, Australia were 71/1 with both batters looking set. Kuldeep then provided a crucial breakthrough as Warner chipped one back to him and then Jadeja took over to cripple the former world champions big time. The left-arm spinner got one to turn and hit the off stump for the key wicket of Smith before he got rid of both Marnus Labuschagne and Alex Carey in the same over. The wickets continued to tumble as the last recognised pair of Maxwell and Green

couldn't rescue Australia either. Maxwell lost his leg stump to Kuldeep and Green gifted Ashwin his first wicket that saw Australia go from 111/2 to 140/7. Things could have been a lot worse for Australia if not for Pat Cummins and Mitchell Starc adding some vital runs in the end. Eventually, that only ended up delaying the inevitable as India cantered home with 52 balls to spare.

## Batters' return to form a positive sign - Samarawickrama

**New Delhi:** The predicament of Sri Lankan cricket couldn't get worse. Over a considerable period of time, there have been financial problems, trouble with the board, and a subsequent fall in the performance of the team since the golden generation hung up their boots.

To add insult to injury, they have timed their low in the worst possible manner in the build-up to the World Cup. Right before the Asia Cup final, it may have seemed like a good thing - reaching an ODI final right ahead of a World Cup. And then the humiliation followed - all-out for 50 in the final. And this was no aberration. It was backed up by more poor performances, like the seven-wicket loss to Bangladesh and a six-

wicket loss to Afghanistan in the warm-ups - teams that Sri Lanka had overcome to reach the Asia Cup final. To cap it off, another steep margin of loss followed in their World Cup opener against South Africa, where they conceded 428 - the highest World Cup total of all time, and three individual hundreds, one of which happened to be the fastest ever. Sadeera Samarawickrama, in particular, was not impressed with the team's bowling performance. "Actually, it's difficult for us as a team to be happy with the bowling (performance). We rarely bowled consistently as a team," assessed Samarawickrama. "On a wicket like this, even a minor mistake from us can result in the opposing team scoring six or four



runs. If we had bowled with more patience, we might have kept them to a lower score." After a deflating bowling performance, Samarawickrama spoke about the talk in the dressing room about chasing down the total and keeping things positive, given that the conditions were extremely well suited to batting. He further opined that if not for the regular

Samarawickrama also insisted that there were positives to come out of the match, with batters playing with freedom in a big chase, and emphasised that the return to form for Kusal Mendis and Dasun Shanaka was crucial.

"Actually, we are very happy that Kusal Mendis and especially Dasun Shanaka have returned to their usual rhythm," said Samarawickrama optimistically. "Also, the way Kusal Mendis and Charith Asalanka gave a lot of confidence to the batting unit of our team was great. When we're chasing such a big number, we don't have time to set up in the middle part."

"I think we always have to play positively. I think it's a significant achievement for us to have been able to play like that in these

## Dharamsala outfield rated 'average' after Afghanistan-Bangladesh game

**New Delhi:** The outfield at the HPCA stadium in Dharamsala that looked patchy in the Afghanistan-Bangladesh fixture on Saturday has been rated 'average'. However, that will not hinder the next game between England and Bangladesh from going ahead on Tuesday (October 10) as a spokesperson from the ICC confirmed that the board's independent pitch consultant Andy Atkinson is 'comfortable with the conditions'.

"The process for assessing the condition of the pitch and outfield lies with the match officials under the ICC Pitch and Outfield Monitoring Process and the

outfield at Dharamsala was rated as average after the Afghanistan v Bangladesh match. Additionally, the ICC independent pitch consultant has taken a look at the outfield today and is comfortable with the conditions as is Javagal Srinath, the Match Referee for the next game," an ICC spokesperson was quoted as saying. The Dharamsala outfield came under the scanner in the first game of the World Cup at the venue as Mujeeb Ur Rahman nearly got injured while putting in a dive in the deep as he ended up jamming his knee on the hard soil beneath that caused some of the soil to kick

## Glenn Phillips emphasises importance of adapting, IPL experience



Phillips said. "Myself and Kane playing here obviously brings a little bit of an advantage to giving information to the boys. We try to take all the information and put it together and as I said, come on the day and adapt to the conditions as fast as possible. Obviously, a pitch can play differently one day than it will for another. So, for us to be able to collate that information, understand what we have in our bank, and stick to our strengths and skills on that particular pitch will be very important. "When 90% of the teams are away teams, it almost levels the playing field quite nicely. India have the home advantage and they play incredibly strong cricket at home. But with the other subcontinent teams Pakistan, Sri Lanka and Bangladesh, these are still a semi-foreign conditions to them... so for us to be able to go

out there and try to adapt as quickly as possible on the day [will be key]. I think that's what we pride ourselves on understanding that you get one shot at each team and it comes down to who can adjust to the conditions on the day. Most of us are all actually very foreign to these conditions, barring probably guys who have had a lot of success in the IPL over the years."

However, with only one game down, he has stressed that the team is trying to not get too carried away by victories or even fall too low in defeat. "The mood is very neutral. Obviously, we enjoyed the first win incredibly much, but obviously, with the tournament being such a quick turnaround, we try to keep things as neutral as possible, not get too high when we win and not get too low when we lose. And I think that's the key for us throughout this

competition." Rachin Ravindra, who was picked in the XI as a fill-in for the injured Williamson, became the third youngest centurion at the World Cup as he cracked a 96-ball 123\*, a knock which included 11 boundaries and 5 sixes, and was declared Player of the Match. While Williamson's expected return for New Zealand's third game could lead to some selection headaches, Glenn Phillips isn't surprised by what

Rachin did deliver in his absence and can deliver in the future. "I wasn't surprised at all [by Rachin's knock]," Phillips admitted on Sunday. "Obviously, I've played a lot of cricket with him back home and he actually plays a very aggressive brand of one-day cricket being at the top of the order. He likes to play with a lot of flair. He plays that square drive incredibly well, which with the new ball is an absolute asset. And then the way he combined with Dev

[Devon Conway] as well, the tempo they both set, they struck at 120, 130 without even almost lifting a finger. It was phenomenal to watch." The unbeaten 273-run stand between Rachin and Devon Conway helped New Zealand overhaul England's total, with the latter also stroking his maiden World Cup century (121-ball 152\*), carrying forward the good show from the second warm-up game. The performance, Phillips

believes, bodes well for the side. "They were absolutely brilliant. Obviously 270-odd run partnership is phenomenal, especially for two guys in their first World Cup. I guess from a team perspective it's really nice to know that those two boys are in some serious form and obviously everyone in the warm-up games obviously had a nice little head out and yeah, it's a good feeling in the camp at the moment," Phillips said. They will be up against a side that maybe lacking in experience and game-time but did manage to give a scare to their opponents - Pakistan - in the tournament opener despite eventually losing by a margin of 81 runs. Phillips admitted that New Zealand will be cautious of the threat Netherlands are likely to pose in their contest on Monday in Hyderabad, especially with their self-admitted nothing-to-lose approach.

"We approach every game the same way every time, every team is strong in their own right, especially on the given day. The Netherlands have a lot of strong players, and we're going to have to still put our best foot forward, as I'm sure they will. So, keep coming up with our plans, doing our scouting, making sure that we have everything set in place, and not taking any team lightly."

"I think they're a really good team. Obviously, they've beaten quite a few good opponents to be able to qualify for the tournament in the first place. So, they're a team definitely not to be taken lightly. They have a lot of high professional cricketers that play all through county cricket as well. So, they've definitely got a good skill set. They know their roles. They bond together well as a team. And I definitely think they're going to be a tough team to beat in this competition."
