BENGALURU(KCN): With torrential rains is being directly held responsible for the in Bengaluru exposing its infrastructure mess, in the absence of the city civic body's woes, sitting legislators from the city and their political parties seem to be a worried lot over the electoral prospects, amid fears

Though Congress has the luxury of blaming the ruling party for the situation and may not be in the direct line of public anger, the grand old party with 11 MLAs may have to bear their share of responsibility, having governed the city and the state for decades

of anti-incumbency and public angst turning against them.

Assembly polls are barely seven months away, and elections to the city civic body the Bruhat Bengaluru Mahanagara Palike (BBMP) are expected later this year.

The downpour and deluge caused by it resulted in large-scale destruction and misery, affecting the normal life of people, with some complaining that the "brand Bengaluru" has taking a hit.

The famed IT industry bore the brunt of the rain fury; there seems to be palpable anger among a section of citizens who felt let down by the political class during the crisis.

According to some political observers and party insiders, this fear seems to be more within the ruling BJP, as the state government

in the past.

Also, several Congress legislators from the city are those who have served as MLAs and Ministers in the past, and there might be an anti-incumbency factor against them.

### Ukraine reclaims swathes of east in shock offensive to oust Russia

KHARKIV(KCN): Ukraine said Sunday that its forces were pushing back Russia's military from strategic holdouts in the east of the country after Moscow announced a retreat from Kyiv's sweeping counter-offensive.

Ukraine's nuclear energy agency said the final reactor at the Russian-controlled Zaporizhzhia plant, Europe's largest nuclear



power station and a focal point of the conflict, was shut off as a safety measure.

The speed of Ukraine's fightback against Russia's invasion has apparently caught Moscow's military off-guard, bringing swathes of territory Russia had controlled for months back into Ukraine's fold.

Crates of dumped munitions and abandoned military hardware were seen scattered in territory left by the Russian forces, images posted by the Ukrainian military showed.

"The liberation of settlements in the Kupiansk and Izyum districts of the Kharkiv region is ongoing," the Ukrainian military said in a general battlefield update Sunday, 200 days into Russia's invasion.

These are key supply and logistics hubs that Russia depends on to restock its frontline positions in the east.

Military observers have said their capture by Ukraine would be a serious blow to Moscow's military ambitions in Kharkiv. 'Weapons, weapons, weapons'

The head of the Ukrainian military announced

early Sunday that as much as 3,000 square kilometres (1,158 square miles) had been wrested from Russia since the offensive began at the beginning of this month.

That figure is already around one-third larger than the total area announced by President Volodymyr

Zelensky late Saturday. On Sunday, he announced that Ukraine forces had taken a village of around 4,000 people between Kharkiv and Izyum.

"The great Ukrainian flag has been returned to Chkalovske. And it will be like that everywhere. We will cast out the occupiers from every Ukrainian town and village," he said in a video online.

Ukrainian officials this weekend hailed the "astonishing" pace of the counter-offensive and on Sunday, the country's foreign minister used the momentum to appeal to Western allies for more stockpiles of sophisticated weapons.

NEW DELHI(KCN): Bengaluru's R K Shishir of the IIT Bombay zone has topped JEE-Advanced 2022, whose results were announced on Sunday. He secured 314 out of 360 marks.

Seventeen-year-old Shishir of Narayana Techno School in Bengaluru had earlier topped the Karnataka Common Entrance Test (KCET) in the pharmacy stream and stood fourth in the engineering category.

The second and third rank holders are Polu Lakshmi Sai Lohith Reddy and Thomas Biju Cheeramvelil. Tanishka Kabra from the Delhi zone is the topper among female candidates with 277 marks. Her all-India rank is 16. Out of the top 500 candidates who have qualified in JEE Advanced, 133 are from the IIT Delhi zone, followed by the IIT Madras zone (132) and IIT Bombay zone (126). Also, five out of the top 10 rank holders are from the IIT Madras zone. These include Polu Lakshmi Sai Lohith Reddy (Common Rank List (CRL) 2), Thomas Biju Cheeramvelil



sion test for engineering colleges across the country, conducted by the National Testing Agency (NTA), is the qualifying exam for Joint Entrance Exam (JEE)-Advanced. Over 1.5 lakh candidates appeared for the exam this year, and 40,712 have qualified. Of the total qualified candidates, 6,516 are females. Candidates can check

Now, candidates must appear for the Joint Seat Allocation (JoSAA 2022) to get admission to these premier IITs. The JoSAA counselling is set to commence on September 12. According to officials, over 16,000 seats are up for grabs in all the 23 elite IITs, a marginal increase in the total number of seats from 16,232 last year to 16,598 this year.

These seats include 1,567 supernumerary seats, which are over and above the sanctioned intake approved by the authority for women candidates - an initiative to encourage gender diversity in these prestigious technological institutes. Along with the result, the final answer key has also been published.

The aggregate marks are calculated as the sum of the marks obtained in Mathematics, Physics and Chemistry. Candidates have to satisfy the subject-wise as well as the aggregate qualifying marks to be included in a rank list, officials said.

Mr Dortse is on the Board of Jillian India Ltd and has clearly emerged as the mastermind of the whole racket of incorporating large number of shell companies with Chinese links in India and providing dummy Directors on their Boards. The arrested person Mr. Dortse had shown himself to be a resident of Mandi in Himachal Pradesh as per the records filed with the Registrar of Companies. ?Evidence procured during the enquiry by ROC Delhi and the simultaneous search operations clearly points to dummy Directors being paid by Jilian India Ltd. to act as dummies in several shell companies. A condolence meeting was held in the library to mourn Queen Elizabeth II's death on Friday. Queen Victoria had died just three-anda-half years after her Diamond Jubilee in January 1901 at the age of 81, said the secretary of the library, Baidyanath Chatterjee. The library at the old bus stand was constructed in 1897 as part of the Diamond Jubilee celebrations of Queen Victoria. "In



The bride, pretty, radiant and in red, sits in front of the sacred fire, her family, the groom and his parents around her, the love flowing like a balmy breeze.

And in that arguably most precious moment, she looks into the camera and asks, "why must a woman be commodified through the custom of 'kanyadaan? literally 'donating a daughter."

The ad for a lehenga brand featuring Bollywood star Alia Bhatt as the much-indulged daughter and granddaughter has fired debate on social media platforms and elsewhere on the age-old tradition of giving away the daughter.

Many term it Hindu phobic for casting aspersions on a ritual that is part of the warp and weft of society, others appreciate it for calling out the patriarchy that underscores the custom and there are those that feel it should have gone even further in its rejection.

"There is a growing number of young women who are beginning to think about the issue, especially as increasing number joins the workforce, has access to ideas (via social media etc) that are critical of 'women as property' concept. This ad reflects that," sociologist Sanjay Srivastava told PTI.

In the 1.41 minute ad, Bhatt, the self-assured woman of today who also does a selfie pout with her father while at the 'mandap', recalls her lifetime of 'othering' in a monologue her fond grandmother saying she would one day go to her own home, her father not reacting when people called her "paraya dhan" (alien property) and her mother calling her a 'chidiya' which would fly away one day.

The Manyawar ad ends with the grooms' parent also joining in in the ritual (though it is unclear whether they too are giving away their son) and Bhatt's bride saying it should be 'kanyamaan' (respect for the girl child) and not 'kanyadaan', and asking, "Am I a thing to be given away?" Her angst finds a wide echo. Actor Dia Mirza, who decided to do away with the rituals of both "bidaai" and "kanyadaan" when she got married to businessman Vaibhav Rekhi, said they wanted the wedding to reflect their "beliefs and not outmoded ideas." "Neither of us believes that women are commodities to be given away or 'donated.' Women have agency, selfhood and can make decisions about their lives on their own so my wedding reflected exactly that by not including a ritual like 'kanyadaan'," the actor told PTI.

She even engaged a female priest for her wedding to emphasise gender equality.

"It is time for young couples to define how they want to get married and if their ceremony is truly representative of their personalities and love for each other," said the actor, who is also the United Nation's National Goodwill Ambassador from India.

The ritual of giving away the bride is, of course, not just about Hindu weddings.

It is also a vital part of a Christian wedding service where the father walks down the aisle with his daughter and "hands her over" to the waiting groom.

Brought up on tradition and a diet of popular culture, including movies, both Indian and western, many women have now begun to question the patriarchal traditions of wedding ceremonies across societies.

Mumbai-based IT analyst Meghna Trivedi, who got married in February last year, said the ritual of 'kanyadaan' does not make sense in today's day and age but had to undergo the ritual anyway.

Trivedi, a Gujarati who married a Punjabi, said she asked the priest to find another way but he maintained 'kanyadaan' is a "must".

"What you mean by 'kanyadaan' is that you're giving away your daughter to somebody else and that is something you have to do in your life and it's related to your duties as a parent that now your daughter belongs to another family," she told PTI.

Actor Kangana Ranaut was among those who disagreed. Criticising the ad in an Instagram post, she said, "Humble request to all brands. Don't use religion, minority, majority politics to sell things. Stop manipulating naive consumers with shrewd divisive concepts and advertising. Please stop mocking Hindus and their rituals."

One of the Twitter users echoed similar sentiments.

"Our traditions are not regressive, your mindsets surely are! Kanyadaan is a sacred tradition, where a father/parent parts with their most precious and cherished daughter, a bittersweet emotional moment filled with hopes, promises and dreams," the user wrote. Women's rights activist Shabnam Hashmi said the attacks on the ad "reflects the highly patriarchal mindsets of our society".

"It is a very progressive advertisement and raises important questions of women's dignity and equality," Hashmi told PTI.

Sociologist Shrivastava added that people reacted negatively because there is an increasing intolerance against anything that is seen to question 'Indian traditions'.

The reaction, he said, also reflects a "male anxiety" about the changes that are happening in addition to the current climate where it has become difficult to question anything Indian/Hindu.

There were also those who felt the ad didn't go far enough.

"The idea should not be to perpetuate the custom but to break away from it," said a young woman, who welcomed the ad and the questioning of traditions but would have preferred that it didn't end with the parents of both sides taking part in it.

A radical break would have been more effective in sending out the message, she said. However, a debate reflects a churn. And in that sense, any discussion is welcome, even if it has unlikely beginnings in an ad for a bridal lehenga.

## **Queen Elizabeth II's funeral on September 19 at Westminster Abbey**

LONDON: The State Funeral of Queen Elizabeth II will take place at Westminster Abbey in London on September 19 at 11 am local time, Buckingham Palace announced on Saturday.

Prior to the State Funeral, the late British monarch will lie-in-state at Westminster Hall nearby for four days to allow the public to pay their respects.

"During the Lying-in-State, members of the public will have the opportunity to visit Westminster Hall to pay their respects to the Queen," the palace statement said.

"On the morning of Monday 19th September, the Lying-in-State will end and the coffin will be taken in Procession from

the Palace of Westminster to Westminster Abbey, where the State Funeral Service will take place," it said.

Following the State Funeral, the coffin will travel in procession from Westminster Abbey to Wellington Arch in London for its onward journey to Windsor. In Windsor, the State Hearse will travel in procession to St.

It will be accompanied on the journey by the Queen's daughter, Anne, the Princess Royal.

The Queen's Coffin will then be conveyed to Buckingham Palace by road, to rest in the Bow Room.

"On the afternoon of Wednesday 14th September, the coffin will be borne in procession on a Gun Carriage of the King's Troop Royal Horse Artillery from Buckingham Palace to the Palace of Westminster, where the Queen will Lie-in-State in Westminster Hall until the morning of the State Funeral," the palace said.

The route of the procession will take in iconic central London sights such as Queen's Gardens, The Mall, Horse Guards and Horse Guards Arch, Whitehall, Parliament Street, Parliament Square and New Palace Yard.

After the coffin arrives at Westminster Hall, the Archbishop of Canterbury will conduct a service assisted by the Very Reverend Dr David Hoyle, Dean of Westminster, and attended by the King and members of the royal family, after which the Lying-in-State will begin for the public to pay their respects.

of innovation Modi wants India to become a hub

AHMEDABAD: Prime Minister Narendra Modi on Saturday called for concerted efforts to make India a global centre of research and innovation, and urged state governments to frame modern policies in the fields of science and technology.

Modi lamented that unlike the western countries, India failed to adequately celebrate the works of its scientists, which turned a large section of the society indifferent towards science.

There is a need to celebrate the achievements of Indian scientists, he said.

Addressing via video link the inaugural session of the Centre-State Science Conclave organised here, Modi said that since 2014, there has been a significant rise in investment in the fields of science and technology.

India is going ahead with the mantra of 'Jai Jawan, Jai Kisan, Jai Vigyan and Jai Anusandhan' (Hail soldiers, farmers, science and research), he said. "We have to work together on various fronts to make India a global centre of research and innovation in this 'amrit kaal'. We have to take our research in the fields of science and technology to the local level. It is the need of the hour for all the states to lay emphasis on innovation to find local "In order to encourage innovation, the state governments should give emphasis on creation of more and ore scientific institutions and on simplification of processes. The number of innovation labs should also be increased in the institutions of higher education in states," he said.

Modi said India's Global Innovation Index ranking improved from 81 in 2015 to 46 due to the efforts of the central government.

There is a need to find localised solutions to issues like affordable housing, climate-resilient crops and

waste recycling, he said. "It is important that to deal with all these challenges, every state should frame modern policies related to science, innovation and technology and implement them. As governments, we should cooperate and collaborate

more and more with our scientists. This will help create an environment of scientific modernity in the country," he said. He also called for "optimum utilisation" of scientific institutions in the states. "There are many national-level scientific institutes and laboratories in states. So the states should take full advantage of their ability and expertise. We also have to take our science-related institutions out of

He pointed out how unlike the West, India failed to celebrate the works of our scientists in the early decades of the last century as much as was required, which led to an emergence of feeling of indifference towards science among a large section of our society.

"When we celebrate the achievements of our scientists, science becomes a natural part of our society, it becomes part of culture. Therefore, today my first request is that we celebrate the achieve-

ments of the scientists of our country with great enthusiasm," he said.

"Today in every area, Indian scientists are working wonders. The inclination towards science created by celebrating every small and big achievements of Indians scientists will help us in our 'amrit kaal'," he

added. Modi said his government is moving forward with changing in the country, he said.

"There is inclination for science, technology and innovation in the DNA of today's generation. They adopt technology very fast. We have to support this young generation with all our might. In India, new sectors are being created, opening up for the young generation today," he said.

"Whether it is a space mission, deep ocean mission, national supercomputing mission, semiconductor mission, hydrogen mission, drone technology...works are moving fast on many such missions," he said.

Modi said emphasis is placed on offering lessons in science and technology in a student's mother tongue.

He also talked about "hyper specialisation", and said that the Centre is ready to help states in the development of global-level specialised laboratories.

"You should also work for the increase in programmes in your states, which helps take science and technology at the grassroot level," he said, adding that states should encourage more schools to participate in science festivals and pay close at-

# 'Lakes remain thirsty even as Bengaluru drowned': Activists blame land mafias for floods

BENGALURU: The torrential rain in the city that flooded the houses and offices of tech honchos and turned roads into rivers of sorts could not fill most lakes, thanks to the land mafia who turned the feeder canals of these water bodies into a sewerage drain and diverted their flow, environmentalists said.

This mischief by the land sharks in connivance with some vested interests in various civic agencies and in the government led to the death of lakes in the city, Leo Saldanha, coordinator of Environment Support Group alleged.

Bengaluru, which the British rulers had called as a 'City of thousand lakes' for having over 1,600 lakes, has about 400 water bodies today in the Bengaluru metropolitan region.

"Those lakes which disappeared gave way for residential layouts, bus stands, bus terminals and tech parks. Sadly, those 400 lakes are also on the verge of destruction,".

Citing the example of Subrahmanyapura Lake in South Bengaluru, he said it has reduced to a cesspool and is choked with weeds.

One can hardly imagine that barely 15 years ago, people used its water from drinking and took bath in it, he pointed out.

"Ironically, not only the Bangalore Development Authority developed a layout on another lake 'Venkatarayana Kere' on upstream of Subrahmanyapura Lake, but a powerful builder also constructed two massive residential complexes exactly on the feeder canals of these two lakes --Subrahmanyapura and Venkatarayana Kere," Saldanha claimed.

ALSO READ | No Master Plan, no Master Plan Scheme...Reason why Bengaluru is flooding Further, the Bruhat Bengaluru Mahanagara Palike (BBMP) reduced the width of its feeder canal from 60 ft to a mere 10 feet wide drain in two years. The feeder canal of the lake carries the sewage of the nearby apartments and residential layouts, he claimed.

The drain does not empty a drop of rainwater into the lake.

Instead, it is diverted to straightaway flow into the subsidiary of the Vrushabhavathi river.

The Vrushabhavathi river is now reduced to a ma-

gally while the civic agency finds itself helpless to recover them.

"The civic agencies had removed encroachment of Chikkalasandra lake a few years ago but today once again the encroachers are back.

This time even the Bruhat Bengaluru Mahanagara Palike is parking its garbage vehicles inside the 'lake



jor sewage drain, Saldana said.

"It is a fact that the Subrahmanyapura lake got the attention of the court from 2009 and we are now in 2022. The attention of the court was focused on it. But even with judicial oversight, the Raja Kaluve (feeder canal of the lake) has been destroyed. Apartments have been constructed. This shows the weakness of the system," Saldanha said.

Ravi Kumar, a resident of Chikkalasandra in the region, charged within a radius of two km of the Subrahmanyapura lake, land sharks gobbled up Chikkasandra Lake, Ittamadu Lake and Narayana Kere and turned them into a residential layout illebed', allowing others to encroach on it," Kumar alleged.

Noted activist S R Hiremath who led a campaign against the encroachment of government land in Karnataka, especially in Bengaluru said Bellandur Lake, which is the largest water body of the city, had been the victim of rampant encroachment as residential developments happened on its wetland region and its feeder canals.

"I had fought a legal battle against the encroachment with the help of eminent lawyer Prashant Bhushan in the Supreme Court and also fought cases in the High Court. The problem is those who grabbed the government lands are very powerful and are holding important posts in government institutions as well as all the political parties," Hiremath said.

As water recedes, Mahadevapura residents now fear infections

Due to the heavy downpour in the past one week, the lake swelled to monstrous proportions submerging all those areas, which were encroached upon. "I live in Bellandur. I am unable to move out due to flooding for the past one week. It's been more than 15 years, since I moved to this place but never ever, I experienced such a flood," an executive of a corporate company told PTI requesting anonymity.

A former IAS officer requesting anonymity said the government is least bothered about the problems of Bengaluru.

"The AT Ramaswamy committee report and V Balasubramanian's report 'Greed and Connivance' are gathering dust in the dingy corners of the government offices.

For the politicians and government officers, these reports are like a can of worms, which they don't want to open," he claimed.

According to noted architect Naresh Narasimhan, the planning of the city is based on land use and real estate and not on climate change and resilience. "You have to think little ecologically. The root of the word economy is same as the word ecology. Both words have derived from a Greek word 'Ecos', which means home. Until we give importance to ecology, the economy cannot improve," Narasimhan said. The architect opined that the flooding in Bengaluru was an extreme climate change event, which was never seen before.

"If this has happened now, then it can happen again and we should plan accordingly," Narasimhan said. He insisted that the government should demonstrate a strong political will to take harsh decisions.

set a target to win all the 21 Lok Sabha seats in the state in order to make the regional party more viable in the national politics and ensure better bargaining power vis-à-vis the Central Government.

The BJP, which won 8 of Odisha's 21 Parliamentary seats, desperately needs more Lok Sabha seats from Odisha this time as its alliance partners like Nitish Kumar's JD(U) and Shiromani Akali Dal (SAD) have broken up with the NDA. There is also no guarantee that the BJP will repeat the performance of the 2019 elections in the wake of the spiral price rise of essential items across the country, huge unemployment and Congress gaining some ground in some BJP ruled states.

### Calls in Kenya for UK to return resistance leader's head

Calls are mounting in Kenya for Britain to return the head of a revered tribal leader who led a bloody resistance movement against colonial rule more than a century ago, after the death of Queen Elizabeth II. Koitalel Arap Samoei spearheaded fierce opposition to the construction of the so-called "Lunatic Express," a railway from Kenya's Indian Ocean port of Mombasa through Nandi in the Rift Valley to Lake Victoria in Uganda.

Many thousands of people are believed to have been killed in the more than decade-long struggle that began in 1895 when surveyors first marked out land in Nandi as a route for the railway. Kenyan historians say British colonial authorities lured Samoei to a meeting in October 1905 ostendespite the history of the British empire and its atrocities", he said, highlighting the strong relations between Britain and Kenya today.

"But as the world is mourning the passing of Queen Elizabeth II maybe now is the right time to implore the British government to do what is only right -return the head of Koitalel Samoei and issue an apology publicly to the people of Nandi."

Tarus said 20,000 people were killed during the uprising and thousands more displaced when British authorities seized 140,000 acres of fertile land in Nandi now used for tea plantations by British multinationals.

"To this date there hasn't been any compensation from the British government," said Tarus, who is

He said this was despite Britain agreeing in 2013 to compensate over 5,000 Kenyans who had suffered abuse during the 1950s Mau Mau rebellion against colonial rule.

AFP has contacted the British government for comment.

In 2006, heirs of colonial-era British army colonel Richard Henry Meinertzhagen, said to be the man who killed Samoei, returned a walking stick and baton to Kenya that had belonged to the tribal leader.

Samoei launched his unsuccessful and ultimately fatal struggle after foretelling that a black snake spitting fire -- a steam engine -- would pass through Nandi, destroying tribal culture and disenfranchising local farmers and cattle herders.

Tarus said he believed the British took Samoei's head not only as a trophy but also to study.

"I think they wanted to find out how... he could resist the British for 11 years with their sophisticated weapons while the Nandi were only using mainly bows and arrows."

## Finance ministry mulls easing laws to increase insurance penetration

NEW DELHI: The finance ministry is contemplating changes in insurance laws, including reduction in minimum capital requirement, with a view to increasing the insurance penetration in the country.

Insurance penetration in India increased from 3.76 per cent in 2019-20 to 4.20 per cent in 2020-21, registering a growth of 11.70 per cent. Insurance penetration measured as the percentage of insurance premium to GDP witnessed handsome growth during the year, mainly due to the outbreak of COVID-19.

The ministry is doing a comprehensive review of the Insurance Act, 1938 and also looking at making relevant changes to help push growth of the sector, sources said, adding the process is at a preliminary stage.

One of the provisions being considered is lowering the minimum capital requirement of Rs 100 crore for setting up an insurance business, the sources said.

Easing capital requirement would allow entry of differentiated insurance companies like in the banking sector, which has categories like universal bank, small finance bank and payments bank. With the ease of entry capital norms, sources said, there could be entry of companies focussed on micro insurance, agriculture insurance or insurance firms with regional approach. So for them, the solvency margin re-

### Jaishankar optimistic about India achieving 7% growth despite Ukraine war challenges

Riyadh: India has made powerful efforts to grow its economy and emerge as a higher-income country, External Affairs Minister S Jaishankar has said, expressing hope that it will be the fastest growing major economy in the world this year with at least 7 per cent growth despite the challenges posed by the Ukraine crisis.

Jaishankar arrived here on Saturday on a threeday visit to Saudi Arabia to discuss ways to further strengthen relations between the two countries. It is his first visit to Saudi Arabia as External Affairs Minister.

"Began my visit to Saudi Arabia with interaction with our community. Appreciated the contribution of our Diaspora in facing national challenges. Spoke to them about our country's resilience, especially during the time of the Covid and national transformation that is underway in India," Jaishankar tweeted.

Addressing the Indian community here on Saturday, Jaishankar said: "India thinks about the ways in which it can change its credit, banking, education and labour policy."

He said that India has made powerful efforts to grow its economy and move towards becoming a higher-income country.

"A lot of this required a vision, prudent management of our fiscal resources," he said.

weapons have been on our agenda since spring. I am grateful to partners who have answered our call: Ukraine's battlefield successes are our shared ones," Dmytro Kuleba said.

"Prompt supplies bring victory and peace closer," his statement on social media read. The reaction in Moscow to the Ukrainian gains so far has been muted, but on Sunday an official in the border region of Belgorod said "thousands" of people had fled the Kharkiv region over the border and into Russia.

More than 1,000 people were being housed in temporary shelters, the official, Vyacheslav Gladkov, said.

The Russian military meanwhile made the surprise announcement Saturday that it was "regrouping" its forces from Kharkiv to the Donetsk region just south to focus its military efforts there. But the announcement came shortly after Moscow also said it was actually sending reinforcements towards Kharkiv. Around Balakliya, one of the first towns to be recaptured by Ukrainian troops, AFP journalists saw evidence of fierce battles, with buildings destroyed or damaged and streets mainly deserted.

With growing public anger, a political slugfest has erupted between the ruling BJP and the opposition Congress in the state, blaming each other for the city's infrastructural mismanagement.

Chief Minister Basavaraj Bommai himself led the charge for the BJP blaming the previous Congress governments' 'maladministration' for the deluge.

He has accused the grand old party of giving permissions for construction activities "rightleft-centre" in the lake areas, on tank bunds and buffer zones, during its regime.

Hitting back, Leader of the Opposition Siddaramaiah, accusing the ruling BJP in Karnataka of trying to shift the blame on the Congress to hide its failures, urged the government to come out with a white paper regarding the clearing of encroachments on stormwater drains in the city, as he claimed that "brand Bengaluru" is getting affected. State Congress Working President and senior MLA Ramalinga Reddy feels the rains and infrastructure woes that Bengaluru witnessed will negatively impact the ruling BJP, and if

people truly analyse and compare with the Congress' tenure it should benefit the grand old party, considering the work it did while in power.

"The issue here is not rain; rain is natural, no one has control, but how the government acts is important as there will be issues like potholes, public infrastructure, also corruption, all this will factor in," he said.

feet-high shrine.

After collecting the fees, the temple administration allowed the hoisting of the flag. However, the issue was highlighted by senior servitors of the temple belonging to various Nijogs who said conservationists associated with the temple should have been consulted and ASI permission taken before the flag was hoisted.

"Wind was extremely strong yesterday and vibrations generating from such a huge flag may have been detrimental to the structural safety of the temple," he said. Usually, flags are changed every day at the temple. "Jagannath temple in Puri has specific norms about the length of the flag that is hoisted on the shrine. Similar norms should be put in place for Lingaraj temple too," said Kamalakanta Badu, a senior servitor of the temple. After being pointed out, the flag was taken down on Friday.

ASI officials said no permission was sought from it before hoisting of the massive flag. If vibrations caused by the flag had any impact on the Dadhinauti, it needs to be examined, they said. Servitors hoisting the flag atop the 'kalasha' have time and again pointed out that the Dadhinauti has developed cracks. The structure was repaired in 2015 by the ASI.

'It was scary'

Iryna Stepanenko, 52, who was outside cycling for the first time in months, said she had hidden in her basement for three months. "There was a lot of fear, shelling. It was scary," she recounted of the Russian takeover and Ukraine's bid to recapture the town, where some 27,000 people lived before the invasion.

She said she was relieved to see Kyiv's forces retake the town but were still worried about the future.

"I'm worried the Russians could return. I'm worried the shelling could start again."

Despite the reported Ukrainian gains, Russian forces have continued bombardments across the frontline, and in the Donetsk region, officials said shelling killed 10 people and wounded another 19.

An uptick in fighting in and around the Zaporizhzhia nuclear power plant meanwhile has sharpened fears of another nuclear incident comparable to the Chernobyl disaster in northern Ukraine in 1986.

Ukraine's state nuclear agency on Sunday said that the sixth and final reactor at the plant had been shut off and instead transferred to a cold shut-down.

Energoatom said that the sixth reactor had been generating energy for the plant itself for three days and that the decision to halt its operations came when external power had been restored to the facility.

It cautioned again, however, that in its view the only way to ensure the safety of the facility would be to create a demilitarised zone around it.

# Iga Swiatek beats Ons Jabeur for 1st US Open title, 3rd Slam

NEW YORK: Good as she's been this year, Iga Swiatek came to the U.S. Open unsure of what to expect. She complained that women use different, slightly

lighter, tennis balls than the men do at Flushing Meadows, where she'd never been past the fourth round. She was trying to grow accustomed to the noise and distractions, the hustle and bustle, of the Big Apple. And she arrived with a record of just 4-4 since her 37-match winning streak ended in July. None of that matters now. Cementing her status as her sport's new dominant figure by winning what is expected to be the last tournament of Serena Williams' career, the No. 1-ranked Swiatek outplayed No. 5 Ons Jabeur 6-2, 7-6 (5) in Arthur Ashe Stadium on Saturday to claim her first champion-ship at the U.S. Open and third Grand Slam title overall.

"It's something that I

wasn't expecting, for sure. It's also like a confirmation for me that the sky's the limit," said Swiatek, who is 55-7 in tour-level matches with seven trophies in 2022, both best in the WTA. "I'm proud. Also surprised little bit.'

She acknowledged harboring concerns about the U.S. Open after a couple of shaky showings at hard-court tune-up tournaments. It turned out OK: She is the first top-seeded woman

to win the U.S. Open since 23-time major champion Williams in 2014.

"I feel like on court, I can just do my job," Swiatek said, "and I'm happy about it, that I kind of can make these doubts go away." Swiatek, like Jabeur, travels with a sports psycholo-

gist, and it took some fortitude to finish this one off. At 6-5 in the second set, Swiatek held her first championship point. Right before Jabeur served, Swiatek jogged over to the sideline to change rackets — an unusual choice at that moment.

When action resumed, Swiatek missed a backhand. That could have been tough to recover from.

Indeed, Jabeur pushed things to the tiebreaker, which she then led 5-4. But Swiatek steeled herself, took the last three points and soon was accepting the silver trophy and a \$2.6 million winner's

all in straight sets — and was great from the getgo.

Jabeur did not face a single break point in her semifinal victory, but she got broken right away when and that, never letting Jabeur use the sorts of spins and variety that she's accustomed to.

"She's really set the bar very high. It's great for our sport," said Jabeur, a 28-year-old from Tunisia who will rise to No. 2 in the rankings on Monday. She is the first African woman and first Arab woman to reach a Grand Slam final and was participating in her second in a row.

But she is 0-2 at that stage, including a runner-up showing at Wimbledon in July.

"Definitely, I'm not someone that's going to give up," said Jabeur, whose support team wore black shirts with white writing that read "Yalla Habibi,"

Arabic for "Let's go, my love!" "I am sure," she added, "I'm going to be in the final again."

Didn't help on this sunny, 85-degree Fahrenheit (29.4 Celsius) afternoon that Jabeur needed to deal with Swiatek, who has won her past 10 finals ---- Swiatek laced a cross-court backhand winner off a short ball to cap a 15-stroke exchange.

"The only match here where I started that well," said Swiatek, who had to come back from a set down in the fourth round and the quarterfinals. Eight minutes in against Jabeur, Swiatek had grabbed 12 of the first 14 points for a 3-0 edge. "Put a lot of pressure on me," Jabeur said.

Using her heavy topspin forehand to take charge from the baseline, Swiatek dictated the tempo and trajectory of points. She ran her opponent this way back when an off-balance backhand won a point in the next game, she stayed there, enjoying the moment, pumping her fists while laying on the ground. Jabeur earned three break chances in that game, any one of which would have allowed her to serve for the set. She could not cash in there, though, missing a groundstroke on each. Swiatek needed to wait 10 minutes from her first match point to the one that closed the contest, but close it she did. Maybe she'll feel more comfortable at the U.S. Open from now on.



# Riske 'excited' to keep up good run

CHENNAI: IT was in 2019 when Alison Riske shone through after a series of impressive wins on the circuit. One of the highlights of her year was beating then world No 1 Ashleigh Barty in the third round of Wimbledon before going down in three tight sets to Serena Williams in the quarterfinals. It tight sets to Serena Williams in the quarterfinals. It also included a triumph at 's-Hertogenbosch apart from reaching the final at Wuhan, a WTA 1000 event. Those run of results propelled her to the WTA Elite Trophy, an end-of-season competition for players ranked between 9 and 19. That in itself was evidence of her improvement. She began the year 48th, she was 18th when the calendar fin-iched ished.

Her 2020 began promisingly, a run to the quarterfinals at Brisbane before her best performance at Melbourne (4th round). Just when it looked like that upward trajectory was taking off, the calendar came to a halt, thanks to the pandemic. After the tournaments returned, she was down with a nasty foot injury that cost her close to nine months of playing time. The wins dried up in the first part of 2021 (4-11 losing record) but a steady late-season charge culminated in a third title (Aus-tria). She needed that, more than any-thing to convince herself that she was past her injury troubles
