#### Odisha: Farmers resent govt delay in announcement of input subsidy

BHUBANESWAR(KCN): Even as the State government promptly sanctioned Rs 128.58 crore for immediate restoration of public property damaged in the recent floods, the delay in the announcement of a similar pack-



age for farmers who sustained crop loss is baffling.

As per damage assessment reports received from 24 flood-affected districts, 1,26,162 hectares of farmland suffered crop loss of

more than 33 per cent.

"The government has been advising farmers to take up short duration paddy or early rabi crop cultivation but it is yet to provide agriculture input subsidy or other financial as-

sistance to the affected farmers. Further delay in the announcement of special package will be of no use," said State BJP president Samir Mohanty.

"Faced with a similar situation in 2020, the State government had announced input subsidy for the flood-affected farmers on September 10. Perhaps the

government is waiting for the crop-cutting reports from districts to announce a package for farmers. It will be of no use if the package is announced a week later," said Dillip Kumar Baral, a farmer of Puri district.

#### **Revenue Rises by 15.55**

Bhubaneswar(KCN): State's own revenue collection from both tax and non-tax revenue has been increased by 15.55 percent till August of the current fiscal year 2022-23.



Both the own tax and non-tax revenue have registered a good growth and almost equally contributed to the total collection during April to August of 2022-23.

According to official data, the total revenue collection was Rs 36,454.89 crore during the period while the State had collected Rs 31,548.49 crore during the same period of previous financial year.CONTINUED ON: P-7



# **Odisha CM Naveen Patnaik to ring BSE opening bell on Mumbai trip**

BHUBANESWAR(KCN): Chief Minister Naveen Patnaik is slated to ring the opening



bell of the Bombay Stock Exchange (BSE) during his three-day tour of Mumbai beginning on Tuesday.

He will visit the commercial capital of the country as part of an investors' meet scheduled on September 14. This is the fourth investment roadshow after Dubai, Ahmedabad and New Delhi ahead of the third edition of the Make-in-Odisha Conclave from November 30 to December 4.

The CM will address potential investors invited from diverse sectors at the Mumbai roadshow. As part of the curtain raiser of the mega industrial carnival, he is also scheduled to meet industry leaders and business tycoons to apprise them of the conducive business environment in the State.

Official sources said the focus at the Mumbai meet will be on new industrial sectors and investors' groups not yet present in Odisha. The target sectors for the event include bank-

ing, fintech, chemicals, renewable energy equipment, plastics and metal downstream.

Kolkata(KCN): Dr. Samir V. Kamat, an Alumnus of IIT Kharagpur has been appointed the Secretary of Department of Defence Research and Development (R&D) and Chairman, Defence Research and Development Organisation (DRDO) by the Appointments Committee of the Cabinet on August 25, 2022. Dr. Kamat has been conducting cuttingedge research and development on materials for various defence applications for the past three decades and has been bestowed the Distinguished Alumnus Award by IIT Kharagpur for the year 2018. As a Distinguished Scientist and Director General, Naval Systems and Materials, Defence Research and Development Organisation (DRDO), he is posted at

Visakhapatnam. His sense of purpose evoked metamorphism in Defence applications for our country and led to the advanced development towards the service of the nation. Dr. Kamat completed his B.Tech in Metallurgical Engineering in 1985 from IIT Kharagpur and was a recipient of the Institute Silver Medal as department topper. A Ph.D from Ohio State University, USA in Materials Science

and Engineering in 1988, he did his Post-Doctoral Fellowship from the Washington State University, Pullman, USA and joined the Defence Metallurgical Research Laboratory (DMRL), DRDO in 1989 as a Research Scientist. He was appointed the Outstanding Scientist & Director, DMRL, DRDO, Hyderabad in 2015 before taking up his current portfolio at Visakhapatnam.

In his role, first as Director, DMRL, and now as Director General, Naval Systems and Materials, DRDO, Dr. Kamat has provided leadership and direction to several critical materials and naval systems programmes and has played a key role in enhancing the interaction of cluster laboratories with academic intechnology. stitutions as well as industry. In 2018-19, the share of government expenditure was 40.6%, substantially higher than the share of 28.6%

in 2013-14. NHA findings also indicate that Government's health expenditure as a percentage of Current Health Expenditure has increased from 23.2% in 2013-14 to 34.5% in 2018-19.

# pen defecation – a national shame

Open defecation is a national shame and India tops in number of people open defecating.



India is a grave issue and needs to be addressed on top priority. According UN report to prompting the Government to admit it as a "huge shame",

Open defecation in

India still has the largest number of people defecating in open in the world. Report of WHO and the UNICEF say 597 million people practice open defecation in India. No doubt, most of the people who defecate in open, lack awareness about sanitation. But apart from this, the single major factor which forces people to defecate in open is poverty. One in three people, or 2.3 billion people worldwide, have to share a toilet with multiple families in a community. Open defecation poses a serious threat to the health of children in India. It exposes women to the danger of physical attacks and encounters such as snake bites. According to the UN, countries where open defecation is most widely

practiced have the highest number of deaths of children under the age of five, as

well as high levels of under-nutrition, high levels of poverty and large disparities between the rich and poor.

No country in the world has more open defecation than India, where one in two people defecate outside. Every year, 200,000 children in India die from diseases caused by fecal contamination. Although toilets were built, without adequate motivation to use them, village people often continued to adhere to centuries-old practices, and abandoned the new toilets or put them to alternative uses. In fact there is still a traditional thought that the presence of toilets in the compound makes the later impure. Educated or uneducated, people in rural areas, for want of indoor plumbing use open space for defecating. There are some people who think that open defecation is more hygienic and having an indoor toilet is dirty and filthy. Improving sanitation in the villages has proved

the main challenges faced in the drive to eliminate open defecation is the inadequate human resource base for sanitation. While leading a non-violent movement for India's independence from the British in 1947, Gandhi spoke about the need to improve hygiene and cleanliness in the country. "Sanitation is more important than political independence," he said.

It is a shame that 70 years after independence and India is still in such a state, where people have no knowledge, no resources to maintain a minimal level of hygiene. It's not that all those 60% people who don't use toilet are not financially able to construct toilets in their homes, actually many of them posses TV, cooler, motorcycles and many other accessories but don't feel the need to have a toilet inside their compound.

No doubt., access to sanitation in rural India is improving, the increase is not equitable. Open defecation is still almost universal

among the poorest 20 per cent of the population. We need a grass root campaign on how many diseases can be avoided by basic cleanliness and how spending on toilets is as important as developing other infrastructure. Whatever welfare measures taken so far by the government has not reached fully the mass. We don't need to build new temples, mosques, churches, gurudwaras etc. Public toilets with good water facility are the need of the hour. In a country like India it is very difficult and takes a long time to change the practice of open defecation in rural areas. # Video recording the court proceedings, an Offence?

Nullum crimen sine lege, nulla poena sine lege is a Latin maxim that means "no crime or punishment without a law." There can be no crime committed, and no punishment



meted out, without a violation of penal law as it existed at the time. This basic legal principle has been incorporated into in-

ternational criminal law. This is also one of the fundamental principles of law which is incorporated in Part III of the Constitution. In simple words, no person can be proceeded against and punished unless the legislature had made a specific act as an offence and has expressly provided punishment therefor. Nothing is an offence unless the act alleged to be an offence finds incorporated in the Indian Penal Code (IPC) or any other legislation. The Contempt of Courts Act, 1971 is one enactment outside the general law, namely, the IPC, defining an offence and providing for punishment. Section 2(c) of the said Act defines criminal contempt thus:

(ii) prejudices, or interferes or tends

- to interfere with, the due course of any judicial proceeding; or
- (iii) interferes or tends to interfere with, or obstructs or tends to obstruct, the administration of justice in any other manner;" Sections 12 of the said Act provides for the

manner in which such an offence has to be tried, punishment and imposed. The allegation against Dr. Vikram 2.

Deshmukh, as could be found in the order dated 11th September, 2019 passed by Shri Justice Ravindra V. Ghuge of the Aurangabad Bench of the Bombay High Court, is that he, Dr. Deshmukh, who was present in the Court during the course of the hearing of a petition instituted by his wife, recorded in his mobile the proceedings of the Court. The order further states

pay a fine of Rs.1 lakh,

without any charge, without any trial and for what offence he is being punished, frightened, Dr. Deshmukh pleaded guilty, profusely apologized to the Court and offered to pay Rs.50,000/- as penalty. Having asked my opinion on the subject, I must say that nothing could have been more painful, nay, heart breaking than the aforesaid order of the Aurangabad Bench of the Bombay High Court. In my opinion, Dr. Deshmukh did not commit any crime because there does not namely, recording of the proceedings of the Court on his mobile, an offence. Equally, there is also no law which provides for any punishment for such an act. He has been convicted and sentenced for something which constitutes no offence and punished for which there exists no law.

5. Fluvoxamine is a type of selective serotonin reuptake inhibitor currently approved by the US Food and Drug Administration as a treatment for



obsessive compulsive disorder, although it is also prescribed for depression. An off-patent drug, fluvoxamine is cheap and widely available, making it potentially attractive as a repurposed COVID-19 treatment—if it can be

shown to be effective.

The drug drew splashy headlines last October, when a study reported that it lowered hospitalization risk among COVID-19 outpatients. But debate on this and other fluvoxamine data has been swirling for some months now.

Currently, National Institutes of Health (NIH) guidelines state there is insufficient evidence "to recommend either for or against the use of fluvoxamine for the treatment of COVID-19." The Infectious Diseases Society of America (IDSA) recommends the drug only be considered for COVID-19 in the context of clinical trials.

Recently, the US Food and Drug Administration (FDA) turned down an emergency use authorization request, filed late last year by University of Minnesota infectious diseases researcher and physician David Boulware, that would have provided official backing for doctors to prescribe the drug

as an early treatment for people infected with SARS-CoV-2.

The agency "determined that the data are insufficient to conclude that fluvoxamine may be effective in the treatment of nonhospitalized patients with COVID-19 to prevent progression to severe disease and/or hospitalization," it announced in a document widely shared online this week.

In the wake of this latest decision, here's a look at the available evidence on the drug's efficacy against COVID-19, as well as perspectives of scientists and health experts about what that evidence means. What do the clinical data on fluvoxamine show?

Despite a recent uptick in media coverage of the drug, most discussions about fluvoxamine's efficacy in COVID-19 patients draw on data from two randomized controlled trials of unvaccinated adults that were published before this year.

The first, dubbed STOP COVID, was launched as a preliminary study in 2020 by Washington University in St. Louis psychiatrists Angela Reiersen and Eric Lenze. Reiersen has written about how she came up with the idea to test the drug while ill with COVID-19, having read that fluvoxamine could dampen inflammation and improve survival in mice models of sepsis.

Different people have come to very different conclusions about whether or not fluvoxamine should be considered a viable treatment for COVID-19. The STOP COVID results, published in JAMA in late 2020, hinted that 100 mg of fluvoxamine taken

three times a day for 15 days could reduce an infected person's risk of

clinical deterioration, as assessed through a combination of measures including reported shortness of breath and a need for supplemental oxygen or decrease in oxygen saturation.

Limitations including a small number of trial participants and a reliance on patient-completed surveys for data collection meant that "larger randomized trials with more definitive outcome measures" would be needed to determine clinical efficacy, the authors wrote in their paper.

The second published study, which Reiersen and Lenze also worked on, was part of the TO-GETHER trial, a multi-arm study designed to evaluate repurposed drug treatments in high-risk outpa-tients with COVID-19. The fluvoxamine arm included more than 1,400 participants in Brazil, about half of whom took a placebo and half took 100 mg of fluvoxamine two times a day for 10 days.

The results, which sparked the spate of media coverage in October when they were published in The Lancet Global Health, showed that treatment was linked to a statistically significant, moderate reduction in the risk of hospitalization due to COVID-19-provided that "hospitalization" included emergency room visits of at least six hours, a definition the study authors justified based on the way Brazil was operating field hospitals at the time. The drug didn't show an effect on mortality in the study's main analysis.

In addition to these studies, there are at least two unpublished datasets from trials that failed to find evidence of fluvoxamine's benefit as an early COVID-19 treatment.

STOP COVID 2, a follow-up to STOP COVID, tested 100 mg twice a day. This trial was stopped early for futility last year, according to an NIH summary, "after lower than expected case rates and treatment effect were observed." Reiersen tells The Scientist that the team had trouble recruiting patients and is planning to publish its data soon. A separate trial run by Boulware and colleagues at Minnesota, known as COVID-OUT, was also re-

cently terminated early for futility. That trial used doses of 50 mg, taken twice daily. Boulware tells The Scientist that the team plans to release the COVID-OUT data when possible.

LONDON: The State Funeral of Queen Elizabeth II will take place at Westminster Abbey in London on September 19 at 11 am local time, Buckingham Palace announced on Saturday.

Prior to the State Funeral, the late British monarch will lie-in-state at Westminster Hall nearby for four days to allow the public to pay their respects.

"During the Lying-in-State, members of the public will have the opportunity to visit Westminster Hall to pay their respects to the Queen," the palace statement said.

"On the morning of Monday 19th September, the Lying-in-State will end and the coffin will be taken in Procession from

the Palace of Westminster to Westminster Abbey, where the State Funeral Service will take place," it said.

Following the State Funeral, the coffin will travel in procession from Westminster Abbey to Wellington Arch in London for its onward journey to Windsor. In Windsor, the State Hearse will travel in procession to St.

AHMEDABAD: Prime Minister Narendra Modi on Saturday called for concerted efforts to make India a global centre of research and innovation, and urged state governments to frame modern policies in the fields of science and technology.

Modi lamented that unlike the western countries, India failed to adequately celebrate the works of its scientists, which turned a large section of the society indifferent towards science.

There is a need to celebrate the achievements of Indian scientists, he said.

Addressing via video link the inaugural session of the Centre-State Science Conclave organised here, Modi said that since 2014, there has been a significant rise in investment in the fields of science and technology.

India is going ahead with the mantra of 'Jai Jawan, Jai Kisan, Jai Vigyan and Jai Anusandhan' (Hail soldiers, farmers, science and research), he said. "We have to work together on various fronts to make India a global centre of research and innovation in this 'amrit kaal'. We have to take our research in the fields of science and technology to the local level. It is the need of the hour for all the states to lay emphasis on innovation to find local "In order to encourage innovation, the state governments should give emphasis on creation of more and ore scientific institutions and on simplification of processes. The number of innovation labs should also be increased in the institutions of higher education in states," he said.

Modi said India's Global Innovation Index ranking improved from 81 in 2015 to 46 due to the efforts of the central government.

There is a need to find localised solutions to issues like affordable housing, climate-resilient crops and

waste recycling, he said. "It is important that to deal with all these challenges, every state should frame modern policies related to science, innovation and technology and implement them. As governments, we should cooperate and collaborate

more and more with our scientists. This will help create an environment of scientific modernity in the country," he said. He also called for "optimum utilisation" of scientific institutions in the states. "There are many national-level scientific institutes and laboratories in states. So the states should take full advantage of their ability and expertise. We also have to take our science-related institutions out of

He pointed out how unlike the West, India failed to celebrate the works of our scientists in the early decades of the last century as much as was required, which led to an emergence of feeling of indifference towards science among a large section of our society.

"When we celebrate the achievements of our scientists, science becomes a natural part of our society, it becomes part of culture. Therefore, today my first request is that we celebrate the achieve-

ments of the scientists of our country with great enthusiasm," he said.

"Today in every area, Indian scientists are working wonders. The inclination towards science created by celebrating every small and big achievements of Indians scientists will help us in our 'amrit kaal'," he

added. Modi said his government is moving forward with changing in the country, he said.

"There is inclination for science, technology and innovation in the DNA of today's generation. They adopt technology very fast. We have to support this young generation with all our might. In India, new sectors are being created, opening up for the young generation today," he said.

"Whether it is a space mission, deep ocean mission, national supercomputing mission, semiconductor mission, hydrogen mission, drone technology...works are moving fast on many such missions," he said.

Modi said emphasis is placed on offering lessons in science and technology in a student's mother tongue.

He also talked about "hyper specialisation", and said that the Centre is ready to help states in the development of global-level specialised laboratories.

### 'Lakes remain thirsty even as Bengaluru drowned': Activists blame land mafias for floods

BENGALURU: The torrential rain in the city that flooded the houses and offices of tech honchos and turned roads into rivers of sorts could not fill most lakes, thanks to the land mafia who turned the feeder canals of these water bodies into a sewerage drain and diverted their flow, environmentalists said.

This mischief by the land sharks in connivance with some vested interests in various civic agencies and in the government led to the death of lakes in the city, Leo Saldanha, coordinator of Environment Support Group alleged.

Bengaluru, which the British rulers had called as a 'City of thousand lakes' for having over 1,600 lakes, has about 400 water bodies today in the Bengaluru metropolitan region.

"Those lakes which disappeared gave way for residential layouts, bus stands, bus terminals and tech parks. Sadly, those 400 lakes are also on the verge of destruction,".

Citing the example of Subrahmanyapura Lake in South Bengaluru, he said it has reduced to a cesspool and is choked with weeds.

One can hardly imagine that barely 15 years ago, people used its water from drinking and took bath in it, he pointed out.

"Ironically, not only the Bangalore Development Authority developed a layout on another lake 'Venkatarayana Kere' on upstream of Subrahmanyapura Lake, but a powerful builder also constructed two massive residential complexes exactly on the feeder canals of these two lakes --Subrahmanyapura and Venkatarayana Kere," Saldanha claimed.

ALSO READ | No Master Plan, no Master Plan Scheme...Reason why Bengaluru is flooding Further, the Bruhat Bengaluru Mahanagara Palike (BBMP) reduced the width of its feeder canal from 60 ft to a mere 10 feet wide drain in two years. The feeder canal of the lake carries the sewage of the nearby apartments and residential layouts, he claimed.

The drain does not empty a drop of rainwater into the lake.

Instead, it is diverted to straightaway flow into the subsidiary of the Vrushabhavathi river.

The Vrushabhavathi river is now reduced to a ma-

gally while the civic agency finds itself helpless to recover them.

"The civic agencies had removed encroachment of Chikkalasandra lake a few years ago but today once again the encroachers are back.

This time even the Bruhat Bengaluru Mahanagara Palike is parking its garbage vehicles inside the 'lake



jor sewage drain, Saldana said.

"It is a fact that the Subrahmanyapura lake got the attention of the court from 2009 and we are now in 2022. The attention of the court was focused on it. But even with judicial oversight, the Raja Kaluve (feeder canal of the lake) has been destroyed. Apartments have been constructed. This shows the weakness of the system," Saldanha said.

Ravi Kumar, a resident of Chikkalasandra in the region, charged within a radius of two km of the Subrahmanyapura lake, land sharks gobbled up Chikkasandra Lake, Ittamadu Lake and Narayana Kere and turned them into a residential layout illebed', allowing others to encroach on it," Kumar alleged.

Noted activist S R Hiremath who led a campaign against the encroachment of government land in Karnataka, especially in Bengaluru said Bellandur Lake, which is the largest water body of the city, had been the victim of rampant encroachment as residential developments happened on its wetland region and its feeder canals.

"I had fought a legal battle against the encroachment with the help of eminent lawyer Prashant Bhushan in the Supreme Court and also fought cases in the High Court. The problem is those who grabbed the government lands are very powerful and are holding important posts in government institutions as well as all the political parties," Hiremath said.

As water recedes, Mahadevapura residents now fear infections

Due to the heavy downpour in the past one week, the lake swelled to monstrous proportions submerging all those areas, which were encroached upon. "I live in Bellandur. I am unable to move out due to flooding for the past one week. It's been more than 15 years, since I moved to this place but never ever, I experienced such a flood," an executive of a corporate company told PTI requesting anonymity.

A former IAS officer requesting anonymity said the government is least bothered about the problems of Bengaluru.

"The AT Ramaswamy committee report and V Balasubramanian's report 'Greed and Connivance' are gathering dust in the dingy corners of the government offices.

For the politicians and government officers, these reports are like a can of worms, which they don't want to open," he claimed.

According to noted architect Naresh Narasimhan, the planning of the city is based on land use and real estate and not on climate change and resilience. "You have to think little ecologically. The root of the word economy is same as the word ecology. Both words have derived from a Greek word 'Ecos', which means home. Until we give importance to ecology, the economy cannot improve," Narasimhan said. The architect opined that the flooding in Bengaluru was an extreme climate change event, which was never seen before.

"If this has happened now, then it can happen again and we should plan accordingly," Narasimhan said. He insisted that the government should demonstrate a strong political will to take harsh decisions.

Noted economist and former Planning Commission member Abhijit Sen dead In a career spanning more than four decades, Prof Abhijit Sen taught economics at Oxford, Cambridge and New Delhi's Jawaharlal Nehru University, and held several important government positions, including the chair of the Commission of Agricultural Cost and Prices. He was a member of the Planning Commission from 2004 to

2014, Manmohan Singh was the prime minister. In 2010, he was awarded the Padma Bhusan for public service.

When the NDA came to power in 2014, it appointed Sen to head a high level task force to frame a long term grain policy. Sen was a vocal advocate of a universal public distribution system for rice and wheat.



#### Revenue Rises by 15.55%



The State Government has collected Rs 17,722.22 crore from its own tax sources while the collection from non-tax stood at Rs 18732.67 crore till August.

The own tax revenue collection has witnessed a growth of 20.30 per cent.

Out of the total own tax collection, the State has collected Rs 11799 crore commercial tax, Rs 2454.57 crore from excise, Rs 1476.06 crore electricity duty, Rs 790.22 crore MV tax, Rs 244.23 crore from land revenue, Rs 834.78 crore of stamps and registration fee, and Rs 123.34 crore professional taxes.

Similarly, the non-tax revenue collection till August of the current financial year registered a growth of 11.39 per cent.

Under the non-tax revenue, mining royalty has contributed the lion share. The collection from non-ferrous mining & metallurgical industries was Rs 16,761.14 crore till August 2022, against the collection of Rs 15,878.64 crore during the same period of last year.

The mining revenue has witnessed a marginal growth of 5.56 per cent till last month of this year. The mining royalty collection during the month of August was Rs 2780.55 crore.

Till August, Odisha has been able to collect 38.58 per cent of the total mining revenue of Rs 43,444 crore estimated for the entire financial year 2022-23.

However, the Grants from Centre has been falling down as the Government of India squeezed its fund flow under various schemes and heads, officials said.

The Grants from Centre fell down by 50 per cent till August of the current financial year as only Rs 401.24 crore released by the Centre during the last month. The State Government has got only Rs 3499.38 crore Grants from the Centre till August 2022 against the receipt of Rs 7004.62 crore during the same of 2021-22 and Rs 11732.58 during April to August of 2020-21.

#### Power discoms' outstanding dues towards gencos to be eliminated by 2026: R K Singh

New Delhi: Outstanding dues of electricity distribution companies (discoms) towards gecos, which remains over Rs 1 lakh crore at any point of time, will be eliminated in the next four years, Union power minister R K Singh said.

The government has converted the total outstanding dues of discoms toward gencos (power generator companies) into Equated Monthly Installments (EMIs).

These EMIs have maximum tenure of four years and thus the total outstanding dues of discoms would be nil by 2026.

"The total outstanding dues of the discoms towards gencos is around Rs 1,13,000 crore. These dues would be totally cleared by 2026," Singh told PTI.

Singh explained that the government has put a very robust payment security mechanism for the power sector knowing about the perennial issue of bulging dues of discoms toward gencos. He informed that the power ministry

has put in place late payment fee Electricity, (Late Payment Surcharge and Related Matters) Rules, 2022 (LPS Rules 2022) which would trigger snapping of discoms' access to power exchanges for procuring supplies in case of non-payment of late payment surcharge.

Earlier in August this year, state-run Power System Operation Corporation Ltd (POSOCO) had asked three power exchanges -- IEX, PXIL and HPX -- to restrict electricity trading by 27 discoms in 13 states for nonpayment of late payment surcharge. The directive from POSOCO to Indian Energy Exchange (IEX), Power Exchange of India (PXIL) and Hindustan Power Exchange (HPX) was given to restrict trade of electricity by utilities of 13 states, including those in Maharashtra, Madhya Pradesh, Rasjasthan, Karnataka, Andhra Pradesh, Telangana, Tamil


