Between Hirakud dam and climate change, spillway plan stutters

BHUBANESWAR(KCN): Depleted water holding capacity of Hirakud Dam reservoir and extreme rainfall events induced by climate change can present an unprecedented challenge of flood management in Mahanadi river, if the medium level flood of August was any indication. Dam safety is a whole dif-

ferent issue in such a scenario.
That was the reason Central Water Commission (CWC) had recommended construction of additional spillways to protect world's longest earthen dam. Yet, the first of the two proposed spillways is yet to get off ground; or rather far from it.

Construction work of the left spillway under the World Bank (WB)-funded Dam Rehabilitation and Improvement Project (DRIP) was left mid-way due a joint venture of Tata Projects Limited and Turkeybased AGE Group.

Sources said, after the Tata-AGE JV backed out of the `369 crore WB-funded project in 2020, the State government cancelled the work contract and decided to construct the additional spillway with its own funding through Odisha Construction Corporation (OCC). Subsequently, the project was also dropped from

The estimated cost of the single spillway has now been revised to `786 crore. The project involves rehabilitation of 716 households and 1429 families which was the bone of contention behind the delay

in carrying out the work. While the JV has moved the tribunal against cancel-

lation of work contract alleging delay in handing over of land for the project by the government, officials in Water Resources department said the firms withdrew after realising the bid amount was too less. The spillway is critical to Hirakud's health because it can decrease load of water on the dam in case the reservoir reaches a peak maximum flood (PMF) level caused by extreme precipitation events. As per available data, the CWC had reviewed the inflow design flood and pegged PMF at 69,632 cubic metre/sec (24.5 lakh cusec) in 1997. Against it, the existing total discharge capacity stands at 42,450 cubic metre/ sec (15 lakh cusec) but effective discharge is about 36,806 cubic metre/sec (13 lakh cusec) due to operational constraint of few gates. This effectively means, in case of extreme rainfall events, the dam will have to grapple with management of about 12 lakh cusec flood water per second.


partment Anu Garg said construction of additional spillways is priority of the government. "The work will start soon once the revised estimate gets Finance department's nod," she told The New Indian Express. Recently, the dam safety division had alerted Hirakud dam authorities about cracks in gate operation gallery and suggested drone based inspection for frequent monitoring of seepage quantity and further study of foundation gallery, gate shaft and sluice barrels. Though survey was to be taken up at least once in every five years, it pointed out, no fresh survey for mapping of new cracks and checking status of old cracks has been undertaken since 1999. Chief Engineer of Mahanadi basin Anand Chandra Sahu said, revised estimate for the first additional spillway is in the final stage of approval. "Since the revised estimate is more than 15 per cent of the primary estimate, the Finance department sought some clarifications, which we submitted recently. Hopefully, the OCC will soon get the administrative and financial approvals soon," he said.

Cuttack(KCN): As part of the celebration of 75th year of the High Court of Orissa, the Chief Justice of India Uday Umesh Lalit inaugurated 34 paperless courts in all the 30 districts here at Odisha Judicial Academy on

The concept of paperless court has been successfully implemented in the Supreme Court and different High Courts including the High Court of Orissa. However, launching of paperless courts in all the districts in Odisha is a first in the country.

The Chief Justice of India (CJI) has inaugurated the courts in the presence of Dr Justice D.Y. Chandrachud, Judge, Supreme Court Justice MR Shah hailed the e-initiatives of the High Court of Orissa and expressed hope that those would be replicated in other states. Sharing his experience Justice Shah said age is never a barrier in learning the use of IT which has become essential for making the justice administration friendly for all the stakeholders.

He also highlighted the positive impacts of paperless courts on the environment.

The CJI said he was happy to know that the judicial officers in Odisha voluntarily came forward for the paperless courts.

Lauding the e-initiatives of the High Court of Orissa, he said the High Court has shown the Indian Judiciary new direction, new light. In his welcome address Dr. S. Muralidhar thanked the e-Committee, Supreme Court of India for the guidance and encouragement to the High Court of Orissa in expanding the horizon of digitization and using information technology for other initiatives like paperless courts, e-payment of court fee, virtual hearing, vulnerable witness deposition centres, e-custody certificates, e-traffic challans and voluntary witness deposition centres in all the districts of Odisha.

Chief Justice Dr .Muralidhar announced that shortly all the judicial officers in Odisha would be provided with screen-touch laptops to facilitate them to function paperless. Stressing upon the need of paperless court for balancing the ecosystem and its other advantages Dr Muralidhar said paperless courts in the district judiciary of Odisha is a significant milestone for the Indian judiciary and thanked the state government and OCAC for the cause.

He thanked the Department of Posts for releasing the Special Cover and Picture Postcards featuring the High Court of Orissa.

Enumerating the advantages of paperless court he said, it is cost effective for litigants, time saving for lawyers, effective in space management, makes case information easily accessible at fingertips and most importantly, it is environment friendly, and said paperless court in district level is doubly beneficial, given the volume of cases.

Justice Chandrachud informed that about 75 lakhs judgments of various High Courts have been made available in National Judicial Data Grid (NJDG) for easy access of lawyers and judges and Real Time Virtual Justice Digital Clocks have been devised for updated information about functioning of every leg of Indian judiciary.

Citing examples of the training of lawyers being held in the Supreme Court on the functioning of green benches (paperless) he stressed upon the need of bridging the digital divide in India.

Orissa High Court directs AIIMS to treat 15 kids suffering from DMD



BHUBANESWAR: The Orissa High Court on Friday directed Bhubaneswar to treat 15 children suffering from Duchenne Muscular Dystrophy (DMD). Acting on a PIL filed by lawyer Anshuman Ray, the division bench of Chief Justice S Muralidhar and Justice Chittaranjan Dash also ordered that the cost of treatment be reimbursed by the Ministry of Health and Family Welfare. The HC asked the

Bhubaneswar to draw up a schedule for AIIMS, consultation of the 15 children suffering from DMD with specialists for receiving the antisense oligonucleotide (AON) therapy in a timebound manner. "This is to be done in

consultation with Assistant Solicitor General of India (ASGI) PK Parhi as well as the petitioner's counsel DP Dhal," the order stated. The High Court also sought an affidavit of compliance to be placed on

the next date of hearing, which is listed for October 11. Ray had filed the petition on behalf of the parents of the 15 children suffering from DMD expecting the State government would procure and provide AON treatment, which costs `40 lakh to `50 lakh annually.

DMD is a genetic disorder with progressive muscle degeneration and weakness. The disease always affects boys, and symptoms usually begin early in

childhood. Children with DMD typically lose the ability to walk when they reach 8 to 12 years of age and need wheelchair for mobility. The petitioner pointed out that there were no facilities for treatment of children suffering from DMD in Odisha. Since there are also no diagnostic laboratory facilities of DMD, he had sought direction to the State government to set up proper diagnostic facilities and hospitals for early detection of DMD.



Scope for Improvement Based on the composite Health Index scores range for the reference year (2017-18), the States are grouped into three categories: Aspirants, Achievers, and Front-runners. Aspirants are the bottom one-third States and six of the eight Empowered Action Group States1 fall in this category. Given the substantial scope for improvement, these States require concerted efforts. Achievers representthe middle one-third States. The need of the hour is to make outcome data available for smaller states and union territories more frequent and updated outcomes for non-communicable diseases, financial protection, and other priority areas, and the robust programmatic data that

The Health Index is a useful tool to measure and compare the overall performance and incremental performance across States and UTs over time. It is an important instrument \in understanding the variations and complexity of the nation's performance in health. The critical factors that contributed to the success of the Health Index include: a) Timelines of the report so that it stimulates action and not merely academic discussions; b) Provision of financial incentives based on the annual incremental performance of states under the National Health Mission; and; c) Verification of selfreported data by states by a thirdparty, independent verification agency to enhance credibility. However, there are limitations to the Index as no single index can purport to comprehensively capture the complex story of evolution of health system.

Also, due to constraints of availability of quality data critical areas such as non-communicable diseases, mental health, and private sector service utilisation could not be captured. Thus, the Health Index is a work in progress and continuous refinements will be made as additional quality data becomes available and data systems improve. ?

With the federal compact among the Central and the State Governments having been clearly defined in the Constitution, the key questions that motivated the team involved in the design of Health Index were as fol-

a. Can we develop a tool to bring health into greater political focus to ensure that what gets measured gets done?

b. Can we benchmark the performance of the health system of various States which can be put forth in the public domain in a timely manner? Is it possible to capture the diversity and yet ensure that high performing states do not get complacent and the low performing States are not discouraged?

c. Can appropriate instrument or incentives be put in place that can nudge the States to try and radically improve their health system performance? Can this be done in a manner that respects the federal compact and allows autonomy to individual State Governments to make policy choices to achieve the specified benchmarks?

d. What are the parameters that could credibly capture the complex story of health system performance? The answer to these questions - admittedly imperfect-was to craft a Health Index – a journey which NITI Aayog embarked upon in 2017 in collaboration with the Ministry of Health and Family Welfare (MoHFW) and the World Bank. It is the firstever systematic exercise for tracking the progress on health outcomes and health systems' performance across all the States and Union Territories (UTs) in India on an annual basis. The Health Index is a weighted-composite Index based on select indicators in three domains: a) Health Outcomes; (b) Governance and Information; and (c) Key Inputs and Processes, with the health outcomes carrying the most weight across the different category of States/UTs. For generation of ranks, the States are classified into three categories (Larger States, Smaller States and UTs) to ensure compadiac care units, are included in the Index. In February 2018, the first round of the Health Index report on ranks and scores was released which measured the annual and incremental performance of the States and UTs over the period of 2014-15 (base year) to 2015-16 (reference year).

This was followed by the second round of Health Index that tracked performance for the period 2015-16 (base year) and 2017-18 (reference year). The same set of indicators and weights were used for the first two rounds. However, as the index is work in progress, some refinements for subsequent rounds are likely. The NITI Aayog has established the Health Index as an annual systematic tool to leverage cooperative and competitive federalism to accelerate the pace of achieving health outcomes and encourage cross-learning among states. The Health Index can be a gamechanger as it can shift the focus from budget spends, inputs and outputs to outcomes. Tracking incremental performance ensures that there is no room for complacency among historically better performing states, while at the same time providing opportunity to states that have lagged in performance to demonstrate perceptible improvement.

tematic tool is to propel States towards undertaking multi-pronged interventions and drive efforts towards achievement of SDG Goal 3. It can be viewed as being akin to an annual health checkup diagnostic report; providing the State Governments to identify parameters in which States have improved, stagnated, or declined. The Health Index report provides the direction and magnitude of change at a composite level as well as for each of the indicators of the Health Index. An analysis of this can help States in focusing attention on better targeting of interventions and improving the delivery of health services and also an opportunity of sharing best practices.

Room for Improvement

The introspection is useful for all States and UTs, as both the first and second annual Health Index report indicates that even the States and UTs that are doing comparatively well have substantial scope for improvement. For example Health Index (June 2019) report on ranks of States and UTs indicates, even Kerala, Mizoram, and Chandigarh, the "healthiest" among large states, small states and UTs respectively, all have quite a distance from the frontier and have room for improving their performance. categories of States. The magnitude of changes was bigger in UTs compared to Larger and Smaller States. Andhra Pradesh and Maharashtra were the only two states that were among the top one-third States on both overall performance and incremental performance. Andhra Pradesh had the highest proportion of indicators (63 percent) among the Larger States which fell in the category of most improved or improved.

Among the UTs and Smaller States, there was a divergence in Health Index Scores from base year to reference year across States (UTs), that is, better performing States (UTs) tended to get better whereas leastperforming States (UTs) tended to get worse. Among the Larger States, there was neither divergence nor convergence in Health Index Scores

over time.

"The biodiversity that had become extinct and the link that got disconnected for decades, today we have a chance to reconnect it. Today the cheetah has returned to the soil of India. And I would also say that along

with these cheetahs, the nature-loving consciousness of India has also been awakened with full force," said PM Modi.

He further said that the Kuno National Park was chosen for the release of cheetahs after a detailed study by experts.

"It is unfortunate that we declared Cheetahs extinct from the country in 1952, but for decades no meaningful effort was made to rehabilitate them. Today, as we celebrate Azadi ka Amrit Mahotsav, the country has started rehabilitating Cheetahs with new energy," said the PM.



Global leaders head to UK for queen's funeral as public pays tribute

LONDON: World leaders begin gathering in London from Saturday for the funeral of Queen Elizabeth II, as princes William and Harry are set to lead a vigil of her grandchildren at her coffin.

The queen's death on September 8 aged 96, after a record-breaking 70 years on the throne, has sparked an outpouring of emotion.

Members of the public braved waits that at one point were estimated to be up to 24 hours and chilly night-time temperatures to view her coffin.

Lines have snaked for miles along the River Thames since Wednesday when her coffin was brought to the UK parliament complex to lie in state.

Police are mounting Britain's biggest-

The vigil will be repeated on Saturday evening by eight of the queen's grandchildren, including the new heir to the throne Prince William and his estranged brother Harry.

Harry -- who served two tours with the British army in Afghanistan -- has reportedly also been given special permission to wear his military uniform despite no longer being a working royal.

The move appeared to be the latest olive branch offered to Harry by the royals after he and his wife Meghan launched accusations of racism in interviews from their new home in the US.

The personal sorrow of the queen's family has been playing out in the glare of intense international attention.



ever security operation for Monday's funeral, as hundreds of dignitaries including US President Joe Biden are set to jet in.

The queen's successor, King Charles III, will meet on Saturday with the prime ministers of the Commonwealth realms -- the 14 former colonies over which he now reigns in addition to Britain.

From Australia and New Zealand to Canada, they have formally proclaimed him their new sovereign.

But republican movements are gaining ground, and efforts to keep them all in the royal fold will likely be a feature of his reign.

Charles on Friday wrapped up his maiden tour as monarch to the four nations of the United Kingdom with a visit to Wales, part of an operation dubbed "Spring Tide" to launch him in his new role.

Large crowds in Cardiff chanted "God save the king" as he shook hands with well-wishers following a multi-faith service in Llandaff Cathedral, and at Cardiff Castle.

Charles met Welsh First Minister Mark Drakeford, an avowed republican, and there was isolated booing on the streets after the new monarch was quick to declare his son William the new Prince of Wales.

But Drakeford said questions over the future of the monarchy were "a footnote to the dominant feelings of the day".

'Tide of emotion'

Back in London, Charles held a 15-minute vigil with his siblings -- Princess Anne, Prince Andrew and Prince Edward -- around their mother's casket on Friday

night.
They stood, eyes lowered and silent, while members of the public filed past.
Andrew -- stripped this year of his royal titles over a sex assault scandal -- was allowed to wear military uniform for the only time during the 11-day mourning period.

The Duke of York, as he is also known, flew Royal Navy helicopters during the 1982 Falklands War with Argentina.

But the queen's youngest son Edward said: "We have been overwhelmed by the tide of emotion that has engulfed us and the sheer number of people who have gone out of their way to express their own love, admiration and respect."

Beckham joins queues

The most striking manifestation of public reverence for the queen has been the vast queues of the hundreds of thousands of people wanting to bid her farewell.

Officials warned on Friday that expected queuing time had reached over 24 hours and briefly paused admission when the lines reached capacity.

Those paying their respects included former England football captain turned fashion icon David Beckham, who spent 12 hours to reach Westminster Hall.

"It's very emotional, and the silence and the feeling in the room is very hard to explain," he told reporters after filing past the coffin.

"We're all there to say thanks to Her Majesty for being kind, for being caring, for being reassuring throughout the years." June Nayler, 76, a retired former local authority worker from Milton Keynes in central England was undaunted by the long wait she faced as she joined the back of the line in Southwark Park.

"I'm here now and going to make it all the way -- it's my duty to do it," she told AFP.
"I'm just overcome by the crowds and number of people turning out."

The public have until Monday morning to view the coffin before the queen is honoured with Britain's first state funeral in nearly six decades.

The spectacular ceremony at Westminster Abbey -- expected to be watched by millions around the globe -- will see 142 sailors pulling the gun-carriage bearing her lead-lined coffin.

It will be attended by more than 2,000 guests, but leaders from countries at log-gerheads with the UK such as Russia, Belarus and Afghanistan have not been invited.

A private burial will follow at Windsor Castle after a committal service.

6 lakh hectare of deemed forest to be granted to farmers

BENGALURU: Revenue Minister R Ashoka informed the assembly on Friday that the government would denotify 6 lakh hectares deemed forest -- around 15 lakh acres -- of 9 lakh hectares deemed forest in Karnataka, and grant it to farmers who have been cultivating the land for decades.



"In 15 days, a meeting will be held to take a decision on demarcation, and about 3,000 surveyors will be absorbed on contract basis to conduct the survey on a war footing. The land which coffee planters and pepper growers in Kodagu and Chikkamagaluru have been cultivating for over 70 years, will be leased to them," he told the House. Leader of the opposition Siddaramaiah, who welcomed the move, claimed that his government had made a move to lease out up to 10 acres in the region."If we continue to lose forest cover for development and illegal encroachments, it will have an impact on the state. The 15th Finance Commission has indicated in one of the guidelines that loss of green cover will eventually reflect in a cut in grants to the state," a top official told TNIE.

Bill to regularise unauthorised lands passed The Karnataka Land Revenue (Amendment) Bill was passed in the assembly to extend by a year, time to apply for regularisation of unauthorised cultivation of government lands. MLAs cutting across party lines welcomed the move as there is a huge number of applicants waiting in their constituencies. Ashoka informed that there are 7,15,705 applications for grants of government lands under Form-57, 1,12,545 under Form-53 and 6,302 under Form-50.JDS leader G T Devegowda asked the government to relax norms on gomala lands. "When mutts are granted gomala lands easily, why cannot farmers who have been cultivating them for decades?" he questioned.

Deputy leader of the opposition UT Khader was the lone MLA to raise an objection. "Affluent people are more likely to misuse the law to get government lands granted. There needs to be strict scrutiny in this regard," he insisted.

He also expressed concern over government lands getting exhausted across the state. If there is rampant grant of land to private parties, there will be nothing left for public utilities, including hospitals and schools, he said.

New Act makes financial fraud non-bailable offence With the Karnataka Protection of Interest of Depositors in Financial Establishments (amendment) Bill, 2022, passed in the ongoing Assembly session, any offence under the new law will be cognisable and non-bailable. The Act provides for setting up of a special court in each district with the consent of the Karnataka High Court. It also aims to protect the interest of depositors and prevent them from being defrauded by unscrupulous bankers and financial establishments. "It will not be a retrospective, but prospective, Act as the law was brought through an ordinance in May 2022. Now, FIRs filed against individuals and institutions at different places will be clubbed together to be tried before special courts," said Law Minister JC Madhu Swamy, who presented the Bill for discussion.

'Tide of emotion'

Back in London, Charles joined the 15minute vigil with his siblings -- Princess Anne, Prince Andrew and Prince Edward -- around their mother's casket on Friday night.

They stood, silent and eyes lowered, while members of the public filed past.

The vigil will be repeated on Saturday evening by the eight grandchildren, including the new heir to the throne Prince William and his estranged brother Harry.

Harry -- who served two tours with the British army in Afghanistan -- has been given special permission by his father to wear military uniform despite no longer being a working royal.

The move appeared to be the latest olive branch offered to Harry by Charles after the prince and his wife Meghan, now living in California, accused the royal family of rac-

The personal sorrow of the queen's family has been playing out in the glare of intense international attention.

But the queen's youngest son Edward said: "We have been overwhelmed by the tide of emotion that has engulfed us and the sheer number of people who have gone out of their way to express their own love, admiration and respect."

The public have until early Monday to view the coffin before the queen is honoured with Britain's first state funeral in nearly six de-

The spectacular ceremony at Westminster Abbey -- expected to be watched by billions around the globe -- will see 142 sailors pulling the gun-carriage bearing her lead-lined coffin.

It will be attended by more than 2,000 guests, but leaders from countries at loggerheads with the UK such as Russia, Belarus and Afghanistan have not been invited. China's vice president Wang Qishan will attend, Beijing's foreign ministry confirmed, after a diplomatic spat saw Chinese officials barred from visiting the coffin inside parliament.



Police are mounting Britain's biggest-ever security operation for Monday's funeral, as hundreds of dignitaries including US President Joe Biden are set to jet in.

Less than two weeks into her premiership, British Prime Minister Liz Truss was on Saturday beginning a packed weekend of meetings with world leaders including her counterparts from New Zealand, Jacinda Ardern, and Australia, Anthony Albanese, at the government's Chevening country residence. On Sunday she was due to meet Biden, Irish Taoiseach Micheal Martin, Canadian premier Justin Trudeau and Polish leader Andrzej Duda in Downing Street.

Charles, meanwhile, was on Saturday scheduled to meet the prime ministers of the Commonwealth realms -- the 14 former colonies over which he now reigns in addition to the United Kingdom -- including those of Australia, The Bahamas, Canada, Jamaica and New Zealand.

From Australia and Canada to Jamaica and Papua New Guinea, they have formally proclaimed him their new sovereign.

MADRID: Real Madrid have condemned racist and xenophobic language and behaviour in football and expressed disappointment at a racist comment on their star forward Vinicius Junior during a TV programme.

Real Madrid were responding after a Spanish agent used a reaction in Brazil, Vinicius' native country, with big names like Pele and Neymar commenting on the issue.

"Real Madrid C. F. condemns all types of racist and xenophobic language and behaviour in football, sport and life in general, such as the regrettable and unfortunate comments said he "won't stop dancing".

In an emotional statement in response to the racist abuse, the Real Madrid ace released a powerful statement via video that reads: "As long as the colour of the skin is more important than the brightness of the eves, there will be war.
