Bishnu Sethi no more

Bhubaneswar(KCN): Deputy Leader of Opposition in Odisha Legislative Assemfection in the lungs. The BJP MLA had also kidney ailment and was undergoing



bly, Bishnu Charan Sethi passed away this morning at the AIIMS, Bhubaneswar following a massive cardiac arrest. He was 61.

AIIMS Bhubaneswar Medical Superintendent Sachidananda Mohanty said Shri Sethi was admitted in the ICU of the hospital a month back as he was suffering from multiple disdialysis thrice a week in the hospital but he died of acute cardiac failure at 7:45 am on Monday, he informed.

Shri Sethi was elected to the State Legislative Assembly twice from two different constituencies of his native Bhadrak district.

He was first elected to the House once from Chandbali Aseases including in- sembly seat in 2000 and again from Dhamnagar Assembly seat in 2019.

He was serving as the Deputy Leader of Opposition in the Odisha Legislative Assembly. He has left behind a wife, son and daughter.

Odisha Governor Prof Ganeshi Lal, Andhra Pradesh Governor Biswa Bhushan Harichandan, Chief Minister Naveen Patnaik, Odisha As-Speaker sembly Keshari Bikram Aarukh, Odisha Pradesh Congress President Sharat Pattanayak and leaders from all political parties have condoled the demise of shri Sethi.

Taking to his official Twitter handle Naveen Patnaik said, "Saddened to know about the demise of Dhamnagar MLA Bishnu Charan Sethi. His welfare work for the people as a public representative will always be remembered. My condolences to the bereaved family members and may his soul rest in peace."

Leader of Opposition, Jaynarayan Mishra said shri Sethi's death was a huge loss to the party. "There are very few leaders who could speak with a lot of conviction about issues and Shri Sethi was one of them," said Shri Mishra.

Senior Congress leader Narasingha Mishra said Shri Sethi was a senior legislator who will be known for his remarkable discussion in the House. "Though we were opposing each other in the political sphere, we used to share a bonding. The state has lost a senior leader, social worker, journalist and speaker and the House, a top-class legislator," said the Congress Lawmaker. Congress Veteran and Senior Lawmaker Suresh Kumar Routray lauded Shri Sethi as a noble soul and one of the finest

Hydrocarbon Exploration Projects in Delta Districts of Odisha is continuing, while Hydrocarbon Production activities are yet to be carried out in the State, officials say.

Hydrocarbon Exploration activities are being carried out in the districts of River Deltas in Odisha, Andhra Pradesh and West Bengal, admit officials. OIL India is the major player in such exploration activities in Odisha, which is covering five blocks awarded under different regimes in the districts of River Deltas.

While Vedanta is engaged in Hydrocarbon Exploration activities in five blocks in Andhra Pradesh, it has one block in Odisha in River Mahanadi Basin. Vedanta is also taking up exploration job in Tamilandu and Puducherry, officials sources say. In fact Mahanadi Basin in Odisha has the potential to emerge as a Hub for Hydrocarbon exploration and production activities in entire East Coast, officials say. Union Government is also implementing several programs and initiatives, which will lead to exploration and production of Hydrocarbon and once potential of Odisha is established through these initiatives, it would attract significant investment to the sector, officials say.

One of such program is National Seismic Program

(NSP), which was implemented with an aim to undertake fresh appraisal in all sedimentary basins across the country including in Mahanadi Basin.

NSP was carried out as scanty data was available and to have better understanding of the Hydrocarbon potential of the country such program is being implemented.

Outcome from the NSP contributed to better understanding of the Sub Surface with the petroleum systems across wider geological ages to explore the Hydrocarbon Reserves in Odisha.

Total investment for seismic acquisition in Onland Mahanadi Basin was around Rs.80 Crore, officials

Seismic data acquired under NSP in the state of Odisha led to offer of five blocks by Director General Hydrocarbon (DGH) and OIL India won all the five blocks for hydrocarbon exploration under OALP-II and III rounds.

OIL India plans to acquire, process and interpret 1502 LKM of 2D seismic data and 1670 Sq Km of 3D seismic data in the five blocks, officials say. The total envisaged expenditure on the entire exploration campaign in the five blocks in Mahanadi Basin (Onshore) is Rs. 1250 Crores of which Rs. 220 Crores is for Seismic survey.

The blocks are spread in eleven districts of Odisha namely Puri, Khurda, Cuttack, Jagatsingpur, Kendrapara, Dhenkanal, Jajpur, Bhadrak, Baleshore, Maurbhanj and Keonjhar.

Referring Questions of Law to Larger Benches is in Ignorance of the Doctrine of Stare Decisis

It is said that even Homer nods at times, meaning that sometimes even very eminent and schol-



arly men err, for, to err is human. Lord Halsbury, known for his monumental work titled "Halsbury's Laws of England", in London Street Tramways Co.

v. London County Council [1898] AC 375 (HL), had held that House of Lords is bound by its own decisions. That was a great deviation from the view hitherto then in force that no precedent is absolutely binding, but is only a guidance. Justinian, known for his great work called "Corpus Juris Civilis", so too Chief Justice Edward Coke and Blackstone known for their works "Institutes of the Laws of England" and "Commentaries on the Laws of England", respectively, only contemplated that not the judgment, but the principle evolved in a judgment, the ratio decidendi, will be applicable to future cases as a precedent, the principle being stare decisis et non quieta movere: "to stand by decisions and not disturb the undisturbed." In a legal context, this is understood to mean that courts should generally abide by precedents and not disturb settled matters.

- When Halsbury delivered the judgment in the case of London Street Tramways Co., no judgment was treated as a legislation or in substitution of a legislation. What was the precedent is the principle, if any, which a Court has evolved for the first time for resolution of the controversy before it for which no principle was available. Halsbury was such a tall figure that his decision that the House of Lords shall be bound by its own decisions was not questioned by anyone; there was no occasion for it as his view did not create any difficulty because what was a precedent was the reason for the decision and nothing else.
- In the Government of India Act of 1935, it was expressly provided that the ratio decidendi of the judgment of the Federal Court and Privy Council shall be binding on all Courts and Tribunals within the territory of British India. The Constituent Assembly incorporated Section 212 of the Government of India Act in the Constitution of India, though it was worded differently. Article 141 of the Constitution reads
- "141.Law declared by Supreme Court to be binding on all courts- The law declared by the Supreme Court shall be binding on all courts within the territory of India.'

But for Article 141, the law would have been simple, offering no difficulty even for a common man to comprehend. Chief Justice Edward Coke said that law is reason. The concept of precedent also is nothing but reason, namely, the 'reason' for a decision which a superior Court has adopted to be binding on coordinate Courts and subordinate Courts. However, we understood and interpreted Article 141 dif-

ferently from what it ought to be in jurisprudence. In actual practice, we forgot the concept that what is a precedent is the 'reason' for the decision, namely, the principle, if any, which the superior Court has evolved for resolution of a dispute before it, and the 'reason' for the decision when repeatedly applied by superior Courts become settled principles. Our Judges misunderstood Article 141 as the power to legislate, and each sentence and word of a judgment became the law of the land. The concept of the 'reason' for the decision being repeatedly applied and thus assuming great authenticity was forgotten and our lawyers and Judges treated the latest decision on a subject as the binding one.

- When Judges started legislating, completely misunderstanding the scope of Articles 141 and 142, a new era of large number of judgments, which cannot stand together, conflicting with each other, became the order of the day. The new practice of referring cases to larger Benches, because two judgments are in conflict, both involving no particular legal principle, became very common.
- What is stated above could be said as the preface to the scenario leading to the constitution of a Five-Judge Bench to authoritatively decide which of the interpretation given by two different Three-Judge Benches of the Supreme Court about Section 24(2) of the Land Acquisition Act is the correct one. In Pune Municipal Corporation case, 2014, a Three-Judge Bench headed by Justice R M Lodha took the view that merely because the Government has deposited with the court the compensation amount to be paid to the land holders whose property was acquired, their right is not lost if the property is not utilized for the purpose for which it is acquired, but only if they have accepted the compensation. In 2018, another Three-Judge Bench headed by Shri Justice Arun Mishra in Indore Development Authority took a contrary view holding that the judgment rendered by the earlier Three-Judge Bench is per incuriam. A Bench headed by Justice Lokur wrongly faulted Shri Justice Arun Mishra for taking the said view observing that he was bound by the earlier decision in the Pune case. Justice Arun Mishra was unfairly accused of judicial impropriety. On the very next day, Justice Mishra, taking note of the observation of Justice Lokur, requested the Chief Justice of India to refer the issue for consideration of a larger Bench. The Hon'ble CJI accordingly constituted a Five-Judge Bench headed by Justice Arun Mishra. When the said Bench assembled to hear the question, which was referred to it, some associations of farmers sought recusal by Shri Justice Mishra

Lordship has already taken a view on the subject and, therefore, it is inappropriate for him to head the Bench, a proposition which has no foundation in jurisprudence.

I am afraid to say that the entire controversy has its root in the failure to be kept abreast of the first principles of jurisprudence. We forget very simple things; we are not often thorough enough about the concepts like res judicata, stare decisis, res inter alios, nullity, etc. The practice of referring a case to a larger Bench for decision on important questions of law is in ignorance of the first principles. As I said at the outset, law is reason, not numbers, at least when it comes to stare decisis. The number has relevance only when a Bench of three or more Judges decides a case and the judgment constitutes to be res judicata. If a Bench of three Judges is to decide a case between A and B, what matters is not the validity of the reason offered by the Judges, but who are in majority. The majority decision as res judicata will prevail, no matter right or wrong. This principle which is only applicable to res judicata, we have been applying erroneously to the doctrine of stare decisis. We did not accept the minority view in A K Gopalan's case as stare decisis because we got confused with the distinct concepts of res judicata and stare decisis. To repeat, so far as res judicata is concerned, all that matters is the majority view. On the contrary, so far as the doctrine of stare decisis is concerned, it is not the majority view which ought to matter, but the 'reason' for the decision. If reason for the decision is understood as the meaning of Article 141 and is followed in actual practice, we will be freed from the slavery and absurdity of needing to search for the law applicable from the thousands and thousands of judgments, reported and unreported and groping in darkness, not knowing what the law is. The majority view if rendered per incuriam will bind none, not even its authors and the minority if not per incuriam is binding as a precedent. The doctrine of res judicata often would mean injustice because unless we accept an erroneous decision of a court, acting within its jurisdiction, in conformity with the principles of natural justice and not involving any violation of the express statutory provisions as final, authoritative and binding, there can be no end to litigation – interest reipublicae ut sit finis litium (it is to the interest of the state that there be a limit to litigation). The doctrine of res judicata is a necessary evil. If we misunderstand stare decisis for res judicata, which is what we are doing when we advocate that judgements of a larger bench on a reference, like the instant case, be followed would mean that persons who were not parties to a case too ought to suffer the irrational judgements

of larger benches. We have suffered enough, for instance the Judges-2 case by which the Collegium system was established, because of Kesavananda Bharathi, PILs are filed claiming no fundamental right being violated but violation of the basic structure. The government could not establish a National Tax Tribunal because some lawyers could get it quashed alleging violation of basic structure. The worst instance in my mind is the quashing of the NJAC because certain "eminent" lawyers pleaded that it is in conflict with the Judges-2 case, which was nothing but the re-writing of the Constitution without the authority of the Parliament. The earlier we realize that, saying law is not reason but brutal majority would be insanity, the better.

A strict adherence to the concept of ratio decidendi would mean the principle employed in arriving at a decision and nothing else. Lawyers practising in subordinate Courts understand this principle better than those practising in the Supreme Court, for, when judgments of the Supreme Court, which are contrary to each other, are placed before a Munsiff, he has no option to refer the issue to a larger Bench but to decide it relying upon the various judgments placed before him, which carry the appropriate principle to be applied.

Those who agree with me will concede that the concept of stare decisis, which is embodied in Article 141, would mean that the principle which the superior Court has evolved and applied in resolving an issue before it is what is applicable to the coordinate Bench or subordinate Courts as a precedent and that the strength of the Bench does not matter at all, only the principle employed. I am sure that vast majority of my brothers and sisters would agree with me that legal principles are not discovered every day and every moment like new planets and moons orbiting the other galaxies forming part of the Milky Way. I am unable to think of even a single principle which the Supreme Court has evolved for the first time during its existence for the last 70 years which never ever existed for resolution of an issue before it which could act as a precedent, except the much hallowed doctrine of basic structure, which is founded on sand, being in conflict with the first principle of jurisprudence, ubi jus, ibi remedium – where there is a right there is a remedyright, remedy and forum. Constituting Constitutional Benches of five or seven Judges is extremely counter-productive, for, it will cement the erroneous concept that precedent means numbers and not the reason for the decision or the principle employed. The earlier we repeal Article 141, the better for

Britain and the world say farewell to Queen Elizabeth II

LONDON: Queen Elizabeth II will be laid to rest on Monday, after a state funeral attended by leaders from around the world and a historic last ceremonial journey through the packed streets of London.

Huge crowds gathered in near silence to watch as the queen's flag-draped coffin, topped with the Imperial State Crown, her orb and sceptre, was carried slowly to a gun carriage from

parliament's Westminster Hall where it had lain in state since Wednes-

To the tune of pipes and drums, the gun carriage -- used at every state funeral since Queen Victoria's in 1901 -- was then drawn by 142 junior enlisted sailors in the Royal Navy to Westminster Abbey. The thousand-yearold church's tenor bell tolled 96 times at one-minute intervals -- one for every year of her life -- stopping a minute before the service began at 11:00 am (1000 GMT).

The longest-serving monarch in British history died at Balmoral, her Scottish Highland retreat, on September 8 after a year of declining health.

Her eldest son and successor, King Charles III, dressed in ceremonial military uniform, followed the solemn procession, alongside his three siblings.

Charles's eldest son Prince William accompanied them alongside William's estranged brother, Prince Harry, and other senior roy-

William's two eldest children, George and Charlotte, who are next in line to the throne, also walked behind the coffin inside the ab-

Late Sunday, Charles, 73, and his wife, Queen Consort Camilla, said they had been "deeply touched" by the public's flood of messages. 'She was my boss'

"As we all prepare to say our last farewell, I wanted simply to take this opportunity to say thank you," he said.

Britain last held a state funeral in 1965 for the country's wartime prime minister Winston Churchill.

The queen's death has prompted deep reflection about the Britain she reigned over, the legacy of its past, its present state and what the future might hold, as well as the values of lifelong service and duty she came to represent during her 70-year reign.

Select members of the public won invitations to the abbey for the funeral after outstanding service to the community.

Hundreds of thousands of people are estimated to have queued, sometimes for up to 25 hours and overnight, to file past the queen's coffin as it lay in state.

Chrissy Heerey, a serving member of the Royal Air Force who joined the marathon queue twice, was the last person through the doors and described the experience as "amazing".

"When they came to me and said, 'right, you're the last person', I said, really?!" she told AFP, before heading off to join the crowds for the coffin's procession through London.

Big Ben tolls Throughout the procession, Big Ben, the giant bell atop the Elizabeth Tower at one end of the Houses of Parliament, will toll and guns will fire at one-minute intervals.

At Windsor, the Sebastopol Bell -- captured in Crimea in 1856 -- and the Curfew Tower Bell will also sound.

A vast television audience is expected to watch the funeral worldwide and live online, in a sign of the enduring fascination with the woman once described as "the last global mon-

Those lining the streets of London -- already jammed at sunrise on Monday -- said they had to bear witness.

"I will talk about this moment to my children," said Jack Davies, 14, camped out for the procession with his parents at Hyde Park Corner, where the coffin will be transferred from the gun carriage for the drive to Windsor.

Making sense of GDP growth and poverty

India's aggregate GDP has become the fifth-largest in the world, overtaking the UK's. Any country's GDP is in its own domestic currency. In India's case,

To make cross-country comparisons, that has to be converted into a common yardstick or numeraire, typically the US dollar. This can be done using official exchange rates, for instance, roughly 80 rupees to 1 dollar. However, 80 rupees can purchase more in India than 1 dollar can in the USA. If everything could be freely traded, all prices would equalize across borders. Such free trade doesn't happen because some items cannot be traded. Economists refer to them as non-tradables. Services are an example. A haircut will be cheaper in India than in the USA. Hence, a notion of purchasing power parity (PPP) has evolved.

The fifth-largest aggregate GDP is based on official exchange rates. If PPP exchange rates are used for conversion, Indian GDP is already the thirdlargest, right behind China and the USA. A slightly flippant example of PPP is the Big Mac Index, based on how much a Big Mac burger costs in different countries. To compute PPP, we need data on prices

London: The longest-serving monarch of the UK - Queen Elizabeth II - who died on September 8 at Balmoral Castle in Scotland, will be laid to rest at Westminster Abbey in London today.

A state funeral means that the UK government has officially declared the day of the funeral as a bank holiday.

> President Droupadi Murmu arrived in London to attend Queen Elizabeth II's state funeral on September 17 and offered condolences on behalf of the government of India.

> Meanwhile, President Joe Biden Sunday also expressed his condolences to the royal family. While mourn-

ing the passing of Queen Elizabeth, Biden remembered Queen's warm candour and said, "The way she touched when she leaned over. The way -- she had that look like, "Are you okay? Anything I can do for you? What do you need?" And then also, "Make sure you do what you're supposed to do," Biden said adding that she reminded him of his mother. Moreover, senior citizens and children are among those camping along the funeral routes, for over 48 hours in some cases, to bid a final goodbye to Queen Elizabeth II on

Monday. Notably, the funeral service will be conducted by the Dean of Westminster, and readings will be given by Patricia Scotland, the secretary general of the Commonwealth, and Prime Minister Liz Truss. The sermon will be delivered by Canterbury's archbishop, the Most Reverend Justin Welby.

Two minutes of silence will be observed across Britain towards the end of the ceremony. The service is expected to end around 12 pm (UK time). The Queen was born on April 21, 1926, at 17 Bruton Street in Mayfair, London. She was the first child of The Duke and Duchess of York - who later became King George VI - and Queen Elizabeth.



According to a statement by the UK royal family, the state funeral of the Queen will take place on Monday at 1100 hrs BST.

Queen Elizabeth's coffin draped in the Royal Standard is currently lying in state in London's Westminster Hall for members of the public to pay their respects to the Queen.

The Lying-in-State will end right before the funeral and the coffin will be taken in procession from the Palace of Westminster to Westminster Abbey, where the State Funeral Service will take place.

Following the state funeral, the coffin will travel in procession from Westminster Abbey to Wellington Arch, after which the coffin will travel to Windsor and once there, the State Hearse will travel in procession to St George's Chapel, Windsor Castle via the Long Walk.

A Committal Service will then take place in St George's Chapel after which Queen Elizabeth II will be buried in the castle's King George VI Memorial Chapel.

in different countries through surveys.

There is an International Comparison Programme (ICP) to gather prices on a common basket of goods and services across countries and it is subject to criticism. There are also time-lags. Present PPP data, collected through Asian Development Bank, are actually from 2017. But to state the obvious, any PPP conversion will relatively increase aggregate GDP, compared to official exchange rates, for a country like India, and relatively decrease it for a country like the USA. There is no inconsistency in this. They measure different things. Aggregate GDP is one thing, per capita is another ('capita' means head—as in decapitate, or capital punishment). Per capita GDP is aggregate GDP divided by population. It is the average income earned by every Indian. One could also say it is the average productivity of every working citizen. Source and year are important when citing any such figure, since they depend on exchange rates, vis-à-

Having said that, India's per capita GDP using official exchange rates (referred to as nominal exchange rates) is just short of \$2,500, while the PPP figure will be a bit more than \$7,500. As a thumb rule, if one multiplies nominal per capita GDP by three to get India's PPP per capita GDP, one will not be too far off. Whether official or PPP, this makes India a relatively poor country.

In the World Bank's present classification of countries, India is a lower-middle income country (the present threshold, using official exchange rates, is \$4,255 per capita). A rather pointless debate, especially on social media, has erupted regarding aggregate GDP rank versus per capita rank. They measure different things.

It isn't quite like 'the blind men and the elephant' debate. To stretch the analogy a bit—one measures the elephant's surface area, while the other measures some other part of the elephant's anatomy. Both tell us something.

In passing, everyone is aware of the work done by Angus Maddison and those who followed him, stretching back the historical GDP series for various countries. India's present geographical area isn't the same as it is in the Maddison-type calculations, for say, 1 CE. More importantly, there too, there is a difference between aggregate GDP and per capita. What is commonly quoted is the aggregate, not the per capita.

Similarly, there has been some unnecessary con-

troversy about UNDP's recent Human Development Report (HDR) 2022 and India's HDI (Human Development Index) rank. Before that, there is a notion of a poverty line and poverty ratio (also known as head count ratio). A poverty line is defined as a minimum basket of consumption required to subsist. Using prices, this is converted into a minimum monthly per capita consumption expenditure figure. It is a minimum and nothing more than that. When originally formulated in the 1950s, it was based on food (calories required), clothing and little else. This was based on private consumption expenditure. Health and education didn't figure, because it was presumed these would be publicly provided by the State. At that time, in 1951–52, when the first National Sample Survey (NSS) was conducted for consumption expenditure, the poverty ratio was around 45%.

Poverty lines aren't constant. As economies advance, more and more items are added to what is regarded as "minimum". For instance, currently, the US poverty line for a single-person household is around \$13,600 US dollars, compared to India's average of \$2,500. India's last official poverty line is one that was devised by the Suresh Tendulkar

The last such NSS survey, which provided data to compute poverty ratios once a poverty line was fixed, was for 2011–12. At that time, the poverty ratio was 25.7% for rural India, 13.7% for urban India and 21.9% overall (numbers vary from state to state and differ between rural and urban). Since then, we haven't had a NSS consumption expenditure survey (there is one which has just been started. The one in 2017–18 had methodological

When talking about poverty, one shouldn't get bogged down by the transient effect of Covid-19. Such an exogenous shock pushes people who are above the poverty line down to below the poverty line. But this reverses itself once growth and employment recover. My guess is—in the absence of data it is no more than that, India's poverty ratio will be around 20% for rural India, around 13% for urban India, and an overall ratio of around 18%. Poverty has declined, though one can legitimately argue that the decline should have been greater. Over time, declines aren't linear. But we should aspire for at least a 10% decline in poverty ratios every decade. I shall delve into more on this and HDI in the next column.

Britain and the world say farewell to Queen Elizabeth II

LONDON(KCN): Queen Elizabeth II is laid to rest on Monday, after a grand state funeral attended by leaders from around the world, and a historic last ceremonial journey through the packed streets of London.

The longest-serving monarch in British history died aged 96 at Balmoral, her Scottish Highland retreat, on September 8 after a year of declining health.

The last state funeral to be held in Britain was in 1965 for the country's wartime prime minister Winston Churchill.

Then, the cranes that once unloaded the spoils of Britain's vast empire that Elizabeth inherited were lowered in respect as his coffin was borne up the River Thames by barge.

In the six decades since, Britain's global reach has been much diminished and its place in the modern world has become less certain.

But the country will still dig deep into its centuries of tradition to honour the only monarch that most Britons have ever known.

Many ordinary people have camped out for days to witness the elaborate specbe the defining feature of Charles's reign. 'Last duty'

The queen's death has prompted deep reflection about the Britain she reigned over, the legacy of its past, its present state and what the future might hold, as well as the values of lifelong service and duty she came to represent during her 70-year reign.

"She was the glue that kept the country together," Andy Sanderson, 46, a supermarket manager who was among the last members of the public to pay his respects as her coffin lay in state, told AFP.

Some 6,000 military personnel have been drafted in to take part in the solemn procession to and from the abbey, on the route to Windsor and the committal service at St George's Chapel.

Britain's highest-ranking military officer, Chief of Defence Staff Admiral Tony Radakin, called it "our last duty for Her Majesty the Queen", their late commander-in-chief, and the first for Charles.

The abbey service itself, taking place under London's biggest-ever police security operation, starts at 11:00 am (1000)

GMT).

After just under an hour, a bugler will play The Last Post, before two minutes of silence and the reworded national anthem, "God Save the King".

Former Archbishop of York John Sentamu said the queen, who headed the Protestant

Hundreds of thousands of people are estimated to have queued, sometimes for up to 25 hours and overnight, to file past the queen's coffin since it was taken to lie in state last Wednesday.

The doors of the cavernous Westminster Hall at the UK parliament will close at 6:30 am before the coffin is transferred to the state gun carriage and pulled by members of the Royal Navy to the abbey. After the service, Charles and other senior royals will again follow in procession past hushed crowds to a waiting hearse and the final journey to Windsor. Throughout, Big Ben, the giant bell atop the Elizabeth Tower at one end of the Houses of Parliament, will toll and guns will fire at one-minute intervals.

A vast television audience is expected to watch the funeral worldwide and live online, in a sign of the enduring fascination with the woman once described as "the last global monarch".

But E.J. Kelly, 46, who travelled with two colleagues from Northern Ireland to stake out a spot on the procession route on Saturday, said there was no substitute for being there.

"Watching it on television is wonderful but being here is something else," the primary school teacher told AFP.

"I will probably feel very emotional when it comes to it but I wanted to be here to pay my respects."

At Windsor, her crown, orb and sceptre will be removed and placed on the altar. The most senior officer of the royal household, the lord chamberlain, symbolically breaks his "wand of office" and places it on the coffin. The heavy leadlined oak casket, draped with the queen's colours, is then lowered into the Royal Vault as a lone bagpiper plays a lament. A private interment ceremony will take place at the adjoining King George VI Memorial Chapel at 1830 GMT.

for weakening the Lokayukta headed by a retired judge by forming the Anti-Corruption Bureau (ACB) helmed by a police officer goes to the Congress government.

The BJP did nothing to fulfil its election promise of disbanding the ACB. It was abolished recently after the High Court order. Recent floods in Bengaluru added to the woes of the BJP. No matter who allowed encroachments and who turned a blind eye all these years, the ire will be directed more against those in power. Bengaluru with 28 Assembly segments is very important for the BJP as well as the Congress. The ruling party had not done particularly well in the 2018 polls when it won 11 seats, three less than Congress. Equations changed post political defections that helped BJP come to power in 2019. But now with corruption being one of the major poll issues, the Aam Aadmi Party (AAP) will be looking to draw a section of urban voters disillusioned with the BJP. That may not help the AAP win seats, but can damage the BJP in closely contested elections.

Meanwhile, the Congress is also changing its approach. The party that finds itself in a blind alley in national politics is adopting a strategy to target the BJP's local leadership and not focus too much on criticising Prime Minister Narendra Modi as that can prove to be counter-productive. As part of that strategy, the Congress is going full throttle firing corruption salvos against the ruling dispensation and has even launched a helpline and website for people to register complaints if they face any demand for bribes.

Now, with former AICC chief Rahul Gandhi's "Bharat Jodo" yatra set to enter the state on September 30 and cover over 500 km in 21 days, the Congress will sharpen its attack on the Bommai government. And the same intensity is expected to be seen in the BJP's rallies to be held around the same time. Corruption continues to be a major talking point in the run-up to the elections, but people also expect those in power to talk about what they have done and those in opposition to explain what they have to offer.

The queen's eldest son and successor, King Charles III, 73, will lead mourners, alongside his three siblings and his heir, Prince William.

Late Sunday, Charles said he and his wife, Queen Consort Camilla, had been "deeply touched" by the messages of condolence and support.

"As we all prepare to say our last farewell, I wanted simply to take this opportunity to say thank you," he added.

The queen's death has brought two of its most controversial members -- the queen's second son Prince Andrew and Charles's younger son Prince Harry -- temporarily back into the royal fold.

In the abbey, pews will also be Liz Truss, whom the queen appointed as the 15th British prime minister of her reign just two days before her death.

All of Truss's living predecessors will be there too, plus her counterparts and representatives from the 14 Commonwealth countries outside Britain where Charles is also head of state.
