DUBAI(KCN): Iran faced international criticism on Tuesday over the death of a woman held by its morality police, which ignited three days of protests, including clashes with security forces in the capital and other unrest that claimed at least three lives. The UN human rights office called for an investigation. The United States, which is trying to revive the 2015 nuclear deal with Iran, called on the Islamic Republic to end its "systemic persecution" of women. Italy also condemned her death. Iran dismissed the criticism as politically motivated. Separately, an Iranian official said three people had been killed by unnamed armed groups in the Kurdish region of the country where the protests began, the first official confirmation of deaths linked to the unrest. Later on Monday, the semiofficial Fars news agency reported that small groups of protesters had again gathered in downtown Tehran, chanting "Death to the dictator." It said the crowd numbered around 300 and that the protesters damaged street signs.

The governor of Iran's Kurdistan province, Esmail Zarei Kousha, told Fars that three people were killed by unnamed armed groups, linking the violence to the unrest. He said the second body was found in a car near Sagez and that the third killing was "completely" suspicious. The province has seen past violence between Iranian security forces and Kurdish separatists.

UN decries Iran's 'violent response' after Mahsa Amini's death

The UN body said Iran's morality police have expanded their patrols in recent months, targeting women for not properly wearing the Islamic headscarf, known as hijab. It said verified videos show women being slapped in the face, struck with batons and thrown into police vans for wearing the hijab too loosely. A similar patrol detained 22-year-old Mahsa Amini last Tuesday, taking her to a police station where she collapsed. She died three days later. Iranian police have denied mistreating Amini and say she died of a heart attack. Authorities say they are investigating the incident.

"Mahsa Amini's tragic death and allegations of torture and ill-treatment must be promptly, impartially and effectively investigated by an independent competent authority," said Nada Al-Nashif, the acting UN high commissioner



while said Amini "should be alive today."

"Instead, the United States and the Iranian people mourn her. We call on the Iranian government to end its systemic persecution of women and to allow peaceful protest," he tweeted.

Italy's Foreign Ministry called for "the perpetrators of this cowardly act" to be held to account, saying "violence against innocent people, especially women and girls, can never be tolerated."

Iranian Foreign Minister Hossein Amirabdollahian rejected the criticism, accusing the US of "shedding crocodile tears." "An investigation was ordered into (the) tragic death of Mahsa, who, as (the) President said, was just like our own daughters," he tweeted. "To Iran, human rights are of inherent value — unlike those who see it (as) a tool against adversaries."

she had no history of heart trouble. Amjad Amini, her father, told an Iranian news website that witnesses saw her being shoved into a police car.

"I asked for access to (videos) from cameras inside the car as well as courtyard of the police station, but they gave no answer," he said. He also accused the police of not transferring her to the hospital promptly enough, saying she could have been resuscitated.

He said that when he arrived at the hospital he was not allowed to view the body, but managed to get a glimpse of bruising on her foot. Authorities then pressured him to bury her at night, apparently to reduce the likelihood of protests, but Amini said the family convinced them to let them bury her at 8 am instead. Amini, who was Kurdish, was buried Saturday in her home city of Saqez in western Iran. Protests erupted there after her funeral and police fired tear gas to disperse demonstra-

The protests spread to Tehran and other cities on Monday. A news website affiliated with state TV said 22 people were arrested at a protest in the northern city of Rasht, the first official confirmation of arrests related to the protests.

State TV showed footage of protests on Monday, including images of two police cars with their windows smashed. It said the protesters torched two motorbikes as well, and that they burned Iranian flags in Kurdish areas and Tehran.

The state-run broadcaster blamed the unrest on foreign countries and exiled opposition groups, accusing them of using Amini's death as a pretext for more economic sanctions.

Iran has seen waves of protests in recent years, mainly over a long-running economic crisis exacerbated by Western sanctions linked to the country's nuclear program. Authorities have managed to quash the protests by force.

KRB Rail Miss forest signal

Bhubaneswar(KCN): The much-awaited Khurda Road-Bolangir (KRB) Railway line project is being delayed due to non-issue of Stage-I forest clearance by the Union Government.

Out of the total length of 301 km of the Khurda Road-Bolangir new railway project, 91 km from Khurda Road to Nuagaon has been commissioned while work is in progress The Odisha Government has given land free of cost from 112 km to 301 km and bearing 50 per cent construction cost for the Khurda Road-Bolangir railway project. However, due to non-issue of the Stage-I forest clearance by the Central Government, the work cannot start in between 112 km to 118 km, an official admit.

Earlier, Union Railways Minister Ashwini



from Nuagaon to Daspalla (91 km to 106 km) and target is set to commission it by March 2023, official sources said here on Tuesday. The work from Daspalla to Buguda (106 km to 121 km) is very slow due to non-issue of Stage-I forest clearance from the Ministry of Environment, Forest and Climate Change, the source said.

Similarly, work from Buguda to Banigogchha is also yet to start due to non-issue of the Stage-I forest clearance.

In total, the Government of India is yet to issue required forest clearance from 112 to 180 km while the work from 180 to 275 km is in progress and work at 275-301 km already commissioned.

For forest clearance, the State Government has already sent its proposal to the MoEF Regional Office, Bhubaneswar. This issue was also raised during the recent meeting of the Regional Empowered Committee, the source informed.

Vaishnaw had informed the Parliament that the completion time of the Khurda Road-Bolangir new line project cannot be ascertained at this time. Giving a written reply to Rajya Sabha, Mr.Vaishnaw had stated completion of any railway project

depends on various factors like quick land acquisition by State Government, forest clearance by officials of forest department, shifting of infringing utilities, statutory clearances from various authorities, geological and topographical conditions of area, law and order situation in the area of project site, number of working months in a year for particular project site due to climatic conditions, etc.

This project involves acquisition of 6162 acres land and diversion of 1844 acre forest land, out of which 5208 acres land has been acquired and diversion of 170 acres forest land has been completed. Further, acquisition of 954 acres land and diversion of 1674 acre forest land have been taken up, he had informed. This Railway Projects was sanctioned in 1994-95 and even Prime Minister Narendra Modi during Pragati Review meetings had already expressed concern for delay in completion of the project.

We have tried to make it as close to Forrest Gump as possible, but it's an Indianised version. Atul Kulkarni (scriptwriter) and Advait Chandan (director) have made a few changes, and we hope the audience loves it. The Hollywood version had a few adult scenes, but since we wanted to make a family film, we decided to do away with them. We wanted to retain the innocence of the character from the original version.

Did you actually grow a beard for the role?



I grew my beard six inches long. It took me almost six months. I met a Sardar at my gym and liked his look. I told him I wanted to have this look for my next film. I did grow a beard but also used extensions.

Your son Junaid gave screen tests for the film. What happened?

Junaid studied theatre at the American Academy of Dramatic Arts and did plays for a year. I told Advait to shoot a few test scenes with him for the film to see if he could handle it. We made him Laal Singh Chaddha and he shot for two weeks. That helped us gauge what Junaid had learnt at school. He was so good as the character that I was in a dilemma if Junaid should do the film. I showed (the tests) to all my close friends who don't give any leeway to my work. Only two people said no--Atul (Kulkarni) and Aditya Chopra. They said that since it was an episodic film, a newcomer should not do it. It's a star vehicle, which is why it was Tom Hanks who played the role in the original.

How did you convince yourself for the role? I prepped for the film, but it stayed in my mind that Laal is an innocent and pure character. I watched her for the first time in Kabhie Khushi Kabhie Gham and I loved her. Then I did 3 Idiots and Talaash with her. She gets into the character completely and is a fantastic actor. She has never given a screen test, but she agreed for this one because we wanted to see how she would look in the film. After we did a reading with her, both Advait and I realised that she was perfect for the role.

What qualities of Laal have impressed you? He is innocent, doesn't complain, and knows how to leave the past behind. If anyone speaks ill of him, he keeps quiet. He knows that you can't rewind the past. A lot of us don't accept that. Even if he feels bad, he just moves on with life. His mother has taught him that. My relationship with my Ammi has been the same. That's why I could relate to the film. I have learnt a lot in life because of her. Are you doing Kiran Rao's next film, Lapata

Ladki? I gave a screen test for it, but she rejected me. Both of us felt that I was not the right fit for the role. I was also busy with Laal, so we

decided that if she cannot find anyone, I will be there as a backup.

House of Lords is bound by its own decisions. That was a great deviation from the view hitherto then in force that no precedent is absolutely binding, but is only a guidance. Justinian, known for his great work called "Corpus Juris Civilis", so too Chief Justice Edward Coke and Blackstone known for their works "Institutes of the Laws of England" and "Commentaries on the Laws of England", respectively, only contemplated that not the judgment, but the principle evolved in a judgment, the ratio decidendi, will be applicable to future cases as a precedent, the principle being stare decisis et non quieta movere: "to stand by decisions and not disturb the undisturbed." In a legal context, this is understood to mean that courts should generally abide by precedents and not disturb settled matters.

- When Halsbury delivered the judgment in the case of London Street Tramways Co., no judgment was treated as a legislation or in substitution of a legislation. What was the precedent is the principle, if any, which a Court has evolved for the first time for resolution of the controversy before it for which no principle was available. Halsbury was such a tall figure that his decision that the House of Lords shall be bound by its own decisions was not questioned by anyone; there was no occasion for it as his view did not create any difficulty because what was a precedent was the reason for the decision and nothing else.
- 3. In the Government of India Act of 1935, it was expressly provided that the ratio decidendi of the judgment of the Federal Court and Privy Council shall be binding on all Courts and Tribunals within the territory of British India. The Constituent Assembly incorporated Section 212 of the Government of India Act in the Constitution of India, though it was worded differently. Article 141 of the Constitution reads thus:
- "141.Law declared by Supreme Court to be binding on all courts- The law declared by the Supreme Court shall be binding on all courts within the territory of India. But for Article 141, the law would have been simple, offering no difficulty even for a common man to comprehend. Chief Justice Edward Coke said that law is reason. The concept of precedent also is nothing but reason, namely, the 'reason' for a de-

Court has evolved for resolution of a dispute before it, and the 'reason' for the decision when repeatedly applied by superior Courts become settled principles. Our Judges misunderstood Article 141 as the power to legislate, and each sentence and word of a judgment became the law of the land. The concept of the 'reason' for the decision being repeatedly applied and thus assuming great authenticity was forgotten and our lawyers and Judges treated the latest decision on a sub-

ject as the binding one. When Judges started legislating, completely misunderstanding the scope of Articles 141 and 142, a new era of large number of judgments, which cannot stand together, conflicting with each other, became the order of the day. The new practice of referring cases to larger Benches, because two judgments are in conflict, both involving no particular legal principle, became very common.

What is stated above could be said as the preface to the scenario leading to the constitution of a Five-Judge Bench to authoritatively decide which of the interpretation given by two different Three-Judge Benches of the Supreme Court about Section 24(2) of the Land Acquisition Act is the correct one. In Pune Municipal Corporation case, 2014, a Three-Judge Bench headed by Justice R M Lodha took the view that merely because the Government has deposited with the court the compensation amount to be paid to the land holders whose property was acquired, their right is not lost if the property is not utilized for the purpose for which it is acquired, but only if they have accepted the compensation. In 2018, another Three-Judge Bench headed by Shri Justice Arun Mishra in Indore Development Authority took a contrary view holding that the judgment rendered by the earlier Three-Judge Bench is per incuriam. A Bench headed by Justice Lokur wrongly faulted Shri Justice Arun Mishra for taking the said view observing that he was bound by the earlier decision in the Pune case. Justice Arun Mishra was unfairly accused of judicial impropriety. On the very next day, Justice Mishra, taking note of the observation of Justice Lokur, requested the Chief Justice of India to refer the issue for consideration of a larger Bench. The Hon'ble CJI accordingly constituted a Five-Judge Bench headed by Jus-

tice Arun Mishra. When the said Bench assembled to hear the question, which was Mathews J. Nedumpara

for him to head the Bench, a proposition which has no foundation in jurisprudence. I am afraid to say that the entire controversy has its root in the failure to be kept abreast of the first principles of jurisprudence. We forget very simple things; we are not often thorough enough about the concepts like res judicata, stare decisis, res inter alios, nullity, etc. The practice of referring a case to a larger Bench for decision on important questions of law is in ignorance of the first principles. As I said at the outset, law is reason, not numbers, at least when it comes to stare decisis. The number has relevance only when a Bench of three or more Judges decides a case and the judgment constitutes to be res judicata. If a Bench of three Judges is to decide a case between A and B, what matters is not the validity of the reason offered by the Judges, but who are in majority. The majority decision as res judicata will prevail, no matter right or wrong. This principle which is only applicable to res judicata, we have been applying erroneously to the doctrine of stare decisis. We did not accept the minority view in AK Gopalan's case as stare decisis because we got confused with the distinct concepts of res judicata and stare decisis. To repeat, so far as res judicata is concerned, all that matters is the majority view. On the contrary, so far as the doctrine of stare decisis is concerned, it is not the majority view which ought to matter, but the 'reason' for the decision. If reason for the decision is understood as the meaning of Article 141 and is followed in actual practice, we will be freed from the slavery and absurdity of needing to search for the law applicable from the thousands and thousands of judgments, reported and unreported and groping in darkness, not knowing what the law is. The majority view if rendered per incuriam will bind none, not even its authors and the minority if not per incuriam is binding as a precedent. The doctrine of res judicata often would mean injustice because unless we accept an erroneous decision of a court, acting within its jurisdiction, in conformity with the principles of natural justice and not involving any violation of the express statutory provisions as final, authoritative and binding, there can be no end to litigation – interest reipublicae ut sit finis litium (it is to the interest of the state that there be a limit to

litigation). The doctrine of res judicata is a necessary evil. If we misunderstand stare decisis for res judicata, which is what we are

We have suffered enough, for instance the Judges-2 case by which the Collegium system was established, because of Kesavananda Bharathi, PILs are filed claiming no fundamental right being violated but violation of the basic structure. The government could not establish a National Tax Tribunal because some lawyers could get it quashed alleging violation of basic structure. The worst instance in my mind is the quashing of the NJAC because certain "eminent" lawyers pleaded that it is in conflict with the Judges-2 case, which was nothing but the re-writing of the Constitution without the authority of the Parliament. The earlier we realize that, saying law is not reason but brutal majority would be insanity, the better.

A strict adherence to the concept of ratio decidendi would mean the principle employed in arriving at a decision and nothing else. Lawyers practising in subordinate Courts understand this principle better than those practising in the Supreme Court, for, when judgments of the Supreme Court, which are contrary to each other, are placed before a Munsiff, he has no option to refer the issue to a larger Bench but to decide it relying upon the various judgments placed before him, which carry the appropriate principle to be applied.

Those who agree with me will concede that the concept of stare decisis, which is embodied in Article 141, would mean that the principle which the superior Court has evolved and applied in resolving an issue before it is what is applicable to the coordinate Bench or subordinate Courts as a precedent and that the strength of the Bench does not matter at all, only the principle employed. I am sure that vast majority of my brothers and sisters would agree with me that legal principles are not discovered every day and every moment like new planets and moons orbiting the other galaxies forming part of the Milky Way. I am unable to think of even a single principle which the Supreme Court has evolved for the first time during its existence for the last 70 years which never ever existed for resolution of an issue before it which could act as a precedent, except the much hallowed doctrine of basic structure, which is founded on sand, being in conflict with the first principle of jurisprudence, ubi jus, ibi remedium - where there is a right there is a remedyright, remedy and forum. Constituting Constitutional Benches of five or seven Judges is extremely counter-productive, for, it will cement the erroneous concept that precedent means numbers and not the reason for

Kejriwal calls for 'Bharatiya' system of education

NEW DELHI: It is difficult to maintain corporate integrity for 78 per cent professionals in India, compared to 60 per cent in emerging markets, amidst volatile market

is likely to be similar if not significant in the Indian startup ecosystem.

"As Indian startups continue to grow, introducing strong corporate governance practices



conditions, an EY report said on Tuesday. The EY report comprises the views of over 2,750 board members, managers, and employees from 34 emerging markets which includes 100 professionals surveyed across India.

"Organisations continue to remain vulnerable in volatile market conditions, with 78 per cent of respondents in India admitting that it is challenging to maintain their standards of integrity in periods of rapid change or difficult market conditions," the report said.

According to the survey, entities in India have faced more action from regulators compared to other emerging markets covered in the survey.

"Amidst shifts in regulatory expectations and economic stress, 60 per cent of respondents from India said that regulators have taken action against their organisation for breaching integrity standards or regulations, compared to 38 per cent in emerging markets," it said. At the same time, 65 per cent in India cited that it is difficult to adapt to the speed and volume of changes in regulations as against 45 per cent in the emerging markets.

EY - India and Global Markets Leader for Forensic and Integrity Services, Arpinder Singh delved into the responses of Indian professionals and observed that with 67 per cent of large organisations in India, having reported issues of misconduct to management or a whistle-blowing hotline, the percentage will go a long way in enhancing regulatory compliance, preventing fines and penalties and protecting assets and reputation. More and more new age companies must prioritise proper implementation of compliance structures as they can significantly help organisations drive long-term sustainable value," Singh said.

According to 65 per cent of respondents in India, it is difficult to adapt to the speed and volume of changes in regulations as against 45 per cent in the emerging markets.

The survey shows a gap between what companies said they have in the way of an ESG policy and how they demonstrate accountability.

"Only 33 per cent of emerging market respondents said their company has a policy on either Corporate Social Responsibility (CSR) or ESG, as compared to 47 per cent in India," it said.

For 43 per cent of professionals, cyber risk is the top risk when acquiring, partnering or investing in other organisations compared to 28 per cent in emerging markets.

According to the report, 8 per cent respondents in India knew very little of policies procedures for keeping office premises, equipment and networks secure as against 28 per cent in other emerging markets. The Congress Rahul walks away from

This Gandhian aspect of Rahul's personality keeps him still a potent force in a world that is pretty quick to seek vengeance for the slightest wrong. And, again, it is this trait that is on display in the idea of the long walk from Kanniyakumari to Kashmir, a distance of some 3,500 kilometres, which he plans to cover in five months. An exercise that Rahul Gandhi hopes will help him in his 'Discovery of India'—the name of the book that his great-grandfather wrote in Ahmednagar jail between 1942 and 1945. This is not just an innocent journey, one in which Rahul Gandhi would just heal divisive society just by walking and talking. The fact is structurally and organisationally, the Congress is an exhausted political force. It is not reasonable to expect a party used to the custom of being steered by a small group of Delhi-resident politicians-and their intellectual retinue, generational accomplices used to the comforts of a certain legacy—privileged, whether they are in power or not, to withstand the BJP.

A BJP that has, with great will and sustained ingenuity, tapped into the chimerical racial and religious subconscious of Hindu India so well that we have begun to look for our future in our past: once we were golden; now we are leaden.

The current woke fashion of victimhood externalises the individual's inadequacy primarily as another's fault. What the BJP is doing convincingly is that India's low performance-victimhood en masse—across all sectors for centuries could be blamed on Mughals, colonial powers, and the Congress. The last for the BJP is just another face of the British, a substitute. Therefore, as a people, Indians are not at fault. The BJP has helped India to externalise her inadequacy. DUBAI: The International Cricket Council (ICC) on Tuesday made the ban on the use of saliva to polish the ball a permanent affair, while also introducing a clause whereby any "unfair" and "deliberate movement" while the bowler is running in to bowl could now result in the umpire awarding five penalty runs to the batting side, in addition to a call of 'dead ball'.

The ICC has announced several changes to its 'playing conditions' after the Chief Executives' Committee (CEC) ratified the recommendations from the Sourav Ganguly-led Men's Cricket Committee.

The main changes to the playing conditions come into effect from October 1, 2022, which means they will be applicable in the ICC T20 World Cup in Australia from October 16.

In a statement on the use of saliva to polish the ball, ICC said, "This prohibition has been in place for over two years in international cricket as a Covid-related temporary measure and it is considered appropriate for the ban to be made permanent." On the issue of unfair movement by the fielding side, the new ICC rule says, "Any unfair and deliberate movement while the bowler is running in to bowl could now result in the umpire awarding five penalty runs to the batting side, in addition to a call of 'dead ball'."

The other rule changes that will come into effect from October 1, 2022 are:

Batters returning when caught: When a batter is out caught, the new batter will come in at the end the striker was, regardless of whether the batters crossed prior to the catch being taken.

Incoming batter ready to face the ball: An incoming batter will now be required to be ready to take strike within two minutes in Tests and ODIs, while the current threshold of ninety seconds in T20Is remains un-

Striker's right to play the ball: This is restricted so as to require some part of their bat or person to remain within the pitch. Should they venture beyond that, the umpire will call and signal Dead ball. Any ball which would force the batter to leave the pitch will also be called No ball.

Running out of the non-striker: The playing conditions follow the Laws in moving this method of effecting a Run out from the 'Unfair Play' section to the 'Run out' section.

Bowler throwing towards striker's end before delivery: Previously, a bowler who saw the batter advancing down the wicket before entering their delivery stride, could throw the ball to attempt to Run out the striker. This practice will now be called a dead ball.

Other major decisions: The in-match penalty introduced in T20Is in January 2022, (whereby the failure of a fielding team to bowl their overs by the scheduled cessation time leads to an additional fielder having to be brought inside the fielding circle for the remaining overs of the innings), will now also be adopted in ODI matches after the completion of the ICC Men's Cricket World Cup Super League in 2023.

It was also decided that the playing conditions for all men's and women's ODI and T20I matches will be amended to allow hybrid pitches to be used, if agreed by both teams. Currently, hybrid pitches can only be used in women's T20I matches.

"It was an honour chairing my first meeting of the ICC Cricket Committee. I was pleased with the productive contribution of the Committee members which resulted in key recommendations being made. I thank all members for their valuable input and suggestions," said Ganguly.

Debris in Odisha's Barabati moat raises suspicion

on Sunday, urged the local administration to initiate action and remove the debris else the moat will be buried.

Acting on the complaint, a team of Cantonment police rushed to the spot and detained some vehicles carrying the debris. CMC Mayor Subhas Singh said he was unaware of the matter. He said civic body would seek details on the issue from the Archaeological Survey of India (ASI), Bhubaneswar Circle. "The fort and its moat are protected monuments of the ASI. The civic body has nothing to do with it. We do not know who is dumping the debris in the moat," Singh said.

Superintending engineer, ASI, Bhubaneswar Circle, Arun Mallick said a temporary road is being constructed by ASI for setting up of a cofferdam for dewatering the moat to facilitate renovation and conservation of its inner wall on the western side. "After the renovation and conservation work is over, the construction and demolition debris will be removed from the moat," he added.

Locals said the ASI should have informed them before dumping the debris in the moat. "Had the agency put up an information slab

at the work site, the dumping activity would have not created suspicion. It seems there is no coordination or simply a communication gap between ASI and CMC," they alleged.
