KENDRAPARA(KCN): The demolition of the tallest twin towers in Noida by implosion technique had an Odisha connection. Chief scientist and professor at the Academy of Scientific and Innovative Research (AcSIR) Debi Prasanna Kanungo (55) from Kendrapara played a vital role in the demolition as the group leader, Geo-Hazard Risk Reduction Group (GHRR), Planning & Busi-



ness Development Group (PBD) of CSIR-Central Building Research Institute (CBRI) Roorkee.

The Supreme Court also praised the efforts of the team leader, Dr Debi Prasanna Kanungo, senior principal scientist at CBRI. for leading his team to give priority to research for the report which was submitted to the apex court prior to the implosion.

Speaking to TNIE over the phone from Roorkee, Kanungo said, "The Allahabad High Court had, in April 2014, ordered the demolition of the twin towers on a plea filed by the Emerald Court Apartment Owners' Association. The Supreme Court in its order in August 2021 directed CBRI to execute the demolition work under its overall supervision and expert guidance on May 22, 2022. I on behalf of CBRI appeared before the apex court and urged to defer the demolition to August 2022 as the preparatory work for the demolition was in progress. The court, considering our opinion, deferred the demolition work to August 28."

The court also allowed a buffer period of one week (August 29 to September 4) to take care of any marginal delay due to weather and technical reasons. "On a war footing, we scanned many demolition companies across the globe and selected Mumbai-based Edifice Engineering which also took the help of Jet Demolition company of South Africa," he stated. The demolition was successful and it took 9-10 seconds for the entire building to crash, added Kanungo. After completing a BSc in Geology from Dharanidhar College, Keonjhar, he went on to pursue M Tech in Applied Geology from IIT, Roorkee and PhD in Disaster Management. Since 1994 he has been working as a scientist in CBRI.

Writhing in labour pain, woman carried on foot for kms -where is DMF resources

Barbil (KCN): In a case of lack of medical facilities, a pregnant woman had to suffer labour pain with no medical assistance. The



woman hails from Pandiya village under Jajang Village under Barbil Tehsil of Keonjhar district, which allegedly lacks basic medical facilities. The 27-year-old woman was identified as Jiddi Oram After struggling with labour pain, the woman was carried on a temporary stretcher on foot from her village to the nearest motor able road which is almost 2 kilometres away where one ambulance was called. Even after being carried for such a long distance to reach a motorable road, the plight of the woman did not end as she had to be carried for another 10 km in the ambulance to reach the nearest primary health centre in Joda. Before reaching to ambulance, she delivered a baby and fell seriously ill. The reason attributed to the villagers' hardship was the lack of medical facilities in the village. It must be noted that the mineral rich Keonjhar district is blessed with District Mineral foundation(DMF) where thousand crores of money is lying to provide facilities to mining affected area. Despite resource, many such pregnant women and other patients being carried on makeshift stretchers is a common sight in many villages and the reason for this is the absence of medical and road infrastructure. The Suryakiran Aerobatic Team of the IAF is one of the nine aircraft display teams across the world. NSD Witnesses Movement of Transit Cargo under ACMP

Kolkata (KCN): The Syama Prasad Mookerjee Port (SMP), Kolkata today added another glory to its cap as the movement of transit cargo under ACMP (Flag off ceremony of India-Bangladesh trial runs between Kolkata-Chittagong-Sheola & Tamabil—



Chittagong-Kolkata at Netaji Subhas Dock (NSD). As a part of the event the container VSTU2031090 loaded with 25 MT TMT bars from Tata Steel was shipped in M/v Trans Samudera for Chittagong port today. The SMP, Kolkata Chairman, Shri Vinit Kumar formally launched the event by breaking coconut. Shri Samrat Rahi, Deputy Chairman, SMP, Kolkata was also present on the occasion.

According to Shri Kumar, in the 13th India-Bangladesh Joint Group of Customs (JSC)



Dhaka, Bangladesh regarding the operationalisation of ACMP or Agreement on the Use of Chattogram (Chittagong) and Mongla Ports it was agreed to undertake four trial runs and SMP, Kolkata was entrusted to complete the trials within six months. The routes are- Mongla to Tamabil, Tamabil to Chittagong, Chittagong to Sheola and last but not the least, Mongla to Bibirbazar.

SMP, Kolkata partnered with Maersk Line India Pvt Ltd to do two trial runs from Mongla to Tamabil and Mongla to Bibirbazar. The first trial movements of Indian transit cargo through Mongla-Tamabil and Mongla Bibirbazar were successful.

Shri Kumar informed that the SMP, Kolkata planned the remaining two trials from Chittagong to Sheola and Tamabil to Chittagong with the partnership CJ Darcl Logistics Ltd. Tata Steel being a major supplier of steel products to the North-East region, is helping by providing cargo for the logis-



tics movement from Kolkata to Silchar at Assam using Chittagong Port and Sheola-Sutarkhandi LCS border points.

The SMP, Kolkata Chairman also stated that the return trial movement of cargo from Tamabil to Chittagong has been planned also and the return cargo will be loaded on the container at Dawki LCS and the container will arrive at Chittagong Port via Tamabil LCS for further shipment to its final destination at Kolkata.



Shri Kumar hoped that such a protocol will open up alternative routes through waterways for transportation of coastal containers from Kolkata or Haldia to the North Eastern States along with other EXIM containers going to Bangladesh in the same barge or vessel. It will not only reduce transit cost and time, but will also help to develop the economy of this part of India.



Cost of Acquisition for computing Capital Gains (Part 1)

1. Cost of acquisition of assets for the purpose of computing the capital gain:



cost The acquisition of an asset basically is the amount for which it originally was purchased by the taxpayer. However, it shall not include securities transaction tax paid on acquisition of shares or units of

equity oriented fund.

However, if the asset had been the property of the taxpayer from a date prior to 1.4.2001 he has the option u/s 55(2)(b)(i) (subject to exceptions discussed hereinafter) to substitute for the actual cost, by the fair market value of the asset as on 1.4.2001 w.e.f. asst. year 2018-19. In this connection it may be noted that w.e.f. asst. year 2021-22, the **fair market value** of an immovable property as on 1.4.2001 is to be taken on the basis of stamp duty valuation as on that day, wherever such valuation is available. Prior to the amendment fair market value on the basis of the report of an approved valuer was being accepted as well.

With the change of base year, the Fair Market Value of such asset as on 1.4.2001, (if asset is acquired prior to 1.4.2001), shall be the cost of acquisition as on 01.04.2001 at the option of the

Option not available in certain cases

: It may be noted that the option of substituting fair market value as on 01.04.2001 is not permitted in case of following capital assets covered u/s 55(2)(a)-

- in relation to goodwill of business,
- trade mark or brand name associated with a business (w.e.f. asst. year 2002-03)
- (c) right to manufacture, produce or process any article or thing,
- (d) tenancy rights
- (e) stage carriage permits,
- loom hours,
- bonus shares allotted before 01.04.2001 Here it would be relevant to mention that in view of the Supreme Court decision in the case of Shekhawati General Traders Ltd. v. ITO [1971] 82 ITR 788 (SC), for ascertaining the fair market value on 01.04.2001 any issue of bonus or right shares subsequent to that date is

irrelevant. As issue of bonus shares after 01.04.2001 does not affect fair market value of original shares on 01.04.2001, any subsequent issue of bonus shares should be ignored - Sutlej Cotton Mills Ltd. v. CIT [1979] 1 Taxman 497(Cal). Urban Land tax and corporation tax are not part of cost of acquisition but are cost of holding - CIT v. SAS Hotel (P) Ltd.

Cost of acquisition in cases where asset was NOT acquired by way of purchase:

[2000] 158 CTR (Mad.) 125.

Where the assets are acquired by way of undermentioned manner, cost of the previous owner shall be deemed to be the cost of acquisition for which previous owner acquired it, as increased by cost of any improvement of the assets incurred or borne by the previous owner or assessee. In case the previous owner has also acquired otherwise than by way of purchase then the cost of acquisition of original owner who has acquired by way of purchase, in the following cases:

- on any distribution of assets on the total or partial partition of a Hindu undivided family
- (b) under a gift or will;
- (c) by succession, inheritance or devolution; (d) on any distribution of assets on the liquidation of a company,
- (e) under a transfer to a revocable or irrevocable trust,
- On a transfer by a wholly owned Indian (f) subsidiary company to its holding company or vice versa as per section 47(iv) & (v);
- (g) On any transfer in a scheme of amalgamation of two Indian companies as per section 47(vi);

- (n) On any transfer by a shareholder, in a business reorganization, of a capital asset being a share or shares held by him in the predecessor co-operative bank if the transfer is made in consideration of the allotment to him of any share or shares in the successor co- operative bank as per section 47(vicb);
- (o) Any transfer in a demerger, of a capital asset, being a share of a foreign company, referred to in Explanation 5 to section 9(1)(i) as per section 47(vicc);
- (p) Any transfer, in a relocation, of a capital asset by the original fund to the resulting fund; as per section 47(viiac);
- (q) Any transfer by a shareholder or unit holder or interest holder, in a relocation, of a capital asset being a share or unit or interest held by him in the original fund in consideration for the share or unit or interest in the resultant fund, as per section 47(viiad);
- Any transfer of capital asset by India Infrastructure Finance Company Limited to an institution established for financing the infrastructure and development, set up under an Act of Parliament and notified by the Central Government not be regarded as transfer as per section 47(viiae);
- (s) Any transfer of capital asset, under a plan approved by the Central Government, by a public sector company to another public sector company notified by the Central Government or to the Central Government or to a State Government shall not be regarded as transfer as per Section 47(viiaf);
- On transfer of a capital asset or intangible asset by a firm to a company as a result or Succession, as per section 47(xiii) subject to certain conditions;
- On any transfer by a private company or unlisted public company to a limited liability partnership firm as a result of conversion of the company into limited

- liability partnership (LLP) in accordance with the provisions of section 56 or section 57 of the Limited Liability Partnership Act, 2008;
- (v) On transfer of capital asset or intangible asset by a sole proprietary concern to a company as on result of succession as per section 47(xiv);
- (w) On conversion of self-acquired property of a member of a Hindu Undivided Family to the Joint family property.
- 3. Further **cost of acquisition** for under mentioned assets shall be deemed to be the cost as

prescribed in Section 49(2) to **49(9)**, which are summarized below:

- a) Where the shareholder of an amalgamating company gets the shares or the amalgamated company in lieu of the shares held by him in an amalgamating company, the cost of acquisition of such shares of the amalgamated company shall be deemed to be the cost of acquisition to him of the shares of the amalgamating company – Section 49(2)

- d) Where the capital asset, being rights of a partner referred to in section 42 of the Limited Liability Partnership Act, 2008 (6 of 2009), became the property of the assessee on conversion as referred to in sec. 47 (xiiib), the cost of acquisition of the asset shall be deemed to be the cost of acquisition to him of the share or shares in the company immediately before its conversion -Section 49(2AAA).

Women top BJD agenda

Bhubaneswar: Ahead of the 2024 general elections for Lok Sabha and Odisha Assembly, it's time for setting the houses in order and sprucing up the images of leaders of all the major political parties in the state. Governing BJD headed by Chief Minister Naveen Patnaik which is in the habit of preparing for the next elections immediately after winning



one, appeared ahead of others.

The regional party has reconstituted its major frontal organizations dedicated to youth, students and women. The party also appointed senior observers in all districts and attempted to calm the frustration of MLAs who were dropped from the council of ministers or could not find a place in the last reshuffle.

This is not all: BJD also attaches more importance to Naveen's image, which is the regional party's USP in the 'Election Market'. The party knows that none other than Naveen Patnaik can ensure victory of the conch candidates in the elections. While BJP and Congress are national parties, the BJD is purely a home-grown and state-based party with Naveen as its sole rescuer. Naveen's everflourishing image is essential and the party always works in that direction, a senior leader said

The BJD has planned a major image makeover of the party president after he gets the lifetime achievement award by the reputed Delhi-based NGO, the Capital Foundation. Naveen, who had felicitated others at a function of the Capital Foundation in 2014, will himself be honoured by the NGO on Sunday by former Chief Justice of India NV Ramana. By winning this award Naveen finds himself in the elite club of former Prime Minister I K Gujral, veteran legal luminary Ram Jethmalani, former Speaker Somnath Chatterjj and others.

Party insiders said that the BJD has planned a grand reception for the Chief Minister when he returns to the State on September 6 after receiving the award. The party has also been working hard to assemble a huge gathering of Odias in New Delhi itself to greet BJD Supremo and Chief Minister Naveen Patnaik. The MLAs, MPs, Ministers and others are working overtime to organize massive gathering at Bhubaneswar Airport for a grand reception of Naveen. The Chief Minister was also given a similar reception at the airport when he returned from Pune after receiving an award in 2018, just some months before the 2019 general elections. The September 6 exercise is expected to be a repeat of the 2018 reception.

Meanwhile, Naveen has also reconstituted the BJD's youth, student and women wings with jumbo teams much ahead of the 2014 elections. While the Biju Yuva Janata Dal has 194 members as office bearers, the number of the Biju Chhatra Janata Dal is 204. The BJD President chose to set up a much bigger team for the Biju Mahila Janata Dal. The women wing now has 363 members as office bearers giving a clear message to the people that the regional outfit continues to value empowerment of women. This is because it is the women who ensured five back to back victories for Naveen, engendered by the Mission Shakti and other welfare measures for the female folks in the state.

Naveen has all along been batting for the reservation for women in the Lok Sabha and Assembly elections for which he had written letters to all party Presidents and Chief Ministers to reserve at least 30 percent of seats for the women. BJD itself reserved 33 percent of seats for women candidates in the

2019 Lok Sabha elections and became the first political party in the country to take such a step in politics, dominated by males.

Naveen fielded Pramila Bisoi from Biju Patnaik's constituency of Aska Lok Sabha seat and got her elected. It is another factor whether Bisoi's election helped the people of Aska or not, but Naveen's image at the na-

tional level was bolstered as a prowoman politician.

Recently, in both the rural and urban polls, BJD fielded many women candidates and a majority of them were also elected. Patnaik also chose women to head 21 of the 30 Zilla Parishads in the state. Similarly, major Ur-

ban Local Bodies (ULBs) like Bhubaneswar and Berhampur Municipal Corporations also got women Mayors while many municipalities and notified areas came under the leadership of women. Now, setting up a jumbo women's office bearers' team, is an indication that BJD may opt to nominate 33 per of women as MLA candidates as it did in the 2019 Lok Sabha polls.

The opposition BJP has also not remained behind. The saffron party is busy in creating an impression among the voters that Prime Minister Narendra Modi places great importance to Odisha due to which a tribal woman from Mayurbhanj district has been elected as the President of India and many other Odias currently occupy important positions at the national level.

Union Home Minister Amit Shah during his visit to the state on August 8 called upon the party workers and leaders to ensure that the message of Modi's good work and his soft corner for Odisha should reach all households in the state.

The BJP has also planned a series of activities in Odisha during the month of September. The BJP national president JP Nadda and other senior leaders will visit the state in September and interact with party workers here. Meanwhile, the BJP has appointed JN Mishra as its Leader of Opposition and also Sunil Bansal as Odisha in-charge ahead of the 2024 elections. The saffron party has given a clear signal that it will not sit silently and give a tough fight to the ruling BJD after Amit Shah said that the BJP will form the next government in Odisha as it has done in other non-Hindi belt.

The Congress which has been relegated to the third place in the state politics, has changed its OPCC president and appointed Gandhi family loyalist Sarat Pattnayak. He has set a mission to take the party to 90 from its existing 9 MLAs in the 147-member House in Odisha. Pattnayak has also announced that the OPCC will appoint its office bearers in the month of September.

It seems the stage is set for multifarious political activities in Odisha in the Pre-Durga Puja period of September before the Puja festivities roll in.

BJP wins Sept 17

HYDERABAD: After years of struggle and protests, the Bharatiya Janata Party finally has its way in getting all political parties of Telangana to agree to observe September 17, 74 years after the success of Operation Polo broke the resistance of the Hyderabad Nizam and his forces—albeit with their own narratives and contextualisation of history.

For the BJP, it is a straightforward tale – the Nizam did not want to be a part of India, and would have been fine with being a part of Pakistan, but for being on the wrong side of geography. Against the reluctance of then Prime Minister Jawaharlal Nehru, the integrator of over 600 princely states into the Indian State, its first home minister, Sardar Vallabhbhai Patel, sent Indian forces and humbled the recalcitrant and truant Nizam into surrender, liberating the people of Hyderabad State from some of the worst atrocities of history.

The BJP has been demanding that September 17 be observed as Liberation Day for a long time, but ever since the inception of a separate Telangana, the TRS government led by K. Chandrasekhar Rao would have none of it.

763 CR for Resilient Embakment

Bhubaneswar: Following the nod of the State Cabinet, the Water Resources Department has notified the scheme titled as "Cyclone Resilient Saline Embankment Projects".

The scheme will be executed during the period from financial year from 2022-23 to 2024-25 with an outlay of Rs 763.48 crore. The objective of the project is to raise and

strengthen the saline embankments to sustain the impact of severe cyclones in order to protect the adjacent landmass and habitation from flood, saline ingress and tidal surge of Bay of Bengal in four coastal districts Balasore, Bhadrak, Kendrapara and Puri.

It will help to withstand cyclonic storms of higher magnitude such as high wind speed and sea storm surges; mitigate floods by keeping flood waters within channel boundary; and protect public infrastructures like school, hospital, anganwadi centre, utilities like electricity & road communication from extreme storm during cyclone.

The projects would also protect nearby habitation, agricultural land from saline ingress. It will also help in early restoration of all forms of economic activities in the region after the cyclonic event.

The State Government has planned for raising and strengthening of 36 saline embankments measuring total length of 198.81 km to cyclone resilient standard to sustain the impact of very severe cyclone with speeds upto 250 km/hr and to protect the adjacent landmass and habitation from floods, saline ingress and tidal surge of Bay of Bengal in Balasore, Bhadrak, Kendrapara and Puri.

According to sources, upon completion of the projects, about 21,690 hectares of agricultural land will be protected from flood and saline ingress and 2,92,500 people in 136 villages in the above districts will be benefitted.

Due to raising & strengthening of embankments, road communication, scope for fishing & eco-tourism will be improved, the officials said.

The Water Resources Department has

planned to make an expenditure of Rs 290.60 crore during the current year while Rs 305.96 crore has been provisioned for 2023-24, Rs 166.92 crore for 2024-25 and Rs 763.48 crore for 2025-26.

The Department has also notified the scheme—"Community Harnessing and Harvesting Rainwater Artificially from Terrace



to Aquifer (CHHATA)" for conservation of rainwater.

The scheme will be implemented in 29,500 private buildings and 1,925 government buildings covering water-stressed 52 blocks and 27 urban local bodies (ULBs) of the State for a period of five financial years from 2022-23 to 2026-27 with a budget outlay of Rs 270 crore.

Target is set to harvest 373.52 crores litres of water roughly on completion of the scheme.

The average cost of rooftop rainwater harvesting system for Government buildings in 27 ULBs has been considered @ Rs.4.31 lakhs per building. The average cost of rooftop rainwater harvesting system for Government buildings in 52 Blocks (Rural) has been considered @ Rs3.06 lakhs per building.

Any person, in the specified ULBs, owning a building having a roof area less than 200 Sqm and not more than three floors will be eligible to apply under the scheme.

There is a subsidy provision of Rs 55,000 or 50 per cent of the cost of the roof top rainwater harvesting systems (RRHS), whichever is less in this scheme to encourage the public to adopt the scheme in their buildings. The maintenance cost of these systems will be borne by the building owners. The RRHS should have a suitable recharge unit (well) which is compulsory under the Scheme for claim of subsidy

Braja Gopal Acharya, GM, Orissa State Road Transport Corporation (OSRTC) has been appointed as Special Secretary, F & ARD Department while Aradhana Das, Land Officer, Odisha State Housing Board, is transferred as Additional Secretary, ST & SC Development, Minorities & Backward Class Welfare Department.

Similarly, the transfer order of OAS officer Smita Biswal, Additional Secretary, Health & FW Department as Additional Commissioner, Additional Revisional Court, Bhubaneswar, under the Member, Board of Revenue, Odisha, Cuttack has been cancelled. Biswal will continue to serve in his present position.

Bisikeshana Dehuri, another Additional Secretary, Health & FW Department is posted as GM, OSRTC; Rasmita Rani Tarasia, Additional Sub-Collector, Khurda is the new Secretary, Odisha State Housing Board (OSHB); Lalat Kumar Luha, PA, ITDA, Bonai, Sundargarh as Sub-Collector, Bargarh; Abhimanyu Majhi, PA, ITDA, Nabarangpur as Sub-Collector, Panposh, Sundargarh; and Akshaya Kumar Rout, is posted as Additional Sub-Collector, Khurda.

Besides, the Government has appointed Soro BDO Sushanta Kumar Barik as Additional PD (Admin.), DRDA, Mayurbhanj and Ramanaguda BDO Benudhar Sabar as PA, ITDA, Nabarangpur.

MC stops Ganesh idol immersion in Kuakhai

BHUBANESWAR: Bhubaneswar Municipal Corporation (BMC) on Friday stopped immersion of Ganesh idols in Kuakhai river after the matter was brought to its notice by The New Indian Express. BMC Commis-



sioner Vijay Amruta Kulange ordered the officials to ensure the idols are immersed only in the three artificial ponds created by the civic body for the purpose.

Kulange also urged devotees and Ganesh Puja organisers to cooperate with the civic body and use the temporary ponds to check river pollution. BMC has created artificial ponds on the banks of Kuakhai and Daya rivers.

The third such pond has been created near Tankapani bridge for idol immersion this season. Two artificial ponds have been constructed scientifically by BMC's engineering division-II and one by engineering division-I. The pond on Daya river bed is 80 feet X 30 feet with a depth of seven feet while the one close to Tankapani Bridge measures 120 feet X 60 feet with a depth of 7 feet. The size of the pond on Kuakhai river banks is around 130 feet X 90 feet with a depth of 12

Earlier, several people were seen holding immersion of idols and puja materials in Kuakhai river. From individual households to educational institutions and commercial outlets, hundreds of groups from the city have already performed the immersion ritual in the river breaching the environmental guidelines. However, after TNIE highlighted the matter through social media, the civic body sent two enforcement teams headed by environment engineers to prevent people from throwing idols and other puja materials into the river. BMC officials said approach roads have been laid for the ponds.

The civic body has taken precaution and created the ponds while complying with guidelines of the Central Pollution Control Board, the officials said.

Corneal transplants are the most common human transplant which enjoys a 95% success rate.

GMR Group exits Cebu international airport in Philippines for Rs 1,330 crores

NEW DELHI: Airport operator GMR Group on Friday said it will divest its entire 40% stake in Cebu international airport in the Philippines for an upfront payment of Rs 1,330 crore as well as earnouts to be received over a period of over four years.



Separately, the Board of GMR Infrastructure approved raising funds of up to Rs 6,000 crore via foreign currency convertible bonds or any other security. Another GMR group company, GMR Power and Urban Infra, on Thursday had approved raising funds of up to Rs 3,000 crore.

The funds will be used for infrastructure projects undertaken by the group. Group firm GMR Airports is developing airport cities on commercial land available around its airports in Delhi, Hyderabad, and Goa. Coming to its

Loan apps can't access users' mobile data: RBI guidelines

BENGALURU: The Reserve Bank of India (RBI) on Friday said that regulated entities (REs) should ensure that all loan servicing, repayment are executed by the borrower directly and not made to a third-party account.

In its guidelines on digital lending, the central bank said any collection of data by DLAs(digital lending apps) should be need-based and executed with prior consent of the borrower. Also, REs should



ensure that DLAs desist from assessing mobile phone resources such as contact list and call logos. Last month, the RBI came up with recommendations of the working group on digital lending. It has also given time to regulated entities till November 30 to implement its new digital lending guidelines. RBI's guidelines are applicable to all commercial banks, non-banking financial companies (including housing finance companies) and primary (urban) co-operative banks, among others. According to the guidelines, the penal interest or charges levied on the borrowers should be based on the outstanding amount of the loan. Also, the rate of such penal charges should be disclosed on an annualised ba-

4 Chinese warplanes, 5 naval ships cross Taiwan Strait

not revoke the latest weapons agreement, while Taiwan's Presidential Office and Ministry of National Defence expressed gratitude for the Biden administration's support for the country's defence needs, reported Taiwan News.

Earlier on Friday, Taiwan had tracked 19 aircraft and three ships from China's military around the country by 5 pm.

Four of the People's Liberation Army Air Force (PLAAF) warplanes entered the southwest sector of the country's air defence identification zone (ADIZ).

The aircraft were two Shenyang J-16 fighter jets, one Shaanxi Y-8 ASW anti-submarine plane, and one Shaanxi Y-8 EW electronic warfare aeroplane, the ministry said on Twit-

The country has been facing more aggressive actions from China's military, especially following the August 2-3 visit by United States House Speaker Nancy Pelosi.

Live-fire missile tests, large-scale military manoeuvres all along China's coast, warplanes crossing the median line of the Taiwan Strait, and civilian drones flying over Taiwan-held islands close to China have all become more commonplace since Pelosi's trip.

Meanwhile, Taiwan's Ministry of National Defence moved anti-drone guns to the off-shore islands of Kinmen and Matsu following several incidents with unmanned aerial vehicles (UAVs) believed to have flown in from China, reported Taiwan News.

Civilian drones have been spotted above Taiwan-held islands close to the coast of China's Fujian Province for several days, with one of them shot down over the sea in Kinmen County on Thursday after it failed to heed warnings.

The appearance of the UAVs is seen as yet another sign of China's provocative behaviour, in addition to recent large-scale military manoeuvres and the almost daily incursions of Chinese warplanes into Taiwan's air defence identification zone (ADIZ), reported Taiwan News.

ences but these should be addressed through dialogue, she said adding that in a number of areas, India and Bangladesh had precisely done that.

She, however, marked out two areas for special praise where the Indian government's support helped Bangladeshi citizens. One of these was the evacuation of Bangladesh students, who like many Indians, were stuck in Ukraine and its neighbouring countries after the outbreak of the conflict.

"I really would like to express my thanks to Prime Minister that during this war between Russia and Ukraine, many of our students were just stuck and they came to Poland to shelter. But when you evacuate your students, Indian students, they also brought our students back home. So it is really... You have shown a clearly friendly gesture. I thank Prime Minister for this initiative," Hasina said.

She was responding to a question about remarks often made especially by western observers that there was a lack of cooperation among SAARC nations. To another question about the Indian government's Vaccine Maitri programme, Hasina said it was a very "prudent" initiative taken by Prime Minister Modi.

"I really thank Prime Minister Modi for this initiative, and that way he... you know, contributed vaccines to not only Bangladesh, also some south Asian countries, and it's really very very helpful. And it's a really prudent initiative he has taken, and beside that we bought vaccines with our own money, and also many other countries also contributed," Hasina said.

Hasina also gave details about her country's vaccination programme. Bangladesh has administered Covid-19 vaccines to 90 per cent of its population. "Usually, you know, people from our country, especially the village level, even in some towns also, I found many people very much reluctant to take vaccine. They don't want to take the... you know... the pinch of needle or 'sui nai lena hai' so... but we have to pursue them. We told them that this is nothing but it will save your life. So that way we engaged everybody, so that they make people... so it was really very good initiative, this Vaccine Maitri itself... very good initiative. I really support," she said.

Hasina referred to India as a "tested" friend and said that country had stood by Bangladesh in its hour of need, first in 1971 and then at later times also.

"We always remember their contribution during our 1971 war. And beside that even 1975, when we lost all my family members. So, the then Prime Minister, she gave us shelter in India. Besides that, you see, these two countries, we are neighbours, close neighbours and I always give importance and priority to friendship with our neighbouring countries," she said.

The relationship between the two countries should be for the betterment of their citizens, she said

Hasina said even during the Covid-19 period, Indian leadership had shown their positive intentions as both, the then President Ram Nath Kovind and Prime Minister Narendra Modi visited Bangladesh as it celebrated its Independence Day.

"I really thank Prime Minister Modi and also your honourable president. Both of them visited Bangladesh when we were celebrating our father of the nation birth centenary and also our independence, 50 years of our Independence Day, and our friendship with India. India recognised Bangladesh early on, so that bonding, I think that is our main priority. That their visit at such a time, even that time there was a Covid-19 pandemic but beside that both of them honoured us, honoured our people," she said.

Coded signals give options to the fielding captain, says Mickey Arthur

Sri Lanka: Sri Lankan computer analyst Prad Navaratnam was seen sending coded messages to his team captain Dasun Shanaka during the two recent crucial Asia Cup matches against Bangladesh on Thursday and Afghanistan on Saturday.

The codes read 2D, D5, A2, C4, D etc. Apparently, the codes were sent in consultation with the head coach Chris Silverwood, who was sitting next to him in the dugout. Sri Lanka seemed to have followed England,



who also used real-time coded signals from the dressing room in the T20 series in South Africa in 2020. It was for communicating with the then skipper Eoin Morgan on the field. Silverwood, who was a coach with the English team then was criticised by former England captain Michael Vaughan.

Lance Klussner, who was a head coach with the Afghanistan team till recently, does not see value in it. "No, I don't like this system (of sending coded signals to the captain). I never used it (during my time with the Afghanistan coaching)", he said over the telephone from Australia, where he is a batting coach with the Zimbabwe team, which won the third ODI against the hosts on Saturday. "It may sound interesting, but it's not new and personally I don't see value in it. The coach can easily send the messages to the fielding side during over-breaks or drinks interval", he added. "If you trust your captain while fielding and your batsman while batting to make the correct decisions there is no need

for this messaging", he concluded.

There's nothing wrong in this, and no rocket science, believe Mickey Arthur and Grant Flower, who were recently the Head Coach and the batting coach with the islanders.

"Those are signals that keep and give the captain options, that's all. You remind the

captain of potential matchups and give him an option. It is then upto the captain whether he wants to use them or not ", Arthur, speaking exclusively, said.

"It is only done when the team is fielding".
"I am not sure how their system works but I imagine that it is a signal telling them which bowler to bowl and when. Then it's up to the captain to make a call", Flower said.

Arthur, during his stint with the Sri Lankan team didn't use this tactic.

World Cup fans will only get beer outside stadiums

Beer will not be sold inside stadiums during World Cup matches in Qatar, where alcohol is severely restricted, but FIFA said Saturday that drinking will be allowed in the stadium zone before and after games.

The global body gave first details of beer sales after months of sensitive talks with authorities in the conservative Muslim Gulf state.

The issue is important for FIFA as beer-maker Budweiser has been a major sponsor for three decades while foreign fans have also questioned what to expect at the November 20-December 18 tournament.

Qatar has predicted more than one million visitors for the World Cup.

A source with knowledge of the plans said beer stands would open in zones around stadiums when gates open for a match and close 30 minutes before each game starts.

The source said stands would reopen for a short time after the game.

FIFA did not confirm times but a spokesperson said it had focused on "catering for those who wish to enjoy an alcoholic drink while being respectful towards the local culture". In a statement to AFP, the spokesperson said

"ticket-holders" would get access to beer "within the stadium perimeter prior to kick-off and after the final whistle."

Inside stadiums, only Budweiser's zero-alco-

Inside stadiums, only Budweiser's zero-alcohol beer and soft-drinks would be available, the spokesperson added.

Coca-Cola, another huge sponsor, has the sole

right to sell non-alcoholic drinks at the eight stadiums to be used for the first World Cup in a Muslim nation.

Alcohol is a sensitive topic at stadiums around the world. In England, most Premier League clubs allow beer sales inside stadiums but fans cannot drink in sight of the pitch. While alcohol is not banned in Qatar as it is in neighbouring Saudi Arabia, it is only sold in about 35 international hotels and restaurants. Foreign residents can buy alcohol in government stores. Drinking in public is illegal.

Budweiser's parent company, AB InBev, did

not comment on FIFA's plans but has in the past said it was looking for "respectful" ways to sell its product at the Qatar World Cup.

Beer has traditionally been sold at fan zones throughout the day at previous World Cups.

But the FIFA spokesman said it would only be available from 6.30pm at the FIFA Fan Festival zone in Doha.

Qatar's World Cup organisers, the Supreme Committee for Delivery and Legacy, have not given details of alcohol sales in the fan zones it is organising.

It tested beer sales at the FIFA Club World Cup in 2019 when a glass of beer cost about \$7 at a special zone on the edge of Doha. Only a few thousand foreign fans were present.

Industry sources have said that fans may have to buy tickets to get access to the local non-FIFA zones where beer is sold at the World Cup.

French tennis player accuses former coach of sexual assault

NEW YORK: A professional tennis player from France who reached a career-high ranking of No. 39 last year has accused her former coach of rape and sexual assault.

The French Tennis Federation said in a statement Saturday that it is "standing by" Fiona Ferro, a 25-year-old who lost in qualifying at the U.S. Open last week, "in the proceedings she has initiated against her former coach, Pierre Bouteyre."

The federation added that it "is examining the possibility of filing a civil lawsuit in this case."

Ferro wrote on social media about her accusation against Bouteyre and said, "I did not consent." "I have full confidence in the justice system of my

situations."

Mentioning Ferro, Azarenka said: "I applaud her for being brave. I hope this situation, she's going to come out of it stronger and tennis is not ruined for her because of that. That's, I think, a very, very heavy topic. But it's the topic that has to come out more."

In March, a tennis player held a news conference after suing the U.S. Tennis Association, saying the governing body failed to protect her from a coach who she says sexually abused her at one of its training centers when she was 19.

Kylie McKenzie said that coach Anibal Aranda touched her inappropriately at the USTA's training



country and confirm that I do not wish to make any other statement on the criminal investigation," Ferro said.

The Associated Press typically does not identify people who say they have been sexually assaulted unless they come forward publicly, which Ferro has done.

Ferro is the latest female tennis player to bring attention to the issue of protecting athletes from predatory coaches.

"We applaud Fiona for having the courage to come forward with these allegations. We are pleased to see a full investigation and legal process being pursued," a WTA spokesperson said via an emailed statement on Saturday. "The WTA is dedicated to ensuring a safe environment across our tour. Safeguarding requires vigilance, and we are continuing to invest in education, training, and resources to improve our efforts."

After winning her third-round match at the U.S. Open on Saturday, two-time Australian Open champion Viktoria Azarenka was asked about the manipulation and exploitation of young players by coaches.

She said the WTA player council, of which she's a member, considers safeguarding a "No. 1 subject ... because we see those vulnerable young ladies that (are) getting taken advantage of in different

center in Orlando, Florida, according to a lawsuit filed in federal court in central Florida. The lawsuit says Aranda, who was employed by the USTA for about seven years and later fired, used his position as a USTA coach to get access to vulnerable female athletes.

In April, former tennis player Pam Shriver, now a TV commentator, revealed in a first-person account published by British newspaper The Telegraph that she "had an inappropriate and damaging relationship with my much older coach" that began when she was 17 and he was 50.

After word of Ferro's accusation emerged, Shriver tweeted: "Sending my best support to Fiona Ferro. The best way to improve safeguarding, is to tell our stories."

Ferro has two career titles and reached the fourth round of the 2020 French Open for the best Grand Slam showing of her career. She is ranked 259th currently.

"We would like to express our support for Fiona Ferro, while respecting the presumption of innocence, at a time that we know is particularly difficult for her," said Gilles Moretton, president of the French federation. "The FFT's sports integrity unit is currently assisting her and we will do everything we can to help her rebuild her life."
